# **J'Accuse**

### The malevolent hypocrisy that now governs Great Britain

# Introduction

I am not so stupid to think that Britain has always been a righteous and benevolent country. No country is such. Neither do I believe that Britain has always been a 'Christian' nation. No nation is such.

Despite that, Britain has been a stalwart defender of the Christian faith for over 500 years and was one of the first ever nations to declare that it was based upon Christianity (perhaps the first nation). Its legal system is based upon the Bible; its parliamentary system is based upon the ideas of liberty that emerged from Reformation principles; many of its vital institutions of infrastructure were founded by Christian philanthropists; and its greatest leaders were Christians.

Neither am I stupid enough to think that Britain's role in the world has always been altruistic. The height of its power was under the Mercantile Empire when trading corporations held foreign power like a small sovereign state, most notorious being the East India Company. We had many inglorious moments: the Irish famine, the Jamieson Raid, the First Zulu War, Boer War concentration camps, the Opium Wars, the treatment of Australian aborigines and Kiwi Maoris, torture camps in Kenya and Aden, the Indian partition leading to millions of deaths, gassing Iraqis and so on.<sup>1</sup>

Despite many failings Britain still widely operated as a force for good. It brought civilisation to backward countries. It brought commerce and prosperity to states that were previously in the Stone Age. It brought top class infrastructure: roads, bridges, railways, reservoirs, communications, defence against attack, and an efficient civil service administration. Many old people in India look back with longing on the Raj and British structures are still operational: roads, railways, and even Victorian beam engines. India still relies heavily on the civil service Britain introduced.

On top of this, Britain brought the Gospel to all the nations under its sway. Indeed, on occasion the Gospel came to a place first and was followed by colonisation, such as Kenya. When it ruled righteously, it transformed a primitive nation into an opportunity for personal mobility and prosperity.

Thus many of the colonised nations still feel an affinity to Britain, even though politically independent. In fact, most of them still give an institutional allegiance to the Queen.

Therefore, Britain came to be known as 'Great Britain' in the days when Queen Victoria could tell an Indian prince that the power of her empire rested upon the Bible.

Churchill was responsible for gassing the rebels in Iraq (1920, the first airborne chemical warfare). He started bombing raids on German schools and villages long before the German Blitz. He worsened the Bengal famine of 1943 which killed 3 million people by diverting supplies to well-supplied British troops and blocking American and Canadian ships from delivering aid. He also stopped the Indians using their own ships or currency reserves to help the starving. When told of the deaths his reaction was callous.

All that has evaporated.

I accuse today's Britain of being a vile nation governed in the interests of Satan, and being full of iniquity and corruption. It is the foulest hypocrite, being outwardly a place of liberty, democracy, integrity and justice, when it is utterly corrupt and full of unrighteousness. Yet most Britons are unaware of just how perverted Britain has become. I will give a few examples.



# Britain is a rich country

The UK is consistently listed in the top ten richest countries, between fifth and seventh. At the moment it is the fifth richest country behind the US, China, Japan and Germany. This is determined by market exchange rates and by this method Britain in 2016 had an economy of \$2,629 billion according to the IMF.<sup>2</sup> The UK's GDP in 2016 was £1,940 billion; by this measure it was also fifth. So Britain is richer than France, India, Italy, Brazil, Russia and Canada.<sup>3</sup>

This means that Britain has sufficient wealth to ensure that its citizens are treated with equity. At the end of the day, the productivity of the nation should be spent on the nation.

Where does this money go?

Governments are always quick to say that we have no money to do this or that; yet when something unexpected arises there is plenty of money that is suddenly found. PM Theresa May suddenly found over a  $\pounds$ 1 billion to grease the palms of the DUP to support her ailing government. This is at a time when the NHS is collapsing as a result of over  $\pounds$ 30bn Tory cuts since 2010. When the banking crisis emerged in 2008 the US and UK governments found trillions to support the corrupt banks that caused the crisis in the first place.

Britain always finds money to spend on illegal wars and military incursions no matter how broke we are. The Iraq War cost at least one billion dollars per day for the coalition. The Afghan War was not only illegal but also a complete waste of time (it served an elite plan to do with an oil pipeline and with heroin production), which we have been paying for for 16 years and counting. Despite not being at war with Libya, Iraq and Syria today, and despite them being no threat to us, we have spent billions dropping bombs on innocent civilians as part of a useless elite strategy.

Then there are the crazy, inexcusable government projects that make no sense to anyone, such as HS2. Multiple billions will be spent, and great damage done to the countryside, to get someone from London to Birmingham 24 minutes faster. Trident is also a multi-billion red herring that is no deterrent at all.<sup>4</sup> You cannot make this up.

So, Britain has money to find when it needs it for something illegal, cruel, or stupid. But it has no money to fix poverty, stop child hunger, help the disabled, build affordable homes, fix the roads, improve the trains, reduce energy costs, or boost manufacturing. Yet investing in these things actually, in time, increases productivity and the economy when wars drain it. We can't find money to help boost the economy but we can find money to damage it.

Yet again, the government finds plenty of money to give tax breaks to multi-millionaires. It has reduced Corporation Tax for example and given various boosts to the rich. Meanwhile it has created up to £57,000 of debt for the poorest kids that want to go to university. This accrues interest at a current rate of 6.1% (when the bank rate is near zero) because George Osborn sold the debt to a private company. When the students get work at a salary of over £21k, they have to pay an additional 9% tax, meaning that they will pick up about half of their salary at a time when they need to pay for wives, kids and buy homes. No wonder graduates are suffering depression and many have committed suicide.

Britain is economically rich compared to most nations. It also finds money when it needs to for some unrighteous purpose. What is it doing with this money and this responsibility of government under God?

# The most corrupt country in the world?

This is the accusation of a Mafia specialist, Roberto Saviano, who studied all the governments of the world and came to the conclusion that Britain was the most corrupt.<sup>5</sup> This corruption was not centred in government or local government but in the banking and financial institutions.

90% of the owners of capital in London have their headquarters offshore. The UK allows criminals access to capital held in Jersey and the Cayman's. David Cameron repeatedly refused demands for the UK to reform offshore tax havens operating on its own Crown Dependencies and Overseas Territories. The UK also ranked 10<sup>th</sup> in Transparency International's 'Corruption Perceptions Index 2015', which measured perceived levels of public sector corruption worldwide.

For example, HSBC was fined 2bn Euros after confessing that it had laundered money coming from Mexican drug cartels, Qatari societies and Iranian companies. Commentator after commentator<sup>6</sup> has exposed the vast corruption of British banks and financial systems. Federal investigations have proved the corruption of Libor, the gold standard, the silver standard, Forex and many smaller financial systems.

Without a doubt, just as in Wall Street, the City (London's financial sector) is thoroughly corrupt – and yet the British government has continually focused on this area as the foundation of British economic wealth. The service sector<sup>7</sup> provides the majority of the UK's economic wealth, while wealth in the real world, manufacturing and inventions, has plummeted.

# **Domestic policy**

# Internal infrastructure collapse

Everywhere one turns we see the effects of seven years of unnecessary austerity measures, which have not only done nothing to help the economy but have doubled the national debt. Every service one uses seems to be falling apart. Day after day one hears personal stories of utter chaos in this or that public sector situation.

#### The NHS

The most obvious area for comment is the health service, which is literally on the verge of complete collapse. All the signs are of imminent collapse: surgeries closing, doctors leaving the country, GPs threatening to retire early or just quit, nursing numbers way down, waiting times getting higher, operations being cancelled, ambulances failing their targets, unnecessary deaths being reported; the list goes on and on.

As someone with several severe medical conditions I have seen this first-hand multiple times, even requiring written complaints to CEOs and the government ombudsman. Some are just shocking. A GP called an ambulance for my father; it took 12 hours to arrive (the hospital and ambulance station are both within two miles). He died two weeks later after being maltreated in hospital, including falling out of bed because the wrong bed was used and failing to be given water so that his kidneys failed. In recent weeks my mother has been given the wrong medicine, no medicine, no food for three days, no assistance to go to the toilet when she couldn't walk, wrongly prescribed drugs that interacted with existing drugs, failed diagnosis and more. Though they made mistakes, I am slow to criticise doctors and nurses who are rushed of their feet trying to do their best because the staff levels have been cut to the bone. I know of doctors working more than 14 hour shifts and nurses staying hours over their time.

The true cause of this are cuts of over £30bn by Tory governments who are committed (in writing) to destroy the NHS and sell it off in pieces to firms that more than 50 MPs are executives of. I do not need to detail this as I have repeatedly written about this.

One simple point: GP practices (primary care) are on the brink of collapse according to leading doctors. There are mounting workloads, staff shortages and reduced funding. The chairman of the BMA GP Committee, Dr Chaand Nagpaul, warned of an avalanche of work on a service that is thousands of GPs short. One in ten practices are not sustainable. Safety standards for GPs are 25 consultations a day yet some practices are seeing 80 people a day. Many doctors are finishing work at 9pm, many often starting at 6.45am.

Let me just offer some concise bullet points to finish:

- The number of people waiting on trolleys more than 4 hours increased from 387,737 (2015/16) to 560,108 (2016.2-17). This is an increase of 45% in one year. The Red Cross described this as a '*humanitarian crisis*'.<sup>8</sup>
- Ambulance response times are the worst since records began. The target of reaching 75% of Category A calls within eight minutes has not been met for 32 consecutive months.<sup>9</sup>

- Infant mortality is rising.<sup>10</sup>
- The Royal Society of Medicine attributed 30,000 excess deaths in the winter of 2015 to cuts to health and social care.<sup>11</sup>
- The NHS has fallen down international league tables of mortality due to treatable causes.<sup>12</sup>
- In 2015, Health Education England calculated that the NHS had 30,000 fewer full-time nurses than needed.<sup>13</sup>
- Nurse's pay will have been cut by 12% by 2020. 59% of nurses report working unpaid overtime each week. 50% of nurses are considering leaving their jobs.<sup>14</sup>
- The percentage of NHS budget spent on for-profit providers rose by 25% in two years.<sup>15</sup>
- Claims of increased spending were lies; money was moved around within the NHS (taken from doctor and nurse training budgets).<sup>16</sup>

#### The care service

The care service is in as equally a frail state as the NHS. In fact, even senior MPs have said that it is not fit for purpose and on the verge of complete collapse. The bed-blocking caused by old people unable to be housed anywhere else is helping to cause the chaos in hospitals.

Again, I have written on this before.

#### Mental health care

This is another area which is facing complete collapse. The underfunding of the last seven years, coupled with a big increase in demand due to government policies, has led to terrible failures of care and even deaths. There is not a single mental health bed anywhere in the country due to cuts.<sup>17</sup>

Again I have explained this before.

#### Poverty

It is a public scandal that poverty levels are so very high with child poverty being at its highest ever level since 2010. 30% of Britain's children are now classified as poor, with two-thirds from working families. The IFS stated that income for working age adults was no higher than eight years ago.

100,000 children fell into relative poverty in 2015-16. About 4 million are now classified as poor. Planned cuts to working age benefits are going to make this even worse. Nearly half of single-parent children are poor.

On this very day a story was aired on the BBC (Radio 2, Jeremy Vine programme),<sup>18</sup> about the growing problem of children in school vacations (who normally get free school meals) having no food when they need it most (due to running around playing). Multiple charities have had to be set up to provide free meals and family support for local kids who do not have enough to eat. One woman who formed such a charity recently in Deal, Kent, is feeding up to thirty kids every day with volunteer chefs and local suppliers giving free food.

Trussel Trust, one of several free meals organisations, is giving out over a million meals a year with special supplies for school holidays. Many people attending such food banks are working people that do not have enough money for food. Famously, many nurses are going to food banks.

The fact that the fifth richest country even has food banks at all is a terrible indictment.

One of the causes of hunger are government policies, such as the Universal Credit roll out, which often leaves claimants (including disabled people) without any money for months on end. The benefit sanctions system also leaves claimants without money for a month or more due to minor infringements (such as being late for a job interview or failing to fill a form out in time on a computer). For a graphic illustration of this wickedness see the Ken Loach film, *I Daniel Blake*.

#### Homelessness

The number of people sleeping rough in the UK has risen for the sixth year in a row.

Official figures say that 4,134 people were forced to sleep rough in 2016, up 16% from the previous year. However, campaigners say that this figure is woefully short of the far greater true figure. Councils simply take a count of visible homeless people one day a year and make an estimate. Many of those sleeping in the cold are youngsters. Charities, like CHAIN,<sup>19</sup> state that 8,100 people were visibly seen sleeping rough in London alone in 2015-2016.

Council figures show that around 20,000 cases of people are found homeless but not in priority to re-house occur each year. They have no legal liability to house someone not in priority (e.g. with children). In June 2016 73,000 households were in temporary accommodation, 9% higher than in 2015.

The main cause for homelessness is the lack of affordable homes, the rise in rents and mortgage costs, and falling wages. In Brighton it is common to pay between  $\pounds$ 800-1,000 per month for a single-room bedsit.

#### Prisons

The president of the Prison Governors Association, Andrea Abutt, recently warned that prisons in England and Wales are *in 'complete decline*'. In addition, recruitment was in a '*critical condition*'. She criticised the Ministry of Justice for failing to address the jail staffing crisis, which followed reports of violent prisoner unrest at HMP Erlestoke, Wiltshire and The Mount in Hertfordshire. Last year there was a 20% rise in prisoner violence with a record 7,159 attacks on staff (20 per day).

Other commentators have reported that the prison service is now in complete disarray with several warning that a major violent event is about to happen, which will result in fatalities. The privatisation of several sections of the prison service has also resulted in multiple

failures, including several prisoners wrongly released from jail. Privatised areas have also resulted in far fewer prison officers on staff shifts, too few to do the job safely according to commentators.

#### Councils

Local government has experienced cuts of 40% since the Tories came to power in 2010. By 2014 the welfare budget had been cut by £25bn. The National Audit Office reports that over half of councils will risk financial failure by 2020 - that means being unable to fund vital local services they are legally obliged to provide. This is unprecedented in British Welfare State history.

Many areas that are already falling apart will collapse entirely – road maintenance, environmental inspection, theatres, leisure centres, and libraries. Areas that are already showing signs of collapse will get worse, including adult and child social care. The existing crisis in this area will become a catastrophe. The current £1.6bn gap between adult social care demand and available resources will grow to £4.4bn by 2019.

Despite cracks appearing everywhere in the social system, the government is planning yet more cuts to budgets. The worst thing about all this is that it is the poorest, most frail, most vulnerable people in society that are suffering, while rich Tory MPs make money out of selling off bits of the NHS and social services systems to corporations that they are on the boards of.

#### Police

Under Theresa May, as either Home Secretary or PM, the police budgets have been cut by 18%. This resulted in a cut to police officers of 21,500 since 2010. New Home Secretary Amber Rudd has refused to rule out further police cuts.

#### Defence

Britain's national security is already threatened by severe cuts to the MOD. In November 2016 a £8.5bn deficit was found in the MOD budget. Military vehicles are left in disrepair due to poor maintenance, The RAF's main base for air-to-air refuelling has been closed over safety concerns.

Experts have blamed privatisation for many current failings. For instance, Capita is the private firm responsible for much of the defence estate but it has not performed adequately against agreed performance indicators.

Despite this, the MOD is being forced to sell off more of its estate by 2040 to meet targets.

#### Education

By 2020 class sizes will be much bigger, schools larger and more ungovernable, while the value of a teacher's salary continues to fall and the crisis in teacher recruitment gets worse.

Support services like school improvement programmes, behavioural support, legal support, training etc, will vanish.

The increase in the birth rate will hit education services at a time when their budgets were never smaller.

#### Immigration

I cannot develop this here but I have written about this situation many times. Immigration and refugee asylum is one thing for a reasonable society to do; but mass immigration of a

barbarous culture that hates us, and which includes a majority of young adult males, many who have been trained as jihadis, is suicidal.

Yet this is what has happened in recent decades and which certain towns are now paying the price for. Multiple towns and cities now have a sexual grooming, abuse, rape and trafficking problem run by Muslim, mostly Pakistani, men. Rotherham was just the thin end of the wedge of a national problem.

Then there is the training of radical Islamist jihadis that is going on under the very nose of the authorities. Saudi Arabian backed mosques are training Muslims in the principles of Wahhabi Salafism that include murder. You can find videos of Muslim leaders teaching students that certain people must be killed according to Islamic law (which derives from Muhammad's teaching in the Qur'an and Hadith).<sup>20</sup>

Then there are the seemingly constant terrorist activities that stem from Salafist Muslims: bombs in stadia; bombs on Underground trains; attacks by vehicles; attacks on restaurants; bombs on buses; murder on the streets; knife attacks on mothers collecting infants from nurseries – we could go on and on. We have imported a culture that hates western Christians and seeks to overthrow society and turn it into a Sharia state. The security services now state that over 50,000 Muslims now pose a significant threat to society – but nothing is done apart from police monitoring of 5,000 suspects, which has not stopped such people committing terrorist attacks.

Yet the government has not only invited these people in without adequate vetting, but gives them benefits and houses before national citizens. One of the key centres for hate-training of jihadis in London is only a few miles from Parliament itself – which does nothing except castigating commentators that raise this issue as racists.

#### Conclusion

Everywhere you look you see a section of society that used to run reasonably well but is now in terminal breakdown and about to collapse. Famous right-wing political commentators are even saying that Britain is finished and that young people ought to move elsewhere (e.g. Peter Hitchens). Left-wing reporters are exposing multiple strands of Britain's evil domestic policy. Many old people are saying that they are glad that they will die soon as life in Britain has been ruined and they want to escape it. I know a Finnish woman who has lived here for decades and has a British family that is planning to return to Finland because the quality of life is so much better in this poorer country. Young people are saying that they don't want to bring children into this world as society is so badly damaged.

There is something rotten going on.

# Employment

#### Debt

One in five people are in moderate to severe financial distress today because of debts amassed in recent years. In the past year consumer credit has exploded. Alex Brazier, the Bank of England's director for financial stability, noted that the volume of credit card balances and personal loans had surged by 10% but household income was only rising by

1.5% a year. The credit ratings agency, Moody's, is issuing alerts this very week and downgraded the outlook for bonds backed by British consumer debt.

The only time that Britain has had the household debt to income ratio as elevated as it is now was ten years ago just before the crash and the deepest recession since WWII. One can only imagine the carnage that will result if the Bank of England raises interest rates from its historic low of around 0.5%.

Behind all this is the lack of any real wage growth. Real GDP per head has grown by less than 2% in real terms since 2008. Productivity has stalled. A new growth model is required because the old system no longer works.

Previous lucrative areas have disappeared due to low interest rates, and banks have chased riskier business models, such as credit cards and car loans. The debt bubble could cause all this to explode, which is why the Bank of England is using various levers to try to get banks to restrain themselves. But money is cheap and banks need profit margins.

The government's policy of printing money coupled with low interest rates was sure to create serious problems and the chickens are now coming home to roost. Add to this a government manufactured housing boom (especially in London) coupled with a recent slow down of house prices and the powder keg is set to go.

#### The lack of real jobs

Although the government can boast about the low unemployment rate, it is at the cost of virtual slave labour, which is no good for the exchequer.

Zero-hours contract jobs and a proliferation of part-time jobs are good for employers but bad for workers and terrible for raising taxes. But this is what has expanded in recent years. While zero-hours contracts may be helpful for a very small percentage of the population (say students at university), they are hopeless for adults trying to get on or for men with a family. They also entail few, if any, workers' rights leaving people with little support if they get sick, disabled or have a baby.

This week I went for a meal with my son's family. The poor waiter was rushed off his feet because the restaurant had cut posts in servers and in the kitchen. Towards the end of the night I said that at least he would sleep well tonight. He replied that he wouldn't get much sleep at all since his second job started at 7am. This is the reality facing many thousands of young people today.

# Paedophilia

I have written on this extensively and will not repeat all that information. Suffice to say that there is a high-level conspiracy in this country (and others) whereby children are abused, raped, and murdered by high-ranking people in all areas of public services.

Politicians to the level of prime minister have been accused of child abuse, rape and murder, but the government finds ways of shutting all the investigations down. Police enquiries are terminated by high ranking officers of the secret services. Public enquiries are a whitewash.

More and more public servants, such as retired police officers and social workers, are continuing to come forward and give evidence that entirely supports the claims of thousands of victims whose lives have been ruined by politicians and others.

It took 50 years for the government to confess and repent for the child slavery it instigated in the 1920s whereby children were taken from parents (usually single-parent girls) and sent to Australia to work on farms where many were abused.<sup>21</sup> As more and more information arises of institutional child abuse by care homes, schools, orphanages, hospitals, at the hands of wicked perpetrators in the royal family, aristocrats, the judiciary, the police force, MI5, Westminster, the armed forces and so on, one can only hope that the full scale of this crime will be exposed eventually.

### Sex education insanity

I have long been writing about the wickedness of stimulating the sexuality of children as young as five through the educational materials of NGOs, the government, and local councils. Over twenty years ago London boroughs were giving leaflets with very graphic images to young children explaining oral sex, masturbation and safe penetrative sex. After this, materials came out extolling the virtues of homosexual sex and homosexual marriage.

Even the dullest parent understands that such information is inappropriate for young minds, to say nothing of the lies in the promotions. The consequent explosion of sexual activity amongst teenagers, and much younger kids, is now well documented. This includes pre-adolescent girls getting pregnant; sexting; grooming; an explosion of sexually-transmitted diseases; children raping other children and so on. The build up of frustration in young people exposed to graphic sexual images and education has even resulted in the growth of bestiality. I have been told of numerous occasions of this in my local school (which is considered of good standard).

However, this has now become beyond the range of any kind of sanity and is entering the realm of government promoted wickedness of the first order.<sup>22</sup>

Behind a great deal of this is the World Health Organisation (WHO) which is just a front for the global elite. This organisation is now promoting all sorts of insanity through the media, education, NGOs and government programmes. For example:

The current activity being pushed on kids is anal sex. This is being taught to kids as young as 8 as being normative, safe, loving behaviour, with either the same-sex or the opposite sex partners. One example is the magazine TeenVogue, a very popular glossy magazine aimed at teenagers but acknowledged as being read by kids as young as 8-years old.

This teaches that anal sex is safe and pleasurable and includes graphic images of male and female biology. Headlines made statements such as that the anus is full of nerve endings that, for some, feel awesome when stimulated.<sup>23</sup> '*Anal sex … is a perfectly natural way to engage in sexual activity … there is no wrong way to experience sexuality*'. [What about bestiality, necrophilia, incest, torture, sex-murder etc. See how the conditioning is preparing kids for yet further horrors.] The writer claims to be a sex-educator and Feminist yet made no mention of safe sex.

Now this is in close connection with the elite's programme of vaccinations that make billions. In this case the vaccine is for the Human Papilloma Virus (HPV). At the same time that the elite uses propaganda to promote anal sex (which is dangerous) it uses

governments to push the HPV vaccine through their health systems. Governments are currently being pushed to give young boys the HPV vaccine. The law allows girls to get the HPV vaccine without permission of her parents. BOOTS are stocking the HPV vaccine which parents can purchase for between £300-400. Some have suggested that Merck (the maker of the HPV vaccine) is behind the article. The magazine's parent company, Condé Nast, has also launched a new pharmaceutical focused division to develop reader targeting. TeenVogue has also produced a stream of articles promoting the HPV vaccine.<sup>24</sup>

There is a greater risk of HPV infection in women and men that have had anal sex; this is a fact. The article also gives no warning about the dangers of anal sex, which include: HIV, gonorrhoea, chlamydia, genital herpes, chancroid, e coli and urinary tract infections, anal fissures, mucosal tears, rectal perforations sphincter injuries, perforated colons or syphilis. Not much of an educator then! Another factor is that the female birth control pill quadruples the chances of suffering from HPV issues.

Apart from the worrying connection between promoting anal sex in kids and promoting the HPV virus at the same time, we see even worse conditioning.

#### Incest

The German Federal Health Education Centre (which is nominated and confirmed by WHO and supported by the Federal Ministry of Health) published two 40-page booklets entitled, '*Love, Body and Playing Doctor*' aimed at the parents of children aged 1-3 and 4-6. This is part of an EU legislation programme to legalise paedophilia.

These books teach manual sexual contact between fathers and daughters in order for the child to feel good about her body.

Kids often touch their father's bodies, and sometimes even excite them. Fathers should do the same to their daughters.

Fathers do not devote enough attention to the clitoris and vagina of their daughters. Their caresses too seldom pertain to these regions, while this is the only way the girls can develop a sense of pride in their sex. (Note that this is addressed to 1-3 year olds.)

The child touches all parts of their father's body, sometimes arousing him. The father should do the same.

Parents that have refused to allow their children to be exposed to school sex-education like this have been put in prison. While this is currently focused on the German situation, until we leave the EU this will be enforced in British education as well.

Medical professionals are also recommending that child sex-dolls should be made available to paedophiles.

The insanity just continues.

# The political support for public homosexual indecency

The annual Pride marches in many UK cities have become a totem of modern mores and untouchable, no matter what criminal acts are conducted. This is part of the focus of a much wider domination of the media, social life and politics by the Gay agenda.

In every walk of life homosexuality is given pride of place and traditional sexual morals are disparaged. The television is covered in pro-Gay programmes and presenters. The BBC has recently broadcast a series of programmes about homosexuals every night of the week. In fact there are sometimes several programmes in succession.

Even Gay people (such as Matthew Parris and David Starkey) have complained about alienating heterosexual people by pushing the barriers even further and thrusting homosexuality in the face of people without relent.<sup>25</sup> One can have a certain respect for homosexuals who behave normally in public, do their job with professionalism and keep their private lives private. One can also appreciate more sane Gay people, such as the London homosexuals that raised money for the striking miners and befriended an obscure village in Wales in the 80s.

The real problem is with the radical agendas to thrust homosexuality in the face of the public all the time endlessly and to do it with lewdness and licentiousness. Politicians seem to favour this.

Thus we could mention numerous organisations, TV programmes, plays, films, activists, celebrations and so on but the Pride march seems the most obvious example.

First, we have to state that if heterosexual couples were to commit acts of lewdness in public they would be arrested. Even acts short of full sex are a criminal offence if conducted in public. Nobody wants to see this and the law must consider the effects on the young, the weak-minded and the vulnerable sick. It is just wrong to flagrantly perform sexual activities in public; consequently the law is strict on heterosexuals in this way.

Not so with Gay people. On Pride marches (and in many other public spaces) Gays are allowed to do anything at all.

It is very common for Gay men to not only appear in briefs thrusting their pelvises left, right and centre, but very many appear in the celebration naked. You can see photos and videos of naked men thrusting their genitals near the faces of young children and the kids squirming in horror.

Then there are all sorts of physical caressing and lewd suggestions that beggar belief. Again in the faces of children.

Worse still, there are many cases of men committing fellatio upon other men on some float passing by.

Worst of all, there are a few cases of couples having penetrative sex in broad daylight on the march.

Why are the police not arresting the scores of people doing this in multiple marches? If it were heterosexuals there would be hundreds of people in prison.

Yet politicians line up to praise the Pride marches. Some even join in the big march in London. Politicians are proud of Pride.

This is immorality gone mad.

When homosexuality became a public celebration in past empires, it marked the downfall of society and the imminent end of the empire.

# **Foreign policy**

### Yemen

The war on Yemen, perpetrated by UK ally Saudi Arabia, is causing the biggest humanitarian crisis since WWII. It is one of the foulest acts of war in history where British made cluster bombs and air-to-surface missiles from drones and warplanes are killing men, women and children, mostly poor peasants. Not only that but these people are some of the poorest in the world and most of them are sick due to the imposition of sanctions. British ships are enforcing the blockade.

It is not uncommon for a British-made bomb to kill an entire family of several generations. Sometimes multiple families are killed at once when a wedding is bombed. Most families have suffered the loss of one or several members and people search the sky when they go to the fields to tend their flocks, looking for the hidden death from above.

Relief agencies have said that two thirds of the people in Yemen are dying slow, gruesome deaths from starvation. In the surrounding region 20 million are affected. The WHO reported in July over 1,700 Yemenis died from cholera. Over 300,000 could be diseased by the end of this month.

Meanwhile, British politicians deny their involvement, even when it is proved,<sup>26</sup> and British courts affirm the lawfulness of selling arms to a vicious, cruel human-rights abusing nation.

This is a wicked scandal that is actually in breach of international law. It rests entirely upon the Petro-Dollar scam that began in the 1970s when Nixon promised that the US would forever aid Saudi Arabia.

Sunni Saudi Arabia cannot claim any genuine threat from an impoverished Yemen; its motivation is to destroy a Shi'ite nation next-door while it has the west's means of doing it. Britain's involvement in this wicked genocidal tragedy is despicable.<sup>27</sup>

# Syria, Libya and Iraq

I have written on Britain's' involvement in these nations in several papers so I do not want to repeat all that. Suffice to say that Britain has been:

- Illegally bombing towns such as Raqqa and Mosul to virtual destruction. These incidents have caused thousands of civilian deaths, many of them Christians (especially in Mosul, the last refuge of Iraqi Christians). Some single bombing runs have caused the deaths of up to 300 people at one time. Nothing gets reported in the western media and no one cares.
- Supporting the terrorists that have invaded Syria under the guise of being an internal rebel group. In fact most of them are from foreign countries and are Sunni jihadis attacking an Alawite Shia nation.
- Airdropping weapons and supplies made in NATO countries to jihadis. Terrorists such as ISIS and Al-Nusra groups have been getting: millions in cash, heavy machine guns, off-road vehicles, tanks, military vehicles, rifles, handguns, food supplies, medical

supplies etc. etc. Your taxes are paying well-armed rebel terrorists to kill innocent civilians (including Christians) and behead children.

- The Syrian government has now produced hard evidence of British made chemical weapons given to Syrian 'rebels', such as CS gas and Tear Gas fired from grenade launchers which are illegal in warfare.
- Training jihadis in Jordan courtesy of the SAS.
- Filling the western media with lies about the progress of the war in Syria, which is not a civil war but an invasion sponsored and initiated by the CIA.

What has occurred in Syria and Iraq over the last few years has been contemptible. Syria is a sovereign state run by a democratically elected president that holds a diverse country together in peace and who has a popularity rating of over 70%. The NATO coalition spent billions supporting Muslim terrorists to attack Assad in order to effect regime change to fulfil a Neocon elite plan for the Middle East. Your taxes paid for this illegal action which has killed scores of thousands of innocent people; indeed it is assisting genocide against Christians.<sup>28</sup>

The coalition's activity in Iraq is sickening. After ruining the nation by sanctions and then an illegal war on false pretences, it continues to devastate areas like Mosul to eradicate ISIS, when America created and supported ISIS for years. Until Russia intervened in Syria, America acted as air cover for ISIS operations.

We have no right to conduct military operations in sovereign states, nor to fund terrorists to attack those states.

The ruination of Libya is a terrible saga. As a result of NATO's intervention, including British airstrikes to support ISIS and al-Qaeda, the removal of Gaddafi has resulted in a failed state and the creation of a bridge for migrants to cross into Europe by the million. Libya was once the crown of Africa with the best standard of living anywhere. It is now a nest of conflicting jihadi groups reigning over a broken nation. It will take generations to fix Libya.

Again, your taxes were used to wreck a sovereign state, ruin the lives of countless people, create a haven for radical jihadis and instigate a massive migration problem for Europe.

British foreign policy could not be more insane than if you asked an insane person to direct it. It has created havoc worldwide, damaged our security, instigated a Muslim blowback (hence terrorist attacks in Britain), killed millions of people and destabilised the world. Only a satanic madman could do such a thing. This means that the British government is both mad and satanic.

# **Elite purpose**

# The planned destruction of Britain

I have said for many years that the global elite desire the destruction of British infrastructure and the demotion of Britain as a dominant sovereign power in the world. This is part of a wider plan for a series of federal blocs that will be a stepping stone for world government (like the EU).

Why is this? I can only surmise but I suggest that it includes:

- Britain has been a bastion of Christianity for nearly 2,000 years and this is a problem for the global elite Luciferians. It played a large part in getting rid of the occult for centuries.
- The British legal system and jurisprudence is a problem to despotic powers and needs to be undercut and ruined (the EU Napoleonic Code is very different).
- The British have a habit of being stubborn, bloody-minded and resisting totalitarianism.<sup>29</sup> It doesn't toe the line.
- Britain constantly produces designers and innovators that can suddenly produce a new wave of technology that could be a game-changer. This needs to be under elite control.
- Being an island nation, Britain is somewhat protected by its isolation from changes that could rapidly engulf Europe.
- Britain once ruled nearly half the world and the elite hate that.
- Britain has a military class that traditionally submits to the Queen and Parliament and would be a problem being part of a global force in submission to some unelected bureaucrat (which is what is being forged in the EU). [This is why the MOD is being scaled down.]

This explains why various UK governments submitted to the elite have allowed policies to enable the mass migration of hundreds of thousands of Muslims into this country. It is a plan to destabilise social cohesion. The strategy to mongrelise European nations by importing millions of Africans and Muslims was written down nearly 100 years ago, as was the strategy to provoke a European war between Christians / atheists against Muslims, called the final war.

Britain, as a bastion of traditional Christian morals, has been a significant target for destruction. All that we have seen that has ruined British social life in the last 50 years is part of this elite attack. The current down-treading of the poor and middle class in austerity measures is but another part in this plot to ruin Britain as an effective social and moral power. People who are starving and too worn out working two or three jobs to make ends meet are not going to mount any effective rebellion against despotic power.

### How did this happen

As in America, it happened when Britain was gradually taken over by international bankers and global corporate interests that were part of a Luciferian system motivated by evil and greed. It is true that many of these people were Talmudic Zionist Jews, especially the bankers, chief of which are the Rothschilds; but not all are Jews. Many are Freemasons (which is Judaism for Gentiles, mixed with Satanism and centred on Lucifer). Others are Jesuits connected to the Luciferianism centred in the hidden papacy. Yet others are the European royal families that appear outwardly Christian but are inwardly also centred on Luciferianism and even outright Satanism.
