

# Suffer the little children

## Introduction

### **Suffer the children**

For this paper I take this quote from the ASV Bible in a different sense to its real meaning. Obviously the real interpretation of Matthew 19:14 is, 'Let alone' or 'permit'.<sup>1</sup> However, this paper regards the real suffering of children in this corrupt society. This Bible verse is one of many that show Jesus' concern for young children. In this he is manifesting the concern of God in general for children, hence the Lord's condemnation in the OT of hurting children.<sup>2</sup>

### **The iniquity of hurting children**

Since God cares for children and commands his people to be good to their children, it is anathema to hurt children; indeed this is ingrained upon the conscience of every rational person. Thus the practice of abusing children is both irrational and worthy of God's condemnation to hell fire. Any government that presided over abusing children, or knowingly tolerated this abuse, is insane, ungodly and worthy of condemnation.

### **The great sin of Israel**

One of the key reasons given in the Old Testament for Israel's judgment and condemnation was that its idolatry from God to idols caused Israelites to sacrifice their children to Molech. Israel's apostasy was so great that its rulers ritually killed their own children.

Ritual killing of children was an evil practised by idolatrous nations and so God commanded Israel, from the beginning, never to do such a thing. Indeed, God judged the previous nations in Canaan for completing their iniquity and making their judgment certain by sacrificing their children in the fulness of their sin.

You shall not let any of your descendants pass through the fire to Molech, nor shall you profane the name of your God: I am the LORD. Lev 18:21

There shall not be found among you anyone who makes his son or his daughter pass through the fire, or one who practices witchcraft, or a soothsayer, or one who interprets omens, or a sorcerer. Deut 18:10

But Israel went the way of all flesh and continually performed this act, the most wicked form of iniquity possible (killing your child – a gift from God that you are called to nurture; plus offering that life to a demon). It constitutes multiple lawlessness: murder, child abuse and idolatry.

He [Ahaz] walked in the way of the kings of Israel; indeed he made his son pass through the fire, according to the abominations of the nations whom the LORD had cast out from before the children of Israel. 2 Kg 16:3

They [Israel & Judah] caused their sons and daughters to pass through the fire, practised witchcraft and soothsaying, and sold themselves to do evil in the sight of the LORD, to provoke Him to anger. 2 Kg 7:17

He [Manasseh] made his son pass through the fire, practised soothsaying, used witchcraft, and consulted spiritists and mediums. He did much evil in the sight of the LORD, to provoke Him to anger. 2 Kg 21:6

They [their kings, their princes, their priests, their prophets, the men of Judah, and the inhabitants of Jerusalem] built the high places of Baal which are in the Valley of the Son of Hinnom, to cause their sons and their daughters to pass through the fire to Molech, which I did not command them, nor did it come into My mind that they should do this abomination, to cause Judah to sin. Jer 32:35

There are other texts on this matter, but this will do.

### **The fulness of evil in a nation**

Thus the OT demonstrates that a nation comes to the fulness of its iniquity when it starts sacrificing its own children in a satanic ritual offering to the devil or to a demon. There is no greater national sin, after turning away from God, than ritual killing of children.

My claim in this paper is that abuse of children in institutional homes, sexual abuse of children, torture of children and murder of children is being carried out on a regular basis by the people at the very top of society right now. High level establishment figures, including prime ministers and members of European royal families, have been involved in paedophilia for decades; but only recently is the full extent of this wickedness coming to light.

### **Should Christians get involved in this awful subject?**

Some people tell me that the world is evil, there's nothing we can do about it and we shouldn't get involved. This is false and is, in fact, disobedient. God tells us to get involved when we know there is a wrong. At the very least we should publicly condemn the wickedness of rulers in the name of Christ.

Open your mouth for the speechless, in the cause of all *who are* appointed to die. Open your mouth, judge righteously, and plead the cause of the poor and needy. Prov 31:8-9

Learn to do good; seek justice, rebuke the oppressor; defend the fatherless, plead for the widow. Isa 1:17

For among My people are found wicked *men*;... they surpass the deeds of the wicked; they do not plead the cause, the cause of the fatherless; yet they prosper, and the right of the needy they do not defend. Shall I not punish *them* for these *things*? 'says the LORD. Jer 5:26-29

Abused children are speechless, needy, poor, fatherless; therefore we must plead their case.

### **The scale of the problem**

It is my contention (and one reported by very many others, but kept back by the media) that most western governments, and Britain in particular, has a portion of the ruling establishment that knowingly participates (either directly or indirectly) in the systematic abuse of children. This abuse runs the gamut from simple molestation (momentary inappropriate touching) through to sexual abuse, rape, beatings, torture and murder. Yes; some of the ruling elite is complicit in rape and murder of children, part of it involving satanic ritual killings.

By the terms 'establishment' and 'elite' I include the following: the police force, the judiciary, the civil service, the armed services, the secret service, the aristocracy, the royal family, the entertainment world, bankers, social services, borough councillors, and the

media. In short, anyone in a position of power. The people that abuse, or that cover up abuse, are the rich and the powerful. The people who are abused are poor, vulnerable, disabled and incarcerated children; very often children in care homes of one sort or another.

### **Insidious aspects**

There are two insidious aspects to this abuse. The worst aspect is the end result of children old enough to identify and issue proceedings against the perpetrators. These are murdered. In fact many are tortured and murdered as part of the abuse in 'snuff films'. Many people simply do not realise that 100,000 children disappear every year from care homes or institutions and are never seen again. While some return and some end up lost and off the radar on the street or to prostitution, most just vanish. There is a systematic killing of young children every year in huge numbers. Poor Madeleine McCann is just one example. Why is there no media reporting of this problem?

The second and shocking insidious aspect to this abuse is that much of it is connected with Satanism in ruling authorities. Most people do not realise how widespread Satanism is today and how it has risen in popularity since the works on magic of Gerald Gardner [1884-1964] and Aleister Crowley [1975-1947] in the 40s and 50s. But ordinary populist Satanism in the form of witchcraft<sup>3</sup> is not in view here; this is the deep, dark Satanism that has infiltrated the ruling classes for hundreds of years. The aristocracy and establishment has been involved in Freemasonry, or other secret societies, and its relative Satanism, since the beginning of time [see later].

To give you but one example; I doubt you know that, in recent years, Satanism has been given the full support of the Crown in the Royal Navy.<sup>4</sup> It is now legal to be a practising Satanist whilst serving in the Royal Navy. Remember that until the early 1950s, witchcraft was a crime.<sup>5</sup>

This is the level that we are dealing with.

### **The difficulty**

Now there is a problem in reporting on this subject. That is, the level that the powers that be will go to in order to protect themselves. It is incredibly difficult to get very hard facts on this because people that try to expose the problem get killed or vanish. To begin with they are threatened, and most just give up, scared to death. Then they are harassed, beaten up, slandered, fitted up with crimes, incarcerated in mental institutions, and so on. If all that fails they are killed. Many people who have tried to expose powerful figures have vanished.

Another problem is that most of the hard evidence available is video clips of witnesses who survived their ordeals. These are usually very troubled abuse victims. As a result of their sufferings as a child, most of these victims succumb to various means to soften the continuing psychological pain suffered every day: self-harm, alcohol, drugs etc. Some are unable to fend for themselves, all are depressed and mentally ill, and some end up as minor criminals and addicts. These people are then castigated as poor witnesses and their

evidence is dismissed or destroyed. Some poor souls end up committing suicide after trying.

Added to this is the alleged complicity of many in the police force. With few people to support them, the victims are treated despicably by the police so that they usually give up and go back to the hole they came from [see examples later]. The pressure put on victims that come forward is immense and this is because there are allegedly large paedophile rings in the police force and the judiciary who will allegedly do anything to prevent any evidence coming to public view, let alone court.

So, with these difficulties in mind, I will try to bring the best evidence that I can to show you that there are huge paedophile rings in the ruling classes today, involving very well known figures and reaching to Number 10 Downing Street. The victories of paedophile cases by the police are always of lesser figures, usually entertainers and media folk, or of someone that has died (e.g. Jimmy Savile). It is suggested that the police do not want to really investigate this matter as it would decimate their own ranks and bring society to collapse.

## The eschatological premise

I have written elsewhere<sup>6</sup> explaining that as the end approaches we see two things.

### **The fulness of man's sin**

The first is that man becomes the epitome of sin. In most people total depravity is a potential not fully expressed. It means that every area of the human soul is damaged by sin so that it is dead towards God; it does not mean that everyone is as evil as Hitler. However, God has ordained it that man's sinfulness comes to fulness at the end and only then is man harvested for retribution on the Day of Judgment. The fulness of man's sin coincides with the last elect person to be converted.

Thus the Biblical revelation that the earth is getting worse and worse. Evil abounds at the end as man fully expresses his sin, which comes to complete expression in a wicked, dystopian world.

### **The antichristian world government**

The second is that the devil is allowed by God to do what he has been hindered from doing throughout history; that is to build a world empire and control it.

At the end Satan, through his agents, is allowed to build a totalitarian, despotic, world empire that all nations submit to willingly. Through submission to this antichristian world government, people are allowed to live a hedonistic, unrestrained evil life. They love it. Part of the governance of this empire is the persecution of Christians and the attempt to wipe out Christianity from the world. When this seems inevitable, then Christ returns in glory and judgment.

Clearly, this empire is Satanism in full form. The world worships the beast (Rev 13:12, 14:9, 11). The world government has two aspects: complete civil power and a religious arm promoting the worship of Satan through its religious system.

So, as the end approaches, Satanism in the ruling establishment becomes more pervasive. That is a clear extrapolation of Biblical revelation, therefore we should expect to see it operating now (at least in some measure). Secondly, the final world government, being the expression of the man of sin, reveals the opposite of all godly virtues. Since one godly virtue is nurturing and protecting children, child abuse and paedophilia are rampant. That is another clear extrapolation.

Therefore, as society merges more and more into this end-time, global, evil government, we should expect to see both Satanism and paedophilia increasing in the establishment. And this is what is happening right now.

We need to watch (Mk 13:37; 1 Thess 5:6) and see what is happening before our eyes. Christians should not be ignorant people but alive to what is really happening. Sadly, the world is more informed in this matter, and declaring it, than evangelical churches; yet another failing of the modern church.

## Paedophilia at high levels in history

Sadly, there have always been a large number of child abusers in the ruling establishment of most cultures, especially in the west.

### Greece

Pederasty was somewhat common in Ancient Greece and was often a rite of passage. However, in Athens, citizens who prostituted boys could be sentenced to death.

Alexander the Great, while certainly homosexual, is claimed by many to also be a paedophile.

### Rome

Decadence was not just rampant in the latter part of Roman history when the empire was deteriorating. It was more open then but it was clearly evident at high levels from the beginning.

#### *Emperor Tiberius*

Tiberius reigned at the height of Roman imperialism. His lust for children was well known. In his later years he often retired to a vacation spot on the coast. Here he trained young children to swim underwater and nibble his private parts while he was treading water.

### Islam

Mohamed was betrothed to Aisha when she was six or seven years old but was married when she was nine or ten. This is the traditional statement of history. A small number of modern writers claim that she was 15 or 16. Some of Mohamed's companions practised paedophilia.

Paedophilia is permitted by the Qur'an and Islamic writings.<sup>7</sup> This is why some paedophile rings in the North of England have been based in Muslim communities.

In Muslim countries the rigid morals regarding relationships with women resulted in tolerance of homosexual paedophilia. For instance, until the 20<sup>th</sup> century, Algeria became a haven for depraved pederasts. It was often stated that a woman was for reproduction but a boy for pleasure.

## Europe

Until around 1800 it was common for girls to be married at the age of as young as twelve.

## China

For thousands of years it was common to castrate young boys and sell them to rich pederasts.

## Joseph Smith

Smith, the founder of Mormonism, engaged in sex with underage girls and was a philanderer.

We could continue with examples of kings, princes and popes, but we have made the point that paedophilia has been rampant throughout history amongst elites.

## The secondary circumstantial evidence of child abuse involving (or tolerated by) senior establishment figures

*In the UK, the United States, Germany, Switzerland and Australia, studies consistently find that around 20% of women and around 8% of men suffered sexual abuse as children. In the current population of UK, that would cover 1.5 million girls and 520,000 boys, a figure that is consistent with the projection of 1.1 million offenders.<sup>8</sup>*

When a person first hears that the ranks of police, judges, secret services, the armed forces, royals, lords, MPs and prime ministers include paedophiles and murderers, one is too shocked to accept that it could be true. Therefore, we need to give as much evidence as possible to support such claims. We begin with confirmed facts that offer circumstantial proof.

### The influence of Jimmy Savile

The one good effect of the Savile scandal is that it has finally broken open the seams of widespread paedophilia. More and more victims are now finding the strength to come forward and give their testimony to abuses suffered as children.

Savile's crimes are hard evidence but of a secondary nature to our purpose here. We have clear documented evidence of Savile's contact with very prominent people, indeed one could say intimate contact, and it raises very serious questions. However, it does not mean that his contacts were paedophiles, but they are possibly accessories. What it does prove is that Savile had deep access to the highest establishment figures of all sorts and that his paedophilia was known and protected.

More and more information is coming to light day by day as more witnesses finally speak out. It would take an entire book to cover the crimes of Savile against thousands of children and older victims over 60 years. We cannot cover that here but simply point out certain aspects of the establishment that relate to Savile.

### *Savile and Thatcher*

We must first say that it was widely known that Savile was a paedophile decades ago. It was known locally in his hometown from the beginning and there were several police investigations, after complaints, that were shut down. It was an open secret. The Daily

Express reported that Savile kept a special room where he took young girls after appearing at the Empire Ballroom in Leeds in the late 1950s.

Since Thatcher was no fool and very well informed, she must have known that Savile had been accused of paedophilia. Yet she honoured Savile by inviting him to have New Year's Eve dinner with her for ten successive seasons on the trot.<sup>9</sup> In addition there are many photographs showing intimate friendship between Thatcher and Savile. What was going on here?

The suggestion of Bill Maloney<sup>10</sup> is that he was giving Thatcher a regular update on information regarding high level people that he incriminated. This enabled Thatcher to have powerful blackmailing power over these people and that she used this to keep senior figures in line and do what she wanted. Something has to explain his despotic power for three terms of office that was unprecedented; there was something more than prime ministerial authority; she controlled people ruthlessly. We now know that there were several paedophiles in her cabinets [see later].

Thatcher was so close to Savile that she made four attempts to get him knighted, despite the warnings of senior Whitehall mandarins that he was unsuitable. Cabinet Office papers reveal that the highest levels of government knew about Savile's activities. Lord Armstrong (then Robert Armstrong) told Thatcher that honouring Savile was 'difficult'.<sup>11</sup> Eventually Savile was knighted in 1990. Harold Wilson had refused to give Savile an MBE in 1970.

Files released in 2012, though heavily redacted for forty more years, show Savile's extraordinary access to the highest levels of society. It shows that he attended high-level lunches with the PM, exchanged personal letters with the PM and was granted access to Chequers. In one letter he said that he loved Thatcher. One file shows that a suggestion from Savile later resulted in new legislation in the following budget (on the covenant system for charities).<sup>12</sup>

### *Savile and Prince Charles*<sup>13</sup>

After an appeal by a newspaper, the censored sections of Thatcher's papers were made available. These showed that Prince Charles had agreed to be a patron of one of Savile's charities<sup>14</sup> – yet someone in high office had decided that the public should not know. This turned out to be Cabinet Secretary Sir Jeremy Heywood. The prince first met Savile during a disability charity function in the late 70s; apparently he was introduced by Lord Mountbatten.<sup>15</sup>

It was already common knowledge that the prince and Savile were pals; indeed Charles had sent Savile cigars and gold cufflinks on his 80<sup>th</sup> birthday.<sup>16</sup> In 1999 Charles accepted an invitation to a private meal at Savile's Glencoe home, where three young girls were dressed as French maids; Charles later wrote a letter of thanks sending his love to these girls. The salmon he served was stolen by poachers.<sup>17</sup> Savile had visited Charles at St James' Palace several times in the 80s. Even then he raised eyebrows when he rubbed his lips up the arms of Charles' young female assistants as a greeting.<sup>18</sup> Charles led tributes when Savile died, aged 84, in October 2011. All this shows how well connected Savile was to high level public figures. Princess Diana described Savile as a sort of mentor to the prince.<sup>19</sup>

### *Savile and the royals*

Again, the royal family must have known about the accusations against Savile. Despite this he was very friendly with some of them (see Prince Charles) and was knighted by the Queen in 1990. He had previously received an OBE in 1972. In 1966 Savile was introduced to Prince Philip by Lord Mountbatten. Savile was a regular visitor to Buckingham Palace, Kensington Palace (where Princess Diana lived) and Highgrove (Prince Charles' country estate). Savile was quoted as saying, '*The thing about me is I get things done and I work deep cover. I've known the Royal Family for a million years*'.<sup>20</sup> Savile was said to be a close friend of Prince Philip until they had a serious falling out.

In 2009 the police interviewed Savile, following accusations by three teenage victims, but sent the transcript to Buckingham Palace (why?). It came back seven months later with 96 deletions regarding the Royal Family.<sup>21</sup> The interview mentioned a friendship with the Queen's cousin, Princess Alexandra, which was also mentioned in his 1974 autobiography. He visited a Surrey school with the princess – the same place where he was later accused of abusing young girls. The police decided not to charge Savile but the process was later criticised in a CPS review.<sup>22</sup>

### *The death of Princess Diana*

The death of Diana in 1997 was certainly an assassination in my view and this is the conclusion of very many people, including professionals and at least one barrister; however, this is not the place to air the evidence.<sup>23</sup> The question is, why was she killed?

There are allegations that Diana was about to reveal networks of paedophilia connected to the royal family, and that the secret services arranged the assassination.<sup>24</sup> If the paedophile ring claim is true, then Savile would be a likely suspect to be providing victims. Remember

what Savile said, *'The thing about me is I get things done and I work deep cover. I've known the Royal Family for a million years'*.

#### *Savile and the pope*

In the same year that he was knighted, Pope John Paul II made Savile Knight Commander of the Pontifical Equestrian Order of Saint Gregory the Great – the Catholic Church's highest honour. Considering the Catholic Church's prolific problem with paedophilia, this connection seems at least intriguing.

For the record, Savile was also made Order pro meriot Melitensi by the Knights of Malta, a very rare honour.

#### *Savile and the establishment*

Savile was given unprecedented privileges and access into various institutions with no reason given. We will see later because this was to allow him to procure children for high powered figures from these institutions supposed to care for them, and also to carry on his own perverse crimes (such as necrophilia).

In an interview with the police in 2009 he boasted that he 'owned' Stoke Mandeville hospital.<sup>25</sup> Savile was a frequent guest at Duncroft Approved School for girls.

#### *Savile and Tony Blair*

On 28 March 2004 Savile was invited to dinner with Tony Blair.

#### *Savile and the army*

In 1966 Savile was awarded an honorary Green Beret by the Royal Marines. This was arranged by Lord Mountbatten, who was Commandant General of the Royal Marines.

#### *Savile and the police*

Savile was literally beloved by the police. He was given at least 14 awards by various police departments. For example: the Fraud Squad gave Savile an expensive onyx lighter inscribed, *'To Jimmy Savile from his friends at the Fraud Squad'*. The Metropolitan Police gave him a special medal in 1979. He also received a wall plaque and his own inscribed Met. Police helmet. In 1974 Leicestershire police gave him a truncheon, badge and handcuffs on a mahogany base; the year he molested Karin Ward. He also received two wall plaques. West Yorkshire police (who investigated him in 1958 for molesting young girls) gave him a plaque.<sup>26</sup> Tayside police gave Savile an award in 1996.

#### *Savile and gangsters*

Savile boasted of knowing gangsters, which included the Krays.<sup>27</sup> He also boasted of his violence and links to gangsters in the BBC documentary with Louis Theroux.

#### *Savile and the IRA*

Savile boasted about his friends in the IRA, saying that they would beat people up or hospitalise enemies if he telephoned them.<sup>28</sup> He used such threats of violence to shut his victims up. He said, *'All I have to do is call my friends in the IRA. They'll have someone waking up in hospital the next morning eating their breakfast through a f....g straw'*.

### *The failure of the police to act on multiple accusations*

There is no doubt that Savile was given protection by very senior levels in the police force. If they had performed their job rightly, Savile should have been prosecuted decades ago and accusations properly investigated. Instead they were dropped. Indeed, there were even occasions when Savile was accosted by police officers whilst he was having sex with a minor in his car and he still got off.

The police regularly dropped investigations into Savile going back to the 50s. For example: In the late 70s a police officer told superiors about Savile's child abuse at Stoke Mandeville Hospital but was told to drop the investigation.<sup>29</sup>

### *Early concerns about Savile*

Sir Roger Jones (former chairman of the BBC charity 'Children in Need', a BBC governor from 1997 to 2002) refused to allow Savile to have anything to do with the cause.

### *Interim conclusion*

One can only conclude that Savile was not only protected by the police and establishment, but that he was given free reign in certain institutions and was on very friendly terms with the very highest people in society for decades.

At the end of his life he started to become more loose in his comments (some think that he was killed for this<sup>30</sup>). In one interview he stated openly that he would never be done for any crimes because he had too much information on the top people and he would bring them down with him. He called this 'insurance'.

The legacy of Savile points to the collusion of the establishment in his crimes. It does not prove it categorically, but it is important circumstantial evidence.

### Sir Leon Brittan

Brittan was a former Tory Home Secretary in Thatcher's cabinet, and later a European Commissioner, who has been repeatedly accused<sup>32</sup> of being a paedophile but evidence given to the police has not yet resulted in any charges. It is alleged that he was a regular at Elm Guest House.

In November 1983 Brittan was given a dossier by the late Geoffrey Dickens as part of his campaign against PIE. It contained allegations of paedophilia in Buckingham Palace, the civil service and the diplomatic service. When he was asked by The Independent about this dossier, Brittan said, '*I have no recollection of these matters, sorry*'.

### **Patrick Rock**

Rock, deputy director of the Downing Street policy unit, was closely involved in drawing up the government's policy on Internet porn filters. He is close to Cameron and has held senior posts in the Tory party and was tipped for a peerage. He was forced to quit after it was discovered that he was the centre of a police probe over child porn images. He resigned from Downing Street and was arrested on 13 February 2014 on suspicion of an offence relating to child abuse imagery.<sup>33</sup>

### **Tony Blair**

Blair, allegedly, received two convictions for cottaging in 1974 and 1983 and was allegedly known to MI5 for being caught importuning young boys in public toilets around London in the 1970s. Police information on these incidents has been subject to a D-Notice. He has been allegedly exposed as a bi-sexual cross-dresser whose nickname when he was a lawyer was 'Miranda'.<sup>34</sup>

It is also alleged that the FBI Operation Ore paedophile investigation threw up a large number of names of senior Labour MPs and cabinet members involved in the BBC/Jersey/Islington scandals. It is also alleged that the police discovered links between the Labour government paedophile suspects and the trafficking of children for prostitution from Belgium and Portugal. It is alleged that Blair stopped any police investigations by claiming a threat to national security and put a D-Notice on it. Some think that the Americans used this information to blackmail Blair to support the Iraq War; I could not possibly comment.<sup>35</sup>

The Sunday Times is reported to have obtained the FBI list (Operation Ore) of Labour MPs who used credit cards to pay for internet child pornography. Blair responded by imposing a news blackout, which is we cannot access these items today; but Philip Lyon was still caught out.<sup>36</sup>

### **Peter Mandelson**

Raised to the peerage by Blair in 2008 after amassing a fortune in politics. He is openly Gay and is a strong supporter of lowering the age of consent.

There are all sorts of claims and allegations about his deeds in this connection but his life is subject to several D-Notices by Blair (something Blair did quite often). One of the common allegations is that he ran a paedophile ring; another is that his name appeared on the Operation Ore list.<sup>37</sup>

### **Phillip Lyon**

A multimillionaire convicted paedophile. He started his career at Islington Council.

Lyon was one of Blair's closest political confidantes and a local neighbour in Islington. He was jailed for a year in 2003 for child pornography found on his PC by a Civil Servant at work. The police were stopped from searching his home after Blair claimed a threat to national security.

### **Lord George Robertson**

Raised to the peerage by Blair in 1999. He has been accused in the Scottish press of using his Masonic influence to get Thomas Hamilton a gun licence despite repeated police objections – who then perpetrated the Dunblane Massacre (see timeline later). His involvement in this was largely covered up in the English press and media.

He was also accused in Scotland of running a paedophile network involving Hamilton for the BBC based in Scotland, Islington and Jersey. However, as claims heated up he was moved out of Parliament and given the job of head of NATO. A 100-year D-Notice was put on the press. Despite threatening to sue his accusers, he never did.<sup>38</sup>

### **The royal family**

The Internet has many sordid claims about the involvement of aristocrats and the UK royal family in sex abuses. However, none of these give any solid evidence that can be printed. Nevertheless, the alleged antics of Lord Mountbatten are pretty well established.

Recently, a European Common Law court has served arrest warrants on Queen Elizabeth and Prince Philip, and also David Cameron, for the abduction and sex abuse of ten boys from Canada in the 60s; specifically from the Canadian Kamloops Residential School. The boys (aged 10) were never seen again.<sup>39</sup> *'We have enough evidence to prosecute and hold both the Prime Minister and Queen of England'*, said ex-Royal Military Policeman Matt Taylor.

On 25 February 2013, six judges of a Brussels common law court [International Common Law Court of Justice] found the Queen, Cameron, former Pope Ratzinger and 28 other global elites guilty in the disappearance of 50,000 Canadian indigenous children. Cases were prosecuted by the International Tribunal into Crimes of Church and State (ITCCS). Two witnesses died of mysterious causes prior to the court case.<sup>40</sup> The ITCCS was formed by Canadian pastor Kevin Annett on the request of Canadian tribal leaders; efforts to bring crimes against their children had all failed in the International Court.

Whether this common law court has any real authority is debatable and it is unlikely that anything is going to happen anytime soon. Nevertheless, the story about the missing Canadian kids lives on, which is associated with shocking stories of abuse in Canadian kids' homes, and an explanation is required. Efforts to excavate mass gravesites on grounds of government-owned residential schools run by Catholic priests and others have been thwarted since the first was discovered in 2008.

They also claim that allegations threatened against Pope Ratzinger were what led to his immediate resignation, which shocked the Catholic world. They also claim that the present Pope Bergoglio is alleged to be part of a child trafficking paedophile ring. Victims who were prostituted as children have come forward to give evidence against senior Catholics, European judges and politicians, Prince Bernhard of Holland<sup>41</sup> and members of the British royal family.

A child abuse advocate (David Compan) and his wife who posted Brussels common law court arrests on the Queen, Cameron and former Pope Ratzinger and 28 global elite figures resulted in their arrests and forced detainment in a psychiatric facility (The Park Royal Mental Health Centre). Newly passed English law has allowed the imprisonment of anyone indefinitely and without charges if they are considered to be fixated on public figures or the Royal Family. Bet you didn't know that.

Matt Taylor, standing for MP in Brighton Kemp Town in 2015, has issued an order for the immediate arrest of Cameron and the Queen on charges of High Treason for sexual crimes on children.<sup>42</sup>

Two appointed sheriffs of the ITCCS attempted to arrest the Queen during her visit to see Pope Francis in Rome. However, the meeting had been relocated at the last minute. The sheriffs found the location (the Domus Sanctae Marthae) but were met by a sizeable security force, not of Vatican police but the National Police.

Kevin Annett (field secretary of the ITCCS) stated on 8 February 2014 that he had been informed by a British MP that the Crown's Privy Council is considering issuing an order to the Canadian government to have him arrested and prosecuted for sedition.

Annett later stated that his organisation revealed that on 16 September 2010 the Vatican and the crown, through their chief officers, entered into a formal agreement of union at Holyrood Castle in Edinburgh. This occurred between the Queen and Pope Ratzinger. This agreement included a formal conspiracy to traffick children and support paedophiles by agreeing a condition of the merger being the placing of all Anglicans under the Catholic law known as 'Crimen Sollicitationias', which requires all child abuse to be covered up within the church.

The present pope, Jorge Bergoglio has recently been accused by an eyewitness of organising the trafficking of the children of political prisoners in Argentina under the military dictatorship there.<sup>43</sup> Victims claim that as orphans of the 30,000 missing people, they were placed in satanic ritual abuse paedophile rings, some going to the Vatican.

### **Interim conclusion**

Already we can see that there are some huge problems here. The number of allegations against very senior public figures is astounding;<sup>44</sup> allegations of crimes committed by the very top people in society.

While much of this information is circumstantial to our chief point,<sup>45</sup> it already highlights a number of questions. For instance, why did Tony Blair put so many D-notices on personal information about his cabinet members? Why was this claimed to involve national security when it was about personal issues? Why has the Queen's secretary not issued a statement denying or ridiculing the charges against her? Why has the media ignored such a massive story? Why has former pope Ratzinger not made a response to the charges against him? Why did Ratzinger resign from the papacy (something almost never done<sup>46</sup>) immediately

after the charges against him? Why has Leon Brittan not sued his many accusers?<sup>47</sup> Why was Savile so close to politicians, the police and the royals when allegations of his child abuse were well known? How can a man twice interviewed under caution as a murder suspect, and who was a friend of the actual murderer (Peter Sutcliffe) be best friends with the royals, Thatcher, the police etc? How could Savile be good friends with Prince Philip and Prince Charles when Savile boasted of his friendship with the IRA who allegedly blew up Lord Louis Mountbatten, Charles' great uncle?

There is something rotten going on here!

## **The hard evidence of child abuse involving (or tolerated by) senior establishment figures**

### **Cyril Smith – confirmed but not convicted paedophile**

In his lifetime Smith (MP for Rochdale) was a popular, larger than life character who frequently guested on news media programmes; he died in 2010. Yet a 2013 investigation revealed that the secret services held a file that contained evidence of the Liberal MP's child abuse.<sup>48</sup> The fact that nothing was done shows that the secret services were complicit in his crimes. In April 2014 the CPS stated that he should have been prosecuted 40 years ago.

As early as the 1960s, Lancashire police carried out investigations into Smith's paedophilia compiling an 80-page dossier. Veiled threats from the political establishment stopped the police prosecuting. The file was locked away by Special Branch (that has responsibility for national security). This means that the political establishment is complicit in his crimes against children. They knew he was abusing kids and they did nothing.

After this MI5 requested the file and Special Branch detective Tony Robinson sent the file to them.

The case of Smith alone proves that the secret services, the police and the political establishment are complicit in paedophile crimes.

Smith had set up a hostel in Rochdale (Cambridge House) supposedly to help boys in need. However, he used this to abuse kids. One former resident, Kevin Griffiths, bore witness to Smith's abuse on the TV programme Dispatches. Smith set up another hostel in Rochdale (Knowl View School) for which he held a set of keys. Another resident there (Chris Marshall) explained how, as an 8-year old boy, he was a victim to Smith.

Smith was also a regular visitor to the famous paedophile ring institution, Elm Guest House in South West London in the 80s, as confirmed by the Metropolitan Police.

Smith's guilt is certain and more evidence has come to light since his death. However, what is also certain is that the ruling establishment protected him and covered up his crimes against children for decades.

While I was finalising this paper Smith's guilt made national headlines after the publication of a book demonstrating his crimes.<sup>49</sup> This began a debate about the cover up of child abuse by prominent people.

### **Edward Heath – confirmed but not convicted paedophile**

It was widely known that Heath was a homosexual paedophile even before he became Prime Minister.<sup>50</sup> Former openly Gay London Assembly member Brian Coleman stated that it was common knowledge among Conservatives that Heath had been given a stern warning about cottaging by the police when he underwent background checks for the post of Privy Councillor. Coleman added that homosexual men had run the Tory Party in the capital for many years, whether as officials, councillors or volunteers.<sup>51</sup> When Baroness Blatch was asked who ran the Tory Party in London she replied, '*the Gay men of course*'.<sup>52</sup>

Gay rights leader of OutRage Peter Tatchell said of Heath, '*It's a long-standing open secret. It's amazing his sexuality wasn't the subject of tabloid revelations during his lifetime*'.<sup>53</sup>

Heath was warned on at least four occasions by the head of the Metropolitan Police not to loiter in lavatories trying to pick up young boys. Indeed, he was severely reprimanded by the security services for picking up a rent boy who was a double agent.<sup>54</sup> A Freedom of Information request to the Met. received a refusal to disclose any information they had.<sup>55</sup>

Heath was named as a visitor to the Kincora Boys Home in East Belfast, the location of a known paedophile ring. He was a visitor at Haut de la Garenne, regularly travelling to Jersey on his yacht, Morning Cloud. His bodyguards called this boat, 'Morning Sickness'.

To distance himself from being identified in dodgy places, Heath is alleged to have later used Jimmy Savile to procure boys for him, particularly from Haut de la Garenne.<sup>56</sup> Some websites allege that some of these boys were subsequently murdered and dumped out at sea. It is claimed that this solves the problem of missing boys from the home which were not found in local grave sites – the bodies are in the channel.

One key witness in this is barrister Michael Shrimpton who has gone public in interviews about Heath's involvement in murder.<sup>57</sup> Shrimpton is currently a barrister and was previously an immigration judge and intelligence and national security consultant. Shrimpton claims that the murdered boys were the ones old enough to recognise who was abusing them. Shrimpton also alleges that the cabinet secretary at the time (Mr Hunt) was also Gay and in on the crimes, covering up the tracks.

When Tory conferences were held in Blackpool, Heath's yacht would be moored offshore. A former member of the Special Boat Service assigned to guard the boat says that Savile was regularly seen taking young boys on board Heath's yacht. It is also claimed that Savile procured boys for many other MPs.<sup>58</sup>

As an aside, it is now common knowledge that Heath admitted to lying to the electorate regarding the entry into the Common Market (EEC, EU as was). He denied at the time that there were any plans for a developing political union, it was just a trade agreement. Researchers now speculate whether Heath was blackmailed into pushing the UK into the EU. In fact, many suspect that he was set up to be PM, despite Enoch Powell being more gifted, clever, popular and suitable for the job. It is without doubt that Heath was an absolutely useless PM (remember the three-day week and constant blackouts?).

David Icke publicly outed Heath not only as a paedophile but a murderer, torturer and a Satanist in a book many years ago.<sup>59</sup> Despite journalists questioning Heath about this, he never sued Icke.

### **Kenneth Clarke – accused paedophile; evidence destroyed by conspiracy**

Ken Clarke is a famous longstanding MP, barrister, Queen's Counsel and cabinet minister who was made Lord Chancellor in 2010. He is currently Minister without Portfolio in the coalition government.

Clarke is accused by Ben Fellows, a former prolific stage, TV and film child actor (trained by the RSC from the age of 10), reporter and photographer. The substance of his testimony is available on many platforms: websites, letters, YouTube videos, and interviews. Fellows is a credible witness who has suffered for his allegations. He had filmed proof of the sexual assault on him by Clarke, which has gone missing due to a conspiracy led, he alleges, by David Cameron. His testimony of certain claims is backed up by secret audio-taping and secret filming, such as his arrest by the Metropolitan Police.

One of the earliest outings of Clarke was on a YouTube interview posted by Bill Maloney interviewing Fellows,<sup>60</sup> as a victim of child abuse when he was in his early teens. Fellows gives a cogent description of many famous people involved in the procuring of teenagers for entertainment celebrities and offered to take a lie detector test to prove his story. The people alleged to be involved in this include Kenneth Clark, Max Clifford, Tom Cruise and others. Fellows was often sent by Clifford to parties at Stringfellow's where, aged 13, he was plied with alcohol and cocaine and then packed off to after parties where abuse took place upon various under-aged hopeful actors, boys and girls as young as 13. He claims that sexual abuse of child actors and models is rife in the BBC at recording after parties, and in film and TV casting processes.

In his testimony Fellows claims that there was filmed proof of an assault on him by Clarke as part of a separate sting when he worked for the Cook Report.<sup>61</sup> Clarke was filmed as part of an investigation into the 'cash for questions' scandal but during this he molested Fellows, who was a minor. This matter was later covered up, according to Fellows' allegations, by David Cameron in his earlier role as an executive for Carlton TV. Central, the TV company owning the tape, was taken over by Carlton TV and then the tape was mysteriously burned in a warehouse fire. Fellows volunteered to take a lie detector test to confirm his statements.<sup>62</sup>

The rest of his story is complicated. I think it best to try (from a wide variety of sources<sup>63</sup>) to attempt a timeline. His story is important because it shows how victims are abused and threatened by the authorities when they try to bring prosecutions of high level people.

- 1994: The Cook Report conducted an investigation for Central television into the ‘cash for questions’ scandal and set up a sting involving Ben Fellows as a child actor who was then 17-years old but appeared to be 15 and was told to say that he was 15. The investigation was into the criminal involvement of Ian Greer (a political lobbyist investigated in the ‘cash for questions’ scandal). This investigation alleged that the scandal went far higher than Neil Hamilton, the main scapegoat,<sup>64</sup> and reached the PM. This was explosive and could have brought down the government (of John Major). Fellows claimed that Clarke was repeatedly in Greer’s office (something Clarke denies as it poses serious questions).
- A secret film showed Ken Clarke (a then cabinet minister) in Greer’s office (in itself a significant problem). By chance it also showed something else.
- Fellows was groped by Clarke in Ian Greer’s office while the secret cameras rolled.
- The secret film of this event was held by Central Television and was taken by a lawyer dealing with the Cook Report. Subsequently that investigation was terminated. David Cameron, whilst working as an executive for Carlton Television (a client of Greer) secured the tapes after Carlton Television hastily acquired Central Television.<sup>65</sup> The tapes were sent by Carlton to a storage facility called ‘Iron Mountain’. Mysteriously, the Iron Mountain facility burned down soon afterwards, destroying the evidence. The police told Fellows that there was a high level conspiracy regarding those tapes as they blew open the ‘cash for questions’ scandal involving the Tories (as well as incriminating Clarke).
- The Times journalist Jack Malvern (not the police) found out about the Iron Mountain fire.
- A certain Sylvia Jones admitted to Jack Malvern that she had seen the tape, but did not see the assault. She later denied seeing this tape when questioned by the police.
- When Fellows went public with the story when he got older (after the Savile affair opened the door for victims of child abuse), journalists and bloggers who published it on the Internet were threatened.
- 13 April 2013: DC Ben Lambskin and a colleague called Andy arrived at Fellow’s house to question him about his accusations.
- On 8 August 2013: the police called Fellows in to make a statement as part of Operation Fairbank (the covert aspect of Operation Yewtree into Savile’s connections, demanded by Tom Watson MP into accusations of child abuse in Westminster). This is part of the Metropolitan Police’s Paedophile Unit.<sup>66</sup> DCI Paul Settle, who was in charge of the investigation, led this request.<sup>67</sup>

- Fellows was whisked off by the CID and interrogated for 8 hours compiling a statement 15 pages long. [The background to this was secretly filmed by his associates.]<sup>68</sup>
- During this, Fellows was arrested for ‘conspiring to pervert the cause of justice’. This allowed the Met. to get a warrant to break into the house where he was staying with someone in Uxbridge and take all the computers to steal any evidence. In the end Fellows was released without charge. Remember that Fellows is a victim who is being a good citizen giving evidence on a crime committed. Instead he is treated as a criminal.
- At this time Detective Ben Lambskin formally stated that even if the police interviewed Clarke, he would lie. He also is alleged to have stated that Clarke was, ‘*above the law*’. He also stated that the matter of the tape was ‘corporate’ and that the police were powerless in investigating large corporations.
- Other police officers named by Fellows in this connection are: Detective Chief Inspector Paul Settle, Detective Constable Nathan Jones (who threatened Fellows to give the police statement on Clarke), Detective Sergeant James Townly; Detective Constable Ben Lambskin, and the clerks who took his statement were called Andy and Julia-Anne.
- Despite all the detailed evidence given by Fellows, the police decided not to question Clarke.
- The police told Fellows that the treatment and suffering he had experienced since going public was a ‘demoralisation exercise’ to stop the complaint.
- The police told Fellows that there were protocols in place preventing them from speaking to Clarke about the complaint of sexual abuse.
- After this Fellows made a speech at the Bilderberg Fringe which was filmed by Pienmash films.<sup>69</sup> [Clarke was on the steering committee of the Bilderbergers.] After the event, the hotel where he spoke was investigated by police in forensic suits. An Inspector Knight told Fellows at 3 am that the men were collecting DNA!
- After being threatened and warned to stay low by the police, Fellows kept a low profile for a time.
- Fellows then complained to the IPCC and was told by Dave Bird that the police had reopened his case, despite Det. Ben Lambskin formerly informing him that it was closed.
- In 2013 Fellows took part in a ‘Walk Against Corruption’ walking from Plymouth to London to draw public attention to his story.
- Fellows wrote a public letter to Clarke challenging him to either sue him or to appear on Newsnight or Question Time with him to answer publicly why he was preventing the police doing their job.
- Ken Clarke’s formal response to these allegations is that he had never been in Greer’s office and that it was a case of mistaken identify (despite Greer introducing Clarke to Fellows formally). He has not sued Fellows so far.
- Note: Ken Clarke is allegedly a Freemason. The police officers in Operation Fairbridge are allegedly all Freemasons.<sup>70</sup>

### *Summary*

Attempts to initiate a police investigation were dismissed, allegedly by the paedophile unit, as Clarke was untouchable, ‘*he is above the law and cannot be questioned*’.<sup>71</sup> Fellows was

subsequently threatened by masked men and feared for his life. He was later arrested by the Metropolitan Police but was not charged. Clarke denies the allegation but the police have not charged Fellows with conspiring to pervert the cause of justice, which they should if he lied.

This is a case where hard evidence was available but has been deleted by a conspiracy. However, it is also evidence of the refusal of the police to process a written witness statement against a senior politician.<sup>72</sup> It appears that the police paedophile unit actually protects paedophiles, if they are of the ruling elite.

### **Peter Morrison – confirmed but not convicted paedophile**

Morrison was the MP for Chester and deputy chairman of the Tory Party. Morrison had twice been caught cottaging in public toilets with underaged boys but was only released with a caution. There was no record kept in police files. Dissatisfied police officers tipped off *The Guardian* complaining that a less powerful man would have been charged with gross indecency. Evidence coming to light later shows him connected to paedophile rings.

When confronted by journalists Morrison used libel laws to block publication of the story. The news only came out after Morrison died and could not sue. This is a common situation.<sup>73</sup> The libel laws are often used as a threat by paedophiles to protect themselves.

### **Graham Ovenden – convicted paedophile, and a friend: Lord McAlpine**

Ovenden is a world famous artist / photographer who has been accused of child abuse for over 40 years. His works have been investigated as possible child pornography by the US and UK authorities years ago.

He has been prosecuted and tried in the past but got off as a result of power applied by high level friends, including judges and lords (e.g. a 2009 prosecution).

However, in April 2013 he was accused of six charges of indecency with a child and one case of indecent assault at Truro Crown Court. The four children involved are now adults and the offences occurred between 1972 and 1985. He was found guilty of these but acquitted (on the judge's direction) of other assaults.<sup>74</sup> Incredibly, on 4 June 2013 he received a suspended sentence by a judge (Graham Cottle) known to give light sentences to paedophiles. The Attorney General reviewed this case and on 9 October 2013 and Ovenden was jailed for two years and three months by the Court of Appeal.<sup>75</sup>

What is interesting is that alleged paedophile Lord McAlpine owned a collection of photos and erotic art by Ovenden, now a convicted paedophile. Indecent images of children created by paedophiles at an ordinary person's home, or even just on his computer, have led to jail sentences, but Lord McAlpine's stash is considered as 'art'.<sup>76</sup>

McAlpine's name had previously arisen, after the Savile exposure, as one of the predators in a Tory ring who abused children in care homes. [See later.] Due to his threats of using libel laws, the BBC paid him £185,000 even though the programme involved (*Newsnight*) never actually named him. Sally Bercow was found guilty by a friend of his, in a High Court libel suit in May 2013, for simply tweeting: '*Why is Lord McAlpine trending?*'

This is an example of how powerful people can shut down accusers that have no money and how people connected to judges get preferential treatment.

*Messham's apology to Lord McAlpine*

Abuse survivor Steven Messham was interviewed on Newsnight about allegations of high level abusers during the North Wales enquiry. He later apologised to Lord McAlpine, though he was not named on the Newsnight broadcast.

The mistake made by witness Steven Messham should have been properly investigated by Newsnight. What Messham claimed was that the police showed him photographs and he identified abusers. One of the men he identified as an abuser was stated to be Lord McAlpine BY THE POLICE; so Messham implicated him (though not broadcast on Newsnight). Clearly this was deliberate disinformation and misdirection to scupper the case and make Messham sound like an unreliable witness. Newsnight should have searched out the policeman who did this and tried to obtain the correct photos. We would then have had a prime suspect. As it is now, the victims have not had justice.

**The Royal Courts of Justice – tolerated paedophile venue**

Complaints that under-age boys are being abused in a toilet will normally result in a police investigation and arrest. Many famous people have been arrested for such ‘cottaging’.<sup>77</sup> However, in the case of the Royal Courts of Justice in the Strand this will not happen under the terms of a long-standing Metropolitan police policy. An operation will only be given the go-ahead here if it has the approval of an officer of the rank of commander or above.

The reason is obvious, and is confirmed by experienced police officers, that those toilets are used by High Court judges and barristers, and the Met. has always said that it does not want to grapple with such a powerful offender without special authority.<sup>78</sup>

**Interim conclusion**

We have shown some hard evidence of high level paedophilia and the cover-up of evidence by the police and senior figures. This may only involve a few people but it shows that the problem exists and that police and state corruption is involved in protecting senior offenders.

As we examine further evidence, we will see that this pattern keeps emerging – allegations against senior figures followed by state corruption and a cover-up.

## Paedophile rings

**PIE: The Paedophile Information Exchange**

This, now outlawed, organisation was once formally supported by politicians that are now high-level public figures, such as Harriet Harman and Patricia Hewitt. Old information is coming back to haunt them. One of the goals of this group was to bring the age of consent down to 4-years old, or even eradicating the age of consent completely, and yet it managed to exist openly for ten years.

In the late 70s PIE was affiliated with the National Council for Civil Liberties, now Liberty. In 1976, in a submission to the Criminal Law Revision Committee, the NCCL asserted that *‘childhood sexual experiences, willingly engaged in, with an adult result in no identifiable*

*damage*'.<sup>79</sup> Consequently they opposed the Protection of Children Bill. Harriet Harman and Patricia Hewitt were leaders of the NCCL at this time. When PIE argued for incest to be decriminalised and photos of naked children not to be considered as indecent, Harman argued that the alternative view would '*increase censorship*'.<sup>80</sup> In 1978 the NCCL passed motions supporting PIE's rights, condemning attacks on paedophiles and their supporters.<sup>81</sup>

The leaders of PIE openly stated that they were paedophiles (such as Keith Hose, the first chairman). Amazingly, PIE received grants totalling £70,000 from the Home Office in 1980, but this did not emerge until 2014 when a whistleblower told the police.

PIE was formed in 1974 campaigning for 'children's sexuality'. At this point it ought to be said that many council and government led education schemes are doing this right now. These schemes sexualise children as young as four with graphic explanations of sexual intercourse, oral sex, and contraception.

PIE gained support from professional bodies and academics, receiving invitations from student groups and media news outlets. PIE tried to conflate its cause with Gay rights, which was burgeoning at the time (homosexuality had only been decriminalised in 1967 and the age of consent for Gay people was 21).

In 1977 the Campaign for Homosexual Equality condemned the harassment of PIE in the press. Many people wrote to The Guardian defending sex with children, after articles had attacked PIE, often giving their names. The Young Liberals (apart from its leader) openly supported PIE. The group was growing in numbers and influence.

Things changed in the 80s. In 1982 Geoffrey Prime (a KGB spy and member of PIE) was jailed for 32 years for passing on secrets and for sex attacks on young girls. A scoutmaster resigned after being exposed as a member of PIE in 1983. A Scottish headmaster gave a dossier on PIE to Scotland Yard after infiltrating the group. PIE chairman Tom O'Carroll was jailed for two years for 'conspiracy to corrupt public morals' in 1982. However, the NCCL (Liberty) continued to defend the group. As late as 1983 the NCCL was campaigning to lower the age of consent to 14 and only excluded PIE during 1983.<sup>82</sup> In 1984 two former leaders of PIE were convicted on child pornography charges, while other leaders fled the country. PIE disbanded in 1984.<sup>83</sup>

Harman and Hewitt still need to explain why their organisation continued to support PIE until 1983, even after prosecutions for paedophilia. Harman constantly lobbied government to legalise child pornography, paedophilia and incest. Despite her denials of this, released government documents have her signature on them proving it.

Hewitt (NCCL general secretary for nine years) issued an apology, after being hounded, saying that she had been '*naïve and wrong*'. Harman (NCCL's in-house solicitor), however, has not apologised, though she expressed '*regret*' at the involvement. Harman's husband MP Jack Dromey, was also involved as a member of the NCCL executive committee.

Note: three current MPs openly supported a paedophile organisation for years, whose leaders had been convicted for sexual abuse, and even openly campaigned to lower the age of consent. Two have not apologised. The Home Office also gave this paedophile ring grants.

### **MP Tom Watson's evidence**

On 24 October 2012 Watson spoke at PM questions saying that a powerful paedophile network may have operated in the UK with links to Parliament and Downing Street. He said, '*The evidence file used to convict paedophile Peter Righton, if it still exists, contains clear intelligence of a widespread paedophile ring. ... One of its members boasts of a link to a senior aide of a former prime minister, who said he could smuggle indecent images of children from abroad. The leads were not followed up.*'<sup>84</sup>

As a result of Watson's questions, Operation Fernbridge was launched by the PM.

### **Elm Guest House – paedophile ring HQ**

Many news services carried stories on the paedophile ring that operated out of Elm Guest House and the Grafton Close care home in Barnes, London.<sup>85</sup> It is claimed that sex parties at this house were frequented by politicians in the late 70s and 1980s.

Operation Fairbank was led by the police into this network, which began in 2012 for a preliminary assessment of evidence rather than a formal enquiry. It was a secret investigation that was later merged into Operation Fernbridge.

Those alleged to have attended this place include: Sir Anthony Blunt (the Soviet spy), Cyril Smith MP, Sir Peter Hayman, a bishop (later charged), pop stars, an MI5 officer, a judge and other politicians from the Tories, Labour and Sinn Féin.<sup>86</sup> A Met. spokesman said, '*We can confirm Cyril Smith visited the premises*'.<sup>87</sup>

The police arrested two obscure men<sup>88</sup> as part of Operation Fernbridge, launched after concerns by MP Tom Watson.<sup>89</sup> The evidence had arisen in the file of convict Peter Righton showing intelligence of a sex abuse gang. One witness had told Watson of links with a senior aide to a former prime minister. Watson expressed concerns that this ring was protected by connections to Parliament.

The guest house was run by Carole Kasir, who died in 1990 aged 47 of an overdose. Surely this death is questionable? Two people claimed it was murder at the time but were ignored.<sup>90</sup> In 1982 the police raided a party where 12 boys gave evidence of their abuse by men at the house. Kasir was convicted of running a disorderly house but the child abuse was not pursued – why? It turns out that two policemen were in the house at the time of the raid, claiming to have been undercover. Kasir had logbooks, names, times, dates and pictures of visitors. What happened to these? It is claimed that Special Branch took over from local police and covered the whole thing up.

In February 2013 it was reported that police were also investigating the Grafton Close Children's Home in Richmond and that Kasir had pictures of many establishment figures at Elm Guest House and one of a former cabinet minister in a sauna with a naked boy.<sup>91</sup> A document later appeared on the Internet showing a list of visitors on one occasion.<sup>92</sup> Police received testimony from boys who had been sent to Elm Guest House and abused while they were residents at Grafton. At least three men named in documents as visitors to Elm Guest House were later convicted of multiple sex offences against children.<sup>93</sup>

Some of those children that were abused later committed suicide.<sup>94</sup>

### **Dolphin Square**

Dolphin Square is a collection of the largest blocks of flats in Europe set in Pimlico, containing its own shops, bars and restaurants, within convenient reach of the House of Commons. About 50, mostly Tory, MPs live there.

Ian Greer [see earlier on Ken Clarke] threw gay parties in suites hired in Dolphin Square by his company. Scallywag magazine (now defunct) exposed a story claiming that boys from children's homes in North Wales were procured for a paedophile network running out of these premises. When this was published in 1994-5 there was at least one resignation from the Conservative Office. A number of other sources also identify this area as being the base of paedophile sex parties hosted by Greer and others.<sup>95</sup>

One person alleged to be involved in this connection is Derek Laud, a personal friend of David Cameron and who contributed to speeches of well known Tories including Thatcher. He has many close friends in Conservative halls of power. It is alleged that he ran a Pimlico PR agency (Ludgate Communications) which supplied young boys for politicians taken from children's homes in North Wales. It is alleged he did this in connection with Ian Greer Associates. This was partially investigated as a 'boys for questions' case, at the time of the 'cash for question' scandal. Laud threw parties at Dolphin Square and one victim swears that he was molested there by a Tory peer.<sup>96</sup> However, despite many websites outing him, there is very little evidence supplied.

Ben Fellows also confirms, in his various testimonies, that Dolphin Square was used to host parties where children were drugged and abused. [See 'Ken Clarke'.]

It is difficult to get real evidence supporting exactly what went on, but there are enough testimonies from victims to warrant a new police investigation looking at all the various claims regarding this site (some of which have already been supplied). The truth could range from Gay parties that were not illegal to a paedophile ring supplying under aged boys to be abused by politicians. Until there is a prosecution we cannot be certain.

### **The BBC paedophile ring**

Claims of institutional child abuse in the BBC have been raised by very many victims over the years, but these are now gathering momentum. Savile was not alone in his crimes. New victims have gone public after the Savile affair claiming that the BBC had a, '*very organised* paedophile ring operating out of BBC HQ.<sup>97</sup> They claim they were abused by Savile and a number of other BBC staff. Liz Dux leads a legal team representing over 20 victims, and says, '*The calls are coming in day by day, including victims as well as witnesses who saw things take place*'. Nine serving BBC employees are under investigation for serious allegations.

One witness (Leisha Brookes) claims that she was, '*abused repeatedly by up to 35 men including Savile over a two year period whilst visiting the BBC HQ in White City, West London*'.<sup>98</sup> She alleges that the abuse was co-ordinated by a BBC cameraman and occurred between the ages of 9 and 11.

Other victims claim that Top of the Pops was a centre of abuse involving a number of men who would procure girls and boys then take them to after parties where they were abused.

#### *Ben Fellows' testimony*

Fellows has given much information in a variety of sources (film, interviews, websites, letters<sup>99</sup>) in which he claims that the BBC was riddled with child abuse during his time there in various capacities, such as castings. He alleges that it was commonplace for after parties to occur on the premises following recordings, say of Top of the Pops or some other programme. Here under aged children would be plied with alcohol and cocaine and then subjected to indecent assaults. He strongly avers that Savile was not alone in his behaviour but that it was common practice amongst many BBC staff. He states that inappropriate behaviour with unsupervised minors was seen as normal by BBC staff. He also alleges that a top female BBC producer is a paedophile having seduced him as a minor.<sup>100</sup>

#### *The Gill Statue*

On the front of the BBC headquarters in London there is a statue depicting a man holding a naked boy next to his groin. The artist involved, Eric Gill, was a paedophile who abused his sisters, two daughters and even his dog. It is supposed to represent Shakespeare's Ariel and Prospero. There have been calls for it to be removed. Why did the BBC choose such a grotesque image to front its HQ?

#### *Jill Dando*

It is alleged that Jill Dando was assassinated on the orders of the highest levels of power because she was about to blow the whistle on the exploits of the BBC paedophile ring.<sup>101</sup> There is no doubt that the Metropolitan police's investigation was a shambles (e.g. they failed to question Dando's neighbours and issued an e-fit photo of the suspect with brown hair instead of blond) and then fitted up poor Barry George; falsely imprisoned for 8 years and left without compensation.

There is no doubt that Dando's assassination was a professional hit by an experienced gunman and not some random act of violence by a bumbling stalker. Why did the police not examine motive for such a professional hit by investigating what Dando was considering?

### *Proved paedophiles working for the BBC*

- Jimmy Savile [see earlier.]
- BBC Bristol presenter Peter Rowell [also one of Prince Charles ambassadors entrusted with assessing young people as part of the Prince's Trust scheme] – jailed for six years for abusing girls under 16-years old.<sup>102</sup>
- BBC presenter and predatory paedophile Michael Souter was jailed for 22 years for sexually abusing seven boys.<sup>103</sup>
- Chris Denning was jailed for three years for indecent assault on a 13-year old boy and possession of indecent photographs in 1988.
- An unnamed BBC presenter<sup>104</sup> was linked to the Paedophile Information Exchange (PIE), which is now outlawed. He used a charity (Azimuth Trust) to cover up abuse of young children on sailing trips. A certain Michael Johnson was later convicted of abusing boys with him and the case is open regarding the presenter.<sup>105</sup> The case is being re-opened by the police.
- Stuart Hall: famous convicted paedophile. Hall was a very famous TV presenter of 'It's a knockout' and 'Jeux Sans Frontières' shows and a BBC radio football commentator. In April 2013 he pleaded guilty to indecently assaulting 13 girls aged between 9 and 17 between 1967 and 1986. He was sentenced to 15 months in prison, later increased to 30 months. Further charges followed.
- Jonathan King was convicted in 2001 for abusing boys. Between 1965 and 1975 he appeared on Top of the Pops many times as a performer and was present as a producer of pop singles. He was involved in many media projects and his series 'Entertainment USA' was aired on BBC 2. He also hosted the BRIT awards for the BBC in 1987.
- The actor and writer Chris Langham; convicted under Operation Ore.

### *Freemasonry*

A woman who was a secretary at the BBC claimed that it was, 'full of Freemasons and queers'. That many Gay people are employed by the BBC is common knowledge but she alleged that she was given Masonic memos to type every day and Masonic literature would be on the photocopier waiting to be copied.<sup>106</sup> Strong links between BBC executives and Freemasons would not be surprising.

### *Summary*

We are again hindered by the lack of detailed hard evidence as to exactly what the scope of guilt is. There appears to be little doubt that Savile and others were abusing many children in after parties of one programme and another. There are also a number of prosecuted and convicted BBC staff. But exactly how far paedophile rings were established and networked is unknown, for now. However, again there is sufficient testimony for a thorough, detailed police enquiry into the charge that the BBC was home to a paedophile ring, or at least regularly used for paedophile activities.

### **The police**

As you will see in this paper, the police are tacitly complicit in the guilt of paedophiles, at least, through the neglect of duty in pursuing allegations and arbitrarily dropping

investigations. They are also clearly guilty in protecting high-level public figures or those (like Savile, Smith) connected to them in some way. It seems logical that Freemasonry has something to do with this.

However, I have received personal testimony from former police officers that there are powerful paedophile rings in the police force itself (which would explain the failure to investigate abuse claims properly). Victims in various areas, such as Devon [see later], have also alleged this.

I have known a number of conscientious police officers who were so disgusted with what they experienced in the police force that they resigned and changed their jobs. These include Christians and one pastor.

One non-Christian ex-police officer was a policewoman in Manchester. She discovered a large paedophile ring in the Manchester police force and was disgusted. She tried to get an investigation going into this and her life was made an absolute misery. The more she tried the more she was harassed. In the end her life was threatened and she resigned on medical grounds suffering from serious depression. Due to her fear of her life I am unable to name her.

Such tactics are a good way to silence critics. Such claims can only ever be circumstantial because witnesses are too scared to sign an affidavit or go public; thus any such claims can be dismissed as merely anecdotal. However, they go a long way to explain why police investigations have repeatedly been terminated with no explanation and why people like Savile, Cyril Smith, Peter Morrison and Edward Heath (to name but a few) were never prosecuted.

#### *Hidden files*

Over and over again, as we investigate specific cases of child abuse, we find that police investigations are suddenly shut down and files either go missing or are placed on a restricted list. This becomes obvious to any researcher; however, the Press has also noticed it.

The Mail exposed that fact that celebrities and politicians had their sex attack files hidden from investigating officers by senior coppers.<sup>107</sup>

It claims that hundreds of files were so heavily protected by senior police that investigating officers could not access them. Information on elite figures was marked as 'secret' or 'restricted' and were only available to a small number of officers. Clearly this enabled offenders such as Savile and Cyril Smith to escape justice. This was claimed in a report on the effectiveness of the Police National Database in the wake of the Savile scandal. Complaints made about Savile around the UK, for example, were not shared with other detectives.

#### *Past record*

For anyone unconvinced of the almost total corruption of senior UK police (riddled with Freemasonry), and especially the Metropolitan Police, note:

- The multiple, questionable, deaths in custody; sometimes of incapacitated people.
- The beating of innocent suspects in custody; sometimes requiring hospitalisation.

- The death of Blair Peach. [A teacher who was killed by police during an anti-racism demonstration in London in April 1979. He died of head injuries sustained from the Metropolitan Police Special Patrol Group. 14 witnesses claimed to see police strike Peach. No one was charged. The police later reached an out-of-court settlement with relatives in 1989.]
- The Cardiff Five. [Described as one of Britain's worst miscarriages of justice by The Independent.<sup>108</sup> It led to the biggest police corruption trial, which collapsed costing £30 million and forcing two enquires. Five people were wrongly accused of the 1988 killing of a Cardiff prostitute by fabricated police evidence.]
- The Birmingham Six frame-up [see the film, 'Sons of the fathers'].
- The Guildford Four frame-up.
- The Maguire Seven.
- The killing of Daniel Morgan in Sydenham in 1987 who was about to expose police corruption.
- The Hillsborough Tragedy cover-up and smearing of innocents (now coming to light slowly).
- The Stephen Lawrence cover-up and discrediting of the Lawrence family (slowly coming to light)
- The shooting of Mark Duggan, an unarmed man (which sparked the London riots). Original claims by the police that he had a gun were exposed as lies.
- The assassination of innocent Jean Charles de Menezes in Stockwell by six shots to the head.
- The death of Ian Tomlinson. [Innocent bystander who died as a result of a police beating while being 'kettled' during a demonstration. Initial police lies about not being involved were proved wrong when a mobile telephone video emerged showing what happened.]
- The multiple crimes and planned crimes perpetrated by police officers, including kidnap, perjury, burglary and robbery, recently reported in the Press.<sup>109</sup>
- The 'Plebgate affair', concerted lying to smear Andrew Mitchell, an innocent politician.
- Shredding 'lorry-loads' documents to cover-up crimes.<sup>110</sup> This has happened many times, but most highlighted was Operation Othona files (into police corruption) in 2003. Operation Othona included intelligence on detectives trafficking drugs, fabricating evidence and selling police information to organised crime syndicates. A leaked 2002 police report (Operation Tiberius) concluded that organised crime syndicates were able to infiltrate Scotland Yard 'at will'.
- Operation Zloty (the second recent Met. police corruption probe) found 'dozens' of Met. detectives in the pay of organised crime.<sup>111</sup>

We could go on. The conspiracy to protect paedophiles, and especially high level celebrities and politicians, should come as no surprise. There have been previous periods of history where it has been proved that many levels of the police force were corrupt; such as the 1960s-early 70s. The Kray brothers, for example, paid off many strata of police officers. The film, 'The Bank Job', based on truth, gives an example of this at work.

### **Example of a paedophile network web**

#### *The Greystone Heath ring*<sup>113</sup>

1965: Keith Laverack starts work at Greystone Heath and commits buggery and indecent assault there raping at least 16 boys over the next four years.

Laverack shared some of these boys with his colleague Brian Percival, the clerk and storeman.

Other abusers join the staff: Alan Langshaw raped at least 24 boys. Dennis Grain raped at least 18. Roy Shuttleworth raped at least ten. Jack Bennett indecently assaulted two. Steve Norris assaulted an unknown number.

Laverack moved to Cambridgeshire. At least four of his colleagues are suspected of assaulting children.

Dennis Grain worked in Doncaster for the same group of private schools as Terence Hoskins who became head-teacher of St Aiden's Community Home in Widnes. He used his connections with the South Yorkshire police to get access to his own file from the supposedly secret National Criminal Intelligence Service (NCIS). His house-master Colin Dick committed assaults.

Dennis Grain had previously attacked boys in Danesford children's home in Congleton. He opened the door there to three others: John Clarke, Joseph Smith and Brian Hudson. Grain then went to work at Eton where he was a housemaster.

When he was principal of St Vincent's, Alan Langshaw recruited a care worker named Edward Stanton, via Roy Shuttleworth, where he abused children. Shuttleworth (still at Greystone) knew Stanton from a course in residential childcare in Birmingham. This course was lectured by Peter Righton, the notorious paedophile. Righton lectured at numerous other colleges before he was convicted. He even became a consultant in child

care and the Director of Education at the National Institute of Social Work in London, where he influenced government policy.

Righton tried to legitimise his position by academic studies. He belonged to the Paedophile Information Exchange, along with Jack Bennett. Righton had worked in the same children's home in Maidstone as Peter Howarth and went on to become an abuser in the homes in North Wales along with Steve Norris, formerly of Greystone.

Though these men claimed to work alone, they were abusing victims yards away from each other and even sharing the same boys.

Laverack, who started the abuse at Greystone Heath, went on to run the Guardian Ad Litem panel for Cambridgeshire County Council, representing the interests of children in court cases. This job introduced him to very vulnerable children and gave him access to their files.

One can immediately see the complex web of interwoven relationships where people collude to abuse and pave the way for other abusers; imagine the complications of the national or international paedophile networks. Arresting a few low-level culprits here and there is going to do nothing to break the bonds of institutional paedophilia. The whole house of cards has to come down starting at the top.

### **Example of a weak prosecution regarding paedophile rings**

#### *Operation Orchid*

Robert Oliver and Sidney Cooke and their friends abducted, drugged, raped and killed Jason Swift, Barry Lewes and Mark Tildesley. They were only convicted of manslaughter. Officers from Operation Orchid were frustrated, first because there was insufficient evidence to convict them of murder, and second, because they were never able to bring charges at all in relation to six other boys who, they believed, had also died at the hands of the same ring.<sup>114</sup>

## **Institutional child abuse**

*After twenty years of scandal and alarm, after numerous inquiries and reports, and despite the best efforts of those who work in it, we have created an elaborate and sophisticated failure, a child protection system which does not protect the children.*<sup>115</sup>

### **Care homes, approved schools, children's homes, orphanages**

*'During the last 30 years, children's homes in Britain suffered an epidemic of rape and violent assault. It was an epidemic that went unnoticed, like a plague that struck dumb its victims or else blinded those around it.'*<sup>116</sup>

If 100,000 children disappear every year,<sup>117</sup> where do they go. Claims that they all return or disappear on the streets or into prostitution are fallacious. Some may do but many simply

vanish. Even if they were all on the streets, what is society doing to try to find them? Nothing! Politicians work and play within a mile of very many homeless people but never do anything for them.

But the real answer, that is being averred in article after article is that many are simply being trafficked by paedophiles, abused and then murdered. Some are tortured and murdered in 'snuff films'. How do we know? Because the police regularly find these films in raids. I have given one example of a torture film in this paper.

However, perhaps a worse ordeal is suffered by severely abused children whom no one listens to, who suffer for years and then lead appalling lives, continuing their suffering in depression, physical problems, addictions, self-harm, unemployment and eventual suicide.

We need to examine the scale of abuse and why it is pushed under the carpet.

### **Whistleblowers just get ignored and sacked or silenced by courts<sup>118</sup>**

I will just give a few examples.

#### *Alison Taylor*

In North Wales, where a huge paedophile ring was uncovered, Taylor was the manager of a children's home who spent five years chasing Gwynedd Council, the police, the Welsh Office, the Dept. of Health and the Social Services Inspectorate regarding child abuse. They ignored her. So she compiled a dossier of 75 allegations, was backed by two local councillors, and finally secured convictions of four men. The government had to initiate its public enquiry, which identified detailed complaints against 148 adults by 300 victims. By this time, however, Taylor had been suspended and then sacked.

#### *Karen McKaye*

In South Wales McKaye was thrown out of her job after demanding that children's complaints be investigated. She was ignored but persistently and doggedly complained. Her complaints finally resulted in a major police enquiry into Taff Vale children's home in Cardiff; now 32 other homes are being investigated. Three men await trial (at 2012); Robert Starr was jailed for 15 years while three others were arrested.

#### *Elaine Bowerman*

In Warrington Elaine Bowerman spent ten years trying to get her union (Nalgo), her employers (Lancashire County Council) and the police to deal with complaints of assaults and violence upon children with learning difficulties at Massey Hall School. Eventually she was forced to tell the parents of some abused children to warn them and was sacked for gross misconduct. By 1996 she had lost everything when two boys approached her at home. She put them in touch with the police who reopened an enquiry. In June 1997 they charged Robert Boyle. He was later acquitted. It later turned out that he had a history of abuse going back to 1977. Other staff were not charged.

#### *Colin Smart*

Smart was the Director of Social Services in Sunderland in the early 1990s. He complained about child abuse to such a degree that Sunderland City Council took him to the High

Court where he was threatened with losing his pension and paying a fortune in damages if he ever spoke publicly about the charges.

It is said that North East is run by Catholics in Jarrow, the Freemasons who control many local councillors and the Labour Party who run the cities, such as Sunderland, like a small state.

A report by the NSPCC into a council home in Sunderland called Witherwack House named 23 men and women who were identified as abusers of children during the 70s and 80s. It also showed that three people had been sacked at Witherwack around 1987 for child abuse but no information had been given to the police, which is illegal. Smart went straight to the police, avoiding local politicians. Smart had turned down an offer to join the Masons in a city which had 34 lodges; including one (the Civic Lodge) entirely devoted to councillors.

Smart's own investigations revealed that the problem was not just the three who were sacked but a wider problem of abuse existed. This included beatings, sexual assault and children being restrained and locked in empty rooms for days on end. Smart went back to the police and told them his findings as well as to the Dept. of Health in London, asking for an enquiry using outside inspectors. Councillors now declared open war on Smart.

Smart had demanded that the abusive practices stopped but was informed that they had continued and worsened. The Social Services Inspectorate drafted a report revealing 'a repressive regime'. Smart's team compiled a list of offences affecting every children's home in the city, identifying 30 staff as possible abusers. He also found dirty rooms, broken furniture, meals consisting of just an apple or a biscuit and thrashings if any child complained. Smart then wrote a piece for The Guardian ('Kids in Crisis') without disclosing details at Sunderland. He said, '*It is debatable whether the majority of children now in residential care have been more harmed by the circumstances which brought them into the system, or by their time with social services*'.

Smart threatened the council to do a list of things to put things right or he would resign. The chief executive accepted his resignation. The council then issued a stream of disinformation to the press. The Detective Chief Inspector (David Wilson) that had worked with Smart was attacked by Nalgo and by councillors. Wilson was moved off the enquiry. The Inspectorate report was sidelined and another local report accepted which covered up the scandal.

So Smart compiled his own report in 1992 in five volumes, one of which regarded the care of the elderly. This was sent to the police, the SSI, the Dept. of Health and the Secretary of State (Virginia Bottomley). The council sued him. They issued a writ for breach of confidence. It turns out that two former residents were suing the council and Smart's report needed to be taken out of court. Smart went to court in 1993 while the council wasted public money on his trial. The judge was lax and the two sides struck a deal. Smart handed over his information and gave an undertaking not to speak out, and the bulk of the costs were dropped. He was now gagged.

The original three sacked workers got off lightly, despite the stories of abuse seeing the light of day in court. One was acquitted and the other two received suspended sentences.

Over the years residents, now grown up, brought suits against the council and a stream of investigations began, leading to a full report by the NSPCC.

### **Bryn Estyn, and other care homes in North Wales<sup>119</sup>**

Bryn Estyn is a children's care home in Wrexham, Clywd which closed in 1984.

The abuse at this home was so serious that victim Keith Gregory claims that at least a dozen kids have killed themselves. Here children were whipped, beaten abused and raped for decades. Visitors to the home who participated in the crimes included Jimmy Savile, his brother Johnny<sup>120</sup> and two senior Tories. One of these was Sir Peter Morrison, who died in 1995.

On occasions children would be taken to a hotel where they were gang raped and some were beaten bloody. The deputy head, Peter Howarth, repeatedly raped Gregory and was eventually jailed for abusing boys in 1994 for ten years.

In 1996 the Secretary of State for Wales (William Hague) ordered a Tribunal of Inquiry into allegations of hundreds of cases of child abuse in care homes led by former judge Sir Ronald Waterhouse QC. The Waterhouse Enquiry was a three-year, £13 million investigation into child abuse at a number of homes in Clywd and Gwynedd occurring between 1974 and 1990. It heard from over 650 people. Half of the witnesses needed psychiatric help after giving evidence. The enquiry finished in 1998 with the report being published in 1999 containing 700 allegations involving 170 kids, most of which involved care staff. 80 were named as abusers. However, many names were redacted. It did recognise that a paedophile ring existed in the areas of Cheshire and Wrexham but denied that it involved famous names. It resulted in changes in policy about dealing with children in care but many claim that it was a whitewash, protecting senior figures.

Keith Gregory (now a county councillor) was involved in the 'Waterhouse Inquiry' into child abuse in Wales, and was told that he could not name a lot of people who visited. The enquiry only focused on staff and care workers. When victims named powerful visitors the names were crossed out. The police were not interested in investigating influential people (like Savile or Morrison). Other victims, such as Steven Messham (who later appeared on Newsnight) also named other high level politicians who raped him; but nothing was done. He was told by one senior politician of the Thatcher years that he would be killed if he told the police. A separate enquiry into investigating these claims was initiated in 2012 led by Mrs Justice Julia Macur who would examine the Waterhouse Inquiry. Theresa May also launched a separate new police enquiry into how the original claims were dealt with (Operation Pallial).

The report of phase one of police investigation Operation Pallial was published on 29 April 2013 revealing 140 allegations of abuse at 18 children's homes in North Wales between 1963 and 1992. Over 200 people gave evidence, but many victims had died by then.

Children at Bryn Estyn were not delinquents, but kids who had been abused or abandoned and needed especial care and love. Instead they were raped by an institution. Staff had made allegations of abuse long before any enquires but nothing was done, according to at

least three reports by leading child care specialists which had not been published as of 1996.<sup>121</sup>

In this connection see earlier piece regarding Alison Taylor, whose own investigations supported reports which had resulted in no disciplinary action. Her own reports to the council resulted in no action. She then reported to the police and was suspended. The council offered Taylor a termination agreement if she agreed to keep quiet; she refused and was dismissed. More evidence of an official cover up would be hard to find. On taking the council to an industrial tribunal the case was quickly closed in an out of court settlement Waterhouse vindicated Taylor, saying that without her there would have been no enquiry.

Taylor then went to the local, Welsh and UK national media with her allegations including further allegations about Bryn Estyn. She discovered that more than ten reports of child abuse had been made to both councils before she raised concern. She compiled a dossier in 1991 of allegations from over 100 children, which she submitted to the police and copied to the council and the Welsh Office. Only the police took action but had no co-operation from the social services.

National concerns about care homes led to 10 public enquires between 1990 and 1996 which showed large scale institutional abuse of kids. In 1993 North Wales Police undertook an enquiry taking 2,600 statements and 300 cases were sent to the CPS. Only seven people were prosecuted and convicted. Six residential social workers were prosecuted for abuse, three having worked at Bryn Estyn. Peter Howarth was jailed.

Following this, there were allegations that the police had covered up allegations. In 1994 Clwyd County Council commissioned a further enquiry (the Jillings Report). This met with considerable opposition. The chief constable refused to co-operate with it and refused access to data. The enquiry had to repeat 70 witness statements. 130 boxes of data given by the council to the police were not made available to the enquiry. The council refused permission to place a notice in the press seeking information. At this point the government should have stepped in and prosecuted both the council and the police for perverting the course of justice. Clearly the cover up was still going on.

The Jillings Report said that allegations into famous names were beyond its remit and required yet another separate enquiry. It found that abuse, violence, beatings, indecent assaults and rapes were common. It estimated that up to 200 children were abused as late as the early 1990s. It found that 12 former residents had died from unnatural causes. It also said that the panel members nearly quit due to '*considerable constraints placed upon us*'. The final version of the report was not published due to fears about libel and legal advice from the council's insurers worried about compensation claims. The insurers, Municipal Mutual, also suggested that the chair of the council's social services committee be sacked if he spoke out.

Thus the Jilling's Report was suppressed and many guilty parties covered up. In 2012 Anne Clwyd MP called for the report to be published saying, '*it shows ... rape, bestiality, violent assaults and torture*' on children. Jillings himself said, '*What we found was horrific and on a significant scale*'. A redacted version was published in 2013.

When Messham appeared on Newsnight in 2012 he made further allegations of a wider circle of abusers including businessmen, the police, and senior politicians and called for a

further investigation. The new Children's Commissioner for Wales supported this saying that the Waterhouse Inquiry had been too narrow. Thus Julia Macur's enquiry began. Tom Watson MP called for a wider ranging enquiry and mentioned allegations of abuse by a former cabinet minister. Thus Theresa May launched an investigation headed by Keith Bristow (head of the National Crime Agency) to evaluate how the old claims were handled and look a fresh allegations (Operation Pallial). In April 2013, 76 new complainants came forward with allegations against 84 individuals; 16 had been named by more than one complainant. In November 2013 police said that 235 people had given information with over 100 alleged offenders.

#### *Interim conclusion*

This story is not just shocking but is a travesty; the country should be ashamed.

That it has had to take over a dozen enquiries, costing millions of pounds<sup>122</sup> and still failing to get to the whole truth is something to be deeply troubled by.

#### *Aside: connection of North Wales and London*

A group of men were believed by police to be abducting homeless girls from the streets of London in the early 1990s and holding them in a converted garage with padded walls, where they were abused and then killed. The man who disposed of the bodies was identified by police in Wales but they were unable to identify those who had hired him or to find evidence to charge him.<sup>123</sup>

#### **Kincora Boys Home, Belfast<sup>124</sup>**

This was a home for orphans and abandoned boys, which closed in 1980.

The Irish Independent first broke the news that there was a sex scandal at this children's home. Allegations had arisen from 1977 involving prominent businessmen but the Director of Public Prosecutions did nothing. We see that this is a familiar story. Later in 1980 three staff members were charged and then jailed.

Then allegations arose that the police had been informed about child abuse for many years but did nothing. The press then linked the home with a number of establishment figures. Private Eye magazine stated that senior Whitehall civil servants and British military officers were involved. In response to Press allegations the Eastern Health and Social Services Board decided not to employ homosexuals in any caring roles, and dismissed some innocent people.

In 1982 a private enquiry was set up. This collapsed when the police failed to investigate properly. In 1984 another enquiry was initiated which submitted a report in 1985. It made certain recommendations including reversing the ban on Gay carers. It denied the existence of a paedophile ring but said that the home suffered from the normal malaise that affected all UK care homes. In 1982 a local councillor (Joshua Cardwell) committed suicide after being questioned about Kincora.

In 2013 the police reopened the case amongst claims of a secret service cover up to protect top level paedophiles. The enquiry is being led by retired judge Sir Anthony Hart, looking into abuse in the wider area between 1922 and 1995. Former Army Press Officer (Colin

Wallace) insisted that the authorities had known about boys being abused at Kincora for many years. He was fired from his job and blacklisted. After resettling in England he was framed for a mysterious manslaughter and jailed for six years. He claims that this was to silence him.

In 1982 a prominent Ulster loyalist and paramilitary man, John McKeague, was interviewed by detectives about Kincora and his involvement. Fearful of returning to prison he said that he was prepared to name names in a large paedophile ring. Within days he was shot dead by the INLA in his shop in East Belfast; it is said that this was organised by military intelligence. Of the two gunmen, one was alleged to be a known Special Branch agent and the other had military links.

Historic files from 1982 on Kincora released after the 30-year rule have been redacted, with key papers removed and one file deleted. Claims that senior people in politics, the civil service, secret services and the army continue to be aired but the establishment is still hiding the facts. One of the men prosecuted, William McGrath, turned out to be on the payroll of MI5 and MI6 and had close links with Ian Paisley.

It also appears that murders took place. The body of ten-year old Brian McDermott was found in a sack in the River Logan in September 1973, mutilated and burned, and the case was linked to Kincora. No one was prosecuted. Information given to senior ministers examining the case<sup>125</sup> was said to be conflicting with information given by the RUC but connections between the murder and Kincora were discussed.<sup>126</sup>

One person claimed to have visited Kincora is Edward Heath. Another named important figure is the late Lord Mountbatten. McGrath also had contacts with Sir Knox Cunningham, who himself has been allegedly linked to paedophile rings and was a friend of Tony Blair. A mutual friend of Cunningham was Sir Anthony Blunt, who was also known to McGrath.

A book by Martin Dillon ('The Dirty War', 1999) claims that McGrath was possibly employed by MI5 since the 60s and was blackmailed by the secret services to provide information on fellow loyalists in return for taking no action on his child abuse.

What is certain is that boys were certainly abused and possibly tortured and murdered. These have not received justice. Due to repeated allegations over decades, it also seems highly likely that top-level ruling establishment figures were involved and that these were covered up in several investigations. It is doubtful that any enquiry will get to the bottom of this if the RUC and the military intelligence services are involved, as is alleged.

### **Greystone Heath, Warrington**

This was an approved school that had a number of paedophile staff who raped many children. From there the abusers fanned out: Keith Laverack went to Cambridgeshire; Alan Langshaw became Principal of St Vincent's Catholic boy's home in Formby; Dennis Grain and Roy Shuttleworth were promoted to homes in Warrington; Steve Norris went to North Wales. They continued their abuse at their new homes and connected with other paedophiles.<sup>127</sup>

## Islington Children's homes

### *Background*

Margaret Hodge MP (nee Oppenheimer) is a multimillionaire whose family allegedly made £300 million during WWII collaborating with Nazis. She has been constantly linked to Care Home child sex abuse allegations and the subsequent cover up when she was Head of Islington Council. Horrifyingly, Blair made her Minister For Children in 2003. She is very close to Jack Straw and Harriet Harman [see those entries].

Patricia Hewitt is an ex-MP [see PIE] who ran Islington Care Homes and was once Secretary of State for Health (2005-2007). She was also leader of the NCCL in the 70s. She retired from frontline politics in 2007 and was suspended from the Labour Party in 2010 after the 'Cash for questions' scandal. She has argued that fathers are not a good influence on children and was a major force behind the sex education of young children adopted by Labour councils.

Islington Council ran 12 care homes for children who were in the care of the state and was run by politically correct Labour party members. At the start of the 70s there were several militant groups in London promoting sexual deviancies. These included: the Gay Liberation Front (GLF), PIE (see PIE) and Paedophile Action for Liberation (PAL), which were all funded by the government and shared an address.<sup>128</sup>

The GLF demanded that the care homes were handed over to its members to run and any political resistance was met with charges of homophobia. The NCCL [see PIE] led by Hewitt, lobbied the government for them and threatened legal action otherwise. By 1972 the GLF were in complete control of Islington Care Homes.

The care homes soon became the centre of an international child rape / pornography / torture / murder ring, with connections to Jersey and elsewhere. Almost all children in those homes were sexually abused between 1972 and 1997. Hundreds of kids went missing after being taken on trips abroad. Some went to Haut de la Garenne others to Casa Pia orphanages in Portugal. Non-compliant children were allegedly raped and murdered. Compliant kids were trafficked to Portugal for European politician paedophiles. Despite the hundreds of kids who travelled away, none are recorded as coming back.<sup>129</sup>

Jimmy Savile's nephew, Guy Marsden, attended parties in London houses in the 70s run by BBC executives which were attended by politicians, judges, BBC executives, and celebrities where children as young as 9, mostly from Islington Care Homes, were raped and tortured. [See Elm Guest House.]<sup>130</sup>

The GLF weeded out non-compliant staff and fired them as homophobic, such as social workers Liz Davies and David Cofie. Victims repeatedly tried to get the police to intervene to no avail. Scotland Yard refused to investigate. Nobody joined the dots between Islington and Jersey. Why?

Eventually the Evening Standard covered the story with determined reporters and the can of worms began to open.

### *The investigation*

Investigations into terrible crimes of sex abuse and murder in Islington care homes were plagued by children's files mysteriously disappearing, claimed award winning reporter

Eileen Fairweather.<sup>131</sup> However, she managed to prove that every home included staff who were paedophiles, child pornographers or pimps. The police later confirmed that several Islington workers were ‘networkers’, major operators in the supply of children for abuse and pornography.

Typically enough vehement denials of abuse emerged. Margaret Hodge, then council leader, denounced Fairweather and others as ‘*right-wing gutter journalists*’ who bribed children to lie, claiming that the kids were ‘*mentally unstable and extremely disturbed*’. Eventually Fairweather’s findings were verified by government ordered enquiries and followed by two British press awards. Yet Fairweather said that they had only scraped the surface of corruption. At this time Jack Straw was deputy to Hodge.

Only one serious conviction was obtained against Roy Caterer, who was sentenced to seven and a half years in jail. The police then closed the case. He is said to have received a £300,000 pay off for taking the fall. The same thing happened in Jersey.

A public outcry forced Margaret Hodge to resign as council leader. In 2003 Blair made her Minister for Children [you couldn’t make this up!].

#### *Nicholas John Rabet*

Nicholas John Rabet was deputy superintendent of Islington council’s home at 114 Grosvenor Avenue. He, and a colleague who was barred from social work, took children on unauthorised trips to Jersey. He became a key supplier of children from Islington’s care homes to paedophile rings. He also inherited a fortune from a woman who suddenly died after changing her will. Despite allegations, nothing was done.

Later, Rabet opened a children’s activity centre in the manor house he inherited near Heathfield, East Sussex. Children from Islington care came to stay. Walter Clack was also a volunteer there. When police raided this place Rabet had been given prior warning and had removed all pornography. However, they found photos of a 10-year old boy from Islington. On questioning him he confirmed months of abuse, but Islington Council hampered further investigations.

Many professionals had expressed grave fears about Rabet but Islington council falsely told Sussex police that it had no files on him or his victim! Staff had been ordered to locate complaints and deliver them to Lyn Cusack, Asst. Director of social services. Only after Fairweather explained their existence did police manage to get these files. A later enquiry (the White Enquiry) found that the Asst. Director destroyed many files, but avoided calling it a conspiracy. Islington also refused to identify other children or interview those in care. In the end the police decided not to prosecute. The ten-year old victim was not surprised and said, ‘*You have no idea how big this is*’.

One Turkish boy was regularly taken from Islington to spend weekends at Rabet’s house and then just disappeared; but no one misses kids in care.

Rabet was eventually caught by police in Thailand, where he had fled after the White Enquiry in Spring 2006 charged with abusing 30 boys as young as 6. The police believe he had abused as many as 300. He died of an overdose in May 2006.

### **Jack Straw**

Straw is implicated in many serious allegations on the web while he was Home Secretary. However, my concern here is with his action in 2009 when he made it illegal for any child to complain about abuse whilst in the care system.<sup>132</sup> When confronted by a London taxi driver about this, Straw stated (whilst being secretly recorded) that he did no such thing. This blatant lie was exposed on a film by PieNMash Films.

One has to ask the question, why would a Home Secretary (and a socialist at that) stop children victims reporting crimes against them?

Interestingly, it was Straw that placed all the Dunblane Massacre papers on Thomas Hamilton under a 100-year secrecy law. This is allegedly to cover up the involvement of fellow Freemasons and senior Labour Party figures who were complicit in the crime. A 100-year D-Notice is extraordinary.

It is also alleged that it was Straw that covered up the Hillsborough tragedy and the BBC/Jersey/Islington abuse scandals.<sup>133</sup>

### **Devon County Council**

Thousands of allegations of child abuse and police cover-ups have been recorded in Devon. From the sheer numbers of support groups established to help victims, something seriously wrong has been going on. Freedom of Information requests to Devon and Cornwall Constabulary into allegations of abuse by police officers failed to get results and the information was said to be destroyed.<sup>134</sup>

#### *Example: Malcolm Lidbury*

One case involved that of Malcolm Lidbury who has repeatedly reported having been abused by a teacher along with his clergy and police friends in 1987-88 aged 6 upwards. In return the police bullied, threatened and intimidated him to try to shut him up. The Devon & Cornwall Professional Standards Unit showed itself to be corrupt and also covered it up.<sup>135</sup>

Lidbury has fully reported the details of his allegations to the police, with witness statements, physical evidence and dates. Year after year he tried to get action from the police and year after year they did nothing, except perjure themselves. On one occasion he gave a six-hour statement recorded on video to the police; but they buried it. They later refused a freedom of information request to access the video.

Lidbury claims to be able to name and identify the police officers that obstructed him. Desperate and becoming suicidal he contacted Essex police. Essex police responded and stated that they had criminal information on one of the men accused. Essex police have now opened an investigation. Lidbury accuses the Devon & Cornwall police from the top down, of disposing of evidence and corruption. Lidbury is now incapacitated as a result of his ordeals and this is confirmed by a Consultant Clinical Forensic Psychiatrist.

Other allegations by other victims demonstrate that there is a serious problem with Devon and Cornwall Constabulary that no one is dealing with.

### *The scope of the scandal*

The Guardian reported that the child abuse cases might rival those of North Wales.<sup>136</sup> The original enquiry (Operation Lentisk, January 1988) into a Devon children's home quickly expanded into three more institutions. At least 80 children were allegedly abused in these. A police spokeswoman then said that 650 children were allegedly abused in care homes over 16 years. However, there were reports that 4,000 children might have been abused between the mid-50s and the mid-80s.

The Guardian wrote that three people were awaiting trial, 75 people were pursuing a civil action against Devon County Council, and other bodies, for negligence.

In the late 1990s the police conducted its biggest ever child abuse investigation. More than 300 people made allegations against 190 people from 41 residential care homes. Four former Forde Park staff were convicted.

### *North Devon*

One police officer, Danny Bryant, was convicted of child sex abuse.<sup>137</sup> Victim Kelvin Whittle was abused by Bryant when he was 24. He waived his right to anonymity to back fellow victim Russel Dawson's campaign into a public enquiry as to how the case was dealt with by Devon and Cornwall Police.<sup>138</sup> Both victims claim that the police covered-up paedophilia amongst serving police officers. It was only through the Savile scandal being publicised that both victims found the courage to speak out. Russel originally reported the crime in 1988. He went back to the police in 2011 but the police dismissed the allegation. It was only after the Savile scandal that pressure was put on the police to pursue it. MP Neil Parish is helping to initiate a public enquiry into the extent of Bryant's abuse.

### *Operation Mansfield*

Devon & Cornwall Police launched this operation into a paedophile ring in Devon in February 2011 after dozens of victims came forward.

### *William Goad - Plymouth*

Police admitted that members of a paedophile ring in Devon linked to Britain's most prolific child abuser, William Goad, may still be at large.<sup>139</sup> This is nine years after Goad was jailed for life in 2004. In usual form, one person took the fall while many other people in the network escaped. After Goad's death many more victims came forward and police sources stated that Goad's crimes may dwarf Savile's.

A new enquiry was launched after complaints that police allegations were not fully investigated in enquiries undertaken in 1987, 1995 and 2005 (Operation Banner<sup>140</sup>). A confidential report (seen by the Plymouth Herald) says that '*prominent men in society*' may have links to the abuse ring and that abused boys were threatened to keep quiet. A former detective, DC Shirley Thompson,<sup>141</sup> stated that officers were told to '*put a lid*' on the original investigation when she raised fears that other paedophiles were at large. Police have

formally accepted that many victims were never fully interviewed and could hold key information on suspects associated with Goad.

The victim who campaigned for years for a new enquiry is Paul Wyatt. He was later joined by a local charity, an MP and Shirley Thompson. Thompson also contacted BBC's Panorama to shame the police into action; this was broadcast in February 2005. As well as claims that others in the ring were not pursued, Thompson raised the point that Goad was known to be paedophile as far back as 1972, 30 years before he was jailed. If the police had acted correctly, hundreds of abused children could have been spared. She also criticised the police for ignoring hundreds of victims and not investigating their complaints as well as not cross-referencing victims' statements.

Thompson also explained that senior police officers had warned her to watch her back and that she would hit brick walls. She also claimed that Goad was protected for many years and that Operation Emotion (the original investigation into Goad in 1994) was rendered useless and enabled Goad to escape to Thailand.

Confidential records seen by the press also show that the local police were fully aware of allegations that Goad was working with a network, including nationally prominent men, in 1996. This alone demonstrates corruption. In addition police log books revealing why decisions were taken has gone missing.

In a video interview Goad named six other paedophiles but only one named Eddie Pratt was investigated. He took his own life the next month, leaving a note saying, 'Ha ha'.

### *Interim conclusion*

This survey only scratches the surface; I would need weeks of research to fully document what went on in Devon alone. However, what is clear is: A) there are enormous numbers of child abuse victims in Devon. B) Assaults on these kids has not been comprehensively

documented or investigated. C) Individual enquiries by the police have been allegedly severely hampered by corruption and cover-up. D) Those convicted are only the tip of the iceberg. E) This cover-up appears to be motivated by protecting both offenders in the police force and prominent public figures.

### **Haut de la Garenne**

Jersey has been described as an ‘*abuse-friendly enclave*’. Paedophilia often follows money and power, and Jersey, as a tax haven, has plenty of both. Victims of child abuse have reported incidents at many care homes and institutions in Jersey, which still haven’t been properly investigated. Even the Haut de la Garenne enquiry was shut down and covered up when the original findings were becoming too serious.

A film by Bill Maloney<sup>142</sup> showed a private house near Haut de la Garenne where the front garden prominently displayed two statues of infant children. One was fellating a large phallus. These statues were altered on a daily basis. For instance the male fellating boy was dressed in pigtails on one occasion. Firstly, this is surely illegal, constituting an illegal image. Secondly, it throws suspicion on the owner being near to a paedophile crime ring. But thirdly, there has been no local complaint or prosecution, despite being openly visible to every passer by. Furthermore, in a local beauty spot in Jersey there is a statue of Satan, literally bold as brass erected by the council. There is something seriously wrong in Jersey.

A 3-year long, £7.5 million police enquiry into historical child abuse was undertaken in Jersey after allegations from former residents of Haut de la Garenne. From September 2007 police took 1,776 statements from 192 victims identifying 151 alleged abusers but only seven low-level people were successfully prosecuted.

Solicitor Allan Collins represents 42 abused Jersey children and says that many of them identified Savile in investigations.<sup>143</sup> Nearly two hundred victims have told terrible stories of abuse, torture and murder carried on at this site. Other witnesses have identified senior public figures involved in a paedophile ring that ran from there. Regular visitors at Haut de la Garenne included Jimmy Savile and Edward Heath.

One of the victims of paedophile Wilfrid Brambell (Steptoe and Son) was from Haut de la Garenne whom he abused in a room at the Jersey Opera House in the 70s.

### *The police investigation*

*‘We know from court cases and statements made to my team that children in Jersey care homes were “loaned out” to members of the yachting fraternity and other prominent citizens on the pretence of recreational trips but during which they were savagely abused and often raped.’<sup>144</sup>*

The initial States of Jersey Police enquiry was led by a conscientious competent officer, Len Harper. Unfortunately he was too good at his job and ruffled many feathers. Harper faced sustained obstruction from fellow policemen as well as threats from the Jersey government and prominent citizens. He had to bring in colleagues from the UK to assist in the investigation. Jack Straw was Home Secretary at the time. Eventually both Harper, and his ally Chief Officer Graham Power, were ridiculed and criticised in a cover up. It is alleged that Margaret Hodge was also involved in the cover up because she was Islington Council leader from 1982-1992 when children were being trafficked to Jersey. She was in the cabinet at this time with Straw.

Barrister Michael Shrimpton states that Harper was up against a cabinet sponsored paedophile ring and would never succeed in prosecuting the true offenders.<sup>145</sup> Shrimpton also said that Harper's life was at risk as the investigation was getting close to the London cabinet and GO2,<sup>146</sup> as well as the Jersey elite. Harper retired after death threats in 2008.

So it occurred that Harper was kicked off the case and replaced by David Warcup<sup>147</sup> who called Harper '*a problem*'.<sup>148</sup> Then followed a complete whitewash with attempts to discredit Harper. In fact the Jersey government issued an arrest warrant for Harper, after he left the island, for falsifying evidence.

In April 2008 Harper had found forensic evidence that corroborated the reports given by abuse victims. Stories had emerged that from the 1960s terrible sexual and physical abuse, including torture and murder, had occurred in the care home. Search teams excavated underground chambers where shackles and a blood-spattered concrete bath were found. Victims identified these as 'punishment rooms' where children were kept in solitary confinement, drugged, flogged and raped. The 160 victim's testimony corroborated the findings.

Harper found numerous milk teeth and bones that were identified by more than one forensic lab as belonging to children. Some bones showed evidence of being cut while others were burned, however there was conflict regarding their age. Throughout his investigation Harper was plagued with criticism from politicians '*at every opportunity*'; however, the scope of his enquiries were approved by his own staff and ACPO.

Then Harper retired and Power was suspended; after investigation by outside forces no misconduct was found in either officer. Warcup was flown in from the UK and within weeks claimed that Harper was discredited, the bones were centuries old and mostly not of children, or even human, and that there was no forensic evidence of abuse. Harper was made to look foolish when Warcup said that a 'skull' fragment was found to be a coconut and shackles were bits of metal.

The forensic investigation was shut down and the home closed. The abuse enquiry continued but lost public interest. A more complete and obvious whitewash could hardly be imagined. At one point it was suggested that some of the finds were really props left over from recordings of the Bergerac TV series. Really!

Harper later defended himself in a Belfast Telegraph article.<sup>149</sup> He claimed that he had been, either deliberately or otherwise, misrepresented. Warcup's press conference said nothing new. Harper had ruled out the 'skull' fragment months before due to its age<sup>150</sup> and never claimed to have credible evidence of murder but had treated the scene as a potential homicide. The rusty metal was claimed to be shackles by the builders who found them in 2003. Others identified the metal as shackles, rusty or not. Closing down the investigation failed to come to any conclusions one way or the other about homicide.

Cellars that were denied to exist by Warcup can be seen in YouTube videos and this is where children were locked away when they complained about abuse.<sup>151</sup> Harper never called them ‘dungeons’, but affirmed that they are not voids as claimed by Warcup; they were cellars which previously formed the ground floor. The victims called them cellars, which is what they are. Warcup seemed to do everything possible, using lies and misrepresentation, to denounce Harper’s investigation.

Harper complained that senior police officers thwarted the investigations of junior officers. Furthermore, even his critics admit that at least three human bone fragments and children’s teeth from between 10 and 65 children of all ages were found in the digs. They are not from a cemetery and one anthropologist claimed they were about 20 years old. There was enough evidence to continue the investigation.

MP John Henning stated that he had no doubt that there had been efforts to cover up. He and Senator Stuart Syvret sought a judicial review of the UK Justice Secretary Jack Straw’s decision not to intervene.

An American investigative journalist (Leah McGrath Goodman) that began researching the truth in 2011 was prevented from access to the UK Jersey for two years. Even when MP John Henning intervened on her behalf her access was prevented for a year (allowing for removal of any evidence).

The sister residence, St Saviour’s Psychiatric Hospital, which was a home for mentally sick people, is claimed to be part of the ring of abuse but this was closed down and made into a listed building in September 2008. The regulations specifically state that no metal or mineral detecting can take place on the site. Convenient!

Only a few low-level individuals have been convicted of any crime.<sup>152</sup> When the investigation began, Jimmy Savile claimed to have never been to Haut de la Garenne until a photograph was published showing him at the site with a group of children. No senior public figure has been prosecuted.

There is no doubt that Haut de la Garenne was the centre of a UK-wide paedophile ring that involved high level public figures still anxious to keep these deeds quiet. Some of these carried out abuse on boats (like Heath) where murders are alleged to have occurred; other children were no doubt trafficked elsewhere, while many were abused on site (this much has been proved). The evidence of bones and teeth on site were suggestive but inconclusive without further processing and excavation, which was terminated by the new police enquiry team.

One man arrested by Harper was a senior figure in Jersey and was named by a victim, who had also been abused by Savile. This man is still employed by the state in a senior position. Harper gave the information to the authorities that he had raped two children at the home, solid allegations that would have succeeded in the UK he said. Yet Jersey’s Attorney General dropped the case. This man’s name aroused more fear in the victims than any

other. He was bold enough to say that he was protected and that if he went down he would take the Jersey government with him. This was what Savile had said. It seems to work.<sup>153</sup>

### *Whistle-blower*

It was not just victims that testified to the crimes but a policeman called Detective Constable Peter Cook gave information to a reporter who had previously exposed the terrible abuse at Islington.<sup>154</sup>

Cook had uncovered a vicious sex ring with victims both in Britain and the Channel Islands. He stated that his superiors had barred him from alerting them officially and he wanted a reporter to get the information to the London police paedophile team. Repeatedly enquiries by junior officers had been closed down.

Many in this ring were powerful and wealthy. The reporter he spoke to knew of these same men from her investigations from separate sources. They included an aristocrat, clerics, senior police officers and a social services chief. The reporter took the information to the National Criminal-Intelligence Squad 12 years previously and nothing happened, until the Jersey enquiry began.

Award winning journalist Eileen Fairweather explains that the murder of children in care has characterised other scandals<sup>155</sup> but Haut de la Garenne is directly linked to the abuse uncovered at Islington and involves the elite. Some of the staff at Islington were from the Channel Islands or regularly took children there on unofficial visits. The sailing trips for abuse of children, then delivering them to other abusers, characterised both Islington and Jersey paedophilia.

Likewise the smearing of investigators and suppression of damaging reports occurred at both places. Jersey social worker Simon Bellwood was sacked in 2007 for speaking out and health minister Stuart Syvret was fired in 2007 for publicising the suppressed Sharp Report into abuse allegations. Syvret then sought prosecution for politicians and police involved in the cover up.

Individuals involved in the abuse included Neil Hocquart, who abused children in Britain and Guernsey and supplied child pornography to a huge sex ring. A raid on his home in 1991 found hundreds of pornographic photos and videos of children; another man (Walter Clack) was also arrested. The victims could never be identified because Hocquart committed suicide after his arrest to avoid questioning. Where were these children from?

One was identified as a boy from Islington care, there were naked photos of this 10-year old boy.

DC Cook explained that a senior police officer broke protocol and informed Clack that his friend was dead. Clack then blamed Hocquart for everything and escaped with a fine and inherited a third of Hocquart's estate.

Apparently a number of suspects had died of heart attacks after leaving wills to others, like Hocquart, who was suspected in their possible murder. No investigation occurred.

Satan worshipper Edward Paisnel ('the Beast of Jersey') got a 30-year sentence in 1971 for raping boys and girls. He played Father Christmas as Haut de la Garenne in the 60s.

Nicholas Rabet had connections with Jersey and two other Jersey born social workers worked in Islington with young offenders. One arranged sailing trips to Guernsey, the other sent kids to Rabet's centre.

In 1995 Fairweather re-investigated Rabet and met DC Cook who had gone through Hocquart's papers and investigated other members of the paedophile ring. He found paedophile after paedophile. A man who married a woman just to abuse her two boys. The vicar who married them and knew about this but did not care as he was also a paedophile. Cook found abused victims in Guernsey whom Hocquart had delivered to a local high-ranking man to rape. He located a man in Wales who copied and distributed child pornography. No action was taken on any account. Senior police officers told Cook to drop his investigation and not to send his information anywhere. This was not the first time that Fairweather had discovered that police officers were forced to drop investigations into child abuse regarding a Channel Islands paedophile.

Fairweather took the information to NCIS on 4 January 1996 and copied it to Scotland Yard. Cook is now retired and free to go on public record. Michael Hames, the former head of Scotland Yard's Obscene Publications Squad told Fairweather that he never doubted that paedophiles were killing children in care.

#### *Other information*

- Birmingham City Council presented Jersey police with a list of children who were sent to Haut de la Garenne but went missing.
- Allegations have been made that pictures of babies being raped were taken in Haut de la Garenne and circulated by an international child porn ring.<sup>156</sup>
- Experts suspect that Haut de la Garenne was the place where 9,000 child abuse photos were taken that were discovered in a raid in Holland in the 1990s (the 'Zandvoort stash').<sup>157</sup>
- The child abuse enquiry has produced over 40 suspects.
- The local authorities failed to charge a couple accused of beating their foster children with cricket bats.
- Disgraced headmaster Colin Tilbrook was in charge in the 1960s who died in 1988. His foster daughter, Tina Blee aged 38, told how she was raped by him every week as a child. She added that he was more than capable of murder.
- A builder has given evidence that he was asked to dig two lime pits in the grounds. Lime pits are used to destroy bodies.
- In 2012, forensic examinations were made in a WWII bunker nearby which victims say was used for abusing children. No evidence is available.
- According to lawyer Alan Collins, Jimmy Savile seriously sexually assaulted a 10-year old boy in Haut de la Garenne.<sup>158</sup> Savile was named several times by victims but Jersey police say that they had only received one complaint linking Savile to abuse there. They deny that there is enough evidence to proceed.

### **Oxford and Cherwell Valley College**

The UK Column has published a series of articles exposing shocking physical and sexual abuse occurring here for many years. Despite being threatened by the college, they continued to expose multiple serious allegations.<sup>159</sup>

### **Eton College**

Eton was originally established as a school for poor children by King Henry VI. It provided free education for seventy poor boys. In time it gradually became the poshest independent boarding school ('public school') to send rich kids to.

Eton has a reputation for providing the ruling classes with fresh leaders. At this point in time Cameron's government has been repeatedly condemned for the high percentage of Old Etonians in positions of power. In fact all Cameron's closest aides are old schoolmates. Even a Secretary of State has criticised this situation.<sup>160</sup>

It is common knowledge that children are sexually abused at this school. Many famous people have admitted that they were abused there. However, only the occasional sacrificial lamb reaches a court.<sup>161</sup>

The BBC is also full of managers who came from Eton. Thus the rife child abuse at the BBC, that has been exposed by many witnesses,<sup>162</sup> is merely the product of what is considered normal behaviour at this school. The lifestyle that was perpetrated at Eton is continued in the establishment where school leavers end up.

At one point the police planned a raid on Eton school but this was halted by 'powerful interests'.<sup>163</sup>

## **A victim's story involving elite figures**

### **Andrew Ash**

Ash claims that he was taken from a government care home to drug-fuelled parties in Westminster where boys and girls as young as 13 were sexually abused. Ash has given the name of a female MP that abused him, when aged 13 in Parliament, to Scotland Yard. The Security Services have also become involved due to the nature of the allegations.

He claims that the paedophile ring involved David Smith, Savile's former chauffeur, who killed himself before standing trial for sex offences.

The parties had plenty of cocaine and speed as well as champagne. The female that abused him was drunk at the time and was goaded on by people around her.

The police have seized videos and photographs of an alleged sex party that may be connected to Ash's story. Ash also claims to have footage showing a senior male MP involved. He has now spoken out to the Press because no action was taken after being

interviewed for 70 hours by the Metropolitan Police. Interviews were conducted in Bridlington and London with police officers and national security members present. Dutch intelligence officers also attended one interview because Ash told about being trafficked to Amsterdam a number of times to be abused by paedophiles that included convicted child killer Sidney Cooke. Ash also identified a big-name celebrity.

Ash cannot understand why no action has been taken when video footage of abuse is in the possession of the police.<sup>164</sup>

## **Just one example of the suffering inflicted on children**

I could not bear to offer any more than this, but it is a typical account that is similar to many. There are stories around the world that are very similar, and many that are worse ('snuff films').

The Guardian revealed an international police hunt for two unidentified men that made the 'Bjorn Tape'. This showed their relentless sexual assault on a Dutch teenager who was hooded in front of the camera. Eventually, limp, he was strapped into a chair and attacked.

Dutch police traced Bjorn's accent to an area in Holland where they combed through files of child abuse and found him. He had contacted the authorities a year earlier to complain that a Dutch man had been drugging and raping him since he was three-years old; latterly with an Englishman. The Dutch man was tried but without evidence he was acquitted, He then sued Bjorn for making a malicious complaint. Bjorn then collapsed into mental illness and was taken to an orphanage.

The tape later proved that Bjorn was telling the truth but also confirmed the identity of the Englishman as John Peters, a former soldier, who was charged with sexually assaulting a 14-year old boy in Sutton Coldfield. He was later convicted in Denmark of a similar offence. However, Peters crossed the border and escaped justice. He is now believed to be in Asia where poor children are a magnet for paedophiles.

Poor Bjorn's entire life has been a traumatic tragedy that could not be more completely ruined. This is what paedophilia is about.

The Guardian, which conducted the biggest investigation into child abuse of any newspaper, estimated that there were over a million paedophiles in the UK in 1998, adding that many academic reports suggest a much higher figure.<sup>165</sup>

## **Child abuse and satanic rituals**

It is easy to find a number of reports that completely debunk satanic ritual abuse (SRA) of adults and children.<sup>166</sup> Indeed, I have no doubt that there have been claims about child sacrifice and such like that are fabricated for some purpose. Sadly I have to admit that certain gullible Christian groups have been responsible for poor judgment and foolish

reporting of things later proved to be false. Some of the testimony paperbacks by ‘converted’ witches did not help when statements were later proved to be false.

There also seem to be genuine cases where disturbed children have made up false claims about parental abuse, which were later dismissed and that professionals were fooled. But despite all these things, it is unwise to dismiss all the claims on the basis of a few false ones. What is necessary is an unbiased investigation into all the claims of SRA. What is needed is the truth followed by justice. Just as there are cases where social workers wrongly removed children from parents, there are proved cases where social workers failed to remove victims from abusers.<sup>167</sup>

### **Why SRA is hidden from view**

Each case of SRA involves a conspiracy (there is rarely only one perpetrator); thus, by its very nature, it becomes hard to prove victim’s stories.

- The activities of satanic abusers are secret and not easy to discover. They go to great lengths to keep their activities hidden. Remember that ‘occult’ means ‘hidden’.
- Cultists often plant disinformation into the minds of young abused children, such as wrong dates or wrong names, along with real experiences. This produces questionable testimony.
- When threatened with discovery, cultists destroy all the evidence; including murdering victims.
- The cultists include many people in positions of power, both locally and nationally. These are able to dismantle investigations, get good investigators sacked, or get enquiries shelved or whitewashed.

### **Satanic child abuse not a myth as claimed**

In 1994 a Conservative government report concluded that satanic abuse was a ‘myth’, in the wake of testimonies from children in Nottingham, Rochdale and Orkney. However, child protection agencies grew increasingly concerned that it was, actually, rife. In 2000 a specially commissioned government report stated that satanic abuse does take place in Britain.<sup>168</sup>

These experts affirm that child victims have actually suffered abuse in satanic rituals and that they are not suffering from ‘false memory syndrome’. Dr John Hale (director of the Portman Clinic) and psychotherapist Valerie Sinason studied the experiences of 50 children. This followed a police investigation into the sexual abuse of up to 4,000 children in care homes in Devon.

Ms Sinason went so far as to say that ‘*some children are born for the purpose of abuse and are not registered on birth certificates*’.<sup>169</sup> She added that many of the 126 ritual survivors she has treated were tortured.

The report was welcomed by Dr Joan Coleman, a Surrey psychiatrist who has spent 14 years treating victims. She said, ‘*A lot of children are born into satanic families who indulge in this ritual abuse*’.<sup>170</sup>

Lee Moore, a barrister who founded the Association of Child Abuse Lawyers, (himself a child abuse victim) explained that it was hard to persuade victims to give evidence, especially after the 1994 report. This is why convictions, and thus confirmed evidence, are difficult.

### **Evidence for ritual abuse**

Despite the massive efforts of the establishment to cover up ritual child abuse (such as the Tory 1994 report), the facts keep returning to haunt abusers. These include:

- The testimony of child victims.
- The physical evidence on the bodies of children.
- The testimony of adult victims who were ritually abused as a child.
- The repeated discovery of mutilated bodies that show signs of satanic abuse.
- The discovery of mass graves in the grounds of children's establishments where ritual abuse was claimed to occur.
- The discovery of partial remains buried in children's establishments suggesting foul play.
- The testimony of doctors and therapists who have studied the problem.
- The capturing of videos that demonstrate actual ritual abuse of children.
- The occasional testimony of an abuser.
- The testimony of whistleblowers.

There is more than enough evidence to demonstrate that ritual abuse is going on in Britain. The evidence discovered in other countries (such as America, Canada, Australia, Holland and Belgium) is even more persuasive. The question is not does it happen, but rather how widespread is it? Some chilling testimonies suggest that it is actually pervasive amongst high-level figures in society and in Freemasonry circles.

### **Example: Savile**

One example is that of Savile in 1975 who abused a terrified victim in a candlelit basement where he chanted 'Hail Satan' in Latin as other robed devil worshippers joined in and assaulted a girl at Stoke Mandeville hospital.<sup>171</sup> The victim was one of the girls who testified to Valerie Sinason, who first told the story in 1992.

Five years later (1980) Savile abused a second victim during another black mass ceremony held at a house in a wealthy London street. The victim was forced to participate in an orgy after the ceremony. She was also a patient of Sinason who told her story in 1993.

These victims did not know each other and lived in different parts of the country. Both victims had reported the events to the police, who took no action. Sinason passed the information on to Operation Yewtree.

### **Example: the Kidwelly cult**

In 2011 four people from Kidwelly, Camarthenshire were convicted of serious sex offences which were accompanied by satanic rituals.<sup>172</sup> The leader of the cult was Colin Batley who exercised complete control over his followers. These people abused children for over ten years, despite the social services being warned, who took no action. Victims were threatened with death if they spoke out and two of them gave birth as a result of abuse. Batley's house was dressed up with paraphernalia to form a satanic altar, with draped

cloth, candles, tanks of snakes and satanic objects and symbols, in which to conduct black masses. The members of the cult wore robes with hoods and upside-down crucifixes.

Some argue that Batley and Savile used this paraphernalia merely to terrify their victims and suggest that they were not genuine Satan worshippers. But this does not matter, we cannot enter into the mind of these criminals; that fact is that they performed these rituals as they abused kids.

### **Example: Ian Watkins**

Watkins was the 'Lost Prophets' singer who pleaded guilty in 2013 to 13 offences at Cardiff Crown Court, including attempting to rape an 11-month old baby.<sup>173</sup> He was sentenced to a 29-year term. His crimes went back as far as 2004. One criminologist, Mark Williams-Thomas, stated that Watkins was on a par with Fred and Rose West. A colleague of Watkins later testified to Watkins's depravity that included Satanism.

While we cannot say that Watkins was really a Satanist, what is certain is that his paedophile fantasies bordered on the occult and his fans certainly offered themselves up to him to be used in satanic rituals, knowing his proclivities.<sup>174</sup>

### **Example: Kincora**

As well as the abuse which occurred on site (see earlier), children from the home would be taken to castles and other homes of the rich or aristocracy. Some of these were connected to the Irish branch of the Hellfire Club, a satanic network that was set up in the 1700s by British politician Francis Dashwood, and aristocrat friends, plus Benjamin Franklin. The Hellfire Club certainly promoted meetings that included satanic rituals. The investigation by the police into child abuse at Kincora did not include these elite figures or look into abuse occurring outside the boys home.

### **Example: Fred and Rose West**

Everyone is well aware of the serial killer Fred West and his accomplice wife, yet fewer are aware of the cover up involved.

The allegation is that Fred West was a procurer of victims for a Gloucestershire witchcraft coven and that the deaths show signs of witchcraft. What are the facts?

The autopsy reports of the murder victims show clear signs of ritual killing. There were digits and other bones missing from the skeletons, which were found under and around the West's home. For instance: one victim had 63 finger and toe bones missing; another had 42; another had 58 etc. etc.

Witches remove the fingers and hands of victims of sacrifice and bury them close to the body for the purpose of enchantments. The hand of an executed person was greatly coveted by devotees of witchcraft. Professor Margaret Murray (a leading Egyptologist and authority on witchcraft) affirmed that there was no doubt that witchcraft was involved.

The Wests had a bar built in their home in Cromwell Street to service Rose's clients of prostitution, which was called 'The Black Magic Bar'.

After his arrest, West was concerned, not about the police investigation but of shadowy figures outside the enquiry. It is alleged that West told one journalist that he was covering for others. He said that information of them would come out in the end, but he was scared to say anything. Whilst in prison he was found hanged. This is despite being in a cell where this was supposed to be impossible and whilst on suicide watch.

West's brother, John, was also arrested and charged with multiple rape and was due to appear in court when he was also found hanged ten months after Fred's death. Does anyone smell a rat?

Thus the Fred and John West cases never came to court.

Experts, such as Jim Cairns,<sup>175</sup> and authors who have looked into the case, claim that the Wests were devil-worshippers and their victims were human sacrifices. Cairns previously uncovered a satanic sect operating in Kilkenny which he claimed was responsible for the disappearances of a number of people. Cairns said, '*Myself and others believe that there is a definite occult or satanic connection to the West murders. The murders reek of human sacrifice with powerful connections*'. Ivor Edwards (who has published a book explaining the black magic rituals of Jack the Ripper) is also writing a book about the Wests claiming that they supplied a Gloucestershire coven with human sacrifices.

Fred West's official biography by Geoffrey Wansell ('An Evil Love') also included a passage that mentioned Rose's fascination with black magic.

There is far too much evidence here for the cover up of something even more sinister than the torture, sexual abuse and killing of 12 innocent victims. There are clear signs of ritual killing and circumstantial evidence of involvement in the occult. To this must be added the convenient 'self' murder of two prime suspects before they could talk in court.

### Testimonies

One difficulty, in this general paper, is detailing accounts of satanic abuse, as they are far too graphic and disturbing for my readers. This paper is not the place to do that. The accounts are like something out of a Hollywood horror film; sometimes even worse. Amongst the less disturbing stories is that of a young girl sealed inside the cavity of a disembowelled animal and then 're-birthed' by her cultic captors during a ceremony. There are several stories of infant sacrifices involving cannibalism by cult members. There are also many stories of torturing and programming children (such as using electric shock) in order to produce certain characteristics, such as animal personalities.<sup>176</sup>

Therapists in America state that over 200,000 survivors of SRA have reported such crimes to their counsellors, with many stories corroborating each other despite no connection between victims.<sup>177</sup>

Just one example is the terrible abuse and satanic torture suffered by a girl, now a middle aged woman, in the Netherlands. She is a therapist called Toos Nijenhuis who names a pope, a cardinal and royals as some of her abusers, as well as Freemason relatives. She also states that abuse took place not only in Holland but also in Canaervon Castle in Wales and

near Fort William in Scotland perpetrated by high-level Freemasons.<sup>178</sup> Again the crimes perpetrated on her are too awful to recount here but this very credible witness deserves to be heard.

### **Why are there multiple accounts of SRA today?**

There are a number of reasons.

- It is a reflection of the increasing sinfulness of man worldwide at the end that was predicted by the Lord Jesus and his apostles. Human wickedness and degeneration increases exponentially as we approach the end of the age. The end is a time of increasing Satanism, both objectively and subjectively.
- Old-fashioned Christian values and moral conscience have crumbled, allowing ‘anything goes’.
- With the increasing permissiveness of society, that began in the 1950s and 60s, the occult became more and more acceptable. Witchcraft became fashionable, instead of a crime, and pure black magic Satanism became more widespread. Today you can readily purchase black magic paraphernalia and books openly on the Internet. Before the web, such things were extremely difficult to locate.
- The power of celebrities to boost interest in the occult; whether rock bands, authors, actors, filmmakers etc.
- Family disorganisation: as society has changed and families have dispersed and broken up, so there are more opportunities for abusers. Divorce and separation rates have skyrocketed in the last 70 years. Single-parent families and co-habitation have proliferated. Both parents are out working all hours so that children are left without supervision. Pressure on families led to serious dysfunction; producing neglect, abuse, incest, custody disputes, child abandonment and many kids being forced into care.
- Mental health diffusion: in the last 60 years mental health practice has been fragmented to an unusual degree. In the past it was the province of accredited medical doctors; today there are hordes of people dealing with specific issues and a massive rise of counselling types and practitioners. There was a shift from intervention to reaction as well as a wide diversity of belief and practice. Much of this has been unhelpful, but it has highlighted case histories.
- Activist opposition to abuse: in the last 50 years there has been a rise of women’s rights activism, opposition to pornography and exploitation of women, activists against child abuse and so on. These have led to more information being made public about abuses.

### **Interim conclusion**

One expert<sup>179</sup> avers that there are between 500 and 1,000 cults operating in the UK and that it is a growing phenomenon. I think that such figures are a gross underestimate; Brighton alone has dozens of covens, cults and sects. Even in the 1970s there were over a dozen operating witchcraft covens in Brighton before the rise of New Age witchcraft. Even a sleepy retirement town like Worthing has its own public witchcraft shop on the high street. Cults are found everywhere, in rural as well as urban areas.

When evidence of ritual abuse arises, why is it soon covered-up; as in the case of Haut de la Garenne? Why were accusations about Savile’s SRA ignored? Why is the testimony of hundreds of SRA victims not developed into prosecutions? Ritual abuse is pervasive enough today to warrant its own dedicated protection and advice services, such as ‘Ritual

Abuse Network Scotland'. We cannot avoid the conclusion that there is secret ritual abuse of children going on in this country.

What is interesting is that all the arguments used to deny the existence of SRA were used of Jimmy Savile. There were no shortages of allegations made against his child abuse from 1958 onwards and his proclivities were well known in his hometown early on. Yet no prosecutions emerged. Over and over again those that came forward were treated as disturbed personalities (who wouldn't be?) whose testimony could not be trusted. The memories were blamed upon imagination and personality disorders. But they were true. It is only now as hundreds of credible cases confirm one another that it is clear that Savile was indeed a monster who preyed on hundreds, perhaps thousands, of women, boys and girls. In the same way, the allegations of SRA are denounced today. But if only 1% were true, we still have huge numbers of victims who have no justice, and powerful perpetrators that escape condemnation.

## **The scale of sexual child abuse**

One measure of the extent of paedophile activity is to note the number of police operations dedicated towards it. But first one must realise that it can take many years before an operation even begins, and once begun the investigation is often very limited, despite there being evidence of a wider conspiracy. For instance the operation into Jimmy Savile (Yewtree) took 60 years to begin. The operations into the North Wales abuse were restricted and limited, despite hundreds of allegations.

What this means in practice is that the occurrences of child abuse will be hundreds of times greater than the number of operations. Yet the number of police investigations going on is staggering. Here is a list.

Note: this is not a full list because certain police forces have refused to assist researchers. These include: Cheshire Constabulary, Dorset Police, Durham Constabulary, Gwent Police, Hampshire Constabulary, Lincolnshire Police, Northumbria Police, Nottinghamshire Police, Staffordshire Police, Surrey Police, Sussex Police. Also the Metropolitan Police refuse to admit more than the three operations listed below but other sources have confirmed that there are more. The information below is up to September 2013.

Considering that each operation can be investigating allegations against between one and several hundred people, this list ought to cause readers to have serious concerns about the picture it portrays.

## **Why do paedophiles commit such terrible crimes?**

**Suggestion 1: personal wickedness**

The obvious answer is the inner corruption and iniquity of the criminal. Some men (and a few women) can only find sexual satisfaction by abusing a pre-adolescent child. Whatever the arguments about psychology, this is an act of gross wickedness which deserves punishment.

The sorts of iniquity involved vary. There is the homosexual desire to abuse a same-sex child. There is the heterosexual desire to sexually abuse a child. There is just plain cruelty; the desire to inflict harm on people you can easily overpower. There are those that 'love' the child they abuse (or rather, love sex with the child) and there are those who hate children and abuse them for that reason.

**Suggestion 2: spiritual empowerment**

Some suggest that there is a sort of New Age occult spirituality at work; that abusers seek to drain the life force from an energetic child. The problem is that this, of course, is mere nonsense. No one can drain energy from anyone else. If people do it for this reason they are suffering from great delusions as well as committing gross wickedness.

### **Suggestion 3: Satanism**

Others have alleged, and there is evidence to support his, that some of the cases are ritual abuses that can even lead to ritual torture and ritual killing. Some of the people involved may not even be homosexuals and yet are willing to engage in a ritual that involves sex with a young boy.

It is commonly reported that satanic cults often demand acts of paedophilia and abuse as necessary rights of passage for new members or promoted members. In extreme cases certain rituals involve child sacrifices.

### **Suggestion 4: Demon expulsion**

Certain religious groups, particularly Black African Pentecostal cults, emphasise the need to rid society of perceived witches and children that possess evil spirits. In Africa there are repeated attempts to burn people suspected of being witches in local villages without any sort of trial. In the same way children are tortured and attacked if they are suspected of harbouring a demon. Triggers for this can range from epilepsy to just being naughty.

This travesty has infected Pentecostal groups in London where Black African Pentecostal denominations are prolific. From time to time the abuse and death of an infant make the headlines, where the cause was a perceived demon. In some cases the abusers are parents who have been deluded by foolish teachings about demonology.

One such piece was by The Guardian in 2012.<sup>180</sup> It gives the example of 15-year old Kristy Bamu who was mutilated, teeth were missing and he was covered in cuts inflicted by a man he called uncle and one of his own sisters, who were convinced he was a witch possessed by evil spirits. He was also starved, sleep deprived, punched and kicked repeatedly; his teeth were knocked out with a hammer, floor tiles and bottles were smashed on his head and his ear twisted with pliers. The pair were convicted of murder and also abusing Kristy's sisters.

Debbie Ariyo, executive director of Africans Unite Against Child Abuse warned that the boom in Pentecostal churches<sup>181</sup> was leading to more children being accused of witchcraft. Another famous example is the Victoria Climbié case. However, the 83 incidents in the last decade are claimed to only scratch the surface of the real scope of the problem. Police deal with an average of 8 cases a year in London, but this only reflects cases where the police have got involved.

## **Why paedophiles are protected**

*The fact that the sexual abuse of children is so hidden is not entirely the result of the age of its victims. This is also a crime of conspiracy, of the abuse of power and, from time to time, of incidents which suggest that a paedophile with prestige may be more likely to escape justice than a more humble offender.<sup>182</sup>*

One of the greatest hindrances to justice is that many in the ruling class, or their cohorts (the police, judges etc.) are members of various secret societies or cultic bodies that affirm

a greater loyalty to that body than to the justice system. In other words they can lie without conscience to protect brothers. Some examples follow.

### **Talmudic Jews**

Modern Judaism is the product of the Talmud,<sup>183</sup> not the Torah.<sup>184</sup> The most authoritative scriptures for modern Jews are the words of the Babylonian Talmud. This is confirmed by the Jewish Encyclopaedia and other sources.<sup>185</sup>

The Talmud openly supports paedophilia. It was rampant amongst Pharisaic Jews (who wrote the Talmud) and is endorsed by them. See these quotes from the Talmud [London, The Soncino Press (1939)].

*A maiden aged three years and a day may be acquired in marriage by coition, and if her deceased husband's brother cohabits with her, she becomes his. [Sanhedrin 55b.]*

*Pederasty with a child below nine years of age is not deemed as pederasty with a child above that. [Sanhedrin 54b]*

*When a grown up man has intercourse with a little girl it is nothing, for when the girl is less than this – that is, less than three-years-old – it is as if one puts the finger into the eye – tears come to the eye again and again, so does the virginity come back to the little girl under three years. [Kethuboth, 11b]*

More importantly, the Talmud has a vow, which when confessed, allows a Jew to openly tell lies without losing righteousness. Indeed, one can deny all the Ten Commandments and still be a faithful Jew. It is a 'get out of jail free card'. Thus it is impossible to trust any Jew that follows the Talmud. They can lie in court and still be righteous if they have confessed this ritual.<sup>186</sup>

Jewish people dominate the entertainment and media industries and it is alleged that these industries are riddled with paedophiles. Indeed, most of the recent criminal cases have been of entertainers or people connected with the media. Detective Chief Inspector Paul Settle (of the Paedophile Unit) said, '*Child abuse has become an industry standard in the entertainment industry*'.<sup>187</sup> Jews also dominate the halls of power. Many MPs, cabinet ministers, judges, lawyers, senior civil servants, leaders of commerce, and bankers are Jews. This is not a racist statement it is just a plain fact.

A number of the powerful people mentioned in this paper with allegations to answer are Jews but I have avoided specifically stating anyone's ethnicity.

**REASON 1: JEWS ARE ALLOWED BY THEIR RELIGION TO BE PAEDOPHILES AND THEY ARE ALSO ALLOWED TO TELL LIES TO OTHERS WITHOUT CONDEMNATION.**

## Homosexuals

It is no secret that many paedophiles are homosexual men. This is not to tar all Gay men, but it is certain that many paedophiles are homosexual.

Homosexuals have begun to dominate certain strata of society since the repeal of laws against them in the 60s. Indeed, there was a concerted effort to do this by Gay Rights activists, with a particular focus upon the media and entertainment industry. Thus we can see a large number of Gay managers, performers and presenters within the BBC, for example. Sometimes this centring on Gay people is over the top. For instance, until recently, Radio 2's four Saturday daytime programmes were dominated by three gay presenters, followed by another one on Sunday.

There is the danger that the loyalty of homosexual men to each other sharing a cause, will cover-up cases of child abuse that may arise. There are allegations that this was the case in the BBC. If, in addition, you have powerful Gay people in government and high office at the same time, the risk of cover-up is even greater. This is alleged to have been the case during the government of New Labour, particularly regarding the Islington – Jersey scandals.

**REASON 2: CLAIMS OF CONSPIRACY BY HOMOSEXUAL MEN IN PRIVILEGED POSITIONS TO COVER UP PAEDOPHILE ACCUSATIONS.**

## Freemasons

The key problems of this group are a) they protect their own above all others; b) they are endemic (a prevalent disease) in higher ranks of society.

Every Freemason is initiated by taking a blood-curdling oath whereby he swears that he would rather have his entrails ripped out rather than betray a fellow freemason.<sup>188</sup> This means that all masons will do anything to protect a fellow rather than obey a court of law. Thus Masons will commit perjury in order to give another Mason an alibi rather than tell the truth. Anything is allowed (lying, perjury, slander etc.) in order to protect a brother.

The problem is that Freemasons are so prevalent in the establishment. It is well known that they pervade the royals, the aristocracy, Westminster, the police force, bankers, the judiciary, town and borough councillors and magistrates, as well as many professions.

### *A personal testimony*

For twenty years I worked in the Post Office; latterly (after the corporate split) in Royal Mail. After working through the ranks I became a senior manager in HQ. While working as a clerk in Brighton I became personally aware of the depth of involvement of Freemasons.

Personal friends and colleagues in the office were Masons and I was invited to become one, which I refused. Because some of my colleagues were senior Masons, Masonic business was often discussed or conducted in the office openly.

One of my colleagues at that time (early-mid 80s) was a man who was also the Lord Mayor and a previous Labour MP (Dennis Hobden; the first Labour MP on the South Coast). He

worked a few mornings in the office and then the rest of the time in the mayor's office. As well as being a spiritualist, Dennis was also the Grand Master of the local Freemason Hall. Indeed, he arranged that we could have the office Christmas lunch there for several years, which boasted a top chef. Note: the Lord Mayor of Brighton was then a senior Freemason and a spiritualist.

However, virtually all the union reps were Freemasons. Of these several were Justices of the Peace (magistrates) and one told me that all the magistrates were Masons. Most of the Post Office managers were also Masons and I was told that promotion would be difficult for me unless I became a Mason. [To become a higher manager I had to leave Brighton to get opportunities in London HQ.] Also a very senior manager told me that I was a problem to higher management because I wouldn't tell lies.

As an example of the power of Freemasons, I once worked as a TV licence enquiry officer (sub-contracted to the Post Office then). I nicked a senior public figure, who then was the landlord of Brighton's biggest public house. He had a flat above the premises and had no TV licence. I processed the paperwork and was told by my boss that the case would not go through. I asked why and he said nothing. The next thing I heard was that the Head Postmaster of Brighton had stopped the case going to court. It was fine to prosecute poor people, single parent families, and old ladies, but not a senior public figure. Lord Selwyn Jones also had case papers in the office that never went further.

### *Freemasonry and Satanism*

Freemasonry is ultimately a form of Satanism, though this is hidden from less than 3<sup>rd</sup> degree Masons; it is also linked to the Jewish Kabbalah. Freemasonry recognises the value of the Kabbalah and its writers note the Babylonian influence of oriental divination, mystical interpretation and symbolism in it. Indeed it was the foundation of Freemasonry, '*all the Masonic associations owe to it their secrets and their symbols*'.<sup>189</sup> Senior freemasons declare that the god of the Kabbalists and Freemasonry is Lucifer.<sup>190</sup>

### *Freemasonry is witchcraft*

- The rituals of Freemasonry are almost identical to many rituals of Wicca.<sup>191</sup>
- Many Freemasons were also witches or magicians. For example, the infamous Satanist Aleister Crowley<sup>192</sup> was a 33<sup>rd</sup> degree Mason as was the founder of Wicca, Gerald Gardner. Others include: A E Waite (occult writer), Alex Sanders ('King of the Witches'), Annie Besant (Leader of Theosophy), Dr Wynn Westcott and SL MacGregor Mathers (founders of the Golden Dawn, an influential magic society<sup>193</sup>), George Pickinohill (Grand Master witch of 19thc. England) and many more.
- Anton LaVey (high priest of the Church of Satan) says, '*Virtually every occult order has many Masonic roots*'.<sup>194</sup>

- CW Leadbetter was a 33<sup>rd</sup> degree Mason and leader in Theosophy with Annie Besant. He wrote showing that initiation into the different degrees brings with it demonic invasion. He even names and describes the demons at each level.<sup>195</sup>
- Albert Pike explains that the light in Freemasonry is the Cabala (Jewish occult mysticism);<sup>196</sup> and Lucifer.<sup>197</sup> Hall claimed that much of Pike's writings were taken from the French magician, Eliphas Levi.<sup>198</sup> Foster Bailey declared that '*Masonry in its true and highest sense is magical work.*'<sup>199</sup>
- Pike extolled the power and virtues of magic and Satanism. In talking about this power he says, '*It was adored in the secret rites of the [witch's] Sabbat or the [Egyptian] Temple, under the hieroglyphic figure of Baphomet or the hermaphroditic goat of Mendes.*'<sup>200</sup> Pike speaks much of '*the great work*', which is a universal term for witchcraft, as well as alchemy and Egyptian magic. He says, '*The Occult science of the Ancient Magi was concealed ... it is found ... in the Rites of the Highest Masonry.*'<sup>201</sup>
- Masonry has taken on board many occult symbols: the pentagram, the Baphomet, the pyramid, the 'symbol of Solomon' (Davidic star) etc. For instance, the emblem of the Eastern Star lodge is the inverted five pointed star; this is the pentagram (or 'pentacle', sometimes pictured within a circle); also note the symbol of the goat of Mendes, the geometric symbol of the demon Baphomet (a form of Satan). This demon is also pictured by Manly P Hall in his book *Dark Secrets of All Ages*.
- The heart of Masonry is communication with demons pretending to be angels of light: '*The Master Mason ... is in communication with the unseen powers that move the destinies of life.*'<sup>202</sup> J F Newton eulogised the Masonic writer Arthur Edward Waite and commended his books. Waite wrote many books on Black Magic and in one gives instructions for conjuring up '*Emperor Lucifer, master and prince of rebellious spirits.*'<sup>203</sup>

This is significant for our purposes here since Satanism lies at the back of many paedophile practices.

#### *Powerful historic people who were Freemasons*

- Benjamin Franklin.
- His Royal Highness Augustus Frederick, Duke of Sussex became Grand Master of the Premier Grand Lodge in 1813.
- His Royal Highness Edward, Duke of Kent, became Grand Master of the Antients Grand Lodge in 1813.
- Britain's Grand Master was Prince Michael of Kent (33<sup>rd</sup> degree).
- Aleister Crowley.

In his book, *The Brotherhood*, Stephen Knight tells of a meeting with a judge and a very senior civil servant who agreed to give information on the secrets of the UK Masons. There

are more than half a million brethren under the jurisdiction of the Grand Lodge. If only 5% abuse their privileges for corrupt ends, there are 25,000 powerful people corrupting the social institutions of the UK. The civil servant stated that more than 12% were abusing the craft, which was originally run by good men, devoted to altruism and social stability.

A number of people named in this paper are Freemasons and it is suspected that many others are as well.

**REASON 3: THERE IS EVIDENCE THAT MANY PAEDOPHILES ARE MASONS. SINCE FREEMASONS ARE COMMITTED TO PROTECTING EACH OTHER, AND SINCE THEY PERVADE THE RULING ESTABLISHMENT, IT GOES WITHOUT SAYING THAT EVEN IF MASONS COME TO COURT ON CHARGES OF PAEDOPHILIA, THEY WILL GET OFF. IN MOST CASES THE ESTABLISHMENT CURTAILS THEIR CASE BEFORE ANY CHARGES ARE MADE. FREEMASONRY IS CONNECTED TO JUDAISM THROUGH THE KABBALAH AND IS ROOTED IN SATANISM.**

### **Roman Catholic priests**

Little needs to be said in this connection because so many cases of paedophile priests have come into public light. It appears that there is likely to be thousands of cases worldwide involving priests. Indeed, the Catholic Church has been repeatedly criticised for covering up the level of child abuse at a senior level.

An evaluation of the breadth of paedophile priests would require a separate paper.

**REASON 4: DUE TO CATHOLIC PRIESTS SUPPOSEDLY HOLDING THE POWER TO ADMIT OR WITHHOLD SALAVTION FROM YOUNG PEOPLE, SUCH FOLK WOULD BE SCARED TO DEATH OF BRINGING ANY CHARGES AGAINST A PRIEST. IT HAS TAKEN THE GREAT COURAGE OF ABUSED PEOPLE THAT HAVE NOW GROWN OLD TO FINALLY BLOW THE GAFFE ON WHAT MUST HAVE BEEN GOING ON FOR CENTURIES.**

### **The paedophiles that occupy places of high power**

As identified in this paper, many people in the ruling classes are paedophiles. This means that they have the power and authority to go to any lengths to stop their deeds becoming public knowledge and to protect their own. These methods include, manipulating the justice system, controlling the police, censoring the media, threatening victims, beating up victims threatening to go public and murdering victims that are considered too risky.

**REASON 5: MANY PAEDOPHILES ARE SO POWERFUL IN SOCIETY, OR HAVE PWOERFIL FRIENDS, THAT THEY CAN EASILY MANIPULATE THE JUSTICE SYSTEM AND THE PRESS.**

### **The closure of police investigations**

Whistle-blowers to activist groups, such as The UK Column, have reported that individual investigations of serious child abuse by good policemen have been closed down by senior officers and locked away in safes. This paper has demonstrated many cases of alleged corruption by police.

**REASON 6: POLICE CORRUPTION AT SENIOR LEVELS.**

## Common Facts arising

Institutions where child abuse was rife continued for decades abusing kids despite the repeated allegations of victims and some staff.

Brave, resourceful, caring individuals crusading to get justice for the abused children are hampered at every turn by powerful ruling elite bodies.

Whistleblowers that demonstrated child abuse got sacked afterwards. Even a cabinet member in Jersey got fired and jailed for exposing paedophilia at high levels.

Many councils are implicated in the guilt of paedophiles and have protected them at every turn. There is a national scandal in the covering up of child abuse by councils (e.g. Sunderland or North Wales).

High levels of the police force are allegedly directly implicated in the guilt of paedophile rings and have covered up credible allegations of abuse by victims over and over again. Allegations against senior public figures or people connected to the police in some way (e.g. Cyril Smith, Savile or via Freemasonry) have been dropped and ignored on multiple occasions.

Certain judges have given extremely lenient sentences to paedophiles. Indeed, many are acquitted or receive suspended sentences. Some judges have acquitted known offenders despite hard evidence.

The CPS has frequently not pursued a case despite hard evidence. In some cases the offender has struck again and subsequently been convicted.

Independent researchers into high-level child abuse routinely get smeared, intimidated by officials or even jailed.

## Some people with questions to answer

### **Margaret Hodge**

When council leader at Islington, why did she allegedly protect paedophiles named by reporters? Why did she denounce an award-winning journalist<sup>204</sup> (winning the award for this story) as '*right-wing gutter press*' who bribed children to lie, when a government enquiry proved the story was true? Did she know about the suppression of documents by the Asst. Director of social services, Lyn Cusack, outed by the White Enquiry for losing files?

### **David Cameron**

Accused by Ben Fellows as leading a conspiracy to cover up the 'Cash for questions' scandal, which also protected Ken Clarke. Why has he not sued Fellows?

### **Ken Clarke**

Accused by Ben Fellows for sexual abuse of a minor. Why has he not sued fellows? Why did the police threaten Fellows? Why did the police say the Clarke was 'above the law'?

**Deputy Chief Constable David Warcup**

Why was Lenny Harper misrepresented, as claimed by Harper in the Press? Why were both Harper and Power discredited when they had the support of their team, professional bodies and the internal investigation exonerated them? Why was the multiple evidence of potential violent abuse, torture and possibly murder not investigated further? Who applied pressure to you?

**The Director General of the BBC**

Since there have been multiple allegations of a paedophile ring operating in the BBC for many years, and since the actions of Savile and others were common knowledge, why are you denying that the BBC was an alleged home for paedophiles? What has been done to stop the alleged common practice of assaulting hopeful actors by casting agents and producers in the BBC?

**Leader of Sunderland Council**

When are you going to come clean and admit the details of widespread child abuse in care homes which the council allegedly covered up?

**Leaders of the councils at Clwyd and Gwynedd**

When are you going to apologise publicly for the way you treated Alison Taylor and allegedly covering up multiple child abuse for kids in your care?

**Sir Ronald Waterhouse QC**

Why were the names of public figures, who were accused of child abuse, eliminated from your enquiry by the police?

**Attorney General Sates of Jersey**

Why did you allegedly cover up child abuse and murder at Haut de la Garenne? Why did you allegedly smear Lenny Harper and arrange a whitewash new police enquiry? How many paedophiles are you allegedly protecting in Jersey?

**Chief Constable of North Wales 1994**

Why did you refuse to co-operate with the Jillings Enquiry? Why did you refuse to share data and witness statements with the Jillings Enquiry?

**The director of Special Branch**

Why did you cover up the evidence gathered on Cyril Smith's child abuse?

**Chief Constable of the Metropolitan police in 1982**

When a party in Elm Guest House was raided in 1982, which led to the conviction of Kasir for running a disorderly house, why was the evidence given by victims of child abuse by prominent people not pursued?

**Head of Special Branch in the early 1980s**

Why did you do nothing with the evidence collected into child abuse by senior figures at Elm Guest House? What happened to Kasir's logbooks, names, times, dates and pictures of visitors?

**Det. Chief Spt. Hamish Campbell**

When temporarily put in charge of 'Yewtree'; why did the imminent arrest of a former cabinet minister suddenly stop?

## The police in general

Why were the hundreds of sex abuse allegations against Jimmy Savile, going back to the 1950s, covered-up?

## Note

There are many websites out there which name all sorts of people as being paedophiles, torturers and murderers of children; this includes three prime ministers and many royals. More than one website claims to know who ordered the kidnapping of Madeleine McCann and who the European politician was who abused her and ordered her murder in Morocco. Many of the pieces of testimony appear to be credible but often do not give source data that can be used to sustain proof. So, while I am personally convinced of a number of these claims, I cannot include them in this paper due to insufficient evidence. This is usually because the evidence has been covered up. What is certain is that various police forces have files on some of these people that are being kept hidden away.

A key part of the evidence in child abuse cases is in video format and some of these are more convincing than others. It is impossible to rule out the fact that some supposed witnesses are just fantasists or liars. However, many videos are clearly very credible indeed; especially when witnesses appear to be suffering emotional pain just trying to tell their story. Only the best actors in the world could fake this; these people are telling the truth. Just one example is the terrible abuse and satanic torture suffered by the aforementioned therapist Toos Nijenhuis<sup>205</sup> who is a thoroughly reliable witness.

## Timeline of UK recent child abuse

This list will focus primarily on British facts, though there could be similar lists given for America, Australia, Europe and many other countries. The evil of child abuse is not restricted to the UK. I will occasionally add information on a certain foreign country if it has direct links to UK cases. This is just select data and not a fully comprehensive survey.

Child Abuse in the UK <sup>206</sup>	
1950s-1960s	Claims of Nazi style abuse of children in Northern Ireland children's care homes. The Sisters of Nazareth order of nuns who oversaw St Joseph's Home in Termonbacca (Londonderry) bathed the children in Jeyes fluid (toilet detergent). Some children were forced to eat their own vomit. Homes were said to be like concentration camps.
1955	Earliest recorded instance of child abuse by Jimmy Savile in a dance hall in Manchester.
Late 1950s	Savile was suspected of working for MI5; visited Moscow.
1961	Tory Monday Club founded by Ian Greig, Paul Bristol, Cedric Gunner and Anthony Maclaren.
1961	Names that appear as visitors to Elm Guest House include: Harvey Proctor, John Rowe, Peter Campbell, Richard Miles, Peter Glencross, Charles Irving and Stan Matthews.
1963-1968	Abuse at Kincora boys home. Claimed to be a boy brothel run by MI5.
1963	Male victim claims Savile raped him in Chesire but is told by the police to 'forget about it'.
1963	Lord Boothby introduced to the Kray twins, who allegedly supplied boys to the elite.
1964	Police intelligence files link Savile to notorious paedophile ring. Police ledger mentions premises in Battersea Bridge Road where two men were prosecuted for living off immoral earnings. Girls from Duncroft School were visiting as well as Savile.
1964	William Combes claims that he witnessed the abduction of ten fellow residential school children by the Queen and Prince Philip in October. They were never seen again. [UK Column: children's issues/time abuse timeline.]
1965-1988	Savile is a volunteer porter and fundraiser at Stoke Mandeville hospital. He had his own room there and claims of

1965	Greystone Heath approved school for boys in Warrington being used by a paedophile ring.
1966	Lord Mountbatten introduces Savile to Prince Philip.
1966	Savile awarded honorary green beret by the Royal Marines.
1967	Prince Edward begins service as Grand Master of the United Grand Lodge of England, the governing body of Freemasons in England and Wales.
1967	Guy Marsden (Savile's nephew) aged 13 is taken to celebrity houses in London where men sexually abused girls and boys as young as 10 with Savile present.
1967	Decriminalisation of Sexual Offences Act – allows homosexual acts in private over 21-years old.
1969	Savile visits Jersey.
1969	Warwick Spinks is caught on camera offering to supply a video in which a 10-year old boy was killed and one featuring the horrific abuse of a young boy.
Early 1970s	Soldier John Peters (participant in the Bjorn tape) goes AWOL after being charged with having sex with a 14-year old boy. Goes to Denmark where he is later convicted of a separate offence of child abuse.
Early 1970s	Snuff films begin to appear; name derived from Charles Manson.
1970s-80s	Child abuse rampant in Islington Care Homes under the watch of Margaret Hodge. Abuse in childrens' homes becomes a national epidemic.
1970s	Savile becomes a regular visitor to Haut de la Garenne in Jersey. Though he denied this during the enquiry, photographs show him there posing with children. He was named by several victims. Abuses 14-year old girl in Jersey (Dee Coles) and her friend in a campervan.
1970	The Spartacus International Gay Pride Guide is published. It lists child brothels worldwide.
1970	First recorded abuse by Savile at Duncroft school in Surrey.
1970	Edward Heath is a regular visitor to Jersey and becomes Prime Minister.
1970	December: photograph of Savile with Prince Charles.
1971	Claire McAlpine (a young dancer at the BBC) commits suicide at 15. Her diary names showbusiness personalities who raped her. All allegations were denied by the BBC and Savile.
1973	Michael Trestrail (linked to Elm Guest House) becomes the Queen's bodyguard.
1973-1982	Children from Grafton Close children's homes are abused at Elm Guest House by establishment figures.
1974-1990	Child abuse at a number of North Wales care homes. Thatcher's friend Sir Peter Morrison is reportedly involved.
Mid 1970s	PIE starts campaign to legalise sex with children over four. Supported by Harriet Harman and Pat Hewitt.
1974	Savile involved with Broadmoor; authorised by Health Minister David Owen.
1975	Prince Edward becomes president of the Scout Association.
1975	Savile reportedly beat and raped a girl at Stoke Mandeville as part of a satanic ritual with other adults in the basement. He is alleged to have chanted, 'Hail Satan' in Latin. The girl spoke out in 1992.
1975	Savile was a suspect in the Yorkshire Ripper murders and was questioned by West Yorkshire Police. The eventual convicted killer was a friend of Savile's.
1975	CGHE (Conservative Group for Homosexual Equality) formed by Prof. Peter Campbell which is affiliated to the Tory Party. Campbell named as visitor to Elm Guest House. Minutes from founding meeting show that the group was a paedophile organisation. Campbell was a long-time researcher to David Cameron and also helped other Tory PMs preparing PMQs.
1975	Norman Fowler MP raises concern in Parliament how Roger Gleaves could secure government and council funding for three charities and a hostel despite being a paedophile with a criminal record.
1976	Savile at Haut de la Garenne and sexually abuses 'John' aged 10. Two top police officers (Harper and Power) claim that the home was at the heart of a 'well-protected paedophile ring'.
1976	Savile in Belfast, site of Kincora Boys Home.
1976	Paul Kidd, a paedophile, is appointed as royal butler to the Queen. After six years he serves the Queen Mother until 1984.
1977	A victim aged 11 abused by Peter Righton and other members of PIE in London until aged 16. Other celebrities (including Cyril Smith) allegedly involved.
1977	Ripper victim number three – Roundhay murder of Irene Richardson, within yards from Savile's flat overlooking the park. Police view Savile as a suspect. David Wilson calls for an enquiry.
1978	Savile thrown off luxury cruise liner SS Canberra after an assault on a 14-year old girl.
1979-81	A 'Vincent' was abused at Elm Guest House aged 11, and also at a house in Sea Road, Bexhill.
1979	Nicholas Fairbairn (named as visitor at Elm Guest House) appointed Solicitor General for Scotland, the second most senior law officer.
Late 70s	Savile forms relationship with Prince Charles.
1980s	Female MP sexually abuses Andrew Ash aged 13. He was brought from a government children's home to Parliament to be abused. The female was part of a paedophile ring in the heart of government that included Savile.
1980s	Peter Hatton-Bornshin was taken from Grafton Close children's home and forced to take part in drug-fuelled orgies at Elm Guest House which involved the elite. When he was older he was sent to Broadmoor mental hospital where he died in mysterious circumstances.

Early 1980s	Derek Laud becomes first black member of the Tory Monday Club.
1980	Savile abuses a victim during a black mass ceremony and orgy in a wealthy London street.
1980-87	Ian Harvey (former junior foreign minister) is president of CGHE.
1981	The Portuguese police accused the caretaker of a Casa Pia state-run children's home of raping dozens of children over 30 years. Later police dropped their investigation and officials destroyed the documents. In 2004 news reports appearing in the Jornal de Noticias claimed that Portuguese President Jorge Sampaio and Portugal's European Commissioner Antonio Vitorino had been mentioned in anonymous letters sent to magistrates investigating the Casa Pia child abuse scandal. The scandal has alleged connections to the Madeleine McCann case.
1981	Three senior care staff at Kincora Boys Home are jailed for abusing 11 boys.
1981	The boy Vishal Mehrotra goes missing within a few hundred yards of Elm Guest House. His body was found in 1982 in Sussex woodland. Martin Allen also disappeared near the site.
1981	October: king and queens party held at Elm Guest House. Many senior people come to abuse children. Carole Kasir took photos.
1982	John Rowe (MI5) and Terry Dwyer persuade Carole Kasir to change her Elm Guest House into a boy brothel.
1982	An advert for Elm Guest House is placed in Spartacus International Gay Magazine.
1982	John Rowe takes boys in care, including a 'Rusty', to Amsterdam. Rowe organised trips to Holland for the Monday Club,
1982	The London police Special Patrol Group of 60 officers raid the Elm Guest House. A 17-year old rent boy is detained.
1982	At least three MPs, a member of Buckingham Palace and leading lawyers, doctors and businessmen are questioned as part of enquires into a vice-ring in a brothel in 'a smart London suburb'.
1982	April: Geoffrey Prime arrested for three counts of indecent assault on young girls. He pleads guilty.
1982	May: Auberon Waugh's diary notes that Thatcher only listens to Ferdinand Mount and Jimmy Saville.
1982	June: CGHE strongly recommends Elm Guest House in newsletter. First actual proof of Tory link.
1982	June: The Met. raids Elm Guest House, Relatively few people present.
1982	July: Geoffrey Prime (ex GCHQ) in court on spying charge.
1982	July: Home Sec. Willie Whitelaw tells Parliament that Michael Trestrail (police officer closest to Queen) has resigned due to relationship with a male prostitute. Trestrail also linked to Elm Guest House.
1982	August: Story breaks on Elm Guest House. At least 3 MPs, a member of Buckingham Palace, leading lawyers, doctors and city businessmen are questioned regarding a vice ring. After ten days newspapers are silenced by libel threats.
1982	November: Geoffrey Prime jailed for 35 years for spying and three years for indecent assault on young girls.
1983	April: The Kasirs, owners of Elm Guest House, are given suspended sentences for keeping disorderly house.
1983	August: 6-year old boy attacked and abused by three men in Brighton. PIE members questioned but attack unsolved. Over 1 million people sign petition demanding new legislation to make groups like PIE illegal but new home secretary Leon Brittan does nothing.
1983	November: Geoffrey Dickens MP alleges paedophilia at Buckingham Palace by an employee. Demands Brittan investigates.
1984	Savile accepted as a member of the Athenaeum, a gentleman's club, proposed by Cardinal Basil Hume.
1984	Geoffrey Dickens MP hands over 50-page dossier on VIP child abuse with links to Elm Guest House to Leon Brittan (Home Sec.). File is then lost.
1984	PIE disbands following the jailing of two executive members.
1984	June: Mark Tildsley aged 7 is murdered by Sydney Cooke and gang. No prosecutions made. Cooke's role not investigated until 1999.
1985	A former government minister is linked to Sydney Cooke who tortured and killed 14-year old Jason Swift in 1985. Swift was from an Islington care home. Cooke's accomplices were Leslie Bailey, Robert Oliver and Steven Barrell.
1985	First public allegation of child abuse in Islington care homes by Demetrius Panton to Margaret Hodge.
1986	The minister linked to Jason Swift was photographed at premises in North London where boys were taken from Kings Cross to be raped. A detective stated that at the time 16 top people were due to be arrested but the police operation was suddenly closed down.
1986	After Operation orchid into Cooke disbands, a former officer returned to check the files which contained photographic evidence of high-profile figures going in and out of buildings where abuse was taking place. He discovered that the evidence had vanished along with any mention of the names of the men, which included Savile.
1986	The Sunday Times exposes Spartacus offering young boys from the Philippines.
1986	Alison Taylkor makes a series of complaints about abuse in Gwynedd care homes to police.
1986	Ian Muir, deputy head of Bryn Alyn, convicted of sex abuse with a girl. Six month sentence.
1986	Haut de la Garenne closes as a home. Used in TV series Bergerac.
1986	Scotland Yard founded their exclusive Masonic Lodge (number 9179) known as 'the Manor of St James'. One of the founder members was Gilbert Kelland who was in charge of all London's 3,000 detectives when he was Asst. Commissioner for Crime (1977-84).
1987	Beat Meier and Roger Lawrence (PIE member) caught by UK customs trafficking a 3-year old boy on the Ostend-

	Dover ferry.
1987	David Gillison (care worker at Bryn Estyn) jailed for three and a half years for abuse.
1987	Plans drawn up to appoint Savile to run a taskforce overseeing Broadmoor hospital during a meeting at the Athenaeum.
1987	Daniel Morgan assassinated in Sydenham after investigating a police corruption probe.
1987	May: Harvey Proctor resigns as MP for Billericay after being involved in spanking sessions with young male prostitutes and being fined for indecency. His lawyer (Sir David Napley) was on an Elm Guest House list. Napley also represented Trestrail.
1988	Police raid David Hamilton-Grant's boatyard and house. He was the ringleader in a paedophile porn ring.
1988	Roger Gleaves convicted, sentenced to 15 years for rape of boys.
1988	Chris Denning jailed for three years for indecent assault on boy.
1988	August: Savile appointed chair of task force overseeing management of Broadmoor Hospital after suspension of board members, by junior health minister Edwina Currie.
1989	Leon Brittan knighted and resigns as MP to be European Commissioner. It is alleged that this was to remove him from the local scene after repeated allegations of child abuse.
1989	Robert Oliver found guilty of Jason Swift's manslaughter. Sentenced to 15 years in jail but only served 8. Released in 1997 and is not on the child offender's register.
1989	Colin Peters, Alan Delaney, Ernest Warrington and Victor Burnett were sentenced at the Old Bailey for involvement in a child sex ring. [Operation Hedgerow.] Police believed that the ring extended into Westminster and Whitehall resembling the Mafia in its organisation. The judge stated that it was possibly connected to the Mafia. Peters was a barrister and former Foreign Office official who was also linked to Elm Guest House.
1989	Sydney Cooke sentenced to 19 years in jail for the manslaughter of Jason Swift. It was claimed that Cooke handed boys over to a former top cabinet minister.
1989	Alleged incident involving Prince Charles's servant George Smith being raped at Kensington Palace. In 2002 Smith claims that he saw a 'shocking incident' with Charles and a male servant in the early 1990s.
1989-1991	Michael Johnson of Azimuth Trust assaults two boys (9 and 11) 50 times.
1990s	Scallywag magazine names Alastair (Lord) McAlpine as an abuser of children from a care home in North Wales. He does not sue. This claim is repeated in many websites, none are sued.
1990	Stephen Norris is jailed for 12 years for rape and indecent assault in North Wales (Cartrefle home, Clwyd).
1990	Carol Kasir gives a list of top people in the brothel to a whistleblower. Soon afterwards she is found dead.
1990	Savile is given a papal knighthood.
1990	In Rochdale 20 children are taken from their homes after social services believe them to be involved in occult ritual abuse.
1990	Investigations into Elm Guest House reveal that Richmond Social Services and the police have been wrongfully taking children into care and falsifying evidence, boys were supplied to a number of MPs.
1990	UK police are informed of Alan Williams trafficking boys into Amsterdam and Warwick Spinks selling a video of a boy 8 or 9 being tortured by two men. Spinks leaves Holland and lives in Hastings when he was charged for abducting and raping two boys from London and selling one of them to a Dutch brothel. Sentenced to five years.
1990	'A' (a teenage abuse victim) contacted NAYPIC claiming he was forced to film snuff movies in Amsterdam by a British paedophile ring. He was pulled into a van outside NAYPIC's Mary Moss' home and disappeared.
1991	Police discover that Rabet's Sussex children's centre is part of a ring of well-connected paedophiles.
1991	Social worker Alison Taylor submits a dossier of allegations from over 100 people to North Wales police, the local authority and the Welsh Office. She had first given evidence in 1986. No charges made.
1992	Five separate police investigations into allegations of abuse at separate homes in North Wales. The enquiry by Clwyd Council was never published.
1991	Frederick Rutter (former Bryn Estyn worker) jailed for 12 years for raping residents at a hostel in Connah's Quay.
1992	Operation Pallial reveals: 125 male victims and 15 female victims. 18 care homes investigated. 75 alleged male abusers and 9 alleged female abusers.
1992	Home of Charles Napier reveals paedophile images from Amsterdam and correspondence.
1992	Adrian Jones, a key witness in the child abuse at Bryn Estyn, is killed in a fire in Palmeira Avenue, Brighton. Family demands enquiry. Trevor Carrington survived the fire but hours after confessing to starting it was run down and killed by a truck. Fire officers stated that the fire was started in three places at once.
1992	Peter Righton guilty of importing / possessing obscene material. Tom Watson later claims the file of evidence contained clear evidence of a paedophile ring. Righton fined £900!
1993	2,600 witness statements and 300 cases sent to CPS re. North Wales abuse. 7 people prosecuted.
1993	Savile assaults another 14-year old girl on a cruise ship in the Med.
1993	Stephen Norris (Bryn Estyn) given suspended jail sentence for sexual offences against 9 boys.
1994	Police launch investigation into child abuse at homes in Cheshire and Merseyside.
1994	Homosexual age of consent lowered to 18.
1994	Peter Howarth (Bryn Estyn) sentenced to 7 years for abuse of boys; dies in prison.
1994	December: Alan Langshaw (formerly Greystone Heath and St Vincent's) jailed for 10 years for abuse of boys.

1995	John Allen, head of Bryn Alyn community schools in North Wales, is convicted of sexual offences and jailed for 11 years..
1995	Warwick Spinks is sentenced to 7 years in jail, reduced to 5 years but Spinks fled the country after 30 months and settled in Prague. It is thought that, like Savile, he worked for the security services.
1995	Adrian John's brother Lee was found dead.
1995	Charles Napier (treasurer of PIE) convicted of sexual assault against minors.
1995-6	John Jillings carried out first enquiry into child abuse rings in North Wales children's homes. The report is not published.
1995-6	In the Belgian Dutroux Affair, which alleged that the highest level of politicians and senior figures were involved in paedophile rings and ritual murder, information emerged that a cabal of top European people (judges, lawyers, bankers, prime ministers and aristocrats) were able to place their own people in investigations into child abuse and dismantle them from the inside.
1996	<b>The Dunblane School Massacre</b> where Hamilton killed 16 children. Thomas Hamilton was supplying pornography and boys to top people, including policemen and politicians. He had access to Queen Victoria School where boys were being sexually abused and taken out by 'toffs' on trips. A teacher at this school kept files of abuse and warned parents in 1991. As a result he was fired and police raided his home and confiscated the files. A book by paramedic Sandra Uttley claims that the police were part of a paedophile ring and covered up what really happened. Central Scotland Police should never have been involved in an independent enquiry. The police had allegedly previously protected Hamilton from numerous allegations of physical abuse at boy's camps and clubs that he ran. Lord George Robertson was the referee on Hamilton's shotgun licence and supported him despite claims that he was not fit to have one. Blair covered up the scandal further by moving Robertson out of the country to NATO HQ. Lord Cullen led enquiries into the shooting even though he had walked Hamilton to the scene of the massacre. The Press claimed it was a Masonic conspiracy. Indeed, a top Scottish Freemason (former Grand Master Lord Burton) has said that the Cullen enquiry was a cover-up. Cullen is a member of an elite Freemasonry group based at Edinburgh University called 'The Speculative Society'. It turns out that a friend of Malcolm Rifkind, and Chairman of his constituency party in Edinburgh Pentlands (Robert Bell), sold guns and ammunition to Hamilton weeks before the shootings [Edinburgh Evening Standard News, 23 March 1996]. Prince Philip was Patron of the Board of Directors of the school, as was the then Lord Justice Clerk .
1996	Waterhouse enquiry starts into care homes in Clyd and Gwynedd. 700 allegations of abuse involving 170 individuals. 80 perpetrators.
1996	Eileen Fairweather hands police a list of paedophiles and trafficking linking Jersey / Islington / Guernsey. No police investigation followed.
1996	Judge Anthony Russell QC resigns his recordership following revelations about his frequenting a Gay brothel. Reinstated in 2001.
1996	Taped interview made by Princess Diana of male servant George Smith's rape claim at Kensington. The tape later vanished from home of Diana's former butler Paul Burrell.
1997	Broadmoor hospital is the subject of an enquiry following allegations of a child pornography ring operating there.
1997	Chris Denning (BBC) jailed in Prague for three and a half years after paedo-investigation.
1997	Princess Diana is murdered in Paris. Some have speculated that she had threatened to reveal networks of paedophilia in the Royal family.
1998	Justin Fashanu is found hanged in a London garage. The People newspaper stated that he gave them the names of two cabinet ministers he had sex with. He was introduced to the MPs by a third party linked to a powerful paedophile ring.
1988	Roger Gleaves rapes two 14-year olds and is jailed for 15 years.
1998	Savile meets with Tony Blair.
1998	David Icke names Lord McAlpine in his book, 'The Biggest Secret'. No legal action follows.
1999	Brice Taylor published book detailing her abuse by her father and participation in orgies & rituals. She said that she was then sold in a slave auction to Bob Hope.
1999	Savile invites Prince Charles to his Glencoe cottage.
1999	Sydney Cooke sentenced to two life sentences for 18 sex offences.
2000	The Waterhouse Report concludes that 'widespread sexual abuse of boys occurred in children's residential establishments in Clwyd in North Wales between 1974 and 1990'.
2000	Homosexual age of consent in England and Scotland lowered to 16 (N Ireland 17).
2003	Following a report into the death of former Bryn Estyn clients, police start a new investigation in which John Allen is cleared of a further 36 offences when a judge ruled that he would not receive a fair trial under EU human rights legislation.
2003	Neville Husband, who worked at the Medomsley juvenile detention centre as a prison officer, is jailed for sex abuse. The centre was used as a boy's brothel.
2004	Savile had dinner with Tony Blair.
2007	Death of Baby P (Peter) in Haringey, London. It is alleged that the facts of this were covered-up and formed part of a top paedophile ring.

2007	Former social worker Simon Bellwood makes an official complaint about the care of children on Jersey. He is later sacked. Social Services Minister of Jersey Stuart Syvret acts on the complaint. He is later jailed after trying to expose the child abuse scandal.
2007	Madeleine McCann goes missing in Portugal.
2008	Police under Lenny Harper start investigation at Haut de la Garenne. Potential evidence of torture and murder are found. Harper stated that children were being loaned out to prominent people where they were savagely abused and raped.
2009	A child sex abuse allegation was made about Savile to Jersey police. They did not charge him and had no access to information uncovered in the Battersea Ring ledger of 1964.
2009	Savile is interviewed by Surrey police investigating an alleged assault at Duncroft School on four children. The CPS took no action.
2009	11-year old Dylan McDonald is found dead at a children's home.
2011	Savile dies.
2012	Victim Steve Messham is interviewed on Newsnight and does not mention Lord McAlpine. McAlpine sues the BBC.
2012	October: Operation Yewtree to investigate sexual abuse allegations against Savile.
2012	October: Police launch Operation Fairbank, a secret scoping exercise into allegations of historic sexual abuse in the 80s by politicians and VIPs – the result of Tom Watson's questions to PM.
2013	Police launch Operation Fernbridge into a paedophile ring involving politicians. Centres on Elm Guest House.
2013	Met. detectives link Savile with Elm Guest House.
2013	Cardinal Keith O'Brien resigns amid allegations of 'inappropriate acts'. He had bragged of his friendship with Savile in the past.
2013	Scotland Yard Commander Peter Spindler quits in the middle of the high-profile investigation into Savile and others. Det. Chief Spt. Hamish Campbell (who led the Dando cover-up) is temporarily put in charge of 'Yewtree'. Imminent arrest of a former cabinet minister suddenly stops.

## A layman's suggestions

Clearly the system is not working. Despite enquiry after enquiry there is no significant clamp-down on paedophiles, just a few sacrificial abusers are incarcerated and the general; abuse goes on. Thousands of victims of child abuse, whose lives are ruined, receive no justice. What could be done?

### **Suggestion 1: A new investigative body**

Clearly, as has been proved many times, we cannot trust the police to investigate other police. What is the point of one corrupt police force investigating allegations of corruption in another police force? Furthermore the IPCC is useless and ought to be scrapped.

What is needed is a new investigative body that needs to recruit officers from outside police forces. It needs to be headed up by a person of indisputable integrity (if that can be found) and it needs to have powers with teeth. Furthermore, a constituent of recruitment needs to be no affiliation with Freemasonry.

The results of investigations needs to be fast-tracked through the court system, if necessary by establishing a new set of judges found to be of impeachable character (if possible) and with no Freemasonry ties. Since most paedophiles are male, perhaps the judges and head of the new investigation should be female.

### **Suggestion 2: amnesty**

Bill Maloney has suggested that one way to get new information on the scale of paedophile rings is to promise amnesty to paedophiles that come forward to spill the beans. In return for informing on the breadth of the networks, they personally will receive lighter sentences or full immunity. This is probably the only way that we will ever penetrate the fulness of paedophile rings.

### **Suggestion 3: severe sentences for corruption**

The scale of police corruption in this country is getting beyond belief. There needs to be extremely harsh sentencing for police officers found guilty of corruption. A new deterrent is required to make it not worth while to commit misconduct. Covering-up crimes, losing evidence, destroying evidence, lying, perjury, threatening victims etc. need to be severely punished.

When the victims of serious crimes cannot trust the police force, or when victims are treated like criminals by the people licensed to protect them, then society is in serious trouble. Bent coppers must be severely punished.

## **Conclusion**

Investigating this subject has been distressing. What is most shocking is that, with only a little research, one soon finds that the sheer number of children being abused is astronomical and universal. The whole world is colluding in the sexual and violent abuse of children as young as infants under three-years old. The reason that this carries on is that people in high power in many countries are either involved in the crime or are protecting those involved.

Paedophilia is endemic in the ruling classes. Indeed, the sheer scale of the problem is so huge that some have claimed that international paedophile rings of wealthy people really form the global cabals that control nations, the EU, NATO, the UN and many more. I have only looked at the UK in this paper, but there is information regarding other nations that is even more shocking, that includes royals from other countries; Belgium and The Netherlands are prime examples.

The shocking truth is that it is likely that there is a paedophile ring operating within a reasonable distance of your house. This ring will include high-level, influential members of the local community and the police will likely be covering it up.

Despite many people being in the know about this, the media consistently fails to publish stories about high level people for fear of retaliation. Some aver that the death of Jill Dando was meant to be a threat to journalists to keep quiet. Certainly young and ordinary people have either disappeared or died in mysterious circumstances when they were perceived by the powers that be to be a threat. Even conscientious police officers have found that their investigations are shut down when they become too provocative for the establishment (e.g. Haut de la Garenne) or are filed away and de-activated.

While it appears that Tory MPs have predominately figured in paedophile rings in the past, there is evidence that there are also some Labour MPs and a few LibDem MPs that are also guilty. The number of judges, media figures, bankers, aristocrats, royals, policemen etc. can only be guessed at. What is certain to all researchers on this subject is that the establishment is up to its neck in guilt.

Christians need to be aware that in the past they may have voted for paedophile MPs, MEPs and even a paedophile Prime Minister. They may have supported policies that advantaged paedophiles and perhaps even placed children in institutions where paedophiles have been active. Its time for the church to wake up.

The ruling establishment is in league with Satan and follows his destructive strategies to increase iniquity. We must avoid all forms of evil and that means distancing ourselves from wicked governments.

I have long known about the powers that exist above national governments and these global institutions are predominately occupied by bankers, rich individuals and certain corporation heads (such as arms manufacturers). I used to think that the glue that held these people together (apart from their common aims) was Freemasonry and the Occult, however, I now believe that a key ingredient is paedophilia (which fits in with Freemasonry and the Occult).

In paedophile rings there is a rich mix of all sorts of exclusive people that would not normally fellowship together: entertainers with bankers, politicians with policemen aristocrats with civil servants, etc. Take a look at the guest list at Elm Gust House for a classic example. Not only does paedophilia allow powerful people to meet up, but it also provides the best form of blackmail to make people cowtow.

A good example of a secret cabal influencing royalty and national government, and nearly breaking a country apart is the Belgian TV series Salamander. This is a useful caricature of what is happening worldwide, greased by the oil of paedophilia.

It is clear that Satan's prime choice of vehicle to bring about his global end-time empire is paedophilia (at a personal level), plus international finance and global corporations (at a structural level). Believers need to know what is going on and start being salt in the world.
