

# A personal political manifesto

## Introduction

I sometimes get asked what my politics are; what system I follow, whether I am Left or Right. Well it is time to put this into a simple paper so that I can direct questioners to it. I have answered this question in various papers before, but this is a fuller explanation.

## Foundations

The foundations of my politics are truth and godliness.

### Truth

This is the expression of the will of God in opposition to lies. It is what is true as opposed to deception. It is the truth of God as opposed to the doctrines of demons.

Everything has to be done on the basis of truth, absolute truth. Nothing can be done if it is not based on truth. This would obviate almost everything done by the British government today, which is based upon lies (e.g. lies about inflation, lies about Ukraine, lies about pandemics and health, lies about transgenderism and so on).

I can't say it loud enough; truth has to undergird absolutely everything; every decision, every policy, every public statement.

Any political MP caught lying to Parliament should be immediately sacked and never hold public office again. Political lies have serious ramifications. Tony Blair's blatant lies<sup>1</sup> about Iraq's weapons of mass destruction posing an imminent threat to British interests led directly to over a million dead Iraqi citizens.

### Godliness

This is the will of God as regards ethics; it is the laws of God for individuals and human society.

God has determined how man behaves since he is the creation of God. The only way to live soundly is to obey the laws of God. This is true both individually and corporately. Governments must pass laws that are in accordance with the will of God.

The guidelines for understanding God's will are laid out in the Bible, the word of God. The principles in the Bible must, therefore, be the foundation for justice, governance, social communication and everything within human society.

When rulers sought to implement God's law in society the country became stronger. Alfred the Great did this as King of Wessex. Oliver Cromwell, as Lord Chancellor, took Britain as the basket case of Europe, filled with political corruption, waste and treason, to be the most feared nation in Europe with a more stable economy, the best army and the strongest navy.

### **Affirm the Bill of Rights**

People must be educated to be aware of their rights under the British Constitution.<sup>2</sup> These include: the right to free assembly; the right to freedom of worship; the right of free speech and expression without censorship; the right to roam; the right to protest; habeas corpus; etc.

Notice that lockdowns were illegal under these rights. A temporary parliamentary executive had no authority to subvert the Bill of Right established for over 300 years.

Any person or body (public or private) infringing these rights should be made accountable at law and suffer sanctions. [E.g. the architects of lockdowns should go to jail.]

## **Political establishment**

### **No political parties**

I am not in a political party and never have been. I identify with no one but God.<sup>3</sup>

Political parties are the bane of Parliament. They force people to vote against their principles in order to support the party in a vote. The Whips enforce this with threats and blackmail. Thus the party must take precedence over the individual conscience. This is anathema.

This system used to make more sense when parties stuck to their founding principles. However, over time parties have lost their moorings and are dominated by secret agendas and higher powers. Thus the current Conservative Party is no longer Conservative at all. In fact it conserves nothing but roots up and destroys traditions. Everything is the opposite of traditional Toryism: it has raised taxes to their highest levels. It has created a bigger government. It has ignored the representation of the shires. It has torn up traditional values. It obeys the bidding of supra-national powers against the British interest. It has reduced the Armed Services to an ineffective shell.

So all political parties should be banned.

### **The Right and Left paradigm**

This also should be abolished. Modern life needs more nuance than this binary system.

### **Freemasonry**

No Freemason should be elected to public service. This includes being an MP, a police officer, a judge or a member of the Secret Services. The reason is that Masons swear an oath to prefer fellow Masons above the laws of the land.

### **Religious acceptance of perjury**

No member of a religious community that endorses perjury should become a member of a public service post. This includes Talmudic Jews who swear the Kol Nidre oath<sup>4</sup> or Jihadi Muslims observing Taqiyya.<sup>5</sup>

**Prime Minister**

The Prime Minister should be elected by all the MPs chosen to sit in the Commons. The basis of choice should be merit and nothing else.

**The cabinet**

Again, the cabinet should be elected by all MPs on the basis of merit. The Prime Minister can choose the relevant departments required.

**The second house**

The Lords should be abolished and replaced with an elected senate. Members of the senate should be elected every four years.

**The monarchy**

If the nation wants a monarchy (to be decided by a referendum) it should be severed from anything to do with government. It should have no power over Parliament in any way. It should not have any authority over the established church. It should have a commemorative, symbolic function. Royals should not be supported by public taxes but should live off their businesses and lands. Junior royals with no financial support should get a job.

**Meritocracy**

MPs should be voted for on the basis of their competence not their affiliation. Removal of parties will help in this.

Thus a representative should be judged on the basis of moral character, trustworthiness, integrity, efficiency, discernment.

**Independence**

Every MP should be independent. Groups in Parliament will no doubt form since that is human nature but these must be unofficial and casual. MPs must be solely accountable to their constituents and no one else. Their job in Parliament is to represent the interests of their constituency. De-selection of erring MPs should be made easier.

**Constituencies**

The House of Commons is too large and unwieldy. The number of constituencies must be reduced from over 600 to about 300. For example, the rather small city of Brighton does not need several wards.

This will enable business to be conducted more efficiently and swiftly.

**Committees**

Scrutinising committees must be fully elected by MPs, both chairmen and members. Executive policies must then be analysed for efficiency. Committees should have powers to hold the executive to account.

## The civil service

**Staffing**

Everyone in the civil service should be immediately sacked. Everyone should then be interviewed by a panel and asked to prove why their job is important. Those that succeed should be reinstated. However, the number of departments must be culled and streamlined.

Mandarins should have their power restricted by law. They must serve the elected government and not hinder it. Any hindrance to government decisions must be disciplined

and relevant heads sacked. No department must have any political power or opinion but must simply administer government policy. The age of the Sir Humphreys must be ended.<sup>6</sup>

### **Administrative efficiency**

All state departments must be efficient and customer friendly. Staffing levels should be commensurate with the demand upon the office. Every complaint must be properly investigated and replied to.

All letters must be acknowledged on Day One and replied to within two weeks. If an investigation requires longer there should be an interim reply every two weeks explaining the situation until the final reply.

If the reply and investigation is not satisfactory to the customer, the case must be elevated to a higher level of management and re-visited.

Operators on the telephone must be fluent in English and articulate.

Enquirers on the telephone should not be kept waiting more than three minutes. Long-winded digitised menus should be scrapped. Menus must be simple and to the point with one filter only.

Ombudsmen must have sufficient authority to be able to sanction erroneous departments.

Enquiries into fraud and corruption, such as committed by the police, must not be investigated in-house but by an external body. If necessary, new departments should be established to investigate corrupt offices and individuals.

### **NGOs**

All NGO government funding should be closed down immediately. Those that can prove a vital use to the nation should then be supported by the government on a probationary basis.

Any government involvement with Common Purpose should be terminated.

The country should terminate all relationships with the UN, the WHO, the WEF, the IMF, the World Bank, the BIS and all secret societies.

### **Children's care homes**

All child care homes should be investigated for corruption and acts of child abuse.

Carers and managers found guilty of child abuse or pimping out children should be given long jail sentences.

A regulatory body should be established containing professionals and parents to continually review all child care homes on a rolling basis. It should have the power to close down a guilty care home.

### **Wokery**

All Woke policies should be immediately terminated. Unrelenting Woke civil servants<sup>7</sup> should be fired. Civil servants must be unbiased and neutral in performance of their duties.

Government policies promoting or encouraging the following should be immediately scrapped: Transgenderism, Intersectionalism, Black Lives Matter, Extinction Rebellion, Just Stop Oil, Me Too, colonialism activism, reparations for claimed historic slavery connections, action against claimed White privilege etc.

## **Taxation**

Taxation must be reduced and made as low as possible. Wherever there is low taxation and regulation, a nation thrives (see Hong Kong after 1945 under the financial policies of John James Cowperthwaite, or South Dakota now under governor Christy Noem). VAT should be terminated. Income tax should be much less than it is today. In fact, it should be terminated and only re-introduced sparingly on the basis of essential need. Tax on fuel should be greatly reduced and all of it used to repair roads. Green levies on energy bills should be cancelled.

Council tax should be abolished and only re-introduced on the basis of absolute need, such as bin collections or street lighting. A proportion of council tax must no longer go to central government. Business rates should be greatly reduced. All council car parking areas should once again be free. Council efficiency should be formally tested every year. Council decisions should be open to question and termination by a quorum of the public. Councillors wasting public funds should be sacked immediately and re-elections instituted. Council positions should be purged and only essential jobs re-instated.

Councils should cease being listed in Company House as a business and must simply be a representative public institution.

Water bills should reflect the cost of providing pure domestic water. There should be no profit margin.

## **The economy**

### **The Bank of England**

The Bank of England must be taken away from private hands and restored to control by the Treasury. It must follow sound economic principles defined by elected representatives, not corporate interests.

### **Fiat currency**

Fiat currency should be abolished. Connections to international central banks must be severed. The government should issue its own currency (treasury notes) backed by gold. Coins should be based on gold and silver with real value. Treasury notes should be issued by the government without interest. National debt should be eradicated.

### **Policy issues**

Fractional Reserve lending should be terminated. Banks must become solvent or be terminated.

Quantitative easing (money printing) should be abolished.

Negative interest rates should be illegal.

Bailouts of banks should only be allowed by decision of a national referendum. Bail-ins should be forbidden.

Britain should seek to institute formal relationships with growing economic blocs, such as BRICS.

## Nationalisation

All vital utilities should be taken into government control and severed from corporate interests. This would include: the railways, Royal Mail, the Post Office, water supply, and energy supply. Billions of customer's money has been provided to shareholders and executives with no added value to the utility. In fact, almost all utilities are facing structural breakdown or even collapse (e.g. Thames Water, which is bankrupt).

## Energy production

All Green 'sustainable' projects should be scrapped. This includes wind and solar farms (which should be removed), biomass pellets, and biofuels. These are not genuinely sustainable or efficient; they also cost more and damage ecological systems.<sup>8</sup>

A programme of new small nuclear power stations should be established. Also coal-fired power stations should be re-commissioned and refurbished (new stations are now clean due to better filtration). Building new ones should be considered. Grants and tax breaks should be given to mining communities to re-establish coal mining. Offshore oil and gas drilling should also be encouraged.

Wave power should be investigated, such as on the River Severn.

Alternatives to powering internal combustion engines with petrol should be developed (there are many that have been aborted by oil companies).<sup>9</sup>

All aspects of Net-Zero strategies should be terminated. These include: ULEZ schemes, 15-minute cities, LTN schemes, planned eradication of: petrol cars, public flights, shipping, gas central heating, gas cookers and meat consumption. EVs should be made illegal.

## The environment

Farming should be encouraged and supported. Britain should aim to be self-sufficient in food production. Farming red tape should be scrapped wherever possible. Subsidies need to be given where necessary for a certain necessary food product. Rape, flax, sunflower and seed oil production should be scrapped and land used for vegetable production.

Farmers should be paid more for their production and the government should control the predatory supermarket contracts.<sup>10</sup>

Green belts should be preserved. Necessary housing in a given area should investigate all available brown-field sites first. Owners of large houses kept empty for investment purposes should be taxed and encouraged to let out.

River systems must be actively preserved and kept clean. Polluters should be heavily fined. Dredging to avoid flood events must be kept up. Flood plains should be left alone.

All sewer systems should be immediately reviewed and repaired where necessary.

All Solar Radiation Management schemes (geo-engineering or stratospheric aerosol injection) must be terminated immediately.

All 5G masts must be immediately taken down and the whole system dismantled.

All LED street-lighting must be cancelled and replaced with sodium lamps.

## **Infrastructure**

### **Houses**

Engage in a plan to build 300,000 houses per annum. Tax-breaks can be used as an incentive for developers to build new estates of social housing. Councils must only build new homes if the long-term plan involves no additional expense to residents.

Planning for new homes should first investigate brownfield sites. Expansion into the green belt must only be allowed on the basis of full local agreement. No building on flood plains, farmland or areas of great natural beauty should be permitted.

### **Sustainable structures**

All wind turbine and solar farms should be cancelled immediately. Existing structures should be removed and disposed of in the best way possible (there is no environmentally-friendly way of doing this).

### **Sewers**

A national review of sewer systems should be undertaken. Grants should be given to councils to repair and improve sewer systems. Areas of constant flooding should have new flood protection channels built.

### **Drinking water**

A review into provision of drinking water must be undertaken with a view to improvement.

After taking water companies out of private control, investment must be made into: better purification systems (e.g. UV); uprating all water pipes and eradicating leaks; complete separation of sewage filtration from drinking water supplies; new reservoirs if required.

### **HS2**

Immediately cancel the HS2 project. Set up a public enquiry into the mismanagement of the project; penalise the culprits. Investigate what can be done to recoup wasted money.

### **Potholes**

All road potholes must be repaired at once. Councils failing to keep up proper maintenance of the roads should be penalised and heads sacked. Every successful complaint regarding a pothole accident should also result in a fine against the council, as well as compensation to the victim.

### **Streetlamps**

Lamps should again be switched on during all the hours of darkness.

## **Railways**

Set up an enquiry into the best management of the railway network with consideration to re-establishing local lines that were cut under Beeching, wherever possible.

Instead of HS2, consider building new fast networks going west to east, such as in the Northeast, the Midlands or the South.

## **The NHS**

The NHS is now one of the most expensive in the world yet performs worse than nearly all other Western nations (16<sup>th</sup> out of 17, Civitas). It has the worst outcomes in cancer, heart disease and stroke conditions. Despite now taking 12.4% of GDP (£280.7 billion in 2021), Britons are more unhealthy than at any other time in history. Administration and managers now dominate the Woke NHS with many non-jobs draining resources (e.g. public relations officers, diversity managers and Life Experience directors costing over £40 million pa.). NHS management needs to be culled severely; non-clinical jobs represent almost twice the number of nurses. There is no accountability for failures<sup>11</sup> and massive wasting of money.

Thus the NHS does not need another reform; it needs scrapping completely and a new healthcare system built from scratch. This needs to take into account the best practice observed in other nations such as Australia, Spain and even India. We need a more flexible system that still provides free care at the point of delivery.

## **National medical emergencies**

### **Non-medical interventions**

There must never be compulsory mandates made by the government to control the behaviour of individuals in the case of an epidemic. In the face of a viral epidemic there must be no facemask mandates (they do no good but do harm), no social distancing (pointless) and no lockdowns (pointless). PCR and lateral flow tests must never be used to make a diagnosis (they give false results).

If there is a serious epidemic (viral pandemics are imaginary)<sup>12</sup> the sick should be urged to self-quarantine. Vulnerable people should stay at home and be assisted by family. If vulnerable people have no family or support, the government should provide carers for the course of the epidemic.

Herd immunity will develop in time and the disease will become endemic.

### **Vaccines**

All vaccine programmes should be terminated. There is no safe vaccine (this is admitted) and all have serious side effects. Vaccines have killed people since they were introduced in the mid-1700s. Some vaccines have killed hundreds of thousands of people, such as the polio vaccines of the 1950s-60s which gave people cancer through the SV40 component. All vaccines contain toxic components such as aluminium (causes dementia), mercury (causes brain and nerve damage), Polysorbate 80 (causes cancer), phenol (antifreeze) and so on. Many vaccines have caused sterility.

**Advice**

The government should give the best medical advice to the population. This will always include:

- Advising intake of Vitamin D and C.
- Staying hydrated.
- Eating fresh food and avoiding processed food.
- Avoiding sugar and transfats.
- Daily exercise.
- Getting sufficient sleep.
- Good quality prophylactics.

Hospitals must never be focused upon a single disease but must function normally to cater for other sick people. The government should provide extra beds or commandeer private hospitals if that becomes necessary.

If an epidemic becomes serious, the government must take advice from the very best, senior epidemiologists and evidence-based medicine professors, such as Carl Heneghan, Tom Jefferson and Sunetra Gupta. Advice must also be sought from public health professors. Government lackeys, such as the chief medical officer or the chief science officer (who are often compromised by relationships with Big Pharma), must not control the policies but merely gather the best people.

**The EU**

Brexit never happened. Britain should properly exit from the EU and sever all political ties that threaten sovereignty, such as the European Court of Human Rights. Northern Ireland must secure its independence from the EU.

Britain should seek a common sense trade deal and economic partnership with the EU. All EU working citizens, and relatives of working citizens, in Britain should be allowed British citizenship and encouraged to stay.

**Immigration**

Immigration must be by legal methods. All illegal immigration should be terminated. Illegal immigrants must be deported back to the area they came from or the last European country they resided in.

Genuine refugees should be allowed sanctuary and assisted.

Economic migrants should be accepted on a points system of value to the country. Genuine legal immigrants should have their naturalisation made simpler and cheaper. Immigrants working as nurses for longer than three years should have an assisted fast-track naturalisation scheme.

**The police**

The police forces should all be scrapped immediately. A chief commissioner should be appointed to re-establish a new police force based on Sir Robert Peel's original principles.

This would include a Bobby<sup>13</sup> walking on the local beat. Sacked police officers can re-apply for the new force and only be selected on merit.

The focus of the new police force should be solving crimes by traditional methods.<sup>14</sup> IT equipment should be greatly reduced. AI, algorithms and robotics should be avoided.

The concept of Non-Crime Hate Incidents must be abolished.

The current two-tier police practice must be cancelled. The police must return to unbiased, consensual policing.

All acts of thuggery by the police must be independently investigated and punished. Guilty officers must be sacked.

The police budget should be greatly reduced. The use of drones and helicopters should be urgently reviewed and only accepted if proved to be cost-effective and actually useful. IT systems should be cut back and reliance upon technology reversed. Proper training on detection and investigative skills should be enhanced.

Any police officer found guilty of corruption should be fired and lose their pension.

## **The judiciary and statutory law**

The judiciary should be completely reformed from the top down. The Supreme Court should be abolished. A venerated commissioner should be appointed (such as Lord Sumption) to redesign the system. All judges must be evaluated for their jobs.

Limits should be placed on the costs of lawyers.

Laws should again be based upon Biblical principles. Laws that allow discrimination (hate laws) and censorship of free speech should be repealed.

Trial by jury and habeas corpus (within 24 hours) should be re-established where they have been removed (such as family courts). Legal rights assistance (legal aid) should be given to those with no money for sensible redress in important cases.

## **Foreign and military policy**

A foundational principle must be that Britain is a neutral country regarding foreign conflicts. Alliance treaties that include going to war to support a foreign nation should be scrapped or amended.

Britain should immediately quit NATO.

All current involvement in foreign wars and military actions must immediately cease. This includes providing weapons, military trainers, intelligence, advisors and secret SAS actions. Britain should have no involvement with Ukraine.

All unethical and illegal weapons must be destroyed; such as depleted uranium shells, bio-weapons, chemical weapons, directed energy weapons and phosphor bombs.

Britain should immediately cease political and military support for rogue nations conducting genocide, apartheid, ethnic cleansing and war crimes. This would include the State of Israel.

Sanctions against Russia should be immediately terminated and rapprochement sought.

All support for ISIS and other terrorist rebels in Syria should be terminated.

Involvement in the emerging EU army should be terminated.

National defence forces should be adequately funded and current shortfalls reversed. All Wokery in the Armed Forces should be rooted out. The policy of recruiting women for front-line fighting forces should be cancelled.

Government grants should be provided to encourage home-grown aircraft development with no involvement with foreign consortia. The TSR-2 scandal should never be allowed to happen again.

## **The Secret Services**

The various secret intelligence services should be fully accountable to select committee scrutiny and should have a non-military, impeccable head.

All involvement with foreign intelligence services (apart from sharing information) should be terminated. Britain should have no involvement with covert CIA operations.

Any involvement in special rendition must be outlawed.

Any proven use of blackmail to control politicians should result in long-term jail sentences.

Any control and subversion of the media should result in prosecution of the heads of department. Actions to hinder, attack or smear specific journalists should result in custodial sentences.

GCHQ should be forbidden from spying on innocent private domestic citizens. This includes monitoring telephones, messaging, texts, emails, social media, websites, domestic appliances and so on. Necessary surveillance in the interests of national security must be authorised by a judge.

All the draconian anti-terror laws implemented after 9/11 should be repealed.

## **The current system**

As a result of continuing infiltration and corruption over decades, governance of the country is now a sham. The activity of the House of Commons is just theatre to delude the masses. Voting in elections is a sop to let common people think they have some say in government policy.

To illustrate the folly of this system take the last Tory government, which was chiefly elected to reduce taxation and stop illegal immigration. Taxation rose to its highest ever level and so did immigration with gross immigration at one million last year. The government literally did the opposite of what they were elected to do.

The real source of political power in this country lies above national government and resides in bankers, financiers, secret societies and corporatists. The immediate

powerhouse is the City of London, ruled over by the Rothschilds. Another power source is the Committee of 300, which includes the Windsor royals. Those in power use instruments such as the United Nations to ratify their creeping plans for world domination.

Here are some examples of policy measures that have been introduced at the grass roots level from directives by the UN which have by-passed Parliament. No one voted for them. No one debated them in the Commons. No laws were passed. They appeared in no party manifesto.

- The graphic explicit sexual education of young children in schools.
- Feeding school-children insects at lunch-time.
- Local councils have declared a climate emergency but the government has not.
- Illegal erection of 5G masts all over the country, including every school and hospital, without any medical risk assessment. [5G causes medical harm.]
- Implementation of 15-minute cities. [Which increase congestion and pollution.]
- Implementation of LTN road closure schemes. [Which increase congestion and pollution.]
- Implementation of ULEZ schemes. [Which increase congestion and pollution.]
- Implementation of LED street-lighting. [Which causes medical harm.]
- Implementation of LIDAR, RADAR, photon-arrays and Infra-Red systems on traffic lights. [Which causes medical harm.]
- Sending weapons, munitions, advisors and SAS trainers and technicians to Ukraine.
- Sending weapons and resources to Israel to commit genocide against the Gaza Strip Palestinians.
- Issuing economic sanctions against Russia. [Which made Russia stronger but caused economic damage to Britain.]<sup>15</sup>
- Implementing Solar Radiation Management (chemtrails) to poison the air, earth and water.

This shows that our government is not in control over what happens at grass-root levels.

## Conclusion

The cost of implementing these policies is minimal. This is because most of them are about removing bad policies and strategies not adding on multiple new un-funded ideas.

Of course, none of these things will ever happen. Even if there were a revolution, human corruption would mean that the new government would soon be just as perverted.

However, these are my principles. They are worth nothing in society, but in my view they have value. You are, of course, free to disagree.
