# **Covid vaccine facts**

### Introduction

Most people have no clue about the issues with Covid vaccines and are antagonistic to alternative views as a result of deliberate fearmongering by the UK government, which used militarised, behavioural psychology to terrify the population into compliance.<sup>1</sup> Folk were coerced into accepting the vaccines through fear when there was virtually no threat to life for 99.9% of people. People who were not afraid of much more serious diseases became terrified of a glorified cold.<sup>2</sup> These people today do not want to accept that they were lied to and that they capitulated to state propaganda.

The pandemic narrative was used to institute various social engineering plans, fascist dryruns and social experiments (e.g. lockdowns) but the main objective was to get populations to accept a series of vaccinations. The pandemic was never about a virus but concerned social control. Even two and a half years later, booster jabs are being demanded when virtually the whole population is now immune and vaccines are unnecessary by definition.

The Covid vaccines were designed for two reasons.

- **The first was to enable transhumanism**, the Internet of Bodies, as published by the World Economic Forum and many others. This implants nano-metallic antennae into the body to create a communications system connected to remote devices. This is based upon Graphene structures, which enables complete surveillance and control of humans. The transhuman society is a goal of the UN, working through the WEF, the WHO and others.<sup>3</sup>
- The second reason was to cause mass deaths in populations through slow mechanisms to avoid detection. This is part of a well-documented depopulation agenda.<sup>4</sup> They used various means: the mRNA vaccines used human-created spike proteins to gradually damage organs and cause huge blood clots, while all Covid vaccines slowly devastated immune systems, thus creating AIDS. The Graphene oxide also resulted in massive blood clots. There were also other harms.

However, the vaccines were so toxic that they actually injured and killed tens of thousands of people within hours or days.<sup>5</sup> Young people, especially boys, were killed by myocarditis and pericarditis. Others were killed by heart attacks and strokes (e.g. hundreds of athletes

dropping dead on the field), and other illnesses chiefly caused by huge blood clots. There are now massive excess deaths when there were <u>none</u> in 2020.<sup>6</sup>

Don't believe this? I will cite data and evidence proving my points. I will try to be as brief and concise as possible.

### Vaccines in general

Vaccine is the cause of more disease and suffering than anything I could name. I believe that such diseases as cancer, syphilis, cold sores, and many other disease conditions are the direct results of vaccination.

#### The irrationality of immunisation

The idea of a vaccine is contrary to sound medical science. The immune system has barriers, one of which is the skin. Injecting a toxin through the skin, when that pathogen is usually breathed in, is an action against the immune system. It makes no medical sense.

Then there is the claim that the dangerous introduction of a pathogen into the bloodstream will so prime the immune system as to make one immune for life to a bigger viral load of the pathogen in some miraculous manner. The claim is unproven. How many millions of people had a flu vaccine and then caught influenza? What about the millions of people who had the Covid vaccine and then caught Covid 5 times?

#### Vaccine history

All vaccines are harmful and always have been. It is alleged that more people have died from vaccines than saved from the very beginning. Even in the 1700s smallpox vaccines were killing people, such as theologian / philosopher Jonathan Edwards who died from a smallpox vaccine in 1758. Immunologist Edward Jenner [1749–1823] was repeatedly accused of causing death by vaccines in the early 1800s; despite this he received government funding for further vaccination programmes.

To take one modern example, over 100 American people died from the measles vaccine in the early 2000s while only one person died from measles (even then from a co-morbidity). There was virtually no risk of death from wild measles but a very high morbidity from the measles vaccine. Likewise flu vaccines have killed people and caused harm.

There is no evidence that any vaccine prevented any serious disease or epidemic. The trust in vaccines is the result of a continual propaganda assault from birth, through school and in the media. The claimed success in the early 20<sup>th</sup> century was entirely due to better sanitation, clean drinking water, better food and more of it, hospitals, dental surgery, better living conditions etc. The vaccine introduction came <u>after</u> the peak in infectious diseases and took the credit.<sup>7</sup>

Historical evidence uncovered in the second half of the 20<sup>th</sup> century shows clearly and unequivocally that the narrative of 'life-saving vaccines' is largely fictitious.<sup>8</sup>

#### Polio vaccines

Another example is that it is now confirmed that polio epidemics in Africa and India were caused by polio vaccines.<sup>9</sup> It is also confirmed that the Johan Salk (Rockefeller Foundation) polio vaccines in the 1950s-60s caused cancer due to Simian Virus 40, a carcinogen mutation, being in the contents. Finally, on 11 July 2013, the CDC admitted that between 1955 and 1963 over <u>98 million Americans</u> received one or more doses of a polio shot which was contaminated with Simian vacuolating virus 40 (SV40), which causes cancer.<sup>10</sup> Independently, Dr Michele Carbone, Asst. Professor of Pathology at Loyola University in Chicago, verified the presence of SV40 virus in tissue and bone samples from patients who died. He found various bone cancers and lung cancer. In 1993 the Seattle Times (6 October) announced that all polio in the US was caused by vaccines.

#### Spanish Flu

This did not originate in Spain; it was not a virus and neither was it flu.

The origin was a series of experimental Rockefeller bacterial vaccines (e.g. meningitis) given to US troops in places like Fort Riley. These were then sent to the WWI frontlines already sick. Four years of wartime privation had made civilian populations weak and trench warfare in Europe had destroyed the immune system of soldiers.

As a new disease spread, vaccination programmes ensued including the civilian population. Those in rural areas that refused the vaccination survived without harm. Those who were vaccinated died in the thousands. The vaccine adverse events were covered up by governments (just as today) with the cover story of a new 'Spanish Flu'. Those in cramped towns and cities at the height of the Industrial Revolution were the worst affected due to poor sanitation (outside loos, no wash basin), wartime food rationing, cramped living conditions, lack of clean air, lack of sunlight, no free doctors or hospitals etc.

Some alternative researchers allege that this was an early planned depopulation event based on vaccines; a prototype of many since. (Rockefeller was an ardent eugenicist.) Mainstream commentators deny this.

#### Vaccines unsafe

There isn't a single risk-benefit trial on all-cause mortality and morbidity vs. placebo for any of the US 70 approved vaccines. Not one vaccine is 100% safe.

According to US medical protocols (LD 50; i.e. Lethal Dose 50),<sup>11</sup> vaccines only have to be 50% safe in order to be considered effective. That is, 50% of people could die and the vaccine is authorised; but not if 51% die.

#### Infant immunisation

In what crazy world is it considered safe to inject babies with 24 diseases in the first 24 weeks of development? Yet that is what happens in America; Britain is not that much different. In what insane society would it be considered safe to inject babies with mercury, one of the most toxic substances on Earth? Yet this has gone on for decades.

This is child abuse and the cause of many chronic maladies; including sudden infant death.

One can chronicle the development of modern childhood diseases that never (or rarely) appeared in history before and correlate them with the introduction of various vaccines.

These ailments include: autism, various allergies, asthma, ADHD, autoimmune diseases and many more.

So why are all children not riddled with diseases? The answer is breast-milk. The best boost for a baby's immune system is the mother's breast-milk. By strengthening the immune system, infants are able to fend off some of the worst effects of vaccines. Babies that are not breast-fed will suffer much more.

Observations the world over show that the very healthiest children are those that have received no vaccinations at all.

#### Vaccines and eugenics

There are multiple claims and many books /articles / seminars explaining that vaccines are part of a eugenics programme. This is to eliminate certain undesirable ethnic groups by people in control.<sup>12</sup>

Thus vaccines have been used in sterility programmes targeted at certain ethnic groups and developing world nations. This has been well-documented in places like Africa and India;<sup>13</sup> but it also occurs in the West.

Dr Carrie Medej affirms that the WHO and the NIH have included anti-sterility drugs in tetanus jabs since the 1970s (in fact since 1972).<sup>14</sup> No one has ever died from tetanus caused by a cut in the outside environment but the 'necessary' tetanus vaccine for such a cut causes sterilisation. The anti-fertility contents in the tetanus vaccine is also mentioned in scientific papers.<sup>15</sup> The WHO conjugated tetanus toxoid with human chorionic gonadotropin (hCG) which works as a birth-control system; pregnancy hormones are attacked by the immune system. Females already pregnant abort. As a result of pressure from the Catholic Church in Kenya in 2014, vaccine vials were tested and hCG was found.

The WHO is now working on more potent anti-fertility vaccines using recombinant DNA. The published aim is to reduce population growth in less developed countries.

#### Conclusion

Vaccines are an unwise invasive medication. Throughout vaccine history there have been many deaths caused by vaccines which were covered up by governments. Local popular statements said of Jenner's vaccines that they killed more than they saved. The real cause of they die-off of many infectious diseases in the 20<sup>th</sup> century was improved hygiene, food, water, sanitation, housing, heat and health care. Salk's vaccines caused cancer. Modern polio vaccines have caused polio epidemics. Flu vaccines have caused many injuries and deaths as well as infertility.

### The Covid vaccine conspiracy

#### Covid was not dangerous

- No vaccine was necessary for Covid-19. We knew after the Diamond Princess outbreak that the infection fatality rate (IFR) was low and affected mostly old people with comorbidities. Stanford professor John Ioannidis then estimated the IFR at less than 1%, probably 0.3-0.5% or even 0.12%. Oxford University stated that it was between 0.1% and 0.41%. Stanford University researchers estimated the IFR as between 0.12% and 0.2% on 17 April 2020. A meta analysis of multiple studies (April to early May) done by John Ioannidis showed a rate of 0.06 to 0.16. This means that Covid-19 is comparable with seasonal flu and less severe than a number of past flu epidemics. Recent studies of 30 nations by Ioannidis shows that Covid is less dangerous than flu. The IFR (though it varies slightly from country to country) is as follows: 0-19 years: 0.003%, 20-29 years: 0.003%, 30-39 years: 0.011%, 40-49 years 0.035%, 50-59 years 0.129%, 60-69 years: 0.501%. The median (average) is 0-59 years: 0.035%
- Public Health England affirmed on <u>19 March 2020</u> that Covid was not a serious infectious disease (i.e. before lockdown). **The official government medical position before lockdowns was that Covid was not a problem!**
- Covid was therefore <u>less dangerous than many diseases</u> (e.g. flu, hepatitis, sepsis, pneumonia etc.). The nation has never panicked about these diseases. Lockdowns had no point. Covid vaccines had no point. '*Covid is like flu*' [Stephane Bancel, Moderna CEO.]

#### Covid was manufactured in America

- The chance of SARS-Cov-2 having a natural origin is less than 1 in 100 million. It has a signature of genetic engineering. There is a direct match between Ralph Baric's (University of North Carolina and funded by Fauci and the NIAID) published research and the genetics found in SARS-Cov-2. [BioRxiv, Valentin Bruttel et. al., 'Endonuclease fingerprint indicates a synthetic origin of SARS-Cov-2', 20 October 2022.]
- Patents for genetic aspects of the SARS-Cov-2 'virus' were filed going back to 2002. These involved a coronavirus (cold) subjected to gain of function technology to make it more lethal to human beings and then hiding the human interference.<sup>16</sup> This was initially developed in America under the leadership of Anthony Fauci, Ralph Baric and Peter Daszak. It was later continued in Wuhan.
- The 'virus' was released in the summer of 2019 in various areas and epidemics appeared from August in various places. The 'virus' did not start in a wet market in Wuhan from a bat in 2020.<sup>17</sup> It began in an American laboratory in 2019.

#### The vaccines preceded the epidemic

• The Pfizer and Moderna vaccines were officially underway before the Covid pandemic formally began (Dec 2019). The Moderna vaccine was being developed and tested in 2017; Pfizer was in clinical vaccine trials on 14 January 2020 two months before the WHO announced a pandemic.<sup>18</sup>

• The Covid crisis created fear in people to enable mass vaccination. This was the real purpose – roll out vaccines that would begin the process of transhumanism for total control of people. The problem was never a virus.

#### The vaccines were not safety checked

- The MHRA (UK drug regulator) did not carry out the necessary toxicity, biodistribution and pharmacokinetics studies that are required of new drugs after government pressure to approve. Two years later these studies have still not been done. When MHRA director June Raine says that the vaccines were rigorously tested for safety, she is lying. The MHRA receives 86% of its funding from Big Pharma; it is not an independent regulator.<sup>19</sup>
- The vaccines are not fully approved and licensed but have emergency use authorisation.
- Pfizer officials have bragged that the vaccine development did not allow for proper scientific protocols being followed and that mRNA boosters were released without proper testing. Kathrin Jansen stated that, 'we flew the aeroplane while we were still building it'. Pfizer then hid side effects by eliminating the control groups before the studies were over.<sup>20</sup>

#### The vaccines are not vaccines

• The Covid vaccines are not vaccines in the normal sense. They do not take an attenuated bit of a pathogen to get the immune system to be able to react without overwhelming it. They are an experimental new class of drugs that are gene treatments that change human DNA. This gene treatment technology when previously used was ineffective and dangerous to humans. Animals previously treated with this technology all died.

#### The damning Pfizer data

- A Pfizer director, Janine Small, admitted to the European Parliament hearing on Covid that the vaccines were never tested for stopping transmission of Covid-19. Thus all the claims of needing the vaccine to protect others (the basis of Covid health passes / passports) were lies.<sup>21</sup> Governments knew this before the vaccine rollout.
- Pfizer and the FDA tried to hide the trial data for 75 years despite approving the vaccine after only 108 days of safety reviews on 11 December 2020 (it normally takes ten years). However, in January 2022 Federal Judge Mark Pittman ordered Pfizer to release 55,000 pages every month.
- During the Pfizer trials, more people died from all causes in the vaccinated group than in the unvaccinated cohort.
- The release of the Pfizer trial data shows that it was fraudulent. It was not 95% effective (absolute effectiveness was 0.8%); it used bad protocols; it un-blinded the trial early by vaccinating the placebo control group; it was never tested on pregnant women; its safety trials are still going on and were never completed; plus many other problems.<sup>22</sup> Despite this, the MHRA and the FDA stated that it was safe and effective. Governments

gave Pfizer immunity from litigation. There was no evidence that it was either safe or effective.

- In the first tranche of released Pfizer trial data (forced by a court) was a document titled, '*Cumulative analysis of Post-Authorisation adverse event reports*'. This showed that within 90 days after the release of the Pfizer jab the company was aware of reports of 1,223 deaths and over 42,000 adverse reports describing 168,893 adverse reactions. These reports were from multiple countries. The most reported category was nervous system disorders and it revealed that three times as many women were damaged than men. It also noted spontaneous abortions, stillbirths, neonatal deaths with spontaneous abortions being the highest number in the reports. This was covered up.
- Britain has spent £25 billion on Covid vaccines during an economic crisis.

## Contents of the vaccines

The manufacturers would not disclose what was in the vaccines. However, various doctors and scientists have done technical analyses to discover what they can (e.g. about 55% of the Moderna contents are known).<sup>23</sup> Technologies used include: Phase Contrast Microscopy, Transmission and Scanning Electron Microscopy and Energy-Dispersive X-Ray Spectroscopy.

#### Lipid nano-particle coating

The mRNA in the vaccines is incredibly vulnerable and prone to becoming inert. It has to be encapsulated with a protective coating for it to survive and get into the body's cells.

PEG (polyethylene glycol) is used as a lipid nano-particle coating to protect the mRNA in mRNA vaccines. This itself causes seizures (anaphylactic shock) in about 30% of people. **Electrically-positively-charged lipids are also highly toxic**. They disrupt the mitochondria in the cells and also disturb oxygen supply, which breaks up water into inactive species. This can result in DNA damage.

#### Messenger RNA changes body DNA

The mRNA changes the body's DNA<sup>24</sup> and gets into every cell where it causes human cells to become spike protein factories.<sup>25</sup> The spike protein is toxic and it does not remain in the injection site but pervades the body. The spike protein then causes damage to every major organ.

#### Graphene oxide

This is a nano-metal that is highly conductive. It is injected via the vaccine whereupon it self-assembles into antennae to receive remote signals. However, graphene oxide acts like razor blades within the blood vessels damaging the epithelium. This results in major blood clotting – which then causes stroke, heart attacks, myocarditis and pericarditis. [See later.]

#### Snake and cone snail venom

Dr Bryan Ardis in the US first discovered this, which has now been corroborated by multiple technical analyses of vaccine contents.<sup>26</sup> Snake venom properties are used to improve the stability of the mRNA.<sup>27</sup>

Dr Airyana Love also discovered snake venom in at least five vaccine patents under 'venom' and 'prophhylictic enzymes'. The more booster shots – the more venom is being injected.<sup>28</sup>

The symptoms that are appearing as adverse reactions to vaccines are also symptoms of snake venom. For example, the long strands of blood clots found by undertakers or killing off immune system T-cells.

The Indian company Biological E produced a vaccine called Corbevax in 2019 (before Covid officially started). In February 2022 this was given emergency use authorisation for vaccinating 12-18-year olds against Covid. This company's main products are snake anti venoms, especially anti venom for Kraits and Cobras. The vaccines contain snake venom.

Victims of so-called 'Covid-19' have also been confirmed to have peptides<sup>29</sup> resulting from snake and cone snail venom discovered in European autopsies.<sup>30</sup> Venom components such as conotoxins, phospholipases, phosphodiesterases, zinc metal proteinases and bradykinins have been discovered.<sup>31</sup>

[Aside: 'coronavirus' can be translated as 'king snake venom'.<sup>32</sup> Venom from the Chinese King Cobra and the Chinese Krait have been identified in Covid victims. Is Covid-19 a euphemism for **Co**bra venom? Is SARS-**Cov**-2 a hidden reference to Cobra venom? Does the '19' refer to the 19 different types of toxins found in Cobra venom?]

The BMJ stated that there were two crises occurring in 2021, not one. These were Covid-19 and snakebites. It affirmed that these presented <u>one</u> research and development opportunity <u>due to their commonality</u>. Various reports suggested that snakes were the source of the outbreak.<sup>33</sup>

Using snake and cone snail venom to make drugs has been going on for several years and is celebrated by the WEF.<sup>34</sup> Many drugs derive from snake venom (e.g. Captopril or Prialt). Companies developing these include: The Welcome Trust, ToxinTech and Phirex.

#### Other contents

- Aborted and murdered baby cells,<sup>35</sup> such as HEK 293.
- HIV 1 (patent owned by Fauci), Ebola, E-coli, SARS and Marburg.<sup>36</sup>
- Parasites. These include hydra and Trypanosoma. These have been observed under microscopes.
- Multiple metals. Some of these have caused the skin of patients to become magnetic. '*I* am warning vaxxed individuals to avoid MRI scans, especially for the first few weeks, as some people have been severely affected by the electromagnetism it produces. The most severe cases have resulted in the death of the patients.' Dr Afzal Niaz, Tweet, 22 September 2021.
- Propane.
- Bromide.

All vaccines have multiple toxic components, such as:

- Aluminium (causes dementia).
- Mercury (thimerosal, highly toxic and causes brain damage).
- Polysorbate 80 (causes cancer).
- Polysorbate-20 (causes cancer).
- Beta-Propiolactone (causes cancer).
- Gentamicin Sulphate and Polymyxin B (antibiotics that can cause severe allergic reactions).
- Neomycin Sulphate (can lead to epilepsy and brain damage).
- Phenol / Phenoxyethanol (used as an anti-freeze; toxic to all cells and can destroy the whole immune system).
- Monkey kidney cells (these are cancerous).
- Flagellin (stimulates inflammation).
- Formaldehyde (damages the brain).

And many more.

#### A bioweapon

Multiple specialists (not conspiracy theorists) commenting on the vaccine rollout have called the vaccine a 'bioweapon'.<sup>37</sup> The Graphene and lipid nano particles represent a toxic bio-artificial intelligence device in the body.<sup>38</sup>

The overarching authority controlling the Covid vaccine rollout is not the US HHS or another medical body, such as the NIH. It is the US Dept. of Defence; the military aspect of

the Federal government.<sup>39</sup> Why is this? Why is the control not with a medical department? The authorising document also states that the vaccines are '*for military and domestic use*'. Thus the vaccine manufacturers are under the control of the US military. The Pentagon is controlling the whole vaccine roll-out through multiple shell companies.<sup>40</sup>

All the safeguards and good manufacturing practice were abandoned in order to roll-out mRNA experimental novel vaccines. Pfizer and Moderna formed a cartel whose contracts were treated as military and thus released from all liability, following commands under the PREP Act (the framework for an emergency). There is no accountability for companies producing vaccines under DOD control. This is why there is varying toxicity in different batches of vaccine produced by unaccountable different companies.

Medical analyst Karen Kingston has researched the patents on Covid vaccines and the associated Federal documentation. She came to the conclusion that the vaccines are bio-weapons pure and simple. She also alleges that the spike protein (the toxic content of the vaccines) is not biological but is a bio-engineered AI structure designed to achieve transhumanism.<sup>41</sup> The patents clearly show the graphene oxide self-assembling nano-tubes that form into circuits that transmit and receive signals. These are identified and explained in the various patents and DOD contract documents.

## Why Graphene Oxide?

That Graphene Oxide is present within the vaccine and the blood of the vaxxed is an observable fact and is present in vaccine patents. That it self assembles into antennae and circuits has also been observed under microscopic analysis (this assembling stops when a Faraday cage is placed over the specimen). I have explained the dangerous medical repercussions of this.

But why is Graphene Oxide present? Why is it self-assembling into antennas / circuits?

There has long been a transhumanist (meta / Great Reset) agenda whereby vaxxed people become cyborgs in a bio-security state that can receive and transmit signals to and from external and remote devices. This makes humans like cell-phone masts. Many Elite figures, such as Klaus Schwab and the WEF have openly affirmed this agenda.<sup>42</sup> Dr Robert Malone has fully explained the science of this. This is to allow totalitarian control over people involving track and trace, continual surveillance, medical functions (e.g. scans transmitted to the NHS) and even mood / brain control; all this is openly stated in the public domain. It is not a theory; it is a published plan.

[The Covid pandemic was] just another social engineering project deliberately planned and implemented by predatory meta capitalism to achieve the ultimate end: redefining and reconfiguring the human nature and condition.

The Elite call this 'The Internet of Things' (connection of all home appliances to the Internet) and 'The Internet of People' (connection of all people to the Internet). Centralised hubs gather and control this data. This will be connected to the Central Banks Digital Currency programme to allow full control of people by allowing or forbidding personal financial transactions remotely for compliance / non-compliance.

The means of connecting and controlling all these systems is a ramping up of electromagnetic radiation telecommunications. They cannot work without the new 5G connectivity. This is why 400,000 5G masts have been illegally erected all over the country during the lockdowns without any debate or Parliamentary approval. They are in almost every school and hospital for example and you can see them at major topographical sites. [For example next to Brighton Racecourse at the top of Race Hill.]

So, the control of populations through the Internet of People requires two main innovations: 1) a universal vaccine that injects Graphene Oxide into people that assembles into the necessary antenna / receiver / transmitter; and 2) 5G connectivity.

The problem is that all electromagnetic frequency radiation is harmful, from cell-phones to telecommunication masts. It causes a plethora of diseases including gliomas (brain cancer). There are thousands of scientific papers going back to 1932 that prove this.<sup>43</sup> 5G towers are incredibly harmful to all life forms. This is why tests of 5G at high power levels killed every bird in the radius of transmission.<sup>44</sup> Thus 5G masts, which contain very powerful super-capacitors, have the power to kill people in the vicinity if the wattage is turned up. Vaccinated people, who have metal antennas inside them,<sup>45</sup> are the most vulnerable to pulsed, non-thermal, electromagnetic radiation.

The US National Institutes of Health asserted that there is an association between Covid symptoms and 5G transmissions. In the beginning of the false pandemic the key areas of severe Covid symptoms were all areas of a previous high level take up of a flu vaccine (which also had metal components, such as Tungsten) combined with switching on new 5G technology; such as Wuhan, Lombardy, Belgium and New York.<sup>46</sup> Autopsies of claimed Covid corpses revealed 'radiation poisoning'.<sup>47</sup> During the 2020 Covid crisis autopsies were cancelled in Britain. Why?

So, Graphene Oxide is present in the vaccines to effect the Internet of People that is necessary for totalitarian control of populations in the transhumanist plan. However, connected with 5G technology the hazards to human populations are extreme.

### The vaccine does not work

Multiple studies and data sets have confirmed that the vaccine does not work; certainly after a few weeks. It was never meant to stop transmission (as a Pfizer director testified to the EU) and Pfizer knew that it did not stop hospitalisations and infections from its post-marketing trial data (i.e. by February 2021).

In fact, it is so ineffective that after a few weeks it is likely to make you more vulnerable to disease. It swiftly achieves negative vaccine effectiveness against Covid, hospitalisation and death. The most recent study confirming this was an Oxford / Edinburgh / Swansea study published in the *International Journal of Epidemiology*.<sup>48</sup> This negativity occurs at around 60-80 days post-vaccination. That is, within two to three months the vaccinated experience a higher rate of Covid hospitalisation and death than the unvaccinated. This is true of the Pfizer and the AstraZeneca vaccines. The second dose of the AstraZeneca vaccine increased the risk of hospitalisation and death.

This should not be surprising, as many vaccinated celebrities have confirmed that they caught Covid multiple times after being vaccinated. Some people as many as five times. Unvaccinated people that originally caught Covid and became naturally immune never caught Covid again, despite exposure to it.

Regarding details:

- AstraZeneca day 98 vaccine effectiveness (VE) is minus-89%.
- The second dose made this worse by -59%.
- Pfizer day 100 –85%.
- Second dose add-46%.
- Any positive effect begins to reverse after 60 days.

The official original affirmation that the vaccine stops infection, reduces hospitalisation and stops transmission (hence requiring vaccine passports) were all lies and the government had the data proving this from March 2021. Eventually Boris Johnson (then PM) stated that the vaccines do NOT stop infection or transmission (but the government clung on to the trope that they reduced hospitalisation – which is now proven false).

It is now confirmed (see following data):

- The vaccines do not stop Covid infection.
- The vaccines do not stop Covid transmission.
- The vaccines make it more likely that you will be hospitalised and die.
- ICUs around the world are filled with vaccinated patients.
- Everywhere where the vaccine was rolled out there is a huge spike in excess deaths.

# Official deaths and injuries so far (October 2022)

- The vaccine adverse reaction <u>official data</u> already shows over 80,000 vaccine deaths in the US, UK and the EU.
- Correlation is not causation. However, an MIT study showed that 86% of the reported claims were directly caused by a vaccine.
- Everyone agrees that the reporting systems are under-reported; they differ on how much. The Harvard Pilgrim study<sup>49</sup> suggests that they are only 1% of the true figure; the MHRA states that they are 10% of the true figure. This means that **the adverse** events need to be multiplied by between 10 and 100. This further means that the actual deaths from the vaccines could already be as high as 8,000,000 in the USA and Europe alone. This would mean about 20 million worldwide. Multiple researchers have stated death figures in this order (such as Steve Kirsch). This is being covered up.
- In Britain alone there are over 1.5 million reported adverse events covering scores of illnesses including: blindness, deafness, paralysis, heart attack, stroke, nerve damage, blood clots, respiratory disorders, limb amputations and many more.<sup>50</sup> The MHRA is doing nothing about these reports and still claims that the vaccines are safe.
- The numbers of adverse reactions has forced a debate in Parliament. MPs like Sir Christopher Chope are demanding government action.
- The deaths and adverse reactions to the Covid jabs are multiples more than for every vaccination added together in the last 30 years. UK Covid vaccines are 75 times deadlier than every other vaccine in the past 21 years.<sup>51</sup>
- The triple vaccinated account for 91% of Covid deaths since the start of 2022 and the fully vaccinated account for over 90% of Covid deaths since May 2021.<sup>52</sup>
- Covid vaccines have killed over 34,000 people in England since May 2022. Since April 2022 94% of all deaths are amongst the triple/quadruple vaccinated.<sup>53</sup>
- The UK government has confirmed that Covid vaccinated children are up to 137 times more likely to die than unvaccinated children.<sup>54</sup>
- The CDC explains that vaccinated people make up the majority of Covid deaths.55

- Despite a massive vaccine rollout, the UK had more cases than it did during 2020's winter wave when nobody was vaccinated. [Oct 20: 4 million cases, Oct 21: 5 million cases.] The H.S.A data shows a negative efficacy to the shots and in some age groups the vaccinated are twice as likely to get Covid.
- 35,924 people died within 21 days of having a Covid vaccination in England in the first 8 months of 2021 according to ONS data and UKHSA. 5,522 people had died within 28 days of a vaccination between 8 Dec 2020 and 21 June 2021 in Scotland.
- See ONS graph '*Death rates 60-69 by vaccine status, ONS Data, published November 2021*'. This shows deaths among the vaccinated skyrocketing but deaths among the unvaccinated dropping. This is the opposite of the government narrative.<sup>56</sup>
- Data analysis in November 2021 confirmed that vaccinated people had a <u>higher risk</u> of death and hospitalisation. In November it was revealed that vaccinated adults under 60 are dying at twice the rate of the unvaccinated. The vaccine doubles the deaths from all causes. Data analysis of three months of UKHSA statistics shows that four out of every five Covid deaths are in the vaccinated.<sup>57</sup>
- The ONS supplied data showing that almost 10,000 extra people have died from non-Covid diseases in England and Wales since the summer. There were about 21,000 more deaths from all causes than average since July. In November there were calls for an urgent enquiry after the ONS showed data that there were more than 20,823 deaths than average of which only 11,531 involved Covid.<sup>58</sup>
- Covid cases in hospitals were largely of the vaccinated. HSA data (in the four weeks up to 14 November) showed that 71% of adults hospitalised with Covid are vaccinated; 29% were unvaccinated. Covid deaths in that period were 18% of unvaccinated people but 82% of vaccinated people. Studies based on new UKHSA (was PHE) data shows that infection rates and deaths are over twice the amount in the vaccinated.<sup>59</sup>
- Iceland and Portugal, with over 75% of their populations fully vaccinated, have more Covid cases per million than Vietnam and South Africa where only 10% are vaccinated.
- US CDC data shows rates of hospitalisations for severe illness in the fully vaccinated went from 0.01% in January 2021 to 9% in May 2021. Deaths went from 0% to 15.1%. If the vaccines were safe then the figures would have remained stable, not increased. Of the five US counties with the highest vaccination rates (84.3% to 99.9%), four are in the CDC's high transmission list. Counties with low vaccination rates have low transmission.
- An Israeli study stated, 'In a large population of adults tested for SARS-Cov-2 by RT-PCR after two doses of mRNA vaccine, <u>a gradual increase in the risk of infection was seen</u> for individuals who received their second vaccine dose after at least 90 days'.<sup>60</sup> Fully vaccinated people face a 400% increase in risk of infection for at least 150 days post injection.

## Statistical data: 2022

#### **Excess deaths**

- There is a surge in excess deaths above the five-year 2016-2019 average. This has nothing to do with Covid. Eurostat (EU statistics) shows excess deaths in every EU state.<sup>61</sup> A more recent report shows that the Five Eyes and Europe have suffered 1.8 million excess deaths since the roll-out of the Covid vaccines.
- An America insurance CEO said that the Covid jabs have caused the largest mass dieoff of the working class in history.<sup>62</sup>
- 400 doctors and professionals declared an international medical crisis due to Covid vaccine injuries and deaths.<sup>63</sup>
- The CDC has confirmed that over 118,000 children and young adults have died suddenly in the USA since the roll-out of the Covid vaccines.<sup>64</sup>
- US military whistleblowers say cancer, miscarriages and heart disease are all up 300% following Covid injection mandates.<sup>65</sup>
- England has a spike in excess mortality.<sup>66</sup> There have been between 447 and 2163 excess deaths every week. In Week 17: 2163; Week 19: 2208; Week 3: 1753 and so on. In comparison in 2020 (pandemic year) the death figure was one of the lowest recorded in the last 100 years. In fact lower than every year before 2009.<sup>67</sup> So the pandemic had low excess deaths but after the vaccine rollout excess deaths are through the roof.
- There have been 9880 more excess deaths in Europe so far in 2022 than during 2020.68
- 1 in every 73 vaccinated people was dead by May 2022 in England.<sup>69</sup>
- Mortality rates are lowest in the unvaccinated group in every age band.<sup>70</sup>
- Vaccinated people begin to die after five months from vaccination.<sup>71</sup>
- In New Zealand, 95% of dead people had received a Covid jab within two weeks of death, often within 24 hours, according to a funeral director (Brenton Faithfull).<sup>72</sup>

#### Hospitalisations

• The vaccinated are more likely to be hospitalised than the unvaccinated. For example, 50-64 year-olds: 129 (9.6%) of the 1342 admissions were unvaccinated. In each age cohort the proportion of hospitalisations were fewer in the unvaccinated.<sup>73</sup>

- This is repeated in every highly vaccinated country the majority of hospital patients are vaccinated. In several cases, such as Israel, over 90% of the hospitalised are vaccinated.
- The seven-day average number of hospital admissions for Covid is currently 132% higher than it was on 7 October 2020 before anyone had been vaccinated. It is also 86% higher than on 7 October 2021 when most people had been vaccinated.<sup>74</sup>
- From Week 35 2021 in each of the age groups from 40 to 80 the double jabbed were testing positive for Covid at a higher rate than the unvaxed. The unvaxed are less of a threat than the vaccinated.<sup>75</sup>
- We can postulate that all this is due to reduced immune function (see later).
- It is not the unvaccinated that are clogging up the hospital systems; it is the obese and overweight who are more likely to suffer Covid symptoms. Yet overweight people have been vocal in vilifying the unvaccinated; including Andrew Neil (BMI 32), Piers Morgan (est. BMI 29), Boris Johnson (est. BMI 34), and Therese Coffey (est. BMI 30).<sup>76</sup>

#### Vaccine uptake

- Vaccine uptake has diminished as more people saw the facts. 18,911,191 people refused the first dose. 21,538,363 refused dose 2. 30,424,793 refused the third dose.<sup>77</sup>
- In Israel, which formerly had a 99% vaccine uptake, only had 2.4% take up the recent booster.

#### Immune system

- The Covid jabs weaken and kill the immune system. 78
- By Week 12 of 2022 vaccine effectiveness was minus-391% among 60 to 69-year olds.<sup>79</sup> This really means that the immune system is weakening. This is why excess death rates are skyrocketing.
- 9 in every 10 Covid-19 deaths in 2022 have been among the vaccinated.<sup>80</sup> E.g. in April there were 206 deaths in the unvaccinated but 3365 in the vaccinated. In May unvaccinated deaths represented about 6% and vaccinated deaths 94%. Other months were similar: vaccinated deaths were 85% in January, 90% in February, 93% in March, 95% in April and 94% in May.
- Pfizer documents reveal evidence of autoimmune disease and ADE.<sup>81</sup> Five months after the UK government approved the Pfizer jab, Pfizer admitted that it did not know if the vaccine caused Vaccine-Associated Enhanced Disease. This meant that the public took part in an experiment to see if ADE resulted. Pfizer observed many cases in the following weeks up to 28 February 2021, leaving people with serious disabilities. It was already known that the vaccine did not stop infection or transmission but these reports showed that it did not stop hospitalisation and serious disease also. By March 2021 there was already enough Pfizer data to terminate the whole rollout of the vaccine.

#### **Myocarditis**

- Pfizer documents show that of the 42086 participants 1050 reported autoimmune diseases. 780 of these were considered serious. They included myocarditis.<sup>82</sup> In April 2021 regulators were aware that the vaccines cause myocarditis (which has recently killed tens of thousands of young people).<sup>83</sup> In the US the rate has risen from an average of less than 10pa since 2010 to a level of over 1200 in 2021.<sup>84</sup>
- A new study shows that **mRNA vaccines injure the heart of all vaccine recipients** and cause myocarditis in up to 1 in 27.<sup>85</sup> Elevated levels of troponin (indicating heart injury) were found in all vaccinated people.
- This is not caused by Covid. Australia did not have significant Covid cases (30,000 reported infections by mid-2021) yet it had a trend in excess non-Covid deaths beginning in June 2021.<sup>86</sup> In any case, the PHE (now H.S.A.) affirmed that Covid was not a serious infectious disease and the IFR is low.
- A recent CDC study revealed that the vaccines increase the risk of myocarditis by  $13,200\%.^{87}$

### Brain damage

- Dr Sucharit Bhakdi explains how the spike protein migrates round the body. If this gets into the heart or the brain there is no escape. He refers to just one autopsy that found the spike protein even in the smallest capillaries of the brain. The spike protein also damaged all the brain cells.
- Vaxxed victims sometimes lose their personality, the ability to think. They become demented. They can't hear, see or speak. All because the brain is being destroyed.<sup>88</sup>
- A similar necrosis occurs in the heart.
- 'These gene-based vaccines are the most terrible instruments that have been introduced into the human body to destroy humans ... these vaccines are going to destroy mankind.' (Bahkdi.)<sup>89</sup>

### **Baby deaths**

- Birth rates are falling and baby deaths are skyrocketing. Neonatal deaths increased to 4.6% per 1000 live births in March 2022.90
- German birth rates have dropped 11%.91
- Covid vaccination increases the risk of miscarriage by over 1,517%.92

- In the Pfizer post-trial data 46% of vaccinated mothers suffered an adverse reaction. 58% of these were considered serious. 23 mothers had a spontaneous abortion; two experienced premature baby death; two had intrauterine death; one had neonatal death and only one had a normal outcome. 97% of known outcomes resulted in baby loss. This was known by 28 February 2021.93 Thus the government knew also. Animal trials also showed deformed and abnormal birth defects and increased infertility. Despite this medical regulators affirmed that animal studies did not indicate any direct or indirect harmful effects of the vaccines.
- Pfizer documents also proved that the vaccine causes infertility in men and women and increases the risk of miscarriage. Studies showed that the vaccine accumulates in the ovaries after affecting every major organ.<sup>94</sup> A subsequent independent scientific study came to the same conclusion.<sup>95</sup>

#### Cancer

- **Covid vaccination increases the risk of cancer**. The vaccines are 1433.33 times more likely to cause cancer than the flu vaccine.<sup>96</sup>
- The reason is that the spike protein obliterates the body's mechanism to repair cancerous cells (the homologous recombination DNA repair pathway).<sup>97</sup>
- An oncologist (Dr Angus Dalgleish) affirmed that people with stable cancer rapidly progress after being forced to have a Covid booster shot.<sup>98</sup>
- Pfizer documents show that the vaccine accumulates in the ovaries and now ovarian cancer is at an all-time high.<sup>99</sup>
- In America the cancer crisis is being hidden by calling death that involved cancer and Covid being listed by the CDC as a Covid death only.
- Cancer rates are spiralling out of control in America amongst the fully vaccinated. Many doctors are anonymously affirming this on Twitter.

#### Early adverse events understood by governments

• In the first 90 days of the vaccination roll out under emergency use authorisation (i.e. not approval) 1 Dec 2020 to 28 Feb 2021, **Pfizer noted tens of thousands of adverse events including more than 1200 deaths.**<sup>100</sup> **There were 42,086 case reports worldwide**. The largest numbers were from the US and the UK. This means that the massive numbers of injuries and deaths that has transpired and continues, was known to the government from the very beginning – yet it continues to push for booster jabs. **The dangers were covered up by the government and the MHRA**. This is corporate malfeasance and it should be prosecuted.

#### Some things that the government knew in early 2021.

- The vaccine does not stop transmission.
- The vaccine does not stop in the injection site but travels around the body.
- The vaccine accumulates in the ovaries.

## Steve Kirsch's data

Some data points include (see slides for data sources).

- Age 20-30: 16.9 people were killed by the vaccine per person saved.
- Per 250 million vaccinated there were: 20 million injured; 2 million disabled; 1 million with a life threatening injury; 600,000 killed.
- The vaccines killed more people than Covid.
- In the US 7 million people are now permanently disabled by the vaccine.
- In the UK there were 13.7 vaccinated deaths per thousand people from 1 Jan 2021 to 31 May 2022 compared to 5.8 unvaccinated [ONS data.].

- Most Covid deaths are believed to be caused by hospital protocols.
- There are over 2,000 articles in scientific journals showing harm.

### Depopulation

Without going into conspiracy theories about a new world order, the fact is that there is a worldwide spike in excess deaths that continues.<sup>101</sup> UK excess mortality is up 17% among the fully vaccinated. Europe has recorded over 193,000 more excess deaths so far this year than normal before Covid. Excess deaths are greatest in the countries with the highest vaccine take-up. There is a drop in birth rates and there is a crisis in neonatal deaths. This will lead to planetary depopulation whether you believe in conspiracy theories or not.

The original Rio Summit<sup>102</sup> UN document discussed depopulation and called the years from 2022 to 2026 as *'the killing years'*. Such statements were so inflammatory that the document was pulled from the web – but every national leader signed up to it. Eminent immunologists (e.g. Dr Delores Cahill), virologists (e.g. Dr Judy Mikovits) and other doctors have affirmed that the vaccines will kill millions of people over the five years since the vaccine introduction; i.e. up to 2026.

Whether you accept the facts or not, there is a genocide going on right now. The public (refusing to accept this and believing the media / government lies) are just like the German people during the war that turned a blind eye to Nazi atrocities.

# Why are some people fine after vaccination?

First there is the claim that many vaccine vials were filled with saline. Some scientists have publicly alleged this but were then censored. Also, vials filled with saline were occasionally found. Photographs of vials show some coloured differently to others. National leaders and dignitaries were not given the bioweapon.

There is another major reason.

Vaccine manufacturing takes many years to perfect, often ten years. This is necessary to ensure 99.9% purity of the product in the vials. Then these must be stored in the correct conditions, especially temperature.

The Covid vaccines were rushed into manufacture; as stated by politicians and manufacturers. This resulted in many imperfections in the vaccine vials, including finding bits of stainless steel, crushed glass, plastic from gaskets etc. It also meant that the contents were degraded with the mRNA separating from the nano-lipid covering and becoming inert. In many cases the vaccine vials were also stored at the wrong temperatures; again the vial contents were degraded. Dr Jane Ruby has also exposed that certain vaccine manufacturing facilities were exposed by the FDA as unsanitary and inefficient.

All this is good news for those who were vaccinated by the degraded contents so that the harmful contents had become inactive. This also accounts for the observed differences in batches in America where certain batches were very harmful but others not.

All properly manufactured Covid vaccines are a dangerous bio-weapon, but a proportion of the batches were poorly manufactured, or wrongly stored, and the harms were reduced.

# Hope for the vaccinated: what can the vaxxed do?

These are my layman's suggestions. Various doctors (such as Dr Peter McCullough) have developed their own medicinal protocols.

#### Boost your immune system

The very first and simplest action is to take supplements that will enhance your immune system to fight invasive particles of whatever sort. This will include:

- Vitamin D3. This boosts the immune system. This is necessary because British people do not get enough sunlight.
- Magnesium. This is necessary to get the D3 into the immune system and not just be excreted.
- Vitamin K2. This is necessary to focus the inevitable calcium build up into the bones and not into the arteries.
- Vitamin C. A high dose of Vitamin C liposomal is necessary to fight infection.
- Zinc. This is also necessary to help get good nutrients into the cells.
- Copper. This balances zinc.

### Get a healthy thyroid gland

- Selenium. This helps to keep the thyroid healthy.
- Iodine. Careful with this but most people are deficient in iodine, which is necessary for a healthy thyroid. Alternatively eat foods rich in iodine (seaweed [e.g. kelp, Wakame, Nori], Cod, dairy, prawns, tuna, eggs, prunes, Lima beans). Be careful with Cod and Tuna since they are often highly polluted with heavy metals,]

#### Keep your liver healthy

Your liver is the key organ to get rid of toxins in the body. If it is impaired you will not be healthy. You can get a simple blood test from a GP to see if your liver function is normal (ALT, AST, ALP, GGT, Bilirubin, Albumin). If necessary use a good detoxification process. Eat food good for the liver (tea, blueberries, cranberries, grapes, prickly pear, beetroot, cruciferous vegetables [e.g. sprouts, cabbage, broccoli], nuts).

#### Eat well

You need a good, balanced nutritional diet of healthy, fresh organic food; preferably locally sourced. Avoid processed food. Avoid transfats and seed oils. Drink plenty of clean (filtered) water. Avoid sugar. Avoid fizzy drinks.

#### Exercise well

Vital to health.

Get sufficient sleep and rest

Also vital to health.

#### Take an anti-parasitical programme

Dr Lee Merritt explains that a key issue with the Covid vaccines is parasites. Other doctors (e.g. Dr Carrie Medej) have also confirmed the presence of parasites such as Hydra and Trypanosoma. A protocol to get rid of any parasites is thus necessary. Many people today are riddled with parasites anyway, especially those in close proximity to animals.

Dr Merritt explains a regime<sup>103</sup> that she uses and which got rid of a big build up of parasites in her own body. Ivermectin and Hydroxychloroquine are also beneficial (this is why Covid patients recovered when using them).

### Conclusion

There was a conspiracy to develop the vaccines and the SARS-Cov-2 'virus' (bioweapon not a virus) before the pandemic occurred. These were released at the appropriate time for some ulterior reason by the globalists in control.

It was known in the Pfizer trials that there were serious problems with the vaccine. It resulted in more deaths than in the unvaccinated cohort. Adverse events were covered up and false claims were made about effectiveness (which is zero after five months).

Tens of thousands (at least) have already died from these vaccines and millions of people have been damaged, many for life. Their cause needs to be heard.
