

Covid-19: A summary of facts arising

An update: 22 - 31 March 2020

Introduction

I analyse the issue of a Covid-19 being treated as a pandemic in my paper: '*Covid-19: Another pandemic panic*', q.v. In this paper I intend to simply list facts as they arise during the early period of the UK lockdown, which I aver is a serious mistake, The social, medical and economic damage of this curfew will, I believe, cause more suffering and death than the virus.

Causes of infection

There is growing speculation, based on the evidence of what actually occurred, that there were multiple causes of disease. I will examine 5G later.

There seems to have been slightly different strains in China, Iran, Italy and Spain. I examined this in my previous paper. A patient in Iceland has tested positive to two different strains of Covid-19 simultaneously. Doctors in Iceland have identified 40 different genetic sequences of Covid-19.¹

The initial claim was that the origin of the disease was an accidental release of a bio-engineered strain of SARS from a government laboratory in Wuhan.

China blamed the release upon a CIA plot.

It later came to light that there was a World Military Games event in China in October.² The 300-strong US troops stayed at the Wuhan Oriental Hotel, very close to the seafood market, the area where the outbreak began.

Five of the US troops developed a fever on 25 October and went to hospital. Soon after, 42 employees of the hotel were diagnosed with Covid-19. At that time only 7 people from the market were diagnosed, and these had contact with the 42 from the hotel. The hotel is thus the most likely origin point of the virus.

The infected troops had earlier trained near Fort Detrick, the military's bio-weapons lab that then closed down following deficiencies. It thus seems that it was not an accidental escape from Wuhan but from America. Covid-19 could be a US military bio-weapon gone wrong.

China's Foreign Minister, Wang Yi, released the information and asked the US Secretary of State, Mike Pompeo, for an explanation. Instead of responding, Pompeo 'phoned Yang Jiechi, Chinese state counsellor in charge of foreign affairs and begged him not to release the information. However, it was leaked.

Could this be a propaganda exercise by China? Or is it the truth?

Cases and deaths

Italy

- As of 24 March Italy, which was the worst case in the world at that time, seems to have passed the peak of infection. The death toll was 601, the previous day was 651 and the day before 793. The death toll could therefore be minimal within two weeks.
- The number of certified cases by 24 March was 63,927. Italy's Civil Protection Agency chief (Angelo Borrelli) reported that, '*a ratio of one certified case out of every ten is credible in this country*'.³ (This would be typical in epidemics like influenza.) This would bring the estimated number of Covid-19 cases in Italy near 640,000. In turn this would mean that the fatality rate was less than 1%.
- In the winter seasons from 2013/14 to 2016/17 there were an average of 5,290,000 cases of flu; an incidence of 9%. 68,000 people died of flu in this period. Italy had higher influenza mortality cases than other European countries.⁴ This is before Covid-19.
- Italian government researchers checked patient records to see whether people are dying from Covid-19 or some other cause. The results were that 99% of the dead had other illnesses. Only three victims (i.e. 0.8% of the total) had no previous pathology.

It is likely that there will be a second, or even a third and fourth, wave of the disease. Time will tell.

Testing

Recently America tested more than 600,000 people suspected of having Covid-19. Over 500,000 tested negative. Of the positives, 12,000 need hospitalisation. The US has 200,000 empty hospital beds at any one time. Draw your own conclusions if there is need to panic.

In Britain, months into the epidemic at the end of March, testing is not fully available even for medics and the kits have been shown to be faulty. In fact, accurate testing kits appear to be difficult to manufacture.

The lack of autopsies

I am not aware of any autopsies being performed on patients that are claimed to have died from Covid-19. This is the only way to ascertain what actually killed them.

My concern is that many of the fatalities were actually caused by something else. I am hearing of regular cases where someone is said to have died from the virus but already had respiratory or heart problems who could have died from a cold, emphysema, pneumonia or many other causes.

At least 30% of all Covid-19 deaths involve other bacteria, which would have killed the patient anyway. If we had not known about Covid-19 the number of deaths due to flu-like symptoms would not be unusual this year.

Flattening the curve may actually make things worse. If the level of the epidemic does overwhelm the health service, instead of being overwhelmed for a short period of time in a peak acute phase, the health service will be overwhelmed for a longer period. Furthermore, an overstretched NHS may create additional deaths due to common diseases and traumas (heart attacks, strokes, bleeding etc.) not being treated properly. Professor John Ioannidis estimates the death rate below 55 years of age as 0.05%.⁵

The lack of evidence

There is a lack of evidence (even at 26 March) on how many people have been infected with SARS-Cov-2 or who continue to be infected. Much better data is needed before any government can make effective decisions, such as installing a lockdown. The consequences of a lockdown are, however, potentially very serious and long-lasting.

Ioannidis states that the data collected thus far on how many people are affected and how the epidemic is evolving are utterly unreliable. We don't know if we are failing to capture infections by a factor of three or 300. Three months after the outbreak began no country has the ability to test a large number of people and no country has reliable data on the prevalence of the virus in a representative random sample of the population. People that have been tested are disproportionately those with severe symptoms and bad outcomes.

This means that reported fatality rates, such as the 3.4% rate from the WHO, are meaningless. Self-contained infection rates (such as on the Diamond Princess) shows a rate of less than 1% even with little specialist medical provision and an elderly population. Ioannidis projects that on to America as being 0.125%. Depending on extra sources of uncertainty he says that reasonable estimates of fatality are 0.05% to 1% based on current data. This is lower than seasonal flu. Even a mild cold coronavirus has been known to create a fatality rate of 8% in elderly people. So far this season in the US the estimated number of flu-like illnesses is between 36 million and 51 million, with up to 55,000 deaths.

In the few autopsies of flu patients, it was found that some people die from more than one virus and bacteria superimposed. A positive test for coronavirus does not mean that it is the prime reason for the death.

Mortality rate

The numbers of infections and deaths are being used by the media to drive panic and fear. This fear is then being utilised by the establishment to implement a lockdown based on numbers, models and projections. This lockdown is an introduction of martial law of the severest kind never seen in peacetime Britain, and in the daytime even worse than WWII (people were not stopped from assembling, dancing, going to pubs and clubs, getting married etc.). This will then be used to reset social conditions geared towards totalitarianism by stealth. How bad this will be remains to be seen.

But the numbers are wrong and the interpretation is wrong.

Official bodies, such as the WHO keep telling us that Covid-19 is worse than the flu and deadly to some. Fatality rates as high as 3.4% or 4% have been used by the WHO compared to a seasonal flu death rate of 0.1%. What they are not telling you is that the calculations for one are different from the other.

The actual truth is that seasonal flu is twice as deadly as Covid-19, which never causes a lockdown.

In the US alone so far this season by mid March, at least 22,000 people died from flu (CDC figures, others say much higher). Using WHO figures, at that time only 69 people had died from Covid-19 in the USA and 6,668 globally. Confirmed cases of USA flu is 22,552 with Covid-19 confirmations of 3,806; 173,316 globally.

The death rate for estimated cases for USA flu was 0.1% but no data for estimated cases of Covid-19.

The death rate for confirmed cases of USA flu was 10% while the same for USA Covid-19 was 2% and globally 4%.

Thus the flu in the USA alone is actually twice as deadly as the global figures for Covid-19.

What the WHO did in media presentations was compare the death rate for **estimated** cases for flu with the death rate for **confirmed** cases of Covid-19. This was to over-exaggerate the problem of Covid-19 in order to justify martial law. There is no public health crisis.

Is SARS-Cov-2 a pandemic?

What are the numbers?

I have argued against this in my previous paper; however, the basic arbiter will be the numbers.

There are many diseases which kill hundreds of thousands, or even millions of people every year; such would include malaria, influenza, Hepatitis A, pneumonia, and TB. No one calls these a pandemic. These also occur all over the world, one of the definitions of a pandemic.

Since there is so much dangerous disease around all the time, the real issue is how many die from it? A pandemic requires millions of deaths around the globe. When this is all over, if there are not millions of deaths it never was a pandemic. Since China, South Korea and Singapore are now clear, and since many nations, like Russia, were not badly affected, the numbers so far seem to be in the few thousands in the worst affected areas, like Italy and Spain. This is not a pandemic.

Furthermore, I argue, with many virologists, that many of the deaths attributed to Covid-19 are, in fact, from other prior causes. This panic is far from being based on a real pandemic.

Previous

The current big issue is the problem of overwhelmed hospitals. We are told that this is a new crisis and beds are appearing in tents in parks. This is hyped to appear novel.

In fact, it has occurred very many times going back to 1918.

My own father, awaiting a very serious operation, was in a bed in a tent in 1945 for the war wounded. Many tent wards were set up in commandeered stately home gardens.

In America in 2017-2018 during a flu epidemic Time magazine ran a story saying, '*Hospitals overwhelmed by flu patients are treating them in tents*'. Articles ran with stories of

overwhelmed hospitals, cancelled elective surgery, setting up triage tents, demanding staff work overtime, restricting family visits etc. This occurred in multiple states. All this is nothing new.

The overwhelming of Italian hospitals was also nothing new. Before the epidemic, waiting lists for appointments stretched out for months. Its limitations of health care were well known before 2020. It was not able to face any sort of epidemic.

Problems with treatment

How do we know that hospital treatment is not actually killing some patients and not the virus itself? In 2000 the number of deaths caused by mistreatments, and errors in US hospitals was 119,000.⁶ Year after year doctors have been in the top three causes of unnecessary deaths, such as from hospital acquired diseases, wrong diagnoses, wrong medication, surgical mistakes, and so on. I have seen family members die from hospital causes. In years when doctors went on strike the death rate fell in various countries.

I explained in my previous paper that the antiviral drugs given to Covid-19 patients will kill those with low iron, heart problems and hypertension. Natural protocols that do work (intravenous vitamin C, B1, hydrocortisone, zinc, etc.) are not used by the NHS.

Ventilators can actually cause death. One of the risks is pneumonia because the breathing tube can allow bacteria into the lungs. This is called '*ventilator-associated pneumonia*'. Ventilators also inhibit coughing, which is necessary to clear the lungs. They can also cause pneumothorax,⁷ oxygen toxicity, blood clots and lung damage. As many as 30% of people on ventilators are killed by the treatment causing lung collapse.

Ibuprofen is often given to sick patients; this can also cause serious problems. Side effects are: heart attack, stroke, stomach bleeds, kidney damage, and abortions.

The push for a vaccine

There is a massive push for a quick vaccine, which is a recipe for disaster.

In the 70s the elite create a false panic about Swine Flu (H1N1). In America nearly 50 million citizens were scared enough to get the vaccine for it because the president warned that a pandemic was coming. In the end the virus turned out to a fake scare; it was no more than a new type of flu. There was no pandemic, there wasn't even much of an epidemic.

However, the vaccine turned out to be far nastier. Many died; hundreds of thousands suffered neurological damage so that they were paralysed and their lives ruined. Thousands sued the government and Big Pharma for billions of dollars.

All vaccines cause damage due to the ingredients; such as mercury, formaldehyde and carcinogens. A rushed vaccine that won't be properly tested (vaccines take years to test normally) will be really dangerous.

Many have explained that a global vaccination programme is planned by the elite to serve a number of goals. I cannot delve into the details of this here but have done so elsewhere.

Some vaccines result in sterility of certain racial types, such as Black people. This is part of the elite's plan to get rid of Black people and especially Africans who are sitting on the world's largest natural resources, which the elite want to steal.

Other vaccines target certain people types, such as homosexuals. It is certain that HIV/AIDS arose from a medical laboratory.

Other vaccines are simply toxic and are part of a plan to make people weak, sick or even die as part of a strategy to stop populations from becoming a threat.

New vaccines will include certain micro-technology that will include microchips that track every individual.

Before readers dismiss this as fantasy, you need to understand that the crusade against vaccinations is being led by medical specialists: GPs, nephrologists, cancer care doctors, medical scientists, trauma specialists, paediatricians, A&E doctors and so on. It is not being led by armchair conspiracy nutters. See, for example, books by Dr Suzanne Humphries or watch the YouTube video '*Vaccinations: the hidden truth*'.

Is a lockdown necessary?

The demand by 'experts' to establish a curfew in Britain was decided by medical scientists based upon computer models. Such models, as with Climate Change forecasts, tend to massively hype the outcome.

Countries that did not instigate a lockdown (e.g. Iceland, Sweden, Belarus, Japan) managed to deal with the virus equally well or better than the UK.

There was not a lockdown in the Spanish Flu pandemic, which was far more serious.

If a lockdown continues and breaks the social fabric, causes riots and causes economic collapse, the fatalities could be in the many millions.

Why is a lockdown necessary?

No expert has explained why a lockdown will hinder the spread of the virus. There is no rational scientific evidence that a severe lockdown works. If people adopt sensible distancing measures a lockdown is not necessary. In fact, no one has yet proved that close contact or breathing on someone transmits the disease.

If the virus survives on cardboard for 24-hours (as claimed, some say three days) then merely accepting parcels, pizzas or food deliveries at your door can transmit the disease, as can reading newspapers, magazines and journals. Opening food in plastic or tins can transmit the virus. Police stopping cars and questioning people can transmit the virus. Tube trains full of people are transmitting the virus. [Why are tube trains allowed to do this while old people are forced under house arrest?]

Emergency measures can stop any vessel, aircraft, train or vehicle leaving any place and can seize buildings and objects for decontamination. Yet new evidence shows that the virus is only viable in the air or on a pavement for three hours and this is not the way that 95% of infection occurs.

Bad models

The ‘science’ behind the demand for a house arrest of everyone is based upon the dreaded computer models that so often prove to be wrong.

There are many commentators and scientists affirming that the models used by the government are wrong.⁸ In fact, the chief scientist behind the quarantine is one with a track record of failure, Prof. Neil Ferguson of Imperial College, London. His apocalyptic report scared the PM into taking drastic action.

This report claimed that 500,000 people would die. Ferguson has now downgraded that claim, saying it could be 20,000 – that is within the bounds of a bad flu season. Other colleagues at Imperial have predicted even smaller figures, such as 5,700.

Ferguson’s previous modelling forecasts have been wrong as critics like Prof. Michael Thrusfield of Edinburgh University have pointed out. He cites as an example Ferguson’s mathematical modelling of the 2001 Foot and Mouth crisis. Ferguson persuaded Tony Blair to cull six million healthy cattle, sheep and pigs; which cost £10 billion. Ferguson’s modelling was later claimed as not fit for purpose. Dr Alex Donaldson (head of the Pirbright Laboratory at the Institute for Animal health) said that Ferguson’s models were in ‘*serious error*’ and in ignorance of farming methods. A report into the situation claimed that, ‘*The mathematical models were, at least, crude estimations that could not differentiate risk between farms and, at worst, inaccurate representations of the Epidemiology of FMD*’.

Prof. John Ioannidis also criticised the major assumptions and estimates used by Ferguson, which have inflated the figures. Dr Nic Lewis claimed that Ferguson’s *model ‘does not support the fatality rate assumptions underlying the Imperial study’*. A team at Oxford led by Sunetra Gupta⁹ trashed Ferguson’s claims and claimed that up to half the country has probably already had the virus.

A social science experiment?

Two professors (Donald S Siegel¹⁰ and Robert M Sauer¹¹) writing in the Jerusalem Post¹² claim that citizens of the world have become human subjects of a grand social science experiment that is being conducted without consent.

They claim it will produce a surge of domestic violence and suicide, psychological depression and an economic crash hoisted upon society by public health officials, the media and politicians.

They add that government policy is being designed by the same unelected public health officials who failed to protect us from the virus. The tragedy is being enhanced by the ‘*crazed media*’ which has sensationalised the situation.

Spread during lockdowns

Data already ascertained from Spain and Italy (at 25 March) shows that lockdowns do not stop the spread of the disease. Statistics prove that after the lockdown started the spread of the virus accelerated rapidly before coming to a natural peak. In both Italy and Spain the virus infection rate rose sharply after the lockdown began.

Not necessary anyway

Data has emerged that has not received any wide publicity but is very important.

Before the British lockdown was initiated on 21 March, Covid-19 had already been downgraded as a threat on 19 March.

The virus was no longer deemed a high-risk consequence infectious disease [HCID] in the UK. The four nations public health group had previously recommended that Covid-19 was a HCID in January based on data available at that time. After much more was understood about the disease the public health bodies reviewed their findings. They determined that several features had changed, in particular additional information about mortality rates.

The Advisory Committee on Dangerous Pathogens (ACDP) also concluded that Covid-19 was no longer a HCID.

Since this is the case, the government had decided to bring in martial law under false pretences. Why?

Knock-on effects

Many medics state that such quarantine methods do not necessarily work. Furthermore, they may worsen the situation.

Take for example children removed from school. Notably, they will still congregate because that is what they do. While walking to a shop I have seen teenagers playing football in the park and kids in the playground. If these kids also socialise with elderly family members at home it will have a bad effect. School closures may also diminish the chances of developing so-called herd immunity.

Medics against lockdowns

800 medical professionals connected to Yale University signed a letter to the White House warning that the effects of the lockdown could cause more problems than the virus.

John Ioannidis, a Stanford epidemiologist, has already warned that the extreme measures are based on low-quality information with little interest in costs.

Quotes from the Yale letter follows.¹³

Mandatory quarantine, regional lockdowns, and travel bans have been used to address the risk of Covid-19 in the US and abroad. But they are difficult to implement, can undermine public trust, have large societal costs and, importantly, disproportionately affect the most vulnerable segments in our communities.

Voluntary self-isolation measures are more likely to induce co-operation and protect public trust than coercive measures and are more likely to prevent attempts to avoid contact with the healthcare system. For mandatory quarantines to be effective and therefore scientifically and legally justified, three main criteria must be satisfied: 1) the disease has to be transmissible in its pre-symptomatic or early-symptomatic stages, 2) those who may have been exposed to Covid-19 must be able to be efficiently and effectively identified; and 3) those people must comply with the conditions of quarantine. There is evidence that Covid-19 is transmitted in its pre-symptomatic or early-symptomatic stages. However, the contribution of infected individuals in their pre-

symptomatic or early symptomatic stages to overall transmission is unknown. Efficiently identifying those exposed will be increasingly difficult as community transmission of the virus becomes more widespread, making quarantine a less plausible measure as community spread proceeds. ...

It will also be imperative not to impose inhumane or discriminatory conditions, as occurred on the Diamond Princess cruise ship. ...

Low-wage, gig-economy, and non-salaried workers who are unable to work because of quarantine or movement restrictions ... face extraordinary challenges. They may find it impossible to meet their basic needs, or those of their family. ...

Information should be provided on the justification of any mandatory restrictions as well as how and where to appeal such decisions. They should be afforded procedural due process, including universal access to legal counsel, to ensure their claims of discrimination. ...

The effectiveness of regional lockdowns and travel bans depends on many variables, and also decreases in the later stages of an outbreak. ... In China these measures may have mitigated but not contained the spread of the Covid-19 epidemic, delaying it locally by a few days.

Globalists not locked-down

While small shops, businesses and local markets are closed, supermarkets, banks, Screwfix, B&Q, TV and radio newsrooms and all other firms owned by global corporations are still running. If a supermarket can provide necessary food, why can't a local farmer's market employing social distancing measures? On the continent McDonald's is open for business while private restaurants have closed.

Why is it necessary for TV channels to be running almost as normal? To entertain those locked in they could run good old movies, dramas, documentaries, panel shows and series with a skeleton staff (and the quality of television would dramatically improve). Instead they continue with the normal rubbish with almost a full staff ratio.

This crisis is not harming globalists and corporatists but it is killing small, local businesses. Advisors warned the government that many businesses face closure within four weeks even with the government stimulus package.

Russia

Because Russia closed its borders properly on 31 January, it has no need to implement quarantine laws. Russia has few cases, hardly any fatalities, has kept civil freedom and has even sent virologists and medical supplies to Italy and Iran. Yet the supposedly free west is under martial law. Putin was also the only national leader to don a Hazmat suit and visit Covid-19 patients.

The EU also betrayed Serbia by withholding medical supplies. Russia and China stepped in to help.¹⁴

Advance knowledge

The US CDC started hiring quarantine managers in November 2019 to cover quarantine centres in Texas, California, New York, Washington, Illinois, Massachusetts and more.¹⁵ This was more than a month before the world had any idea that there was a potential problem with a new virus outbreak in China.

The possible real reasons for the lockdown and hype

- Covering up an impending economic collapse caused by the corruption of bankers.
- Get nations into even bigger debt than they are already in – more in hock to the bankers.¹⁶
- Push for a cashless society. China is already burning banknotes.
- Push for a global vaccination programme.
- An excuse to inflict martial law and ramp up a totalitarian state.
- To test how far the elite can push western populations before there is a violent reaction.
- Covering up a serious lack of investment in health care.
- Killing off the weak, sick, poor and elderly. [People whom Henry Kissinger called, ‘Useless eaters’.]
- Creating a field day for the news media; an attempt to get the people to look at mainstream media non-stop reporting on Covid-19 and diminish interest in alternative news.
- Get rid of the family. This is a long desired goal of Marxists and others. The George Soros sponsored NGO ‘Open Democracy’¹⁷ has formally stated that the present crisis is the perfect time to abolish the family.¹⁸ This has affirmed that male-dominated families are oppressive. The reason that this is an elite strategy is because godly families are the centre of Christian spirituality and the basis of society. Get rid of families and the state then controls and programmes children (and initiates widespread paedophilia).
- Destroy churches.

Social ramifications of the lockdown

Note that prohibiting the right to free assembly is the illegal overturning of a basic human right and demolishing a basic feature of English Common Law. Not even King John or King Charles I would have dared to do such a thing. It is also a denial of the American Constitution’s First Amendment. No government has the right to do this. Recent hastily drafted Acts are contrary to the Constitutions of the UK and the US.

Suicides

As some had predicted, the first suicide has been reported of a 19-year old young British girl unable to cope with being shut in. Mental health specialists aver that very many more will follow. Modern society has not prepared people in the way that past generations did.

Threats of state violence

An Italian mayor threatened to send police armed with flame-throwers to break up graduation parties as some people still continue to ignore social distancing rules in a nationwide lockdown.¹⁹

Actual violence

After weeks of a lockdown in Italy, there are stories emerging of people starving. As a result crime has rocketed and supermarkets have been attacked and food stolen. This was inevitable.

One man issued a video in Italy waving a gun threatening to kill the politicians responsible for social chaos.

Unemployment

Inevitably, with businesses shut down many will never recover and hordes of people will be unemployed.

America has seen its highest ever levels of registered unemployed at over 3 million claimants in a single week (400% worse than ever before), and the civil service offices have been unable to cope with demand for welfare. As a result huge numbers have not yet registered and thus the figures will be even higher. This situation is already worse than the 1929 Depression. As I edited this paper figures were released showing 6 million claimants in one week.

A police state

The lockdown itself is evidence of a totalitarian state but as days went by the situation worsened.

Governments began to turn to invasive surveillance methods to track citizens' whereabouts. The UK privacy watchdog gave the government approval to use personal data from people's smart phones to track their behaviour.²⁰ This is unbelievably Orwellian. Location and usage data will be used to compile movement maps to check if they comply with the lockdown.

The police very quickly began to overreach their powers; for example:

- South Wales Police shamed MP Stephen Kinnock on Twitter for dropping off essential supplies to his Dad on his 78th birthday.
- Using drones to film people doing their daily allowed exercise.
- Dyeing a lake black to deter tourists.
- Dictating to shop owners what essential items they can sell.
- Berating shop owners for chalking two-metre lines outside their shops to enforce social distancing.
- Claiming that outdoor exercise is limited to one hour.
- Stopping drivers at roadblocks to question why they are driving.
- Stopping and questioning people walking in the countryside.
- In Shropshire police cordoned off a park to stop walkers.

All these things are beyond the legislation.

In Paris, two policemen forced a woman to the ground on suspicion of breaking quarantine laws.

Certain local governments have already posted websites asking people to inform on their neighbours if they are breaking quarantine laws. This is a Stasi type of society.

Sceptical posts on social media about the virus panic have already been removed.

Totalitarianism

Hungary's response to the virus has been the imposition of blatant totalitarianism. Measures include:

- A state of emergency without a time limit.
- Rule by decree.
- Suspension of Parliament.
- Elections cancelled.
- Spreading 'fake news' results in five years in prison.
- Breaking quarantine results in eight years in prison.

In America a pastor of a 4,000-member church who kept his church open and claimed the government was violating rights to religious freedom was arrested, even though members used hand-sanitisers and kept social distancing. The US Justice Department has already stated it desires to suspend parts of the Constitution indefinitely.

Tax generation

UK quarantine offenders (how do you identify such?) are going to be fined up to £1,000 or a stretch in jail.

Other fines:

- The regional government of La Rioja, Spain imposed fines of 3,000-6,000 Euros (\$3,380-677,000).
- In Ireland new fines are nearly £1000.
- Violating quarantine rules in Malta results in a fine of 3,000 Euros.
- Norway's fines are \$2,000.
- In Western Australia, fines for breaking the rules to self-isolate can be up to \$50,000.
- In Washington DC residents face 90 days in jail and a fine of \$5,000 if they leave their homes. Other states have imposed similar fines but Alaska has implemented a \$25,000 fine.
- In France all citizens must carry an attestation when leaving home. 94,000 French people have been fined for not having the attestation on hand.

A sober history lesson

National panics repeatedly occur in history and always have terrible consequences. Sometimes there is a material reason for them; at other times there was no reason but a panic ensued anyway.

One example is the 'Great Fear' in France from 22 July to 6 August 1789. Social unrest was whipped up into a frenzy, driven by grain shortages and rumours of a plot by aristocrats to starve the peasants. The real reason is disputed but is thought to possibly be ergot²¹ poisoning (which probably caused the Salem witch trials).

Historians consider this mass hysteria to be one of the prime drivers of the French Revolution which began to develop in May 1789.

The current situation is certainly mass panic since the nation is committing economic suicide that could last decades and is causing serious harm to citizens, especially the weak, old and vulnerable, plus putting multiple small businesses into bankruptcy. The deaths so far, at the height of the curve, are less than a bad flu epidemic. In the US so far 23,000 people died from flu and at this point 3,000 from Covid-19.

Lack of quarantine

There may be some attempts to justify a complete social lockdown on the basis of establishing quarantine, but this becomes utterly pointless if the door is left open to all and sundry to fly in from the Covid-19 hotspots around the world.

Heathrow airport is open and functioning as near normal with hundreds of flights coming in every day that includes flights from Italy, China, Spain and America. No one is tested as they enter the country. Officials don't even check anyone's temperature. There is no quarantine; these travellers are simply left to go on public transport, on trains and underground, and roam freely.

What is the point of forcing the population into house arrest if potential carriers of the virus enter on hundreds of flights every day?

The effects of an economic collapse

Effects in Britain

It is certain that the lockdown is going to severely hurt the British economy. In general this means that there is going to be less money available for services that are currently in dire straits. These would include: the NHS, mental care, social care for the elderly, local social enterprises that were cut in the austerity measures, raising the poor out of poverty and so on. Remember the Tories continual rant that a strong NHS was reliant upon a strong economy, used as an excuse for a decade of austerity. Well a crashed economy is going to mean a much worse NHS than ever before.

Vanity projects like HS2 must be terminated and the budget reallocated, but I doubt this will happen.

In this case, provision of care for all sorts of vulnerable and sick people is going to be cut back, possibly for a decade. [The previous austerity measures, supposedly required by an economic crash, lasted a decade.]

It is therefore highly likely that far more people will die from a lack of support due to a lack of funds than will die in the Covid-19 outbreak. Those likely to die will be the elderly, the poor, the very young in poor circumstances, the mentally ill and others. If renewed austerity lasts ten years, probably hundreds of times more people will die from this than Covid-19.

It is understood that the global elite want to bring austerity measures on to states under their control. This is part of the plan to create a feudal state of the ruling cabal lording it

over a nation of serf drones. Imagine a '*Hunger Games*' scenario – that is what they are working towards.

The British economy is not just in trouble, it is facing its worst collapse in living memory.

The IHS market CIPS purchasing managers' index (PMI) is a strong indicator of our economy. Every month the PMI of every country is published and this is used as base data for economists. A PMI of 50 is level; greater than 50 represents growth; below 50 is an economic downturn. The most recent PMI reading for the UK for March is 34.5. The reading for February was 53.2. This is the fastest decline in activity since readings began in 1996, yet it is only two weeks into lockdown. This shows the enormity of the economic crisis we are already in.

Bankruptcies

Within less than two weeks of the total lockdown, business have already started to collapse.

- High Street store BrightHouse filed for insolvency on 23 March. 4,500 jobs under threat.
- Carluccio's restaurant chain of 70 restaurants and 2,000 employees filed for administration on 23 March.

An aviation consultancy [CAPA Centre for Aviation] stated on 16 March that most airlines would be bankrupt by the end of May unless they get government help.²²

An ONS report showed much concern about failing businesses, many of which still face rent demands. One fear of economists is that thousands of maritime companies could collapse; the firms that are responsible for the import of 95% of vital food and medicine supplies.

Then there is the situation of the elderly that rely upon dividends to enhance a meagre pension. According to brokers Peel Hunt 120 firms have suspended dividends over the last four weeks of March. This is a cost of £11.8 billion to investors. Another 100 firms have not yet decided if they will pay out or not. This is going to plunge many elderly folk into poverty and debt.

As workers cannot pay into pension schemes, the pension pots begin to collapse that were already weakened by historic low interest rates. The shortfall will end up causing inflation since firms will increase their costs to make their pension funds solvent.

We are not facing a recession, but a depression much worse than 1929 when people were still working or looking for work. It could take decades to recover from this with a ground up reconstruction of business and social life.

The initial stock market collapse

Economics are sensitive and complex. There was a recent collapse in the stock market, which was blamed on Covid-19. However, on 25 March there was a rise as the Dow Jones index was up a staggering 11.4%. This suggests that the stock market collapse was nothing to do with Covid-19, which was a convenient distraction.

Eurozone PMI

The Eurozone economy is already contracting at an annualised rate of 10% with worse to come.

Regarding individual nations (remember that 50 is the figure for staying level):

- France: services: 27.4; composite: 28.9.
- Germany: services: 31.7; composite: 35.0.
- Italy: services: 17.4; composite: 20.2.
- Spain: services: 23.0; composite: 26.7.
- The Eurozone: services: 26.4; composite: 29.7.

This is extremely serious. Yet experts tell us that many more weeks of lockdown are necessary.

The lockdown is based on the risk of infection; but the risk of a trashed economy and being plunged into the Stone Age is even worse.

Busting the system

The massive surge in American unemployment came at the same time as a promised government bail out that will mostly benefit banks. The Dow Jones index surged upwards as a result.

The US GDP is in chaotic downfall. In the 2008 crash it fell to nearly -10%. This year it is falling to a predicted -24%.²³ This will be the largest decrease in history. At the same time, global debt is at its highest ever level.

Think of the stupidity: the government has made it illegal to go to work and earn money, but will give certain people free money which it just prints out of thin air - causing economic problems down the line and reducing the value of savings and pension schemes.

Already there is a crisis, especially in America, as a result of tenants being unable to pay their rent. This is especially the case of businesses in rented property. While a very few landlords have offered a temporary relief period, most have not. The immediate result is that businesses fire all their staff to pay the rent. This boosts the unemployment stats. Even big corporations such as restaurant chains and Burger King have stated that they will not be able to make payments on 1 April. Commercial mortgage debt at the end of March in America has increased by \$3 trillion, more than it was in 2008.

Gradually no one can pay rent and this has effects on the whole system. The renters are at the bottom of the pyramid. They feed the money stream that goes up the ranks and is eventually converted to securities that finances the markets. If this money vanishes, which it is already showing signs of doing, then the whole edifice begins to fall. Money flows up in a system based upon consumers.

The situation in the markets already is that they are based on more debt than there was in 2008. No one learned their lesson and corruption continued. The housing market, that underpins many securities, is now under severe threat again. In 2008 people began defaulting on their mortgages and the effect went all the way to the top causing a recession.

As in 2008 it will be the banks that get bailed out with taxpayers money but the small people will still have to pay their debts and try to make enough money to cover the bills of being out of work for months. This will create a massive recession because folk will not have any money to spend, except for necessities. This will keep people down for decades.

As people lose their houses yet again, and struggle to find money to continue, there will be a huge stimulus for a populist uprising. In America, France and Italy there could really be a revolution. There is no way that ordinary folk are going to tolerate being stitched up by the financial system twice in just over a decade.

The connection with 5G?

As more information unfolds, it seems very possible that there has been more than one type of infection (targeting different countries) and more than one cause for sickness. This could be the result of targeted bio-warfare.

Videos have emerged from Wuhan showing healthy people walking into a mall or down a street whereupon they suddenly collapse, get sick and die and this was blamed on Covid-19. This is not like flu or pneumonia which grows steadily making a person feel gradually more sick. A person with no symptoms of a coronavirus suddenly collapsing and dying did not die of Covid-19.

The dry cough, typical of Covid-19, is also not like flu or pneumonia, which creates a wet cough producing phlegm in the lungs.

However, both these symptoms are a characteristic of the effects of 5G on life-forms.

A quick run-down on 60GHz frequencies²⁴

60Ghz frequencies have an impact on oxygen in all living cells.²⁵ This frequency is absorbable by oxygen. This is why trees are being cut down to aid transmission between towers because the water in trees absorbs the frequency and stops transmission.

Water in the body is made up of a molecule of two atoms of hydrogen and one of oxygen (H₂O). The oxygen atom has a partial negative charge and the hydrogen atoms a partial positive charge. 5G frequencies cause electrons in this molecule to spin. The result is similar to the effect of microwave ovens, which cause molecules to vibrate (rotate) making water heat up.

The human body breathes in oxygen, which transferred in the alveoli of the lungs into the bloodstream where it is carried by the blood in iron-containing haemoglobin to organs. Lack of iron in the body is anaemia. Severe anaemia causes weakness and death.

I understand this weakness fully as my kidney disease causes anaemia making me very weak as my muscles don't work very well (insufficient oxygen in the cells). I have to have occasional transfusions of iron to keep going.

60GHz transmissions stop oxygen from binding to haemoglobin properly.²⁶ A severe lack of oxygen in the blood will cause a person to suddenly collapse.

Symptoms of supposed virus sufferers recorded by intensive care units listed: shortness of breath, rapid breathing, respiratory distress, shock, arrhythmia, kidney damage and bluish skin. These are all symptoms of a lack of oxygen and acidosis of the blood. Many virus patients had seizures. This is also a result of a lack of oxygen but rare with flu or pneumonia. A proportion of patients had no fever. This would be unusual with a coronavirus attack.

Pneumonia can cause similar respiratory problems, which is caused by fluid in the lungs. However, the Covid-19 patients had a dry cough with no fluid.

The fact that telecommunications companies already admit that 60GHz interacts with oxygen is shocking since none of them have done any medical studies in their roll out of 5G to see if it does harm to living things. They (Mr Gillen) admitted this openly in a US Congressional hearing in answering a question from Mr Blumenthal. There is no research on the medical implications of 5G.

The places where Covid-19 initially suffered most were all places where 5G rollout had occurred, especially Wuhan. China had also recently built the biggest antenna in the world close to Wuhan. Spain and Italy also had a rollout of 5G, which damages the elderly more because their immune systems cannot cope with the radiation poisoning. Russia has hardly any deaths from Covid-19 but it also has not rolled out 5G in the population yet; it only uses it in the military.

What about cruise ship infections in the ocean?

The Covid-19 outbreak on the Diamond Princess line cruise ships led to dozens of people getting sick. These ships had recently had a refurbishment to contain satellite-based 60GHz wireless connectivity technology, which they boasted about in their brochures.²⁷ They used advanced antennae connected to MEO²⁸ satellites supplied by the SES company, which also supplies US warships, as well as utilising geo towers when near land.

No one knows whether the sick people on the cruise ships had a virus or were affected by high frequency radiation.

Conspiracy theory?

Mainstream commentators label the proponents of a theory of harmful effects related to 5G as conspiracy theorists and nutters. The scientific reaction should be to investigate, analyse and consider if there is any truth in it. The medical advisor to the government simply saying that the dangers of 5G are nonsense, on the basis of zero evidence, is hardly scientific.

This much we can say:

- Multiple scientific studies have shown that there are serious debilitating effects from microwave ovens, cellular mobile 'phones and computers.
- Studies have shown that there are already medical repercussions to mobile 'phones using 3G and 4G. However, the danger is the close proximity of devices to the human body. The dangers include cancer.

- 5G is much more intense using a higher frequency waveband and a capability for high wattage.
- 5G antennas include very high-power super capacitors capable of emitting high power radiation.
- Unlike 4G, the damaging effects of 5G can be felt from a distance rather than touching.
- Studies have shown that 5G signals can cause electrons and even molecules to vibrate, or at least the water in the cells vibrates. This causes cells to heat up and be damaged. 5G (which is ten times more powerful than 4G) poisons cells.
- There were widespread reports that tests of 5G in various cities resulted in birds falling dead out of the sky.
- Experience has shown that trees in the vicinity of 5G impulses develop diseased bark.
- Neither the government, nor the telecomm industries, have shown any proof that 5G transmissions are safe to the public.

The reason for 5G

The great aim of the global elite is to roll out the 'Internet of Things' so that they can completely control absolutely everything in social life.

This means that everything in life is interconnected and able to be controlled in a data centre. Everything in your life, your car and your house will be controlled via the Internet; from your bank account, medical records, to your electricity smart meter and domestic appliances. This is necessary for the ruling cabal to be able to control their serfs.

In order to run the Internet of Things the elite need 5G connectivity.

The mystery of viruses

The early understanding

Viruses were not discovered until 1892 by a Russian scientist. In 1898 a Dutch scientist understood that they were a new kind of infectious agent, although he mistakenly thought that they were live organisms. They were not classified until the 1940s when electron microscopes were able to see them.

I mentioned in my last paper the theory of Steiner that viruses were not like bacteria but were the result of toxicity in cells. They were produced by cells reacting to toxic shock. In this theory you cannot 'catch' a virus from someone else; they are not transmitted through the air.

'Virus' derives from the late Middle English to denote the venom of a snake. It arose from the Latin word meaning 'slimy liquid' or 'poison'.²⁹ Steiner's theory was based on the earlier medical belief, that a virus was a substance produced in the body as the result of disease, especially one that is capable of infecting others with the same disease. This was superseded by modern allopathic scientific understanding,

The earlier theory is dismissed by microbiologists but is upheld by a minority of medical practitioners. The problem is that even microbiologists admit that there are many mysteries about viruses, such as their origin and exactly what they are.

What are they?³⁰

Viruses are not plants, animals or bacteria. They are not organisms because they do not reproduce and can't carry out metabolic processes without a host cell. They cannot synthesise proteins because they lack ribosomes (cell organelles). Viruses use the ribosomes of their host cells to translate viral mRNA into viral proteins. They cannot generate or store energy in the form of ATP. The virus derives energy from the host cell. The virus uses the nucleotides and amino acids of the host cell to synthesise its nucleic acids and proteins.

A virus is an infective agent that typically consists of a nucleic acid molecule in a protein coat, is too small to be seen by light microscopy, and is able to multiply only within the living cells of a host. It has either DNA or RNA as nucleic acid but not both. The nucleic acid contains the genetic information unique for each virus. Some are more complex containing a lipoprotein layer surrounding the structure (enveloped viruses), which commonly also have 'spikes' on the outer surface consisting of glycoprotein.

A virus is a minute particle (approximately 20–30 nanometres in size, visible only with an electron microscope) that is capable of infecting a living cell and directing it to make multiple copies of the virus's own components. The host cell may die as a result, as in chickenpox, measles, and influenza, or be transformed in such a way that it multiplies uncontrollably, causing a cancer.

Reproduction

Virus particles must enter a cell in order to replicate. Once inside the cell, the nucleic acid is uncovered and inserted into the cell's replicating sites, where viral proteins and nucleic acids are synthesised. After acquisition of the outer membranes, a new virion (fully formed virus) is released ready to infect another cell. DNA viruses and RNA viruses differ in the precise mechanism of replication. Viruses are capable of spontaneous mutation, which alters their genetic structure; this process may make the virus more or less able to cause disease. Mutations often tend to become more benign since killing off the host kills the virus. This is why viral epidemics gradually fade.

Conclusions

A virus is not a living thing because it cannot reproduce without a host. It is a parasite that needs a host to multiply. In fact, taxonomists believe that viruses need their own specific sub-group.

Some alternative medics claim that because they are not alive, you cannot catch a virus. But microbiologists explain that viruses invade living cells in order to replicate and thus readily infect people.

Exactly how infection occurs is debatable and varies with each virus. Some claim that Covid-19 is transmissible through the air even through masks. Others that it can invade the body through the eyeball. Others that it can stay active (not alive) on certain substances for up to three days, or a few hours. Thus touching an object, say cardboard, then touching your face will result in infection. The trouble is that none of this is certain. Political decisions have been made on the basis of very little real knowledge.

Unintended consequences

If this situation was engineered by the use of a bio-weapon it has developed unintended consequences for the global elite. This is actually common occurrence in history; no one can be certain how any event will pan out in the end.

The EU

The EU is certainly one of the casualties in this event.

Firstly, the open border policy, at the heart of the EU cabal, has been shown to be foolish. Even at the height of the epidemic, EU officials were still demanding that borders be kept open for purely ideological reasons. Despite this command, several nations closed their borders because it was the sane thing to do. Hungary was one example, which brought down threats from the EU cabal.

Secondly, the lack of cogent crisis response from the EU government has been disgraceful. It has been unable to rise to the occasion due to its inherent inefficiency and bureaucracy. This has shown what the true colours of the EU are, exposing its weakness.

Then there is the situation of money and aid. This has also been disgraceful. Many member nations have requested aid and failed to get any (despite a huge aid budget). Crisis meetings with senior finance ministers completely failed to agree anything. Italy has complained about this vehemently, so have Spain and Portugal. The treatment of Serbia has been shocking. At the beginning of the epidemic Italy appealed for supplies of medical equipment. The EU sent absolutely nothing at all and then Germany banned exports of certain medical items. The anger in Italy is shown in people publicly burning the EU flag online, in the streets, or taking it down from buildings.³¹ Politicians are turning to China for help; Russia has already brought medical support as have some Christian organisations (such as 'Samaritan's Purse').

[This raises] questions about the point of an organisation that pledges solidarity as a founding principle, but abandons that principle the moment it is most called for.³²

Solidarity is enshrined in EU treaties, such as Article 222 of the *Treaty on the Functioning of the European Union*, one of its two fundamental treaties. Note: [Regarding] 'the victim of a natural or man-made disaster. The Union shall mobilise all the instruments at its disposal ... to assist a member state in its territory, at the request of its political authorities.'

What the coronavirus crisis reveals is that the member states of the EU will revert to national interests when extreme circumstances call for it.³³

Then there is the continuing migrant crisis (chief vectors for transmitting the virus) which the EU has left in the hand of Greece. Turkey manufactured this crisis for political reasons and all the EU did was for the EU Commissioner for Home Affairs, Ylva Johansson, to order Greece to allow the migrants to apply for asylum. Poor, fractured, broke Greece is alone dealing with a threatened million immigrants from Turkey. Erdogan's blackmail worked as Merkel capitulated to demands and further migrants will be held up.

Then there are the economic effects of the virus. Germany was already facing recession, the Deutsche Bank is close to collapse. Greece is still in severe trouble. The southern nations, already in crisis, will be in very dire straits and the EU will not be able to meet its budget requirements, already threatened by Brexit.

In general the virus has exposed the fact that strong nation states able to make their own decisions are far more capable of dealing with such a situation than a federal block.

Marine Le Pen has claimed that the epidemic is sounding the death knell of the EU. Brexit had severely wounded the body but the virus epidemic afterwards has caused a fatal blow.

Nationalism

Nationalism has been proved to be the natural order of political entities. Strong nation states have been able to weather this crisis far better than states in a federal system, such as the EU or America – both of which face the worst experience of the virus attack.

In fact the preparations that Britain made for Brexit (such as food supply chains and backups) enabled Britain to cope with the emergency far better than other European nations. This has not gone unnoticed.

Russia

The common sense, nationalistic, essentially Christian, foundations laid by Putin in recent years have proved to be far more able to deal with such a crisis than the west, which is based on debt, war and corrupt bankers.

Putin has got rid of the national debt enabling it to weather an economic storm. Russia's currency is also backed by huge gold reserves securing its protection. Putin has harnessed natural resources in an efficient manner, often in conjunction with inward investment from China, India and others. He has played his political / economic cards very well so that he can even cope with the collapse of oil prices. His closure of the borders on 31 January proved to be very effective in stopping the spread of the virus, avoiding any need of a lockdown. Business continues in Russia while it has shutdown in the west.

China

With claims that the crisis has passed in China after six weeks, people are getting back to work. In fact, China is profiting from the global crisis by large scale medical production such as surgical masks, ventilators and testing kits. However, it seems that many of these are sub-standard.

The post Covid-19 world

This period is a watershed in history; things will not return to how they were before. Exactly how this pans out remains to be seen but life will be different.

Apart from this being obvious, academics are also affirming it. The *MIT Technology Review* had a headline saying, '*We're not going back to normal*'. The editorial then explains multiple ways how things will change.

How will things change?

There will be more surveillance than before, which is already at a very high level.

Censorship will become even more severe.

Technological innovations will be authorised and waved through advancing the Internet of Things, 5G (unless the towers get destroyed, which they already are in Slovenia), and AI.

Power will become centralised covering all aspects of social, business and private life through technology. Everything you think, say and do will be monitored for compliance.

There will be pressure to create a cashless society; China is already burning bank notes in a supposed effort to kill the virus. Eventually, microchips inserted under the skin will replace credit cards. In this world without money the establishment will be able to cancel a person's ability to purchase anything on a whim.

The emergency powers governments have granted themselves in creating a police state may not be fully rescinded. There are already plans to control social mobility. People will be tracked from their Smartphones and this will be used to allow or forbid entrance to buildings and venues. This is already happening in China. Then there will be a mandate for a global ID card which everyone will have to carry at all times or face prison. ID cards will probably become necessary in order to make purchases, which will then become biometric. Digital ID cards are already a necessity in Estonia. There will also be digital certificates to prove that a person has been treated by the required mandatory vaccines; eugenicist Bill Gates is already pushing for this. This is headed towards technocrats taking over the human body of every person.

Overall, the planned changes will tend towards creating a one-world culture:

The task before UNESCO is necessary ... opportune, and ... single. That task is to help the emergence of a single world culture, with it's own philosophy and background of ideas, and with its own broad purpose.³⁴

The foundation of this will be the dictat of scientists (whether right or wrong); just as the lockdown was based on the wrong advice of medical scientists.

The threat of war

Many commentators are concerned that a war is looming on the horizon. This would not be unusual in these circumstances.

In the past, economic depressions were covered up and defeated by a global war. The depression in 1929 onwards in America was not fixed by Roosevelt's New Deal but by WWII.

The US Secretary of State, Mike Pompeo, has just ordered all Americans to urgently return home. Why is that? Furthermore, high-level Pentagon officials have been ordered into NORAD underground military complexes in Colorado.³⁵

The official cause for a long anticipated world war, desired by Zionists and the elite, will be that one nation used Covid-19 as a bio-weapon act of war against the other. China says the US started it; the US says that China started it. It doesn't matter which, WWIII will be a massive disaster.

Even if the release of Covid-19 was an accident, the global elite will waste no time using the opportunity to their own advantage and goals. One can only hope that this does not mean war.

Curious precedents in various ways

Life imitates art, according to Oscar Wilde.

The global elite always broadcast their plans to fulfil their Luciferian philosophy. Under this religion³⁶ they believe that they will not be culpable for crimes committed against the public if they warned them about it first. So they publish their plans in movies, books, art, poetry and so forth. Thus we see life fulfilling the prophetic works of earlier fiction.

In other cases, some very prescient artists saw the way that mankind was progressing and, learning lessons of history, wrote fiction warning us about how things could pan out.

Here is a very short list of dystopian / totalitarian scenarios that seem more and more relevant. [Bold means especially relevant.]

- **George Orwell, 1984** (book). The hero is victimised in a highly surveilled totalitarian state.
- **George Orwell, *Animal Farm*** (book). A parody on the rise of Communism based on farm animals.
- **Aldous Huxley, *Brave New World*** (book). People in a futuristic totalitarian society have no control over their lives.
- **Terry Gilliam, *12 Monkeys*** (movie based on the book *La Jetée* by Chris Marker.). The hero is sent back in time to find out about the origins of a virus that wiped out most of the human population.

- Terry Gilliam, *Brazil* (movie). An administrator in a dystopian world tries to correct a clerical error and becomes a public enemy.
- **The Hunger Games** (movie series based on Suzanne Collin's novels). In a totalitarian society ruled by a small cabal, the underclass of each district has to produce a fighter-gadiator to compete in the televised Hunger Games.
- **Steven Soderbergh, Contagion** (movie). A virus causes a pandemic, which threatens to destroy society.
- *Soylent Green* (movie, based on *Make Room! Make Room* by Harry Harrison). Overpopulation is controlled by an elite who turn people into food.
- *The Omega Man* (movie). The struggle for existence of the last man on a post apocalyptic Earth that has not succumbed to a horrible disease that makes people feral.
- *Logan's Run* (movie). In a future totalitarian society, population and consumption are controlled by the deceived voluntary death of everyone over thirty.
- *Akira* (anime film). A secret military project endangers Neo-Tokyo when it turns a biker into a powerful psychopath.
- **Fahrenheit 451**, (movie / Ray Bradbury novel). A fireman in a totalitarian society has to burn all books and starts to question his orders.
- **Gattaca** (movie). In a dystopian society dominated by genetic engineering one of the underclass assumes the role of one of the privileged class by iron discipline in order to get into space.
- Isaac Asimov, *I, Robot* (book series). An android must be stopped from creating a dystopian future.
- **Fritz Lang, Metropolis** (movie). A man living a privileged life in the city discovers how the city is really run by slaves.
- **V for Vendetta** (movie, based on Alan Moore's graphic novel). The rebellion of one cultured man against a totalitarian state.
- **Zardoz** (movie). A post apocalyptic society is divided into the immortal technocrats and the mortal food suppliers.

Advice for believers

I gave a number of practical counsels in my last paper. To those I would add these.

Focus your attention on the sovereignty of God. Mediate on texts like these:

Your eyes saw my substance, being yet unformed. And in Your book they all were written, the days fashioned for me, when *as yet there were* none of them. Ps 139:16

My times *are* in Your hand; deliver me from the hand of my enemies, and from those who persecute me. Ps 31:15

The LORD of hosts *is* with us; the God of Jacob *is* our refuge. Selah Ps 46:7

As for God, His way *is* perfect; the word of the LORD is proven; He *is* a shield to all who trust in Him. Ps 18:30

For the LORD God *is* a sun and shield; the LORD will give grace and glory; no good *thing* will He withhold from those who walk uprightly. Ps 84:11

I will say of the LORD, '*He is* my refuge and my fortress; My God, in Him I will trust'. Ps 91:2

Times are not hidden from the Almighty. Job 24:1

Spend more time in prayer.

Spend more time in worship.

Comfort those who have little faith.

Keep yourself pure.

Try to do good to your neighbours.

Conclusion

I am continually shocked at how much the public buys into the hype about this epidemic (flu events have been worse). Apocalyptic, endless news broadcasts have created mass fear and subjugation that have allowed draconian measures to be enacted with little resistance. This panic has been caused by: 1) experts trying to boost their reputations based on little data; 2) a crazed media monopolising fear; 3) a bemused government cowed by experts and media.

Despite a track record of previous flu-type pandemics that failed to actually occur (e.g. Bird Flu, H1N1) the public this time has ignored the evidence and bought into the hype. This time it may be worse than H1N1 but it is, so far, not worse than a bad flu season. Even if it becomes worse than normal flu, martial law and killing the economy is not the right response. Sane nations are not in a lockdown.

What will be the individual, social and economic cost of this overreaction? Will anybody try to actually find out? Will there be legal redress for lost lives and lost businesses? What if millions of people sue the government for false imprisonment?

What will the impact on churches be? In past pandemics believers and unbelievers flocked to churches; today they are closed. How many will never re-open?

The panic buying, leaving the elderly and sick with empty shelves, is open proof of human selfishness and original sin. No amount of clapping for medics can alter the fact that the overwhelming response has been negative. Months into the epidemic shelves are still empty, despite assertions that there is enough food for all. Elderly, sick and disabled people that rely upon food deliveries can no longer get them as they are booked months into the future. This, with the lockdown, will hurt the most vulnerable people in society the most. Will anyone ever count the toll of this tragedy?
