# The Evils of the Lockdown

### Introduction

The law of God demands that governments look after the vulnerable in society; indeed, the teaching of the Bible honours old people, demanding respect for their grey hair. However godless modern society is, it still remains a fact that the British justice system and social policy was historically determined by Biblical doctrines. The great emancipating social structures of society were all developed by Biblical Christians. Britain must not turn its back on its vital historic virtues.

Outside of the Bible, plain old common decency demands that the weak, sick, vulnerable and elderly should be especially cared for. Throughout history the elderly were treated with respect and honour and their experience and wisdom meant that their counsel was prized.

This is reversed by the effects of the government-imposed house arrest and social immobility called 'the lockdown'.

Now I have explained, in other papers, that eminent medical professors (such as John Ioannidis of Stanford) have declared that there is no medical evidence to support such a mass quarantine. There are some medics who even affirm that it will make the epidemic worse.<sup>2</sup> Certainly in Italy and Spain the epidemic increased after the lockdown. Worse still, many eminent observers, including medics and scientists, are more concerned that the economic disaster that will certainly follow the lack of employment will actually kill more people than the virus. Worst of all, the government's own medical authorities scaled down Covid-19 from being considered as highly dangerous five days before the lockdown started.

The lockdown is a serious mistake and a grave threat to British life forever.

Of most concern is that the effects of the lockdown give the impression that, if it were implemented maliciously (I'm not saying that it was), the plan was to kill old people. The effect will be to cause mass human suffering on an unimaginable scale.

This paper will merely scratch the surface of how evil the effects of this lockdown will be, and already are. The points are merely my observations so far. What is needed is a full public enquiry with expert submissions from various fields to analyse this properly and stop any future government ever doing something so stupid again.

## **Section One**

A cynical attack on the elderly, weak and vulnerable (by design or accident).

## **Background information**

- As with any crisis, stupid people with spare money panicked and began to hoard food depriving others. This immediately resulted in empty shelves in stores, creating more panic. But it also led to dominating the on-line supermarket delivery slots way into the future, stopping immobile vulnerable people from getting food deliveries at the time they needed them most.
- At the same time, government social distancing measures meant that all firms had to reduce their staff by at least 50%. This meant that call centres in vital industries were everyday so overloaded with calls to the few remaining operators that 99% of people could not get through. This means that people could not get their bank to operate or seek help to get access to food.
- Failing to get a bank to set up mandates or effect transfers, people who were self isolated (all old people) quickly ran out of cash to pay those friends and neighbours who were getting their food. They had no way to pay for any eventuality. No one wanted a cheque (which not many modern people even use) because bank's hours were reduced and long queues resulted from social distancing staff reductions. Also many old people do not use on-line banking. The veteran journalist Joan Bakewell bewailed this in her own situation on Newsnight, early into the lockdown.
- Self-isolated people were thus facing no food deliveries, no ability to fetch any (old people were told to stay indoors) and no money to pay friends who fetched it for them.
- The government published a list of especially vulnerable people to get special assistance. This was laudable but the list was far from complete. It included cancer patients whose immune systems may be suppressed by oncology (but many cancer patients would have OK immune systems) yet it ignored very sick people that needed help. These include Chronic Kidney Disease Patients, all of whom have suppressed immune systems and all need special diets. The list should have also included diabetics that need special diets and asthma sufferers or indeed any recent pneumonia and chest infection patients. None of these were on the list. This meant that free food boxes often went to people that did not need them while sick people that vitally needed them did not get this help.
- The real problem with this incomplete list was that very needy vulnerable people could not get priority deliveries by on-line supermarkets the very people that needed them most. Because no deliveries were generally available for weeks, places like Ocado set up a priority delivery system for people on the vulnerable list, but many people in urgent need were not on the list and could not get food.

## Social effects: the elderly but mobile

The enforced demand for self-isolation (house arrest) for fit elderly people is cruel.

### Lack of sun when it finally arrived

Firstly, the Spring has brought much needed sunshine after a long, intensely wet winter that would have kept many old people indoors for months on end. Sunshine is vital for the production of vitamin D, which in turn is vital for developing the immune system. Yet old people cannot leave their homes by government dictat, the very people that need the sunshine most. The ones that live in apartments and high-rise flats will suffer the most.

### No change of scenery

Old people also need a change of environment to keep themselves fit and aid their mental health. Since they are not at work, they urgently need to get outside and do things to stay healthy. The very people that need to go outside for their well being are the ones that have been forbidden to do so.

### **High-rise flats**

Those in high rise flats are in serious trouble. Not only are they worst affected by social isolation they also are forced to gamble with infection all the time by virtue of getting in lifts very close to other people. They have no choice. To get rid of their garbage they have to use a lift. To receive food collected by friends (if they have any) they need to use the lift. To walk the dog they need the lift. To attend clinics they need the lift. To collect prescriptions they have to use the lift. [Government instructions are that delivery people do not even come to the door of a property let alone go inside.]

#### **Food**

The biggest problem is the inability of many to get food. They cannot go out, they cannot get cash and they cannot get through to their banks. (Many old people do not use on-line banking.)

If they have friends or family to get food for them, they are unable to pay for it. If they have no one to collect food, they are really in trouble. What are they supposed to do? The government is only helping over-70s and certain sick people. What are people in their late 60s who are very sick supposed to do – many of whom cannot walk to any shops.

What about the rural sick elderly people? With no on-line deliveries, no local food shops and no help from the government (unless you are registered vulnerable) you will just starve. How many people are starving right now quietly in some village? We know that even young people were starving in Italy during their lockdown because some protested about it and were filmed, others broke into supermarkets.

The government has not taken into account the food crisis that occurred and is still going on. It made no provision for that whatsoever, apart from people on the list. Many will die or get very sick from malnutrition and put an even bigger stress on the NHS as the virus dissipates. Many will develop illnesses they needn't have succumbed to, such as kidney disease or diabetes.

#### Important but unessential items

Many elderly folk will suffer because important health outlets are shut down because these are deemed by the state to be unessential. These include opticians and outlets dealing with deaf aids.

There will be many people (including this writer) that urgently need new spectacles because they can no longer see with their old ones. Some folk will have broken their spectacles and need a replacement. Others need a new deaf aid. Nobody can access these things in the lockdown.

## Social effects: care homes for the elderly

This section is one of the worst effects. The emotional pain that is caused to families with loved ones isolated in a care home is beyond description. The grief of this will affect some people their whole life.

#### Food

Care home managers have complained that they are struggling to get food for their elderly residents. As with others, they were unable to get home deliveries by on-line supermarkets. They were also affected by the 'phone operator shortages affecting every firm and could not get through to explain their special needs.

Because care home managers were not actually old themselves, they were not on the government register of vulnerable people and could not get priority treatment from on-line stores. This meant that they struggled to get any food, even though it was intended for multiple old people. This is a big mistake by the government.

The lockdown actually caused old people to be undernourished or even face starvation.

### **Family contact**

The distress being reported, such as on Jeremy Vine's BBC Radio 2 show, is alarming.

Strict isolation rules prevent any family members seeing elderly folk in care homes. Even wives are not able to see their husbands.

Yet care home staff come and go as they please. The care home is not isolated from the virus because it is brought in by different staff members every day. Indeed, residents have already died from the virus caught from a staff member. In Italy whole care homes have been killed off.

Worse still, the heavy demand on hospitals is causing care homes to receive patients that have the disease, which will then affect all the residents in the home. This policy is too stupid to even believe possible.

What is happening is that beloved family members and spouses are getting the virus and slowly dying without any family member present to comfort them in their dying days. This is shocking. The guilt caused by this to family members will last all their lives.

But ordinary patients are suffering too. Many residents have dementia and cannot understand why their family is no longer visiting them and are becoming severely depressed and ill.

The conclusion is that the lockdown itself is causing mass suffering and even death to the elderly in care homes.

#### **Entertainment**

Care homes regularly have visiting entertainers and performers to help their resident's mental health. The use of music to Alzheimer patients is especially important but the social benefits of community singing are well understood for all sick people.

All that has now stopped.

#### Reduced care

Some care homes have struggled to cope as care workers have been forced into self-isolation or have to look after children in isolation. This has meant lower than normal care levels when people need them enhanced.

### Death rate

One care home network reported 1,000 recent deaths; this is highly unusual. Another network reported 88 deaths. The Guardian was quick to claim that these were due to Covid-19 but no one can possibly know without an autopsy and a proper test (which doesn't exist).

It is far more likely that the lockdown measures, hindering food supply, isolation from family, reduced care, stress etc., was the cause. As the lockdown went on, more reports arrived showing multiple deaths in care homes running into the thousands – entirely predictable and avoidable.

## Social effects: care homes for the needy young

#### Food

Newsnight had a report about care homes for young people. It seems that due to fears of catching the virus many care home workers were self-isolating or too scared to come to work. One interview was conducted by a reporter with a young person through an upstairs window who said that the residents were starving and had no food at all.

### **Security**

Some of the residents of such homes are very troubled people, and potentially violent people. If the care home staff have mostly failed to go to work, what horror stories will emerge about abuse perpetrated by violent residents free to roam as they please?

# **Banking**

Banks, like many other businesses, discriminate against the elderly and vulnerable in this crisis.

As I have explained, call centres have reduced staff levels by order. This means that it is nigh impossible to get through due to heavy demand on the staff remaining. This week I tried to ring my bank and waited until my 'phone battery died (more than 40 minutes) to no avail.

In this crisis people need money or to be able to make transfers. In an age where cheques are unwanted, and many folk don't have them anymore, you need cash or transfer. You cannot get cash if you are under enforced self-isolation (as the elderly are). This means that you need to make transfers to pay those who are bringing you food. With no access to call centres you cannot make a transfer unless you have on-line banking – but most elderly people (like me) do not trust on-line banking.

At the very time that elderly people most needed the banks to work, they stopped working for them. They will deny this but in reality it is the case for the old.

## **Repairs**

At the time when they needed support most, the elderly were also let down by insurance companies and telecomm firms.

Many elderly people have insurance policies to deal with the breakdown of appliances. Again this was ruined by the problem of reduced staff at call centres. Some would have found it impossible to get through to the insurance or other company for this reason and were perhaps facing a broken washing machine, tumble dryer or boiler.

For the few that did get through, they then faced the problem that the service engineers would not go into the house to fix the problem. I personally know of one old lady whose telephone broke down (it did not receive calls) and she did not have a mobile 'phone. She eventually got through to BT Open Reach who sent an engineer round. He checked the outside cable and service box but flatly refused to come indoors to check internal wiring. The problem was not fixed. This was a sick old lady that had her communications cut off.

Another problem is the government directive for delivery operators not to go past the threshold of people's houses. In the case of a new kitchen appliance, firms require the householder to get the appliance either to the doorway or into the garden. They will then only bring the new appliance to the front door. This happened to me this weekend. Despite being a very sick old man I had to disconnect and drag my tumble dryer to the door and then, with great difficulty, get it over the doorway and a step into the garden. I then had to reverse this process with the new one. It made me very ill with rampant high blood pressure for 24 hours. How would a little old lady cope with such things? How could any elderly person single-handedly move a fridge-freezer or a washing machine? Again the lockdown discriminates against old people.

## **Shops**

I have heard numerous sad stories regarding the lack of food. Famously, one newspaper ran a cover story showing an old man looking shocked at empty shelves. A social worker friend told me that she saw an elderly lady crying in the aisles of a supermarket where the shelves were all empty. She said that she had no food at home, burst into tears and then collapsed on the floor.

To their credit, some stores, such as Sainsbury's, established special opening times for vulnerable old people between 8 and 9 am. However, many very sick old people do not rise until late in the morning. Such early priority times are no use to them.

Very shocking is the news that some wicked stores heavily inflated their prices of certain goods, such as eggs.

# Litigation

At the moment the media is whipping up a combination of fear and panic about the virus but also frivolous hero worship of NHS staff. I commend NHS staff that are trying to help people but the level of praise for the NHS is superficial and alarming and a bit like Nuremberg rallies or a circus side-show. Clapping NHS staff is a pointless distraction; more important is giving them personal protection equipment to save their life.

When the crisis has passed and the horror stories begin to come to the surface, and a tsunami of grief envelops the country caused by needless suffering to the old and needy, there will be a change of mood. In this climate I wonder if there may be a tide of angry people ready to bring civil actions against the government that caused this for no reason (the virus was declassified before the lockdown on 19 March). If so, the damages could be in the billions, unless the government enacts indemnity from being sued for emergency measures.

If this occurs, the already ruined economy will be even further trashed.

## The reaction of Christians to the lockdown

Let your light so shine before men, that they may see your good works and glorify your Father in heaven. Matt 5:16

Throughout history the church has always risen to the call in a national crisis, doing good works to all. It was often Christians that kept communities going.

In this current crisis believers should take every opportunity to seek to do good. Search for ways to do good to others. Try to find out where there are elderly and vulnerable people that need assistance. Try to do the opposite of what the government is doing – which is damaging the elderly and the needy. Be a lighthouse of charitable works.

Support Christian charities that are providing food banks for needy people or aid for suffering people overseas.

Pray for opportunities to share the Gospel on the back of doing good in this crisis.

Since worship services are now illegal, try to set up video-conferencing (e.g. Zoom) to share and pray with fellow believers on-line.

Stay in close contact with distant family members by 'phone or computer.

## **Section Two**

# Factors arising from the lockdown

There are so many developments that I can only list a few as bullet points. This is the greatest assault on human freedom since the tyranny of Charles I (which led to a civil war).<sup>3</sup>

### The medical principles of the lockdown denied

Dr Knut Wittkowski

- Eminent epidemiologists (such as Dr Knut Wittkowski)<sup>4</sup> affirm that the only thing that defeats a virus attack is immunity. A lockdown is the worst reaction. Herd immunity needs to develop naturally as fast as possible (i.e. let young people get the disease). Kids should still go to school because they will cope well with any infection; they are low risk. Protection should be given to old people to prevent infection since they are more vulnerable. Getting kids to catch the virus is vital to creating herd immunity. Government policy has made the virus' effects worse. We need 80% of people to become immune; then the virus is unable to spread to new victims and dies down.
- Viruses do not cope well out of doors in sunshine; this is why the flu season ends every Spring. Keeping people indoors is a bad thing; it helps the virus to spread. Going outdoors is what stops every respiratory disease.
- Social distancing has not helped to hinder this virus. This is proved by hard data examining the situation in China. China reached herd immunity before its hard lockdown, which actually helped the virus survive. 'We will see more deaths because of this social distancing' (Wittkowski).
- The impact of the lockdown is to disproportionately damage the elderly and to take longer to create herd immunity which is the only solution.
- Herd immunity lasts for a couple of years. If we had let the virus run its course and for herd immunity to develop, there would be no second or third wave. Thus the end of social distancing will create a second wave.
- Contact tracing for a respiratory disease is impossible. In airborne diseases any close contact will spread infection; it is not possible to stop it (family members, neighbours, delivery staff etc.). By the time you know you have a respiratory disease, you have already passed it on to thousands of people on public transport, colleagues, shops etc.
- Flattening the curve of infection actually makes the epidemic last longer than necessary. Without the overreaction the virus epidemic would already be over globally.
- Left alone coronavirus respiratory diseases (and there have been many) usually last for two weeks and then burn out.
- Wittkowski believes that the virus peaked around the end of March. He also states that although this may be a bad type of flu, it is not essentially different from other seasonal flu epidemics. The numbers are consistent.
- There are no spikes in nature regarding the spread of viruses; the course of an epidemic is always smooth. Spikes in reporting are due to faulty data collection, which are then emphasised by the media to create panic.

- The Internet and modern media have magnified the drama of this epidemic due to daily exposure to mounting data and highlighting fearful images.
- The virus itself does not kill people. It damages the lungs and results in pneumonia because bacteria have settled on damaged tissue.
- The virus made its way through the population long before the lockdown and the outbreak was beginning to level off in statistical terms before the lockdown.

Another world class epidemiologist's views.

Professor Johan Giesecke<sup>5</sup>

- The flattening of the curve is due to the most vulnerable dying first rather than the lockdown.
- There is no medical evidence to support the UK lockdown.
- The correct policy is to protect the old and frail (which the government failed to do).
- It is vital to get herd immunity.
- Social distancing alone is the best policy.
- The Imperial College paper was poor, based on wrong assumptions and has never been published or peer-reviewed. Giesecke has never seen such an unproved paper have so much political impact.
- He dismissed the 510,000 death figure of Ferguson.
- The paper was too pessimistic and did not factor in increased ICU capacity. Computer models are a dubious basis for public policy.
- The results of the virus will be roughly the same for all countries.
- Covid-19 is a mild disease like flu in its effect and spread though different in symptoms.
- The actual fatality rate will turn out to be roughly 0.1%.
- At least 50% of the population will be later shown to have had the disease when antibody testing becomes available.

Giesecke completely agrees with Wittkowski. The lockdown is wrong. The medical advisors to the government are wrong. Giesecke says that Britain's social distancing measures were fine but the U-turn and lockdown after the Ferguson paper was wrong.

On his advice to the Swedish government, Sweden is not in lockdown. Schools are open, there is mild social distancing; shops are open, no police stop and question people, public meetings of less than 50 people are allowed but care homes for the old are quarantined.

#### **Vaccines**

- Vaccines are ineffective against coronaviruses. There is no vaccine for the common cold. There are vaccines that claim to fight flu but they are ineffective and contain very harmful substances. It is a lie that vaccines prevent flu; they do more harm than good and cannot stop you catching one of the many influenza viruses.
- 'Researchers are trying to ensure that their [vaccine] candidates don't spur a counterproductive, even dangerous, immune system reaction known as immune enhancement.... Researchers need to understand in particular whether the vaccine causes the same types of immune system malfunctions that have been observed in past vaccine developments. Since the 1960s ... some animals or people who received the vaccine and were later exposed to the virus developed more severe disease than those who had not been

- *vaccinated*. <sup>6</sup> Scientists are particularly concerned that a vaccine may negatively affect old people. Vaccines are a risk.
- One theory as to why some healthy young people got severe Covid-19 symptoms when most do not is that they were vaccinated for the flu and ADE<sup>7</sup> resulted.
- Throughout history nature has ensured that mankind has naturally survived all respiratory diseases.

## **Hospitals**

- The media presents pictures of hospitals being overwhelmed and the need to set up medical wards in tents in parks.
- Videos have been appearing (until they are deleted) showing that hospitals are empty; A and E wards are empty, car parks are empty. This should not surprise us since all sorts of accidents and traumas will have virtually ceased. Most roads are empty, there are fewer (if any) RTAs and other sorts of emergencies are reduced since people are indoors. Admissions will now be mostly chronic conditions worsening (such as heart disease) or sepsis or trauma etc.
- Hospital beds are four times emptier than normal. Tens of thousands of beds remain unoccupied. Figures from the HSJ showed that 40.9% (37,500 beds) of NHS general acute beds were unoccupied as of 12 April. The new Nightingale Hospital built in Tyne and Wear may never be used.<sup>8</sup>
- A NHS whistleblower report from Northern Ireland stated that there had been only two deaths in the Altnagalvin area (pop. 200,000), being old people with other issues. A doctor said that only 5 out of 16 ICU beds were being used at that time. No one was on a ventilator and doctors were standing about using their mobile 'phones.<sup>9</sup>
- A NHS whistleblower report from major hospital in London said that it was not being overrun.<sup>10</sup>
- Multiple videos emerged showing that, far from being busy, nurses had time to plan and stage flash-mob dance routines in hospital corridors. These involved many nurses and ancillary staff, possibly including doctors, sometimes in long lines. When there is supposed to be a national hospital crisis, it is sickening to see hospital staff, laughing, joking and dancing in corridors. Yet there were many examples of this.<sup>11</sup>
- An ICU doctor was interviewed on Newsnight stating that normally he would see at least one sepsis patient every day; now there are none at all. This means, as others have stated, that very sick people are so scared by the media that they are not going to hospital when they need to. This will mean that many people died unnecessarily as a direct result of the fear-mongering. Someone needs to be accountable.
- Doctors warned that cutbacks to cancer treatment (in favour of treating Covid-19 patients) could cause 60,000 premature deaths. This would be many times higher than Covid-19 deaths. Add to this many other ailments that are not being treated (like Sepsis) and the death toll caused by the lockdown will be greatly more costly in deaths than the virus.<sup>12</sup>

- Hospital procedures are working to presume that patients have Covid-19 unless there is a good reason not to. Nurses are complaining that figures are being manipulated and inflated to make the virus seem worse. Whistleblowers are claiming that treatment of patients is being compromised. Front line staff are being pressurised to follow the management line blaming Covid-19. Patients that were in hospice care homes (i.e. already dying of some disease) were classified as dying from Covid-19.
- In America hospitals are paid \$13,000 for each Covid-19 diagnosis. They are also paid \$26,000 for each patient treated with a ventilator. Senator Scott Jensen (who is also a doctor) averred on Fox News that the American Medical Association is encouraging doctors to over-exaggerate the virus deaths.
- As many as 80% can die from the invasive treatment of ventilators while the hospitals make money. Studies show that in Wuhan 37 critically sick patients were put on ventilators but 30 died within weeks. In Seattle the same story emerged. Seven patients aged over 70 were put on ventilators; only one survived. As I explained previously, ventilators can collapse the lungs of patients or spread bacteria to damaged lung linings. Too much oxygen pressure can also collapse the lungs. Older people who are weaker can die from the hospital treatment. Note that Boris Johnson was not put on a ventilator but on oxygen and left the hospital days later. The fact is that doctors are not certain how to treat Covid-19 (which reduces oxygen levels in the blood) and their methods may be wrong. Forcing air at pressure into the lungs which have been damaged by the virus or bacteria (such as viscous fluid in air sacs) ruins the lungs because the air sacs don't work. Doctors in China realised that sick patients only need a nasal cannula.
- Dr Cameron Kyle-Sidell of New York<sup>14</sup> has affirmed from his experience of treating Covid-19 that ventilators may be harming people. He believes that doctors are treating the wrong symptoms. Covid-19 is not a normal pneumonia but oxygen deprivation. The virus is not a respiratory disease but blood-oxygen deprivation; it is not ARDS (acute respiratory disease syndrome). Patient's muscles work fine (ventilators are brought in when patients are too tired for muscles to work) but they need more oxygen.
- In America all preventative care is being shut down. This makes sick people sicker.
- Donor services have been shut down. People could die because of this.
- Face to face consultations have been shut down. This potentially makes sick people more at risk as early signs of a problem are ignored.
- The stress caused by Covid-19 panic is causing a great deal of sickness. Cortisol, created in the body by stress, weakens the immune system.

#### **Death stats**

- The registry of deaths reported figures for the first three months in the UK revealing that the number of deaths is **less** than usual.<sup>15</sup>
- It also appears that the average number of deaths by pneumonia is less than normal and the remainder is being attributed to Covid-19.
- Even the BBC had to revise publications from previous fear-mongering to showing graphs revealing that **current death rates are lower than normal.**<sup>16</sup> They also

- quoted a scientist stating that the people claimed to have died from Covid-19 would have died anyway.<sup>17</sup>
- Reports from Italy also show that, 'the total deaths at the Treviso hospitals in the first three months of 2020 is in line with that of previous years. The data is incontrovertible.' 18
- In America it was reported that the death statistics are being manipulated to inflate the number. It has been stated that probably the real figure is 1% of what the government affirm. Another study affirmed that the death rate was 0.1% (comparable with seasonal flu).<sup>19</sup>
- The ONS studied 4,000 deaths during March in England and Wales where coronavirus was mentioned on the death certificate. It found that 91% of cases had underlying health problems, notably: heart disease, dementia and respiratory illness. People dying had an average of three medical conditions.
- 511,000 Brits die every year; 1400 every day. By early April it was claimed that 6,000 or so had died from Covid-19; at the end possibly 20,000 may die (though the number will be inflated). This is less than a bad flu season.
- Globally, 75 million people die every year. So far in early April, claimed Covid-19 deaths are less than 60,000.20
- On current statistics, your chance of dying from Covid-19 in Britain is 0.0005%. The global figure is 0.00000005%.
- 12 million die from starvation every year why not fix that?

### Countries not on lockdown

- Countries that did not introduce a lockdown are faring better than those who did.
- Statically, non-lockdown countries had a large rise in cases that passed very quickly. Lockdowned countries kept the epidemic going longer.
- Chad (Africa) has had no deaths at all.
- Sweden only has 373 deaths at early April. You are statistically twice as likely to die from the virus in Britain as Sweden, which is not in lockdown.
- Mexico and most of South America are not locked down. Mexico only had about 125 deaths by 31 March. [Strangely it then instituted a lockdown in mid April.]
- Iceland has no lockdown. 3 had died of the virus by 31 March, one was from Australia.
- Taiwan has no lockdown and is faring better than the UK.
- Japan had no lockdown. By 9 April it registered 94 deaths from the virus.
- Denmark had a less severe lockdown (e.g. shops were open) and is now cancelling it.

#### **Testing**

- The media constantly bangs on about testing issues to distract from the truth.
- **There is no test for Covid-19 yet**. The usual PRC test is for pneumonia. If you had flu within the last two years, you will test positive for this test. Thus normal flu and pneumonia deaths are being attributed to Covid-19.
- Some specialists are saying that only 12% of Covid-19 deaths are actually from Covid-19.21 Since no test is available the death stats are pure guesswork.

- The media blows up statistics. One claim that 40 doctors died treating patients was later amended to reveal that they were all over 65, many were 80.<sup>22</sup>
- Testing is pointless. Testing for people who are infectious have already spread the disease to thousands of people. Testing cannot stop the spread of the disease.
- Many people who were tested negative later were tested positive.

### The panic merchants

Imperial College London, the body that has been most responsible for convincing the government that a lockdown is necessary, received \$209 million in 15 years from the Bill and Melinda Gates Foundation. Gates wants mandatory universal vaccination and wants to dramatically reduce the global population. He is also pushing for mandatory immunity passports (you cannot get anything, e.g. a driving licence, unless you have been vaccinated).

### The real problem

I explained in my last paper that Public Health England and the ACDP reclassified Covid-19 from being a High Consequence Infectious Disease to one with low mortality and less serious.

The real problem is the suppressed immune system of most modern people living in the West. In Chad, which has no deaths from Covid-19 and few cases, the people eat basic foods, such as roots and they get plenty of vitamin D from prolonged periods in the sunshine.

People with a strong immune system can fend off C-19 very easily. But western lifestyles, where people eat bucket-loads of sugar, high fructose corn syrup, table salt, GM food, additives and processed foods, is causing immune systems to be severely depleted and unable to cope with stress. Doctors do not understand the immune system properly and know nothing about nutrition. With faulty treatment, one-third of the immune system goes into overdrive and attacks the cells of the body, creating auto-immune diseases. Many such diseases (such as Lupus) are caused by hospital treatment.

Viral treatment must complement the immune system and focus upon intravenous vitamins A, B, C and D, plus other measures such as zinc with cypress oil. (Zinc on its own is excreted. Zinc requires a transport agent to get it to cells.) Forcing people indoors with no access to the suddenly plentiful sunshine is ridiculous.

#### Health issues<sup>23</sup>

- Covid-19 death rate: the WHO claimed that it was 3.4%, which is exceedingly high. A study in Nature Medicine affirmed that it was really 1.4%, which is more in line with influenza.<sup>24</sup> With many cases being unreported and only mild symptoms, it is certain that the rate is even lower.
- 99% of Italy's deaths from Covid-19 occurred in people with underlying medical conditions (and being elderly). Only three people died that had no underlying conditions. These issues included hypertension (high blood pressure), diabetes, obesity

and heart disease. The average age of those who died was 80. Everyone under 40 who died had serious health issues. Multiple other studies confirm this trend.<sup>25</sup>

- Researchers from Basel found that ACE inhibitors, ARBs (treatments for hypertension) and Ibuprofen aids Covid-19 to enter cells and multiply.<sup>26</sup>
- A key health issue underlying these diseases is insulin resistance caused by a highcarbohydrate, processed food diet. It contributes to these diseases and also impairs the immune system.

### The economy

Economists posit that the government has destroyed one-third of the British economy. Even before the lockdown has ended, they are positing the worst economic recession in 300 years.

Britain has spent £1.6 trillion because of a few thousand deaths from a virus officially deemed not serious. The number of deaths is much less than a bad flu season.

The USA has already spent \$2 trillion on social distancing. By 16 April 20 million people had been made unemployed in four weeks.

The International Labour Organisation has warned that the lockdown will destroy 195 million jobs globally and also reduce the income of another 1.25 billion people.

Coronavirus pandemic has delivered the fastest, deepest, economic shock in history.<sup>27</sup>

### Unemployment

Economists fear that unemployment could reach 10% by the end of the lockdown, which is higher than in many decades. Already two million UK people are registered unemployed.

All sorts of people have been dramatically damaged by this quarantine, but mostly low-paid workers. In some cases people have lost their jobs and their homes at the same time, such as hotel workers that lived in the hotel. Some of these were literally turned out into the streets when the hotels were forced to close.

If certain businesses fall that are not being fully considered at this time (such as haulage) then the unemployment and economic effects could be catastrophic.

### **Food production**

We are triggering a future crisis in food production.

The lockdown has severed the supply chain that is necessary for the distribution of all sorts of farming produce to purchasers, such as restaurants, cafes, pubs, bars, clubs etc. This means that food is literally rotting in the fields.

I have seen videos of a farmer in America bewailing his fields containing millions of rotting onions. Dairy farmers have been forced to dump milk. Butchers, e.g. in New Zealand, have been forced to dump meat.

More worryingly, farmers in America, such as small dairy farmers, have received letters telling them to quit production completely. Presumably this is paving the way for Big Aggro corporations to take over all farming, which is an elite objective.

Bill Gates is also working (as Monsanto has already done) patenting seeds. This is to ensure the global elite take-over of all seeds so that only GM crops will be produced and all agriculture becomes reliant on global corporations.

At a local level, the mass hoarding of panic buyers has now led to a post-panic glut. This means that lots of fresh food is now being dumped, such as fresh bread, because hoarders have filled their stores.

### The haulage industry

The haulage industry is a vital piece of the country's infrastructure. As a result of the lockdown the haulage industry, which is normal vital for the continuance of everyday life, is on the verge of complete collapse.<sup>28</sup>

No provision has been made by the government to alleviate the crisis that the industry is in. It is a complete mistake. The government has put at risk the entire economic infrastructure of the UK, which depends on the distribution of goods.

The Road Haulage Industry [RHA] reports that 46% of lorries have been taken off the road. There is no longer any haulage of bricks, furniture, clothes, conference materials, concert gear etc. There are no aircraft landing at airports that need goods removed and transported by lorries. Container traffic has also dropped. The only traffic is basic food items from distribution centres to supermarkets and medical supplies.

The chief of the RHA recently warned that many haulage firms are in danger of going out of business permanently, explaining that government relief measures do not work. There is no cash flow to furlough employees.

In addition, all of the motorway services have been shut down so that drivers no longer have anywhere to eat or go to the toilet.

If this business does collapse it will have an impact on food distribution and other goods. Without an effective haulage industry, there is no chance of any sort of economic recovery. When this is realised by the public, there will be a massive backlash against the government as normal life collapses.

#### **Democracy**

- The lockdown is contrary to the British Constitution and is thus illegal.
- The Coronavirus Act, rushed through Parliament in a week, consists of 330 pages of draconian measures. This could not have been produced in days; such an act would normally take weeks or months to develop. This means that the act was already prepared waiting for an opportunity. This is part of a bigger undemocratic plan.
- The act states that some of the clauses will never be repealed.
- The Coronavirus Act has been likened to Adolph Hitler's Enabling Act of 1933, which overrode the German constitution and eventually paved the way for fascism.
- Politicians are working against the people.

- Democratic western nations have only had real freedom for about 200 years or so; some European nations only for a few decades. In this crisis we are in great danger of losing liberty forever.
- British MPs were awarded £10,000 in extra expenses to cope with isolation (i.e. to use Skype, which is free) while working class people lost their jobs. After this their salaries were increased above the inflation rate.

#### Police overreaction

- Police are everywhere overreaching their authority above the level of the Coronavirus Act.
- Northampton police chief constable Nick Adderley warned that the police would set up roadblocks and check what people purchase in supermarkets if the public did not follow social distancing.
- Other police have cordoned off park benches and deter people from sitting in the sun!!!
- Several police officers broke into a man's house, smashing a door in, to check that he was not having a social gathering.<sup>29</sup>
- Police fined a UK shopper for buying wine and snacks claiming that these were not essential items.<sup>30</sup> Several other people reported also being fined for this new 'offence'.
- A nurse in uniform in West Lothian was fined £50 after leaving a patient's house.31
- One police force bragged that its officers may be 'hiding in the shadows' to catch people who were having picnics in rural areas.
- A London resident was fined for taking his dog for a walk, which is acceptable under the new law.
- A woman who had just walked her dog and was about to buy groceries for her aged mother was fined.
- Priti Patel has had to slap down the police warning that they are going beyond government guidance.

- All over the country the police utterly failed to protect young girls from being predated on by Pakistani rape gangs and failed to prosecute rapists, despite clear evidence, for many years. Yet they are assiduous in stopping people sitting on park benches or walking on beaches.
- If you thought that Britain could never descend into a police state like the Stasi or Gestapo, think again. Within a couple of weeks of a fake emergency the police have behaved like Gestapo all over the country from the north of Scotland to London.
- In Germany a female medical lawyer (Beate Bahner) who criticised the lockdown as illegal was arrested and taken to a psychiatric ward where she says she was violently abused and allowed no toilet facilities or bed.<sup>32</sup>

#### **Bank bailouts**

- The corrupt Ponzi-scheme banking system is close to collapse and an economic crisis is overdue.
- Many big banks are actually bankrupt and in huge debt; Deutsche Bank is just one example.
- As a result of the virus the USA has printed \$6 trillion and given it to the banks.
- The ECB has printed 1.8 trillion Euros.
- The UK has given the banks £321 billion.
- Through the virus, wealth has been transferred from taxpayers to the bankers, from the poor to the rich.
- Pension values will now be halved or worse.

#### The WHO

- President Trump announced on 15 April that the US would be de-funding the WHO for its incompetence in dealing with the epidemic.
- The WHO blocked doctors from urging border controls to stop the spread of the virus. This definitely cost many lives (Russia closed its borders on 31 January and has had no major epidemic thus far). Medical experts pushed for this but were silenced.<sup>33</sup>
- It also campaigned against profiling international travellers to stop potentially infected Chinese carriers to avoid stigmatising Chinese people.
- It initially wrongfully claimed that the virus could not be transmitted from person to person.
- It resisted travel restrictions on countries that were experiencing the virus until March.
- New York's record level of virus victims was due to open borders from European nations.
- The WHO receives funding from Bill Gates' foundation. Gates is an ardent depopulation activist whose vaccination experiments in various parts of the world have killed and injured tens of thousands of people, mostly women and children

#### **Miscellaneous**

• Evidence of media manipulation: an image of the same boy has been used as the youngest virus victim in the UK, Portugal and Belgium. In actual fact the image is of a boy that died in Ireland in 2017.<sup>34</sup>

- Dr Thomas Cowan, in a lecture at the Health and Human Rights Summit in Tucson, made a connection between 5G rollout and Covid-19 hotspots (for example Wuhan and Milan, New York). He posits that 5G damages the immune function and makes people more prone to infection.
- The government is arranging chartered planes to bring over low-skilled workers from Romania and other nations to pick fruit and veg. The only health checks are taking temperatures and filling in a form. Since Covid-19 infected people can incubate the disease for up to 30 days they can be infectious while showing no fever. This policy contradicts the massive quarantine of British people and introduces the danger of fresh infections of new strains. It is insane. Why not arrange coaches and accommodation for Brits freshly out of work?

# The global elite strategy

There are multiple strands to the globalist objectives and I have explained many of them before. Some key issues for them are:

- Keep the people in fear.
- Keep the people poor and in debt.
- Keep the people reliant upon state handouts.
- Keep the people watching television as much as possible. This is the Soma of the modern age.<sup>35</sup>
- Keep people isolated.
- Stop people from being spiritual and especially from hearing the Gospel.

Usually the strategy is by slow incremental progress over decades, but occasionally the elite initiates a sudden sharp shock that instigates severe changes in a short time. 9/11 was one of these cases; the lockdown is another.

Through the lockdown and the virus panic we see:

- The people are in deep fear.
- Millions of people are suddenly becoming poor and bankrupt.
- These are reliant upon state benefits and government loans.
- Being in lockdown, most people do little but watch television.
- People are more isolated then ever before and are satisfied with proxy social fellowship via a computer.
- The lockdown has closed churches and stopped even private fellowship in homes.

What the lockdown does is to acclimatise people to vast social changes so that when draconian measures are later taken permanently (for claimed health reasons), nobody protests. Without 9/11 there could not have been the Patriot Act or Homeland Security.

Possible expectations following the end of the lockdown may include:

- Keeping social distancing for a long period of time.
- Instating new health protocols, such as wearing masks at work.

- Mandatory vaccinations in order to be able to be part of society. Medical passports.
- Institution of global cashless transactions; perhaps based on a microchip.
- Generating constant fear of a new pandemic; there will be flurries of new epidemics here and there.
- Destruction of small businesses and enlarging global corporations.
- Increased reliance upon on-line shopping.
- Destruction of local independent farming businesses.
- Calls for a global currency, a global tax system and a global health care governance. The latter would have the power to force entire countries to lockdown on the basis of some scare. The precedent has been set.

All these are part of the plan to get people to be good consumers and enjoy their oppression by the upper class of globalists.

The elite already control: the banks, the finance houses, the government, the media, the education system, 99% of corporations, the healthcare system and most food production. They now want to control you; your freedom of movement, freedom of assembly, freedom of worship and get rid of the little of what's left of free speech. The stage will then be set to institute a feudal state with you as a slave and them as lords.

## The need of a public enquiry

There needs to be a public enquiry into the institution of a lockdown for these reasons:

- The lockdown is illegal and treasonous. It is contrary to the British Constitution; from the Magna Carta onwards. [The government cannot act against Common Law and cannot imprison citizens without evidence of a crime. It cannot ban free assembly or freedom to roam, freedom to worship or freedom to pursue vital employment.]
- The lockdown is an unprecedented confinement of the British people.
- The lockdown did huge amounts of damage to the old, weak, sick, depressed, anxious, poor and vulnerable. It will likely cause more deaths than Covid-19.
- The lockdown went against the advice of the world's top epidemiologists and virologists. It made the epidemic worse.
- The lockdown damaged small businesses, bankrupted many firms, and caused financial hardship, especially to low-paid workers.
- The lockdown has severely damaged the UK economy and cost the country trillions of pounds.
- The poorly qualified advisors that demanded a lockdown need to be investigated and penalised.
- Government ministers need to be held accountable.
- The media need to be investigated for its fear-mongering that caused mass-hysteria.
- The police need to be investigated for usurping powers they do not have.
- The truth about the effects of Covid-19, i.e. that it was less severe than a bad flu season, need to come out and the public be informed.

## The church needs to change and prepare

What does the church do in the face of recent unprecedented events?

The Devil is clearly accelerating his strategies to produce a global fascist state, as prophesied by Revelation 13 and 17. Never before has Britain initiated a lockdown in such a manner that even worship services were shut down.<sup>36</sup> The time is now ripe from Christians to understand the depth of the attack on Christianity and how to cope with it. We are approaching times that are parallel to those of the early church under the ten persecutions of Roman imperial fascism. The church must start being radically Biblical.

### Stop unbiblical nonsense

The church must abandon all the worldly and fleshly accretions that it has long established. These include:

- A focus upon money.
- Reliance upon marketing and publicity strategies.
- Seeking a prominent place in society.
- Having a complex administration system.
- Relying upon charitable status.
- Relying upon dedicated buildings.
- Having large public services, large leadership hierarchies and large memberships.
- Large instrumental bands.

### Adopt the Biblical principles used in the early church

- Establish small churches not more than around 30 people.
- Abandon leadership hierarchies. Establish multiple elders to cater for multiple small churches. These do not need to be salaried or full-time. Two elders that have jobs can easily lead a small church well. I have led a church of 30 people (teaching three times a week) while working 12-14-hour days in secular employment.
- The church must now only meet privately in homes under the radar of the state.
- Abandon all instrumental music. Worship must be vocal only; singing must be a cappella.

### Prepare for persecution

The church needs to establish a Biblical deaconship.

Hard times are going to come, perhaps sooner than we think. Local churches need to prepare in every possible way to alleviate the inevitable suffering that will come, mainly through hardship. This is the work of deacons.

The giving of the saints must be directed to storing up for the poor and needy. This needs to be started now.

• Start a financial fund that is safe (do not trust banks). This fund must have sufficient reserves to pay for whatever is needed in privation (such as saints losing their home, having no food etc.). Build up stocks of silver – which will always be usable when

money or financial systems fail. Gold and platinum will hold their value also but they are not liquid; you cannot use a gold bar to buy a loaf of bread.

- Start a reserve food bank of long-lasting food. Saints with large properties or outhouses can store this. Encourage the saints to all do this at home as well as much as possible. Never be without large reserves of food.
- Keep a large store of Bibles and good theological books; again rich people can keep them in their properties. A time will come when Bibles and Christian books are banned. Be prepared.
- Set up a network system to aid your church and others locally. For example, keep a roster of people that can repair appliances, fix plumbing or electrics etc.
- Teach saints to become self-sufficient: to grow their own fruit and vegetables, learn how to sew and knit, keep necessary building tools and materials in stock for all to share.
- Saints with large homes should prepare rooms that can be used to house believers on the run at short notice.

### The church must go underground now

Since the Charismatic Movement started in the 60s, the church has not only apostatised more and more but has also sought local prominence and acceptability. Church leaders have become accepted pillars in the secular community. Services became centred on outsiders. Church buildings are even rented out to local councils for various usages. All this must stop.

As in the early church (which often met in catacombs and caves) the future church must go underground. The church has always been a mystery to the world and now it must be a mystery in literal terms. The church must meet in secret in homes as quietly as possible. Growth must be cellular – by planting new home churches after a larger church divides in two. Evangelism must be personal not corporate. All large churches must disband and divide into multiple congregations if they are to survive. The quicker they do this, the more likely the membership will continue.

#### Conclusion

All this may seem extreme and pessimistic to some, but that is foolish. The church has had to act like this many times in history in multiple nations; it is nothing new. Church history has seen more persecutions than peace, even in recent years. It is just parts of the west that has had a period of stability since the 17<sup>th</sup> century. Christians are being persecuted to death in many countries right this very moment.

In fact, my proposals are nothing but what the church should have been already doing for hundreds of years. The church has not been faithful to God in its development of church life. But now circumstances demand that we act Biblically because the time is clearly short; the satanic inspired elite have shown their hand by instituting global lockdown.

None of this is negative. In fact it should encourage joy as it means that the return of the Saviour is close at hand. In fact, decentralising and localising churches will produce a spring of joy and edification as local churches begin to fellowship properly for the first time, relying upon mutual edification instead of centralised formality and domination by one man.

Obeying Biblical principles is never a problem; it is always liberating. None of my suggestions are unbiblical.

## Conclusion

As I stated in the introduction, this is only a small sample of the suffering that is currently being caused by the lockdown. We could look at those whose businesses have gone bankrupt, or those who have entered into huge debts for no fault of their own. We could consider the massive economic damage we have inflicted upon the country, which will last decades. We could imagine the massive flood of mental health suffering that is being unleashed upon the nation that does not have the capacity to deal with it. We could think of those trapped in abusive situations at home who cannot escape.

The enormity of emotional, mental and physical suffering this lockdown is creating is beyond the scope of one writer. We must call for a public enquiry into this to examine the enormity of self-inflicted damage and determine who must pay. Certainly medical scientists using erroneous computer modelling should be prime candidates. But the fear-mongering media should also be taken to task; the level of scaremongering has been unprecedented – and this has driven politicians into questionable action.

But most important is that this is a wake-up call for the church. It is time for the church to abandon all its accretions of fleshly nonsense and get back to obeying Biblical principles. Churches must again become house churches and act like salt in the world – thinly spread about and hidden.

## **Appendix**

# A summary of Covid-19 known facts up to mid April 2020

#### The virus

- SARS-Covid-2 is a novel type of virus.
- It is a coronavirus. This is a group of viruses that have spikes on the cell wall that look like a crown. Coronaviruses include colds and influenza (there are many strains).
- The genome of SARS-Covid-2 is unusual and not wild. It is a combination of SARS with bacteria. This means that it is most likely bio-engineered.
- There appears to be more than one strain of SARS-Covid-2. Two have been identified in one man in Iceland, while some aver that there are over eight different strains. One strain is mild while another is severe.
- The disease caused by SARS-Covid-2 is called Covid-19.
- There are claims that SARS-Covid-2 discriminates against Black people especially. Whether this is due to environmental conditions in society (where they are more susceptible to infection) or an aspect of the genome is unknown. It is known that vaccination programmes have been found to have a sterilising effect on Black people.

#### **Effects of Covid-19**

- On the 19 March 2020 Public Health UK (four nations) and other bodies, reclassified Covid-19 as **not** highly dangerous. This was days before the lockdown was introduced.
- Covid-19 effects on young healthy people with a strong immune system are usually mild. Indeed many may not even know they have experienced it.
- Its effects on the old and those with underlying conditions, (such as: heart disease, renal disease, respiratory disease, hypertension, diabetes and obesity) could be fatal.
- Epidemiologists mostly compare the effects to influenza, though some aspects are unusual (such as a dry cough instead of a mucous cough). It chiefly seems to cause oxygen deprivation resulting in a struggle to breathe.
- Where it damages the lining of the lungs, bacteria can reproduce in this environment causing pneumonia. In hospitals, bacteria can be transmitted via treatments, including ventilators. Ventilators are invasive and severely damage at least 30% of patients and can cause lung collapse.
- The fatality rate appears to be less than 1%; some experts say 1.4%. The WHO claim of 3.4% has been discredited. Covid-19 fatalities in Britain and Italy (even with inflated figures) are less than a bad flu season, so far. The UK Registry reports that the death rate for the first three months of 2020 show less than normal fatalities.

#### Good and bad treatments

- Prescribing anti-viral drugs can do damage as several reduce iron levels, but the virus also collapses iron levels. These could be fatal for anaemic patients.
- Ibuprofen, ACE inhibitors and ARBs aid the virus to reproduce.
- Where lungs have been damaged, ventilators and increased air pressure oxygen masks can cause the lungs to collapse. This treatment can do more damage than the disease.
- Known effective treatments include intravenous vitamin C, B1, D, zinc (with a carrier like cypress oil), and ozone. These are not used by the NHS. They were used successfully in China, which shipped 50 tons of vitamin C to Hubei province in early February.

### Mass hysteria

• The media stage-managed a massive panic by constant fear-mongering reporting that dominated the airwaves.

### Situation in hospitals

- Reporting on the effect in hospitals was biased and censored. Media reports showed a serious crisis with overwhelmed wards. In fact, data, videos and whistleblower testimony showed that, while some aspects of some hospitals were stressed (e.g. respiratory wards, ICUs), most aspects of most hospitals had empty beds and staff with little to do. With normal treatments and clinics cancelled (due to the lockdown and isolation), plus fewer accidents and traumas, many departments had less work than normal.
- Reporting by hospitals of fatalities from Covid-19 were claimed to be highly inflated by whistleblowers. Patients dying from several causes were claimed to be from Covid-19.

### **Testing**

- There is no specific test for Covid-19 yet. The current test in use merely tests for any coronavirus. A recent flu infection will give a positive result, for example.
- The tests used are very flawed. Many do not work effectively, some from China don't
  work at all and some give false positive/negative results. Tests cannot identify the
  number of coronavirus cells in the body.
- There is no point in testing anyway. No test stops infections or reduces fatalities. Many medics were tested as being safe to work in a hospital but then succumbed to the disease only days later. Since there is no specific test for Covid-19, testing medics to allow them back to work is pointless.
- Emirates airlines has started mandatory tests for Covid-19.

## **Defeating the virus**

- The only solution to a virus epidemic is achieving herd immunity, say about 80% of the population. Since the young only have mild symptoms, schools should remain open to enable herd immunity to develop. Only the elderly and vulnerable should be contained. Once herd immunity is achieved, the virus has nowhere to go and dies out. This is why the flu season only lasts during winter months. Sunshine boosts immunity by creating vitamin D in the body.
- Top epidemiologists and virologists affirm that a lockdown makes virus epidemics worse and last longer.
- The experience of nations that did not effect a lockdown proves that the epidemic quickly increases and then dies down fast. Nations on lockdown saw the epidemic last much longer.
- Long before the lockdown, Britain was likely to have had more than half of the population exposed to the virus anyway. Many people (including this writer) stated that they had had all the signs and symptoms of Covid-19 in December before Christmas. These include: flu-like symptoms, breathing difficulties, a severe dry cough that lasted three weeks, fever, crashed iron levels, crashed platelet levels and raised Ferritin levels. In China, data shows that the epidemic had peaked before the lockdown was introduced.

#### The lockdown

• The lockdown is unprecedented in British history (even worse than WWII curfews) and is un-constitutional and therefore illegal and treasonous.

- Many nations did not institute a lockdown and fared better than the UK. These include: Japan, Sweden, Belarus, Iceland and others. Some countries, like Denmark, only advocated social distancing but did not impose a full lockdown. They also ended this before Britain closed its lockdown.
- The scientific advice for Britain to effect a lockdown came from the discredited Imperial College London, and especially the very discredited Professor Neil Ferguson. Ferguson's past mistakes included the unnecessary killing of millions of cows, sheep and pigs in the Foot and Mouth crisis and claiming hundreds of thousands would be killed by Mad Cow Disease effects (CJD, 200 died). He initially claimed that over 500,000 Brits would die of Covid-19. The worst is over and it is less than 12,000 so far.
- The lockdown has severely damaged the UK economy with effects that will last years. A Depression has already begun. Trillions of pounds have been wasted. Many small businesses are ruined.
- The lockdown cut the supply chain for farmers. As a result food is rotting in the fields, milk and meat are being dumped. This bodes badly for food resources later in the year.
- The lockdown discriminated against the elderly, weak, poor and vulnerable in particular. Some people faced starvation or malnutrition due to food shortages. It has led to many suicides and cases of mental illness already.
- The nation was not prepared for panic buying by selfish hoarders. Not enough was done to protect the elderly, poor, weak and vulnerable. The government list of very vulnerable people was woefully inadequate and should have been much longer. For example, renal patients and diabetics were at high risk.
- The cancellation of operations, scans, treatment and consultations was also detrimental to the old and sick. This will create a massive back up of replacement scheduled appointments that will further damage the NHS and patients. Some will die as a direct result. For example, cancer patients have had vital operations cancelled (such as brain surgery to remove tumours).
- There needs to be an enquiry into the overreach of powers by the Police far beyond the provisions of the *Coronavirus Act*, such as claiming to be able to check supermarket purchases, effect road-blocks, cordon-off park benches or shame dog-walkers in common land by using drones. Officers usurping such powers should be disciplined.
