

It's not about a virus

What is it about?

Introduction

Only someone with their head buried in the sand could possibly believe that the rampant totalitarianism rolled out in the last 18 months has anything to do with an infectious disease.

Society has been turned upside down. Australia has become a police state with more restrictions than North Korea or China. New Zealand is being led by a fascist. Both these nations have had very few deaths from so called Covid-19.

The freest nations in the world are currently Russia and Taliban Afghanistan, which are not mandating vaccines or vaccine passports. 27 US states are suing the federal government over vaccine mandates.

The developed world has seen unprecedented social restrictions. It has also seen the genocide of the old and vulnerable resulting from government policies; such as sending infected people into care homes. The elderly are also being killed off by care pathways that slowly kill them with morphine and Midazolam. Patients in western hospitals are still being denied known cures for Covid-19 but are given treatment that kills them instead (such as morphine, Remdesivir or intubation, or all three). In many hospitals nursing care has collapsed.

A generation of kids have had their education and their lives ruined. Psychologists are now saying that they will be permanently mentally damaged by what they have been forced to submit to. Many have committed suicide. We know that kids are at virtually no risk from Covid, yet a vaccine programme is being forced upon them which poses huge known risks, such as myocarditis. How can that possibly make any sense? When the JCVI would not recommend vaccinating 12-15-year olds, the government overrode them and had already planned and given jobs to implement the programme – clearly the best interests of child safety is not in the government's mind. Teenage boys are six times more likely to suffer heart problems from vaccines than to be hospitalised by Covid.¹

Vaccine passports are being enforced by various measures; currently being required at large venues and night-clubs. In France, Israel and other places you need a vaccine certificate to buy food.

We could continue in this vein for a long time.

Yet Covid is currently 26th in line as the most dangerous pathogen. Multiple diseases (which we live with quite happily) are far more dangerous.

It is not about a virus. I say again; it is not about a virus; that is plain to see.

So, what is the purpose of all this?

Why is all this happening?

Now I have explained the list of things many times. These are plans of the global elite and they are, at least in part, being worked out in this Covid crisis scare panic. These goals include:

- **Depopulation.** [At the date of writing, if you ask Alexa the current UK population it says 67.8 million. If you then ask what is the predicted population in 2025 it says 22 million. Why?]
- **Global individual surveillance** through a biomarker ID in vaccines.
- **Eugenic measures**, such as sterility programmes.
- **Transhumanism.** [The hybridisation of people with digital technology.]
- **Technocracy.** [The rule by a small cabal mediated through technology.]
- **AI / Internet of Things / 5G.** [Enables the Internet of Things.]

These are being enacted to some degree but there is a more pressing issue for the elite.

It's about the vaccine rollout

It is obvious that all that has happened in the Covid crisis leads to the vaccine rollout. This is really why this has been going on. Again, only a fool could fail to see that.

I have explained that the vaccine does not work; this is easily proven by looking at Israel.

Israel is one of the most highly vaccinated places in the world. Most of the population has now had two or even three jabs. Yet the more they vaccinate, the worse the infection cases rise. Israel is currently in a major surge of Covid hospitalisations, worse than ever and the worst in the world. The trend for the Covid surge directly parallels the trend of the vaccine roll out. So the vaccines have not only not worked, they have made things worse. This pattern is being repeated everywhere (e.g. Singapore, Montenegro etc.). British undertakers have reported that deaths have skyrocketed since the vaccine rollout.

In comparison, Uttar Pradesh in India has completely eradicated Covid and has declared that it is free of the virus. It did this with Ivermectin.

Now multiple doctors and scientists have explained why there is a Covid surge. It is due to several issues, but mainly the mRNA / spike protein in the vaccine which makes the body produce this deadly protein in every cell. As it progresses in the body it not only ruins the immune system (hence people catch Covid more easily, especially through ADE) but it also starts eating away at every organ and damages the blood vessels. The first US autopsy of a vaccinated man who died from Covid showed that the spike protein had damaged every major organ. The vaccine also creates the variants. To fight the vaccine, the virus mutates as a self-defence mechanism. This is why there has never been a successful coronavirus vaccine in history.

The spike protein is deadly; it is a pathogen. The vaccine makes your body a spike protein factory. Hence vaccinated people are filling hospitals.

In addition, many people are dying from blood clots because the first part of the body to suffer from the spike protein is the blood system. The spike protein causes damage to the interior lining of the blood vessels, thence inflammation and clotting. The clots, depending where they are, cause strokes, heart attacks and thrombosis.

This was a mistake made by the elite. They did not intend for there to be so many adverse reactions, which is why they are desperately trying to cover up the truth. Governments all over the world are hiding the deadly effect of the vaccines but the data keeps rolling in. Hundreds of thousands have died already, yet they keep pushing the vaccines.

Sweden and Denmark are control cases. In these nations life has returned to normal while Sweden never imposed mandatory lockdowns, yet even the Delta variant is not troubling them as excess deaths are lower than average. There is no Covid surge and herd immunity gained from an open society is dealing with the variants. Vaccines are not necessary to get herd immunity.²

Everything is about pushing the vaccine. If one jab doesn't work, get two jabs, then three jabs, then four jabs, then booster jabs on top. Some authorities are already saying that people will need to be jabbed every five months forever.

It's all about the vaccine programme, even though it is killing many thousands.

Under normal circumstances the vaccines would have been stopped. The decades old polio vaccine was terminated after 27 people died. In the Swine Flu panic, the rushed vaccine was terminated after it killed 47 people noted in the reporting systems. To date hundreds of thousands of people have been killed by the Covid vaccine.³

The vaccines have no effect in controlling this virus; note:

- Unvaccinated people under 50 are less likely to die of Covid than vaccinated people.
- People that are vaccinated and unvaccinated have the same viral load.
- Vaccines do not stop people catching the virus.
- The vaccines do not stop people transmitting the virus.
- The vaccines are ineffective against the Delta variant.

Thus there is no epidemiological, medical or scientific reason for a vaccine passport. It simply cannot be justified whatsoever. It is not about a virus.

Despite this, and the government knows this data, vaccines are being pushed harder and harder, to lower and lower ages, with sanctions and restrictions. One university in America (Rutgers) has already restricted unvaccinated students from even watching zoom distant tutorials.

What is the vaccine programme going to deliver?

Why this insane push for vaccines even when there is overwhelming evidence (being hidden for the moment) that they don't work and cause sickness and death?

It is because the elite desperately need this for the next stage of their world control.

The world economy

I have written many papers explaining the coming collapse of the global economy due to the mismanagement and corruption of bankers. I will not repeat all those arguments here but will try to concisely explain the situation.

Bankers have been corrupting the money system and the markets for over 100 years, and especially since 1913.⁴ Many people have explained this massive racket led by a banking Mafia ('banksters'). For example, the price of gold has been deliberately suppressed or note the perverted use of the fractional reserve system.

To curtail the normal repercussions in the economy from spiralling out of control (the natural result of their corruption)⁵ the bankers have been pouring printed money into the system and holding interest rates at ridiculous low levels. Debt has not only been encouraged but boosted. National debts of governments, and even certain banks, are now at levels that cannot ever be repaid.⁶ But this cannot continue forever; the markets will naturally rise up and bite them. Massive inflation is but one eventual result. When this gets out of control, the whole financial system of the world falls apart. There will be major revolutions when people starve. In fact the beginnings of an economic crash are already upon us; note the initial signs of collapse in the bond market and problems with Chinese bonds.

The elite cabal began to panic when it realised that it cannot keep control of this debt system any longer. Even so, they managed to keep it going far longer than any of us believed possible, so stupid and reckless are these criminals. But it cannot go on any longer. It is about to blow. Inflation in Britain is officially already over 3% but other economic measures put it well over 10%. This is already a crisis. When the furlough scheme ends soon many businesses will close, unemployment will skyrocket and recession will get worse. There is already a supply chain crisis and empty shelves. Some suppliers are already restricting construction materials to business owners only. This comes in conjunction with an energy crisis of huge proportions because governments have not secured energy supplies and green energy does not work.

Thus the elite need to bring in a new system; a great resetting of the global economy; a new system; a new normal. It had long planned for this but was intending for a world war under Hillary Clinton. Trump put a stop to that hence the rushed plan B of the Covid crisis. This rush has led to mistakes; such as the huge numbers of immediate adverse events instead of a slow death rate by ADE⁷ each winter (which could have been covered up by claiming a bad flu season).

The proposed escape route for the elite is Central Banks Crypto-Currency (or Central Banks Digital Currency). They are currently working on creating new crypto systems to establish a global economic system under their control. For example, the Bank of England currently has staff urgently working on developing such a system. This work is actually very difficult with many aspects needing careful management and critical algorithms, and so on.

The development of Bitcoin and other crypto currencies was either, 1) prototypes being tested out by the elite in the real world, or 2) an attempt by the good guys to circumvent the new reset. Opinions differ.

The banking crypto currency programme will fit in with other elite objectives at the same time: the Internet of Things, AI, cashless society and so on. But what is necessary for this system to work is a global digital ID system that every member of every nation is plugged into. It cannot work if half the population is not in that ID surveillance digital system. This is where the vaccine programme comes in.

The vaccine programme is the entry point into this new economic system. It is a bio, digital ID surveillance system which can track everything you do. This is necessary for the resetting of the global economy in a crypto system. In this system the establishment can terminate your ability to function at a moment if they disapprove of what you are doing through their constant monitoring. For example, by monitoring your social media, if they did not like what you have been saying, they could freeze your credit cards. If you attended places they disapproved of, they could cancel your ability to travel.

Inter-connected systems of control include (some are already operative):

- Facial recognition cameras monitoring your every location attended.
- Biomarkers in vaccines that constantly track your every movement.
- Surveillance of every communication.
- Surveillance and control through every Smart device (copying or deleting all your data, web activity, messages, texts, speech, what you watch on TV etc.).
- Plugging you into the new banking system through personal digital ID.
- Bio ID required to do anything in society (work, entertainment, voting, education, purchasing etc.)
- Fines taken immediately through digital systems with no processing.

The vaccine is not about combating a disease, it is about creating the conditions for a vaccine passport which you will be required to show for every aspect of life. The passport plugs you into the new economic reset. The Great Reset is not primarily about social changes, but initially it is about the setting up a new economic system as the old system finally collapses.

Despite claims otherwise, America and other key nations have less than 50% take up of the vaccines. This is why there is such a relentless push, with carrot and stick, to accept the vaccines.

The transfer to this new reset will be ugly and will take many months. In this period you need to be prepared for survival.

Summary of clear facts

For people that dismiss claims of a superior cabal ruling over national governments and that attack alternative commentators as conspiracy theorists (a derogative ploy created by the CIA after the Kennedy assassination by the way) let us just summarise some basic facts in the current narrative. [I won't reference these points, having done so in many previous papers – unless I refer to new information.]

Facts opposed to government measures

- Most nations all over the world decided, at the same time, to implement novel measures (never used before and without any medical basis) to combat a viral

epidemic. Before the virus peaked the government medical bodies confirmed that the virus was not a serious highly infectious disease – so no measures were necessary. Then lockdowns were instituted days later. Medical establishments confirmed that facemasks were pointless, but then most nations mandated facemasks. Social distancing was discredited, but then most governments mandated social distancing. An experimental, unproved, unauthorised vaccine programme was rushed out that would normally have been outlawed. Then most nations rolled it out. It is clear that these nations were following a pre-ordained script from a higher authority. That script was identical to strategies previously published or simulated by Bill Gates, Johns Hopkins University, The World Economic Forum, the Rockefellers and others.

- The driver of fear in populations was driven by governments, government advisors, the mainstream media and medical establishments. These are all controlled by the same people. Big Pharma and the media are owned by a handful of global corporations; chiefly Vanguard and Blackrock. The UK SAGE advisors (chiefly Whitty, Vallance and Ferguson) are all in the pay of Big Pharma and profit from vaccine sales. Pharma also controls most governments in conjunction with central bankers. Big Pharma has also controlled and corrupted the medical system and medical journals for decades.
- There is no Covid crisis and never was. Excess deaths in 2020 were normal. This is now confirmed by the ONS and the Institute of Actuaries as I have explained before.
- Death from Covid only affects less than 1% of people.
- Public Health Four Nations downgraded Covid from being a serious highly infectious disease on 19 March 2020. It is a minor problem.
- According to PHE England only around 1,300 people died from Covid alone in the crisis. All the other cases were due to co-morbidities.
- At the current time, so-called Covid-19 is so low down the line of pathogens as to be ignored. At the latest check, it was the 26th worst cause of death. We live with many other more dangerous diseases such as TB, cancer, heart disease, dementia, sepsis and so on. It is more dangerous to cross the road, but we don't prohibit that.
- Most nations of the world followed the exact same script and enacted restrictive policies, particularly lockdowns, that had never existed in history and had no epidemiological foundation. Medical scientists that confronted this and suggested focused protection were sidelined, smeared, and censored. This is evidence of a global, superior controlling influence.
- Countries and states that did not lock down (e.g. Sweden, Belarus, Japan, and South Dakota) performed better than most other places, and much better than Britain. These have now achieved natural herd immunity and life is normal. There is no major surge of Covid deaths.
- Countries with a high vaccination take up are experiencing very high surges of Covid infections and hospitalisations, such as Israel or The Seychelles.
- There is an explosion of chronic illness after 81% of Singapore was vaccinated.⁸
- In Idaho 20 times more vaccinated people are contracting cancer than unvaccinated people.⁹ The owner of the largest independent Idaho diagnostic lab, Dr Ryan Cole, reports a 20 times increase of cancer in vaccinated patients.¹⁰ He observed a drop in immune T-cells, and the immune system goes into reverse. The results are also a number of other diseases.

- America's top ten vaccinated states are experiencing the highest rates of Covid infections.¹¹
- The FDA's Vaccines and Related Biological Products Advisory Committee (17 September 2021, virtual meeting) discussed Pfizer's booster shot (third dose) in people 16 and older. At 4 hours 21 minutes into the presentation a slide was shown giving excess death stats ('*Excess death:life ratio is unacceptable*'). This revealed that excess deaths required to save a Covid life for Pfizer was 6, from the VAERS reporting system, 2. That is for every person saved, two people are killed by the vaccine. It recommended AGAINST booster jabs for everyone aged 16 and over (excepting over 65s) by 16-2.
- The vaccines do not stop you catching Covid.
- The vaccines do not prevent transmission of Covid.
- Vaccinated and unvaccinated people can have exactly the same viral load.
- Natural immunity after contracting Covid confers a far higher immunity level than the vaccines.
- Two senior chiefs of the FDA have resigned over concerns about the vaccine rollout.
- FOI requests show that the MHRA and the PHE did not scrutinise the vaccine trial results. There have been no safeguard checks by government medical bodies.
- There is growing evidence that the vaccines were not properly tested by the manufacturers and the beneficial claims were fraudulent.
- The vaccine trials are not due to be completed until 2023, which means that the vaccination of the population is a massive experiment.
- The adverse reactions in all countries to the vaccines are literally skyrocketing. Many thousands have died. Many more thousands have been seriously maimed and permanently disabled. Up to a third of pregnant women had a miscarriage. The shocking level of adverse events is being hidden from the public by deception. Data on the MHRA site is even being deleted from one week to the next.
- Vaccines have negative effectiveness in the over-40s, as low as Minus 38%.¹² The data shows that vaccines make things worse (as I have long claimed).
- Fully vaccinated people are 65% more likely to be hospitalised and 1540% more likely to die from Covid than people who are unvaccinated.¹³
- In August 2021 PHE data shows that over 70% of Covid deaths were amongst vaccinated people.¹⁴
- 30,305 people died within 21 days of having a Covid jab in England in the first 6 months of 2021 according to ONS data.¹⁵
- PHE data shows vaccine effectiveness against the Delta variant down to just 7.6% in the over 50s and the vaccinated continue to experience a higher infection rate.¹⁶
- The children of the vaccinated are getting sick and the hospital children's units are filling up. The WHO and CDC have written to hospitals telling them to identify this as Acute Flaccid Myelitis (like Polio) to hide the fact that it is paralysis caused by the spike protein and viral shedding. Children did not get sick in the heat of Covid but are during the vaccine rollout.
- The organs of transplant patients are now being rejected in vaccinated patients.¹⁷

- 80% of Covid deaths in August were people who had been vaccinated.¹⁸
- In summer 2020 Covid deaths flatlined to virtually zero. This summer there are higher levels of Covid deaths – due to the vaccines.
- A Japanese study showed that the Pfizer jab increased infections.¹⁹
- Multiple doctors are claiming that the mass vaccination programme is actually causing the new variants (e.g. Dr Peter McCullough,²⁰ Dr Geert Vanden Bossche – who warned that this would happen and was censored).

Despite all this, the government:

- Is constantly creating propaganda and fear about the need to get a vaccine.
- It uses fear and coercion to get people to have the vaccine.
- Claims by ministers that the vaccines are ‘100% safe’ (Hancock) are lies.
- Deception is being used to get people to take up the vaccine.
- Informed consent is not being given for the vaccine.
- The government is allowing children to get vaccinated without parental consent.
- Pressure is being placed upon school children to be vaccinated. [Pfizer is seeking authority to vaccinate children as young as 5.]
- Students cannot go to university unless vaccinated.
- Vaccination is necessary for international travel.
- Vaccination is now being required to enter large venues and night-clubs.
- Vaccination is being required for certain jobs – which is illegal.
- Care home staff have been mandated to have the vaccine (which is illegal) or be sacked in a few weeks.
- Nurses have now been mandated to have the vaccine or be banned from seeing patients.²¹ This will cause a new care crisis unless over 10,000 nurses suddenly get vaccinated.
