The reality of the satanic agenda

Christians accept that Satan is outworking his plans in the world today. However very often they do not understand the way in which those strategies are working out in nations and many are very gullible when it comes to governments; indeed many poor Christians find themselves supporting wicked satanic strategies being promoted by their favourite political party.

Christians have been confused by the fact that we do not fight flesh and blood but are fighting a spiritual war based on temptation, sin and doctrinal deception. This is true regarding our personal lives; we do not fight people but demonic attacks on our thinking. However, in the world Satan is pursuing a very materialistic policy; he is working to gain a world empire that submits to him. Let's familiarise ourselves with some Scriptures.

Characteristics of Satan's strategy

Satan controls the world through the sin of men.

He does not own the world, which is God's, neither does he have any legal authority over the world itself; but he works in men (especially rulers) to achieve his purposes. Thus he rules over the rulers. The darkness of the age we live in is controlled by satanic forces.

Now the ruler of this world will be cast out. Jn 12:31

The ruler of this world is coming, and he has nothing in Me. $Jn\ 14{:}30$

The ruler of this world is judged. $Jn\ 16{:}11$

The prince of the power of the air, the spirit who now works in the sons of disobedience. Eph 2:2

The [demonic] rulers of the darkness of this age. $Eph\ 6{:}12$

The whole world lies *under the sway of* the wicked one. 1 Jn 5:19

Note that 'the darkness' does not always seem dark; the darkness in the world is only perceived by mature Christians in God's light. Thus the world believes that many things of darkness are not only good, but are altruistic and enlightening. This is the level of deception. Thus some satanic policies are portrayed in society as beneficial, enlightening, and moral. For example, elevating homosexuality (so that homosexuals have more rights than heterosexuals) on the basis of tolerance and fighting bigotry.

His method of working is by deception.

You are of *your* father the devil ... He ... *does not* stand in the truth, because there is no truth in him. When he speaks a lie, he speaks from his own *resources,* for he is a liar and the father of it. Jn 8:44

For those who are such do not serve our Lord Jesus Christ, but their own belly, and by smooth words and flattering speech deceive the hearts of the simple. $Rm \ 16:18$

As the serpent deceived Eve by his craftiness. 2 Cor 11:13

Satan himself transforms himself into an angel of light. 2 Cor 11:14

The trickery of men, in the cunning craftiness of deceitful plotting. $Eph\ 4{:}14$

The coming of the *lawless one* is according to the working of Satan, with all power, signs, and lying wonders, and with all unrighteous deception among those who perish. 2 Thess 2:9-10

Evil men and impostors will grow worse and worse, deceiving and being deceived. 2 Tim 3:13

The great dragon was cast out, that serpent of old, called the Devil and Satan, who deceives the whole world. Rev 12:9 $\,$

He cast him into the bottomless pit, and shut him up, and set a seal on him, so that he should deceive the nations no more. Rev 20:3

Conversion involves opening the eyes to see what the deception is.

Non-Christians are blind and follow satanic deceits. Note that this blindness is under God's sovereign control; he ensures that the elect alone will see the light of the truth in Christ. The blinding by Satan is under God's control and for his purposes.

He [God] has blinded their eyes and hardened their hearts, lest they should see with *their* eyes, lest they should understand with their hearts and turn, so that I should heal them. Jn 12:40

I will deliver you ... to open their eyes, *in order* to turn *them* from darkness to light, and *from* the power of Satan to God. Acts 26:17-18

Whose minds the god of this age has blinded, who do not believe. 2 Cor 4:4

People, and especially leaders, are in bondage to Satan through sin.

To whom you present yourselves slaves to obey, you are that one's slaves whom you obey, whether of sin leading to death, or of obedience leading to righteousness? Rm 6:16

You were slaves of sin. Rm 6:17

The spirit of bondage. Rm 8:15

We, when we were children, [before receiving Christ] were in bondage under the elements of the world. Gal 4:3

How *is it that* you turn again to the weak and beggarly elements, to which you desire again to be in bondage? Gal 4:9

Those who through fear of death were all their lifetime subject to bondage. $\operatorname{Heb} 2:15$

They themselves are slaves of corruption; for by whom a person is overcome, by him also he is brought into bondage. 2 Pt 2:19

Thus all nations are serving Satan and not God.

Do not defile yourselves with any of these things; for by all these the nations are defiled, which I am casting out before you. For the land is defiled; therefore I visit the punishment of its iniquity upon it, and the land vomits out its inhabitants. Lev 18:24-25

It is because of the wickedness of these nations that the LORD is driving them out from before you. ... because of the wickedness of these nations that the LORD your God drives them. Deut 9:4-5

Why do the nations rage, and the people plot a vain thing? The kings of the earth set themselves, and the rulers take counsel together, against the LORD and against His Anointed. Ps 2:1-2

For the land is full of adulterers; for because of a curse the land mourns. The pleasant places of the wilderness are dried up. Their course of life is evil, and their might *is* not right. Jer 23:10

Men loved darkness rather than light, because their deeds were evil. Jn 3:19

The world cannot hate you, but it hates Me [Jesus] because I testify of it that its works are evil. Jn 7.7

This present evil age. Gal 1:4

Friendship with the world is enmity with God? Whoever therefore wants to be a friend of the world makes himself an enemy of God. Jm 4:4

This is incredibly important to understand: all the nations serve Satan and not God. Indeed, they are all in rebellion to God and working to a purpose planned by Satan. This is only logical; men are rebellious against God and servants of Satan (Eph 2:2) so also the rulers of men are servants of Satan. Therefore the direction of governments will be satanic.

Many in the west do not want to believe this because their countries were originally established on Christian principles or by Christian founding fathers. This fails to see the deception that occurred after godly men tried to establish a Christian state (there is no such thing). Look at the moral delinquency rampant in the Netherlands despite a rich Christian heritage. Sweden once had a Christian king but is now libertarian, humanistic and permissive.

America is one of the most morally bankrupt nations in the world and one responsible for millions of unnecessary deaths through its aggressive foreign policy, and yet it began as a Christian safe haven for persecuted refugees. However, not long after the Pilgrim Fathers, federal politics soon became infected by unrighteousness, humanism, hubris and Freemasonry. Manifest Destiny (a plan for the genocide of Native American Indians based on the higher status of white men) was one early wicked and unchristian policy. This was followed by illegally stealing the land of other people in an imperialistic expansion (Texas, New Mexico, Florida, Cuba, Hawaii etc.) to feed a lust for power and money, which developed into continual, illegal foreign intervention.

Far from being Christian, the founding fathers of America developed what George Washington called, '*a nascent empire*'. The continual expansion of America was planned by its founding fathers from the beginning. Benjamin Franklin, 25 years before the Revolution, complained to Britain that its fleet was placing limits on expansion (e.g. Cuba). He called the Native American Indians, '*beasts of prey*'. Thomas Jefferson said, '*We shall drive them with the beasts of the forests into the stony mountains; then our country will be free of blot*'. All the areas around the colonies were targets of expansion by land and sea.

Thus Britain blocked the invasion of Canada, first attempted before the Revolution. The US did not formally recognise the sovereignty of Canada until after the First World War. Eventually America grew more powerful and no other country could stop them. Thus Florida was taken from the Spanish; Texas¹ and New Mexico from the recently independent Mexico and so on. This imperialistic expansionist policy partly stemmed from insecurity (ever expand to protect the homeland) and partly from mercantile interests to steal the resources of other people (thus the sugar industry in Hawaii).²

The point is that the original Christian principles of the Pilgrim Fathers, who survived winters only with the help of the Indians, soon vanished to be replaced by the imperialistic notions of Freemasons, power hungry zealots and radical socialist founding fathers.³

¹ Texas began as licensed settlements from Mexico, which saw them as a buffer against Comanche raids; but the settlements expanded illegally in huge numbers. Considering your nation to be Christian is being a friend of the world. Far too many Christians are friends with the world, which makes them enemies of God; this is very dangerous, ['Do not love the world or the things in the world. If anyone loves the world, the love of the Father is not in him;' 1 Jn 2:15]. There is no such thing as a 'Christian nation'.

All nations are serving Satan. Anyone who thinks that their government is essentially Christian is a fool. The only theocratic nation that ever existed was Israel; but despite the massive advantages of having God's law, prophetic direction and knowledge of the Holy God, it utterly failed to be faithful to God, deserted him and fell into flagrant idolatry. No nation since has had such advantages.

It is a deceit of the enemy to trick Christians into thinking that their nation is an obedient servant of God and that God blesses that country. This is true of all nations whether it is America, Holland, Britain or Israel. All are following a satanic agenda. God only blesses a righteous nation and no nation is righteous at all.⁴

Satan's working in national governments today

So, the general principles have been established – that Satan is in control of the world and is working through human governments to achieve his goals. So we must consider how this is being worked out in detail in our midst. If we do not do this, then we are likely to be deceived and could support satanic polices. How many Christians voted for David Cameron?

Given that Satan has an agenda for the world in the end times, it is obvious that he is going to work out those plans in the governments of the world through deception. This means that the ruling governments of nations are almost certainly going to be deceived people whose plans are not going to be altruistic or the representation of the people, but rather are going to be working towards the end that Satan is engineering. Unless a national leader is a very strong Christian who is able to withstand and resist the powerful deceptions of the enemy, he will certainly be a deceived person. Note this: most, if not all, people in power are deceived people pushing a satanic agenda.⁵

An example

A simple and recent example of this is the promotion of Gay marriage by David Cameron, leader of the Conservative Party. Now most conservative Christians who are political probably vote Tory; indeed the Anglican Church was long described as 'the Tory party at prayer'. Now nothing is more iniquitous to conservative Christians than ruining the institution of marriage, a divine ordinance and established in common law for thousands of years. Yet here we have a Tory leader bringing in a law to overturn the very meaning and purpose of marriage to pursue a definite satanic objective. Without any shadow of doubt, Cameron is a very deceived man. Even the equally deceived Tony Blair did not go this far.

Leaders are not what they seem

Satan can do the most work through leaders that are winsome and attractive. For example Barack Obama, who has pushed forward the Gay agenda far than any other president before him and has killed many innocent civilians as a result of authorising Predator drone attacks.

Another example is Tony Blair, who despite his attractive and engaging qualities, that even drew many Christians toward him, did more social damage than any Prime Minister before him. He was partially responsible for the deaths of over 1 million innocent civilians in Iraq; he furthered the Gay agenda more than any Prime Minister before him; and presided over lies, spin and deceit that became a byword in British politics.

The nature of satanic deception especially in politics is that things are not as they seem on the outside. Often what is really going on in politics is the reverse of what is said.

The purpose

Therefore, the plans and strategies of nations are going to be the outworking of satanic strategic objectives. Of course, all satanic working and all the actions of governments are under the sovereign control of almighty God and are only allowed to succeed as he sees fit according to his eternal plan. But God himself has told us in his word that at the end the divine plan is to allow sin to come to fulness in the global expression of an anti-Christian kingdom throughout the whole world. Therefore at the end we are going to see all national governments working towards a satanic global objective that ensures the development of a totalitarian global government in rebellion against God promoting sin and wickedness.

Thus we can perceive that many of the policies developed by national governments are not in the interests of the people and in fact may represent the very reverse of the historic interests of the people, but are in pursuit of definite Satanic goals. Individual policies are, in fact, various strands of Satanic strategies that, when united together, constitute the global satanic purpose. It is for this reason that God calls national governments beasts in the book of Daniel; he also calls the final expression of sinful rebellious leadership 'the beast' in Revelation. A beast is something that is untamed and uncontrollable that devours what it wants.

In such a scenario we would expect to see a number of initiatives that go against traditional public opinion and the absolute principles of established Christian religion. However in order to achieve such a reversal there has to be a prior propagandising of the nation in order to secure reasonable support for these new strategies and policies, Otherwise there would be a swift reaction against them and governments would fall. Thus we would expect to see a network of brainwashing methods that work throughout the population and particularly target the education system.

Brainwashing the nation

The satanic strategy is a long-term one and indeed Satan has been working to this plan for thousands of years. In recent decades this plan has gone into overdrive in order to secure a transformation of public opinion regarding strands of satanic policy that are necessary to achieve undisclosed ends. Foremost in the strategy of changing public opinion and implementing worldwide social changes are the following:

Covert brainwashing of children in schools.⁶

⁶ Note: 'Education is thus a most powerful ally of humanism, and every American public school is a school of humanism. What can the theistic Sunday schools, meeting for an hour once a week, teaching only a fraction of the children, do to stem the tide of a five-day program of humanistic teaching?' C.F. - Overt propagandising of children in schools.7
- Brainwashing of teachers and the education system; scandalising and ejecting teachers with principles that do not fit the satanic agenda.⁸
- Brainwashing Parliament. [It appears to me that once you become a minister you leave your brain and principles at the door. Apart from that, no principled man can survive under the whip scheme. Only independents have any chance at keeping moral principles in the Commons.]
- Establishing well-placed influential people who follow ulterior motives, such as is found in Common Purpose⁹ or Freemasonry.¹⁰
- Brainwashing parents to teach kids wrong things or not teach them at all. [This begins when parents are kids themselves at school and continues in the constant brainwashing by the media.]
- Dominating the media, especially television. [Note that any group that controls the media controls society in time. This is why the Gay agenda has been so successful since homosexuals have flooded the theatre world, movie making, newspapers, TV production and magazines.]
- Using the global influential bodies to enforce or strongly influence nations to accept the strategies; such as the UN, or the European Union.

Now each of these items could be developed into a book on their own and we cannot delve into them in detail here. We will explain more, in due course, about some; particularly the UN.

The purpose behind brainwashing society - Doublethink

The best book to read regarding how a totalitarian society is controlled by doublethink is George Orwell's *1984*. Every Christian should read this because it is a chilling commentary on what will happen in the future, and beginning to happen now. It shows how authoritarian governments can manipulate society by brainwashing people into thinking that black is white. Thus, in this book, the ministry of truth is actually a ministry of propaganda publishing lies; the ministry of peace is a ministry promoting constant war.

⁷ Note: behavioural psychologist B.F. Skinner proposed '*a perfect society or new and more perfect order*' where children are reared by the State, rather than by their parents and are trained from birth to demonstrate only desirable behaviour and characteristics. *Walden II*, 1948. Skinner's ideas would be widely implemented by educators in the 1960s, 70s, and 80s as Values Clarification and Outcome Based Education.

 $^{^{8}}$ An example of this is the persecution (yes, that is the correct word) of professors and teachers who have tried to teach creationism alongside evolution in a balanced discussion. Many have lost their jobs, lost their research funding and have been ridiculed and scandalised in academic circles.

⁹ Common Purpose is largely unknown to the general public yet it is funded by the tax-payer; it has over 80,000 trainees in 36 cities, 18,000 graduate members and enormous power. It recruits and trains leaders to be loyal to the directives of Common Purpose and the EU, instead of to their own departments, which they then undermine or subvert. It is alleged that it uses fraud to reward pro-European local politicians. Corrupt deals are, allegedly, enabled that put property or cash into their pockets by embezzling public assets. It has members in the NHS, BBC, the police, the legal profession, the church, many of Britain's 7,000 quangos, local councils, the Civil Service, government ministries, Parliament, and it controls many RDA's (Regional Development Agencies). For example, Cressida Dick is the Common Purpose senior police officer who authorised the 'Shoot to kill' policy without reference to Parliament, the law or the British Constitution. Jean de Menezes was one of the innocents who died as a result. Her shoot to kill policy still stands today. A book is required to analyse this scandal alone, but it is a significant means of furthering the satanic goal without going through Parliament. ¹⁰ Freemasonry is an old and occultic secret society that demands loyalty to its brethren above all else on pain of death. It is portrayed as a charity but its members have gained control, or significant influence, over many parts of the establishment; especially the police, magistrates, judiciary, trade unionism and local government. See my paper, *A Concise Evaluation of Freemasonry: It's Claims and History*.

Thus brainwashing leads people to think that certain mores, that had a traditional and absolute meaning, now mean the opposite. Thus homosexuality used to be forbidden and criminalised; now it is acceptable and promoted throughout the media. Marriage, from ancient times, was heterosexual only; now it is also homosexual. Abortion was once illegal; now it is legalised and millions of babies are killed each year in what is really genocide. Pornography was once considered wicked, dangerous and only available with difficulty; now pornography is available very easily everywhere and accepted as normal behaviour.¹¹ Even supposedly educational TV programmes contain pornographic segments. This change of thinking begins with the graphic sexual education of kids in school from the age of five.¹²

So, first sins are promoted as acceptable, and then even desirable; after that governments legislate to support these sins. What was once forbidden under law and despised in the public mind, is now legislated for and accepted by the public.

The satanic agenda is to cause doublethink to affect more and more forbidden, iniquitous matters in society. This eventually leads to the destabilisation and disintegration of society and the need for a strong, despotic ruler to sort the mess out. In the past it was after strong empires degraded into a moral cesspool that their power and control weakened and they became fodder for invaders.

So, for instance, we will show in this paper that western governments are not only promoting but demanding (sometimes with sanctions) that populations accept: LGBT¹³ rights, homosexual marriage, homosexual adoption, legalisation of prostitution and so on. Polygamy, incest and paedophilia are just around the corner.¹⁴

What are the key satanic objectives.

To kill as many people who do not serve Satan as possible.

You are of *your* father the devil, and the desires of your father you want to do. He was a murderer from the beginning. Jn 8:44

Your adversary the devil walks about like a roaring lion, seeking whom he may devour. 1 Pt 5:8

Cain who was of the wicked one and murdered his brother. 1 $Jn\ 3{:}12$

One aspect of this is the strategy to reduce the world population by millions in the coming years, based upon the published errors of Malthus¹⁵ on over-population. This is one reason

¹¹ Psychological counsellors often tell individuals and married couples that watching pornography is helpful.

¹² For many years, especially under New Labour, councils have been using graphic comic book illustrations, in leaflets, to explain homosexual and heterosexual sex to children as young as five. This began with Lambeth council. Masturbation and viewing pornography is frequently advised as normal and helpful behaviour.

¹⁴ Several ancient societies made these legal before they fell. Emperor Tiberius was a paedophile while Caligula committed incest with his sisters Agrippina the Younger, Drusilla, and Livilla. Already there are high-level paedophile rings in this country containing large numbers of the police, judiciary, and media personalities (many of whom are Freemasons). [E.g. claim by an ex-chief inspector on Jeremy Vine show (chaired by Vanessa Feltz), BBC Radio 2, 31.5.13.] This is why Jimmy Savile was protected in his lifetime. He even boasted about this while alive claiming that if he fell he would take scores of very high level people down with him because he used to provide rent-boys for them.

why governments with great power do nothing (or very little) to stop famines, poverty, pestilence or disease in third world areas, such as Africa. They actually want populations decimated.

Note that the US did not deal with the Congo crisis in which 4 million died. The US not only ignored the genocide that killed 800,000 Rwandans (Tutsis) in 1994 but also prevented the UN from acting to stop it. America also did nothing to stop the genocide and ethnic cleansing in Darfur. If it is really dominated by humanitarian motives why did it ignore these (and many other) situations?

[See later on reducing population growth.]

To develop a global totalitarian government.

Authority was given him [the beast, Antichrist] over every tribe, tongue, and nation. Rev 13:7

He causes all, both small and great, rich and poor, free and slave, to receive a mark on their right hand or on their foreheads, and that no one may buy or sell except one who has the mark or the name of the beast, or the number of his name. Rev 13:16-17

He cast him into the bottomless pit, and shut him up, and set a seal on him, so that he should deceive the nations no more till the thousand years were finished. But after these things he must be released for a little while. Rev 20:3 [I.e. Satan was bound from developing a world empire in history to unify mankind ('world empires' in history were relatively small and restricted to Eurasia). However, at the end the restraint is released and Satan is allowed to gather mankind into one great, intercontinental empire.]

To encourage iniquity.

Then Jesus was led up by the Spirit into the wilderness to be tempted by the devil. $Matt\ 4:1$

The prince of the power of the air, the spirit who now works in the sons of disobedience. Eph 2:2

It is the nature of the devil to tempt people into sin. The more people sin, the more he can control them by their lusts. The sin enslaves and the slavery is ultimately to Satan, not just the sin. Thus he works in the sons of disobedience.

Often if one type of sin is given in to the point of uncontrollable addiction, then that sin leads to another and another. The end is always death. Thus Joe Meek, the quirky 60s record producer who recorded Telstar, was deeply into the occult, was a homosexual, became increasingly paranoid and out of control and eventually murdered his landlady and then committed suicide. Thus a creative, imaginative person was eventually twisted into a deranged double murderer.

Giving into sin is dangerous.

To be the focus of worship

Then the king [Antichrist] shall do according to his own will: he shall exalt and magnify himself above every god, shall speak blasphemies against the God of gods, and shall prosper till the wrath has been accomplished; for what has been determined shall be done. He shall regard

neither the God of his fathers nor the desire of women, nor regard any god; for he shall exalt himself above *them* all. Dan 11:36-37

They even sacrificed their sons and their daughters to demons. Ps 106:37 [Idol worship is worshipping Satan and demons.]

The things which the Gentiles sacrifice they sacrifice to demons and not to God, and I do not want you to have fellowship with demons. $1\,{\rm Cor}\,\,10{:}20$

The son of perdition, who opposes and exalts himself above all that is called God or that is worshiped, so that he sits as God in the temple of God, showing himself that he is God. 2 Thess 2:3-4

They worshiped the dragon who gave authority to the beast. $\operatorname{Rev} 13:4$

He opened his mouth in blasphemy against God, to blaspheme His name, His tabernacle, and those who dwell in heaven. $Rev\ 13:6$

All who dwell on the earth will worship him [Satan, through the beast], whose names have not been written in the Book of Life. $Rev\,13{:}8$

Note this satanic tendency – to attract the worship of sinners. The further one falls into sin, the more one is given over to a destructive tendency to worship something; whether it is money, power, fornication, gambling, possessions or anything else. The lust and desire, even worship, of these things does not evaporate but is absorbed by Satan and his hordes of demons. They manipulate people through deceit and temptation to be addictive to a sin and then soak up the lust that is expressed by the sinner.

For instance, idolatry is a sin but the focus of the worship given to an idol is not the idol itself, but the demon behind that idol (Lev 17:7; Deut 32:17; 2 Chron 11:15; Ps 106:37; Isa 45:20; Dan 5:23; Rm 1:23, 25).

In giving in to sin people have fellowship with demons (1 Cor 10:20). Even Christians can fall into this trap according to Paul. When a believer falls into sin and lives in his old nature, he is dominated by Satan and fellowships with him: 'Do you not know that to whom you present yourselves slaves to obey, you are that one's slaves whom you obey, whether of sin leading to death, or of obedience leading to righteousness?' (Rm 6:16).

To destroy the Christian church.

The same horn [Antichrist] was making war against the saints, and prevailing against them. Dan 7:21

He [Antichrist] shall speak *pompous* words against the Most High, shall persecute the saints of the Most High, and shall intend to change times and law. Then *the saints* shall be given into his hand for a time and times and half a time. Dan 7:25

We do not wrestle against flesh and blood, but against principalities, against powers, against the rulers of the darkness of this age, against spiritual *hosts* of wickedness in the heavenly *places*. Eph 6:12

The devil is about to throw *some* of you into prison, that you may be tested, and you will have tribulation ten days. Rev 2:10

Antipas was My faithful martyr, who was killed among you, where Satan dwells. Rev 2:13

The dragon [the devil] was enraged with the woman [the OT church], and he went to make war with the rest of her offspring [the NT church], who keep the commandments of God and have the testimony of Jesus Christ. Rev 12:17

It was granted to him to make war with the saints and to overcome them. Rev 13:7

I saw the woman, drunk with the blood of the saints and with the blood of the martyrs of Jesus. ${\rm Rev}\ 17{:}6$

Note the plans for genocide against God's people in Daniel and Esther.

To destroy Christian morals in society.

He [Antichrist] ... shall intend to change times and law. $Dan\ 7{:}25$

How long will you judge unjustly, and show partiality to the wicked? $Ps\ 82{:}2$

Shall the throne of iniquity, which devises evil by law, have fellowship with You? They gather together against the life of the righteous, and condemn innocent blood. Ps 94:20-21

Moreover I saw under the sun: in the place of judgment, wickedness was there. Eccles 3:16

If you see the oppression of the poor, and the violent perversion of justice and righteousness in a province, do not marvel at the matter; for high official watches over high official, and higher officials are over them. Eccles 5:8

Justice is turned back, and righteousness stands afar off; for truth is fallen in the street, and equity cannot enter. Isa 59:14

The prince asks *for gifts,* the judge *seeks* a bribe, and the great *man* utters his evil desire; so they scheme together. The best of them *is* like a brier; the most upright *is sharper* than a thorn hedge; the day of your watchman and your punishment comes. Mic 7:3-4

Her princes in her midst are roaring lions; her judges are evening wolves. Zeph 3:3

He who sins is of the devil, for the devil has sinned from the beginning. 1 Jn 3:8

Woe to the inhabitants of the earth and the sea! For the devil has come down to you, having great wrath, because he knows that he has a short time. Rev 12:12

By definition, all that the devil does is anti-Christian and so tends towards the destruction of Christian morals in society. In the time of the end, when Satan is set free, what happens is that nations begin to legislate wicked acts. Any Christian basis in society is eroded and legislated iniquity is put in its place. The more time goes on, the more iniquitous and antichristian nations become until they merge flawlessly into a global antichristian fascist government.

To subvert the family unit.

To kill children

Idol (demon) worship frequently involved child sacrifice:

He [Ahaz] made his son pass through the fire, according to the abominations of the nations. 2 Kg 16:3

They [Israelites] caused their sons and daughters to pass through the fire, practised witchcraft and soothsaying, and sold themselves to do evil. $2~{\rm Kg}~{\rm 17:17}$

He [Manasseh] made his son pass through the fire, practised soothsaying, used witchcraft, and consulted spiritists and mediums. He did much evil. 2~Kg~21:6

They built the high places of Baal which *are* in the Valley of the Son of Hinnom, to cause their sons and their daughters to pass through *the fire* to Molech.¹⁶ Jer 32:35

You have slain My children and offered them up to them by causing them to pass through *the fire?* Ezek 16:21

The worst forms of satanic worship and black magic involve child sacrifice and this goes on today. Paedophile groups are closely connected to satanic groups; frequently a paedophile is also a Satanist. The fact that the height of pagan idol worship was to kill children (as it is in witchcraft) shows that Satan hates children. Producing a new sentient life is analogous to divine creation and is only available to men given this gift by God. Satan cannot procreate and hates the fact that people can. This hate is transferred to children.

Satan is also intent on destroying children before they can grow to be against him. One of Satan's servants failed to kill the baby Messiah, despite killing hundreds of other babies and Satan has not forgotten what one baby can become. He also failed to kill the baby Moses, who did significant damage to the devil's kingdom.

It is for this reason that legalising abortion was one of the early strategies in the modern collapse of society. By legalising abortion millions of babies have now been killed. If proof were needed that Satan desires to kill children, this is it.

To ruin marriage by encouraging adultery, fornication etc.

Many temptations to sin are sexual but the end of these is usually to destabilise a marriage bond. What starts with a fascination for forbidden sex becomes adultery and then all ends in divorce. This then starts a ripple effect that damages children, the parents and all their family and friends. All of this works to Satan's good. Society is weakened, and damaged, vulnerable people are easier to manipulate.

To apply social pressures to families to destabilise them

For instance, tax laws that favour co-habiting couples and discriminate against married couples. Pressurising women to work, through financial hardship, which damages children and weakens marriage. Forcing families to split up and relocate long distances through financial and housing pressures.

Targeting families in strategies that strengthen the state

Most obviously seen in Communism but western governments are actively considering moves in this direction. Laws are being passed that take decision-making away from parents and give them to the state: such as enforced vaccination of kids, early sexual education, secret contraceptive prescriptions, propaganda through education, criminalising physical discipline, affirming children's rights against parents etc.

Promoting cults that separate families

One of the prime tactics in brainwashing people to submit to a cult is to separate members from their families. Families pose a constant threat to cults by offering wisdom, common sense, familial attachment and priority interests above the cult, to wavering members. Such a threat has to be removed and so members are brainwashed into seeing family as a threat to a higher goal, something that will hold them back from personal achievement or

spiritual enlightenment. The damage that this does spreads throughout the wider family; I have seen first hand how much harm is caused by this.¹⁷

Many cults and religious sects use this tactic, such as: Jehovah's Witnesses, Scientology, The Children of God (Family of God) and many Hindu cults. Some radical Charismatic churches may not formally promote this behaviour but commitment to their leadership tends to lever members away from family; cultic churches stress commitment to the church above the family – which is a mistake.¹⁸

To spread fear in the population in order to keep people submissive, to make people passive, trust governments and be obedient willing citizens.

A fearful society is a more easily controlled society. Thus terror icons are continually required to keep people fearful. In recent American history this has been successively, the Nazis, the Japanese, Communism, Qhadaffi, Saddam Hussein, the war on terror, Osama bin laden, the Taliban and now Muslim radicals. It will soon be Iran.

The satanic effect on national governments

Note all this! If these items are all aspects of the devil's plan in the world, and if the devil is controlling national governments, then our governments are going to be involved in achieving these aims. Uncomfortable as it may make you feel, your government has a part to play in achieving these aims.

Thus it should not be very surprising to learn that international bodies are the worst culprits in this. The UN in particular is an extremely hypocritical body that is actively promoting all sorts of devilish polices, as we shall shortly see.

Remember, with satanic deception, things are not as they seem outwardly. Thus many supposedly altruistic bodies are not working for good but are actively promoting devilish strategies.

Caveat

I am not saying that all people in government are guilty of all the satanic strategies. For instance I am not saying that all MPs in Parliament are guilty as accessories, before and after the fact, of murder. I am not saying that all rulers are deliberately trying to kill thousands of people. There are many sincere people in national governments, including some believers.

What I am saying is that the overall effect of governmental policy will tend towards achieving the satanic goals in one way or another over time.

However, there are ruling elites of very powerful people, some well known, who are part of international cabals who really control world governments,¹⁹ either through money,

economic power or loyalty to a certain group. Some individuals in these cabals actually do desire satanic goals; they actually do intend to kill people, establish paedophile rings, promote Satanism, control national resources for wicked ends and so forth. Some of these cabals have such power that they dominate national governments. Note the comments of Franklin Roosevelt:

The real truth of the matter is, as you and I know, that a financial element in the larger centres has owned the Government every since the days of Andrew Jackson.²⁰

See also President's Clinton's former mentor:

There does exist and has existed for a generation, an international network which operates, to some extent, in the way the radical right believes the Communists act. In fact, this network, which we may identify as the Round Table Groups, has no aversion to co-operating with the Communists, or any other groups and frequently does so. I know of the operations of this network because I have studied it for twenty years. ... It wishes to remain unknown.²¹

The key point is that, through various means, national governments are going to fall in line with the overall satanic objectives for the world over time. Governments no longer simply represent their constituents but find themselves being dominated by higher powers to fall in line with global agendas.

For instance, in the UK most people are against membership of the EU – yet most politicians are in favour of remaining in it. The majority of people were opposed to the war in Iraq, which was illegal – New Labour pushed it through on lies. Most people are against Gay marriage – the House of Commons has just voted for it. Most people, and economists, are against austerity measures – yet the government continues with them. Governments do not represent the people but follow orders from a higher source.²²

Examples of policies that have direct satanic repercussions

Of course there are very many strategies initiated by Satan in the world and no list would be exhaustive. However, we can isolate some key polices that are active in the world today which are generally supported by the populace, as a result of deception, but are wicked and lethal in their effects.

- The gay agenda.
- Abortion.
- Evolutionary theory.
- Human climate change policies.
- Moves towards fiscal, political and monetary union.
- Wars and incursions that destroy many lives.
- Allowing or ensuring famine and pestilence to reduce the human population.

of men controlling the whole world is unfeasible. What is the case is that Satan and his demons control the affairs of men through various elite groups, networks and governments. The real controlling cabal is demonic.

Again, we could develop a separate paper on each of these items but have to restrict our thoughts to keep to our overall point. We will give some examples of some aspects in this list.

Example: restrictions on childbirth, legalised abortion; coerced sterilisation and forcible abortions.

The facts about modern abortion are truly staggering. Millions of babies have been killed in the west alone since the 1960s.

However, I wish to look at a specific example, which appears to be a paradigm for the future (the UN is already pursuing similar policies in Africa); this is the situation in $China.^{23}$

After 1949, Mao's policy of outlawing contraception and abortions, and encouraging women to have large families, produced a ticking population time-bomb. China's population doubled from 500 million in 1949 to a billion 30 years later. After the Cultural Revolution, when Deng Xiaoping took over in 1978, he was persuaded that to meet economic targets by 2000 the population would have to be restricted to 1.2 billion. The one-child policy was introduced; couples could only have one child (except in the country where they could have two if the first was a girl). Childbirth was subject to quotas just like grain. This is still in force and produces barbaric consequences.

Two generations of children have grown up without siblings, aunts, uncles and cousins. The state owns women's wombs. In the country, where children are needed to help work the land, there has been resistance followed by enforcement. In Bobai County (Guangxi province) officials are under pressure to meet birth targets and crackdown on violators. Squads rounded up 17,000 women and subjected them to forced sterilisation and abortions. They also gained 7.8 million yuan (£800,000) in fines for illegal births; often ransacking the homes of those who refused to pay. Government slogans can be seen on hoardings, reading: '*After the first child insert an IUD; after the second: sterilise; after the third: kill, kill, kill, kill, kill, kill, kill*.'

Ma Jian interviewed many victims, including Ah-Li who had experienced a forcible abortion. '*It crippled me*', she said, '*I couldn't stand straight for weeks afterwards and had to spend hundreds of yuan on painkillers*'. The squad tore her baby from her cradled arms and kicked her in the belly, then forced her into a minibus. After sedating her, she woke up two days later with no baby in her belly. She had also been sterilised. She explained that every woman in her county had been sterilised apart from those who fled to live in hiding.

Another woman explained how the forced abortion extracted an eight-month-old boy who was still alive. He clutched on to the nurse's fingers and would not let go. The nurse peeled off his fingers and dropped him into a bin. It is common in certain rivers, such as the Pearl River, to find the bodies of babies floating past in black bins or even exposed; they are also found on rubbish tips and in communal dustbins. Sometimes these bodies are fully-grown babies with the cord still attached.

A director of a family-planning centre in a village in Guangdong explained that he monitored the menstrual cycles of every woman in the village. Mandatory ultrasound checks are made to ensure that IUDs are still in place. Pregnant women are 'persuaded' to abort. If she refuses she is fined three times her annual salary. This is by demand of the central authorities. Authorities stated that 336 million abortions and 196 million

sterilisations have been performed under the one-child policy. These are atrocities that have not occurred in a time of revolution, instability or war, but a period of growing peace and prosperity.

This has gone on while the world watched in silence. Indeed, the west has rushed to make friends with China to ensure lucrative trade deals. In sealing these deals the west made no comment on these millions of murders, or even the appalling human rights atrocities that target dissenters and Christians. Forced abortions and sterilisations are now happening in Africa under UN policies (see later). Do not be surprised when this happens in the west.

Example: the use of sexual (particularly Gay) rights to ensure population decimation through AIDS in Africa.²⁴

We have seen that the satanic strategy involves killing many people, population decimation and pursuing the Gay agenda. In Africa these things come together as western governments actively pursue all three in the name of liberty.

Obama's administration, through various UN bodies has been pressurising African countries that have high rates of HIV/AIDS to lift restrictions on the very behaviour types that spread HIV and also to minimise the institution of monogamous marriage. The outcome of this has been the rising of HIV/AIDS cases in areas where they were previously going down as a result of abstinence policies.

The demand for sexual rights (such as Gay marriage) in the name of HIV prevention has raised infection rates. An example of this is a booklet called *Healthy, Happy and Hot*, distributed by International Planned Parenthood Federation (IPPF) at the United Nations (sponsored by UNESCO). It teaches young people (as young as ten, in some cases five) about their sexual rights to sexual pleasure and gender choice. Its guidelines include pornographic material, such as telling kids to 'talk dirty', practice oral sex, act out fantasies, masturbate and so on. It encourages HIV infected people to indulge in sexual freedom, including to make their own choice whether to tell their partner that they are infected, stating that laws which force them to do so violate their human rights.

The only conclusion you can draw is that the UN actually wants infected young people to infect more young people. There is even a cynical angle to this as Planned Parenthood profits since their business is providing sex counselling, condoms, HIV testing, abortions and HIV treatment. Sexualising kids increases their business by adding lifetime clients. Furthermore condoms are not truly effective in the battle and voluntary counselling and testing have proved completely ineffective in practice, and very expensive.²⁵ In fact some counselling has made things much worse.²⁶

But it does not stop there! A UN report demands the legalisation of prostitution and homosexual sex in every nation, as well as the legalisation of intravenous drug use.²⁷ In a

supposed battle against AIDS, the UN supports the very practices which have the highest incidence of AIDS and seeks to de-stigmatise them. This is nothing but iniquitous.

The same arguments have been used by the Obama administration and other UN agencies; indeed Obama has made this a foreign policy priority. The strategy claims to be based on supporting infected people to come forward for treatment by removing social stigmas. Thus sinful behaviour is promoted as good behaviour and the result is that you encourage sexual behaviour that has the highest risk of infections.

Even history is opposed to this strategy. Sodomy has been legal for a long time in France and widely practised but here the HIV infection rate amongst homosexuals is out of control. In America the CDC (Centre for Disease Control) demonstrated that the only group where HIV infection rates are rising is amongst homosexual men, even though it is already de-stigmatised. In fact health professionals have noted that stigma has a positive effect on social health; compare the effect of stigmatising smoking or drink driving.²⁸

There can be no doubt that influential sexual rights activists in the west are manipulating the AIDS pandemic to encourage promiscuous sexual behaviour in Africa and elsewhere. I maintain the behind this is a satanic purpose of killing as many people as possible.

The Global Commission on HIV and the Law are founded upon the Yogyakarta Principles. These were established by a group of sexual rights activists who assert that sexual rights are more important than free speech and religious liberty.

Another strand of UN/US policy regarding HIV infection is the promotion of condoms. However, it is well-known that this method is not a guaranteed protection and cannot be relied upon, even when used (and they are frequently ignored). Many infected with HIV have stated that they often have sex without a condom.²⁹ In fact studies have shown that condoms had virtually no impact on HIV levels.³⁰ Other studies have shown that increased condom use actually correlates with greater HIV risk.³¹ Trusting in a condom's effectiveness leads many to increased high-risk sexual activity. The UN is ignoring all this evidence for ulterior motives.

What is certain is that abstinence and monogamous marriage do completely prevent any infection. By promoting this some countries (such as Uganda) effectively brought down their very high infection rate. This was, however, reversed by the introduction of UN/US propaganda.³²

The ABC³³ approach in Uganda was extremely effective. By 1988, Uganda had the highest percentage of HIV infections in the world. In 1991, 15% of the total population was infected

(21% in urban areas). As a result of this pandemic, in 1986 Uganda started the revolutionary ABC program in conjunction with church leaders and education of kids.

From 1989 to 1995 both men and women saw a remarkable drop in the reported number of casual partners (35% down to 15% for men, and 16% to 6% for women). Uganda's program cut its AIDS rate by two-thirds, from 15% to 5% between 1991 and 2004, before condoms were widely available within the country.

Rand L. Stoneburner, MD, a former WHO epidemiologist, estimated that had the ABC program been implemented in South Africa alone, it might have saved 3.2 million lives between 2000 and 2010. Further, 80% of all HIV infections in sub-Sahara Africa might have been prevented.³⁴ In 2004, *The Lancet* printed a consensus statement which recommended ABC programs for populations with general epidemics, emphasising fidelity and delay of sexual experience.³⁵

The opposite UN sexual rights approach is presented in the *International Guidelines on HIV/AIDS and Human Rights*, published by UNAIDS. This tells countries that they must legalise: abortion, adultery, sodomy, fornication, commercial sexual encounters, (i.e. prostitution) and same-sex marriage. This is despite UNAIDS having studies showing that this behaviour spreads AIDS fastest.

There is no doubt that the UN (and the US) is deliberately seeking to spread promiscuity in Africa in the guise of AIDS prevention. Indeed, both David Cameron and Barack Obama have said that aid will be restricted or refused if these principles are not supported by legislating for sexual rights. Since deaths will inevitably result from these changes to the Christian faithful marriage social background of many African nations (note Uganda) it is irrefutable that the west is bent on killing people in Africa. Note also that the polices are the opposite of Christian values, despite both men claiming to be Christians.

The sexual rights movement in general.³⁶

Since time immemorial there has been a consensus view regarding sexuality. This has been dominated by natural religion and, in much of the world, by Christian ethics. This has affirmed monogamous, heterosexual marriage and scandalised (or outlawed) adultery, incest, bestiality, polygamy, homosexuality, paedophilia, transsexual behaviour, sodomy, and transvestite behaviour. Even in the Roman Empire where emperors committed incest (causing a scandal however) adultery was punishable by death.

Furthermore, social science data supports the traditional view and has categorically demonstrated that sexual intercourse outside of marriage (heterosexual, homosexual, premarital or extramarital) has a negative outcome to the individual and the wider social sphere. In fact, there is a very significant economic cost to this behaviour.³⁷

In the modern world, where Satan has been released to fill up the sin of man at the end, there is a new worldview regarding sexuality promoted in the west. [Note this: the satanic agenda in this regard is predominantly western.] The western sexual agenda is now being

Abortion is acceptable and a personal choice.	Abortion is murder and acceptable only in extreme medical (life threatening) circumstances.
Prostitution should be legalised.	Prostitution should be kept illegal.
Sexual rights education should be promoted to all children.	Children should be protected until they are old enough and education must be by parental connset.

The western, sexual rights, agenda is now being forced upon people worldwide, using sanctions against those who hold the traditional family worldview. The World Health Organisation has defined 'sexual rights' to include all the items in the left-hand column.³⁹ The UN has promoted the same rights in the Yogyakarta Principles, which affirms that these principles have more authority than religious liberty and free speech rights. Enshrined in these principles is the call to nations to ensure that opinions and beliefs fall in line with human rights. That is, convictions and beliefs are to be regulated by governments to make them compatible with the sexual rights agenda.

Targeting children

The UN also promotes the Yogyakarta Principles in the form of comics to children,⁴⁰ and part of this encourages lesbianism in young children. This is part of a more recent strategy of sexual rights activists to especially target children by promoting sexual education as a human right mandated by law. If you can successfully brainwash children, then you have won the next generation of adults.

This sexual education involves the following:41

- Teach children various ways to obtain sexual pleasure.
- Promote condoms to children without informing them of their failure rates.
- Teach children to masturbate.

- Encourage children to experiment sexually with individuals of their own sex or the opposite sex.
- Promote anal or oral sex to children or teach them these behaviours are safe.
- Promote promiscuity to children as a right.
- Denigrate the religious and cultural values of their parents or community.
- Provide sexual counselling, information or services to minors without parental consent.

In pursuit of this sexual revolution, the UN – dominated by the US - consistently opposes any pro-family arguments by conservative countries. In fact, The US has refused to allow a a recognition of the prior right of parents to guide the education of their children.⁴²

A key lobby group in this matter is the International Planned Parenthood Federation (IPPF). The aim of their programmes is to get the next generation to demand their sexual rights. They operate in most countries and in 2010 alone received \$3.5 million from UN agencies and the World Bank. A number of the people representing developing countries in UN negotiations are actually paid employees of International Planned Parenthood. One of their leaflets distributed at the UN says:

Young people . . . are entitled to sexual pleasure and how to experience different forms of sexual pleasure is important for their health.⁴³

This is given to children as young as ten-years old.

Their '*It's All One*' programme was launched at the UN HQ, is endorsed by the United Nations Fund for Population Activities (UNFPA) and was created by the Population Council. It gets teachers to lead discussions on homosexuality, sexual diversity, how sexual minorities are treated in society, and how children's rights are violated. It claims that its priorities were established by, 'the global health and education agencies, including the United Nations General Assembly, UNAIDS, the World Health Organization (WHO), the United Nations Educational, Scientific and Cultural Organization (UNESCO) and that it "respond[s] to international policy mandates including the Millennium Development Goals." Therefore, the UN is behind this agenda. Some examples from this publication include:⁴⁴

- Preparing a short skit involving an intimate relationship for a married, male–female unmarried, or same-sex couple.
- A worksheet on sexual desire that includes questions on erections, vaginal lubrication, and sexual fantasies.
- Discussion on how sexual minorities are treated in society and how their rights are violated.
- Real case studies and discussion on homosexuality with the objective of empathising with them.
- A true/false test on sexual behaviour that includes questions and answers on masturbation, orgasm, ejaculation, oral sex, sexually pleasing a partner, and penis size.

Working with Planned Parenthood and sharing their objectives is UNESCO, indeed one of the main authors of a UNESCO document (*International Guidelines on Sexuality Education*) was from SIECUS (see later). Furthermore, in October 2010 the UN General Assembly claimed that there is a human right for children to have sexual experiences and

this requires comprehensive sexual education at the beginning of their schooling.⁴⁵ This means sexualising children as young (or younger) than five.⁴⁶ In wiser years gone by this would have been seen as the agenda of paedophiles. This report is damning about the restrictions placed by religious beliefs and even ignores, or downplays, the danger of sexually transmitted infections and affirms the Yogyakarta Principles. It also criticises parents who remove their children from such sexual education. The report also calls on the UN High Commissioner to react to challenges to this agenda.

The policy of the UN in this matter can only be said to be astounding in its stupidity and wickedness. Since when was it the state's job to mandate for sexual pleasure?

The role of Obama

In 2008 Barack Obama's representative to the UN (under direct instructions from Obama) supported a provision endorsing the *International Guidelines on HIV/AIDS and Human Rights*, which call for the legalisation of prostitution and same-sex marriage, and graphic sexuality education for children in all nations. This was contrary to what Obama had pledged in his election campaign. He said one thing at home and another at the UN. This led to a shift in American policy on sexual rights at the UN.

A snapshot of Obama's policy is seen in this quote:

Agencies involved with foreign aid, assistance, and development shall enhance their ongoing efforts to ensure regular Federal Government engagement with governments, citizens, civil society, and the private sector in order to build respect for the human rights of LGBT persons.⁴⁷

This began an aggressive policy towards African and Islamic nations, which has been detailed elsewhere in this paper. Obama issued a directive to all US embassies and foreign agencies making LGBT rights a 'top priority'. This has done untold damage to local people in various countries, especially those with a strong Christian or Islamic tradition on the family, where the UN has imposed the sexual rights agenda with sanctions. This has, in turn, exacerbated hostile relations against the US. In June 2011, for example, a Gay Pride and LGBT event, instituted by Obama in the US embassy in Pakistan, led to serious anti-American protests and condemnation in the legislature. The largest Islamist party labelled it as an act of '*social and cultural terrorism*'.⁴⁸

Despite a backlash to Obama's policy, especially in the African states, Obama threatened developing countries with withdrawal of humanitarian aid to those countries that do not comply with his LGBT agenda. David Cameron supported him on this. Despite officials denying this blackmail, representatives of African nations have stated that this is exactly what is happening. Demands issued in 2011, under the Freedom of Information Act, regarding communications between the US government and foreign embassies on this matter have not been forthcoming (which is illegal).

Examples of local initiatives:

- The Obama administration set aside \$3 million to fund LGBT activists groups in foreign countries.
- The US government funded a concert by Lady Gaga to promote LGBT rights.

- The Obama policy allows LGBT rights groups to determine what constitutes discrimination, homophobia and intolerance. These organisations are to be given funding and training to document anything they consider to be a violation of their claimed human rights. [In the past supposed 'violations' have included: church teaching that homosexuality is wrong; failure for schools to teach homosexual sex as normal; laws on heterosexual marriage and adoption; therapies for people seeking help to counter homosexual feelings etc.]
- In June 2010, Mari Carmen Aponte, the ambassador Obama appointed to El Salvador, angered Salvadorans by writing an editorial in a major newspaper encouraging their people to accept homosexuality. Her letter caused uproar.
- US embassies hosted Gay Pride events in Hungary and Kenya resulting in particularly strong negative reactions.
- The Obama administration issued a fact sheet boasting about advancing LGBT rights across the world and in the US.
- Promoting (and seeking mandatory) explicit sexual rights 'comprehensive sexuality education' in co-operation with the International Planned Parenthood Federation.
- US Department of State calls officials have been accused of threatening and pressurising heads of developing nations to accept provisions in UN documents under negotiation to protect sexual orientation and other sexual rights.

There is not the space here to continue detailing various moves made by Obama to pursue this LGBT rights agenda; suffice to say that there are continuing strategies and policies (many activated by Hilary Clinton) being pursued to overtly influence, or threaten, developing nations. For more information see: standforfamiliesworldwide.org which has supplied much of this information.

The roots of the modern sexual rights movement

For detailed information on this point one should read the works of Dr. Judith Reisman who has written widely on the origins and history of the sexual rights movement.⁴⁹

The key figure in the sexual rights movement is Dr. Alfred Kinsey (1894-1956) who was an atheist and eugenicist. He taught that children are sexual from birth, pornography is harmless, adultery can benefit marriage and that most people have promiscuous lifestyles. While portrayed as a typical academic professor, in fact he was a sex addict who exposed himself in public, produced sex films with his students and wife, and had sadomasochistic tendencies, which led to an early death.

Part of his research documented the sexual abuse of children by paedophiles. Data was even obtained from Rex King who raped at least 800 infants, children, relatives and strangers. Kinsey called Rex King his 'hero'. There is no doubt that Kinsey was sick and wicked. His associate and co-author, Wardell Pomeroy, claimed that religious taboos were restrictive and the whole American belief system needed to be revolutionised.

Despite all this, Kinsey is today revered as a sexual rights pioneer. He was funded by the Rockefeller Foundation and Playboy magazine to conduct sex research at the University of Indiana. He used a questionnaire to discover the secret details of people's sexual activities to produce a paradigm for society. However, the volunteers in this programme included prisoners, prostitutes and paedophiles; the data was never going to be normal, but it was touted as 'mainstream America'.

His research was published⁵⁰ and led to a rising belief that everybody was sexually promiscuous and that this was normal behaviour. Sex offenders were just those who were unlucky to get caught. He also claimed that 10% of the population is homosexual when the reality is that it is usually about 1% and rarely rises in some places to 3+%. He influenced the US penal code to reduce penalties for 52 sex crimes; indeed, the legal database, at one point, had 650 citations to Kinsey. Needless to say, STIs and rapes in America skyrocketed.

After this a number of lobby groups were established based upon Kinseyan principles, such as: Sexuality Information and Education Council of the United States (SIECUS) and the Planned Parenthood Federation. Pomeroy was the Vice President of SIECUS's Board of Directors in 1980. Some key officials within SIECUS were so radical that they argued publicly for relaxing the restrictions against adult/child sexuality and even incest.⁵¹

These heavily influenced policy in the US and the UN. A SIECUS employee was the main author of the UN's '*International Guidelines on Sexuality Education*'. They also promote graphic sexual education literature and comics; including instruction in high-risk sexual practices. The strategy of the lobby groups is to battle to gain one item at a time so that society fails to notice what is going on. For instance, what began with the legalisation of sodomy in 1975 in California, has now ended up with successive laws including a bill in 2012 making it illegal for minors to receive therapy for unwanted same-sex attraction.

Conclusion

History shows us that one of the quickest ways to destabilise a society is to overturn family values and remove religious taboos by introducing a promiscuous sexual revolution. Once this has been established, society slides downwards in an ever increasing hedonistic chaos. Such a society is then easily overcome by a dictator figure or a powerful force.

If Satan is seeking to eliminate family and Christian religion in order to establish a totalitarian world government (which the Bible makes clear) then the current sexual rights revolution should come as no surprise. It is part of a satanic strategy where much worse will follow.

Example: the application of man-made global warming lies to prevent the industrialisation and progress of African nations.⁵²

Man-made global warming is a gigantic lie. It is hubris to even think that mere men could directly affect such a global, complex phenomenon as the weather, which is largely controlled by the power of the sun and a complicated natural system of clouds, oceans and so on.⁵³ In any case, global average temperature has been steadily declining since 1990 and the UN warnings about disasters (such as eliminating the population of the Maldives) have not occurred and they have been removed from the UN website.

An example of global warming scaremongering is given by Ted Turner, founder of CNN: We'll be 8 degrees hotter in 10, not 10 but 30 or 40 years and basically none of the crops will grow. Most of the people will have died and the rest of us will be cannibals.

Civilisation will have broken down. The few people that are left will be living in a failed state like Somalia or Sudan. And living conditions will be intolerable. The droughts will be so bad there will be no more corn growing.⁵⁴

Instead of being 8 degrees hotter, the global temperature has declined significantly, and continually. It had already been declining for eighteen years when he uttered these foolish words.

The weather has always developed in cycles of cold and warm. The Romans could grow grapes in York and the Medieval Warm period enabled European Renaissance prosperity. This was followed by the mini-ice age, which, at its worst, enabled fairs to be held annually on the frozen Thames. After that we had a growing warm period which lasted up to 1990 and now it is annually getting colder. Australia and Rome have experienced unusual snowstorms for instance.

However, Satan never lets something as banal as facts get in the way of his objectives, and world governments are still using global warming (now called 'climate change' since it is obviously getting colder) to generate taxes⁵⁵ and encourage fear of Armageddon. This is a general effect. However, there is a much more sinister direct effect of this rogue environmentalism.

Indoor smoke is the deadliest form of pollution. According to the World Health Organisation, 4 million children under the age of 5 die each year from respiratory diseases caused by indoor smoke, while millions of women die early from cancer and lung disease. African poor people need electricity but are being denied it.

Environmental campaigners say that we should impose stringent policies to cut human carbon emissions [the 'Precautionary Principle'] and the use of this global fear drives a political agenda; but it is not balanced by an argument about the possible benefits of using fossil fuels for development of the Third World.

The current political focus to reduce carbon emissions has the consequence of halting necessary industrial development in the third world, prolonging endemic poverty and disease. Efforts to reduce CO₂ are killing Africans, who have to burn fires inside their home, causing cancer and lung damage. This is because their governments are being encouraged to use wind and solar panels that are not capable of supplying the continent with electricity, instead of coal and oil-burning power stations that could.

My big concern with global warming, is that the policies being pushed to supposedly prevent global warming, are having a disastrous effect on the world's poorest people. ... Let me make one thing perfectly clear. If we're telling the Third World that they can only have wind and solar power, what we are really telling them is, 'You cannot have electricity'.⁵⁶

The environmental movement has evolved into the strongest force there is for preventing development in the developing countries.⁵⁷

We are being told, 'Don't touch your resources. Don't touch your oil Don't touch your coal.' That is suicide. 58

I don't see how a solar panel is going to power a steel industry, how a solar panel is going to power a railway network. It might work to power a small transistor radio ... There is somebody keen to kill the African dream, and the African dream is to develop.⁵⁹

A group of US engineering students designed a solar energy system to power a clinic in Getongoroma village in Kenya. This provides the clinic with 24 kilowatt hours per day; but note that this is 20% less than the average US household uses. The cost to implement this is \$120,000. Kenyan economist James Shikwati complains that, 'The rich countries can afford to engage in some luxurious experimentation with other forms of energy. But for us, we are still at the stage of survival.' In Kenya the average person earns a mere \$2 a day.

Solar power is useful in desolate areas nowhere near a power grid. Clinics along the Thai-Burmese border utilise solar panels which each cost \$525. However, each of these panels supplies *130 watts of power*. - less than two or three light bulbs usage. A fridge uses 200-700 watts, so these clinics can't keep many medicines or blood, neither can they use electrical scanners, electric microscopes (for night-time), ultrasound– exactly what they need. In many African clinics with solar power, they can either use lights or the fridge, but not both at the same time.

Imagine being denied hot water, light, unable to preserve food or water, forced to go to sleep early and unable to work in the dark. This is the life the West is forcing upon many Africans in the name of global warming. After an impoverished life full of suffering, many African people die early. Yet Africans are sitting on huge reserves of coal and oil.

Is it extremism for Shikwati to claim that someone is killing the African dream? Apparently not. Elizabeth Whelan⁶⁰ quotes Charles Wursta, the head scientist for the US Environment Defence Fund, in her book *Toxic Terror*.⁶¹ Regarding the worldwide ban on DDT in the 70s which was feared would to lead to millions of deaths; he said 'This is as good a way to get rid of them [the black poor] as any'. DDT had controlled malarial mosquitoes but after the ban in the 60s, some claim that 10-30 million poor people, mostly children, died in Africa from malaria as a result. While the causes of DDT cessation are disputed (the mosquitoes had developed resistance to it anyway), and while many claim that environmentalists did not cause the ban, the point is that African lives were considered expendable by a senior US scientist.

We have to ask, 'Why is Africa being kept undeveloped'?

One clear thing that emerges from [the global warming] debate is the point that **there's somebody keen to kill the African dream**. And the African dream is to develop. By telling developing countries to use 'clean energy sources' what we are saying is, 'You will not have electricity at all.' We are saying, "You will live a life of backbreaking work. You will see at least one of your children die in early

childhood, probably more than that. You will experience incomparably more painful and dangerous pregnancy and labour than women in developed countries, and you will face it more frequently because you will fear losing your children to disease, starvation or violence. You will be too busy struggling for survival to protest the rampant official corruption or the government troops who rape you, destroy your villages and disregard your votes. Ultimately, you will die 20-30 years younger than I will. But it will be worth it, because I' ve been told there is a scientific consensus that all this is necessary to avert global warming.⁶²

One of the biggest threats to western stability, and especially American hegemony, is the rapid development of China. America is already bankrupt and in hock to China and Japan, but the rate at which China is swallowing up natural resources and flooding markets with cheap goods is terrifying to American economists.

Oil is running out (by some estimates within 5-10 years) and the US cannot face being without oil and gasoline, hence the corrupt wars in Afghanistan, Iraq and even Kosovo. All these military actions are tied in with oil and gas reserves or connected to oil/gas pipelines. Despite being politically tied to the necessary withdrawal from Iraq, the US has built 14 massive military bases as well as industrial complexes in the country, in addition to controlling the oil exports. So desperate is it to protect an infrastructure based on fossil fuels which will never be able to be sustained new forms of 'green' energy.

But China is now dominating the world's markets and has the economic clout and labour force to match. It is eating up natural resources and America is frightened. The situation is made worse by the fear that relations with Vladimir Putin may destabilise the supply of oil from the Caspian Sea area.

The existing situation is very threatening to the US and this scenario was not predicted when it seemed that China was doomed to eternal serfdom by Communist regimes. The economic rise of India is also a threat. But imagine if the sleeping giant of Africa was awakened as well. Africa has a huge population and massive natural resources. If African states were allowed to industrialise and co-operate it would be another China, perhaps worse. Third World states could possibly end up dominating world affairs. As America fumbles into worsening bankruptcy by massive military spending⁶³ and futile wars,⁶⁴ the last thing it needs is a prosperous, developed Africa. Hence all the US polices that have the effect of keeping Africa poor and disorganised: doing nothing to stop humanitarian crises caused by tyrants, resisting cheap generic AIDS drugs, ignoring genocide and ethnic cleansing, refusing to aid development projects, refusing to pass on necessary technologies, giving pitiful amounts of aid for the poor, demanding that sustainable fuels are only used due to global warming etc.

The US cannot have Africa develop or its place as world leader will be eventually threatened (the US is facing its demise anyway due to its tunnel vision, heartless unrighteous policies and ridiculous military spending). Thus the use of global warming to stop Africa (and hinder India too) from developing by using their prolific amounts of fossil fuels.

Despite its posturing with aid, America (and the UN) is deliberately hindering African states from developing; and this contributes to millions of deaths each year. Thus global warming is used as an excuse to achieve two satanic ends: killing lots of people (the majority of whom are Christians) and preventing Africa from industrialising and thus making the development of a global totalitarian state more difficult and complicated.

Example: reducing the world population.

Based on the errors of Malthus, many in power believe that the planet cannot sustain the growing world population. Furthermore, they fear that there will be insufficient economic growth to enable all to have jobs, which will create an underbelly of unstable miscreants in society. In fact, God promises to supply sufficient resources for human society; the problem is that people and nations in power (20%) aggregate great wealth and affluence to themselves and leave the poor (80%) to starve.

When the world's population was much smaller in ancient times, there were still the same problems that we face today: famine, failed harvests and less food, warfare, pestilence and plague, genocide etc. A small population does not guarantee Utopia. Furthermore, the planet is large enough to cope with a high population if the rich did not squander resources. It has been estimated that the whole human population could fit comfortably in a corner of Brazil with several acres of land per person. It could fit (with little space to move) on Vancouver Island. This puts things into perspective.

Ever wanting more wealth, there is evidence that the secret powers that really control the planet want to reduce the human population by as much as 90%. This is part of a plan to invent a new civilisation. This is to be achieved through direct and indirect means: limiting the population increase and engineering the deaths of millions.

The need to restrict the world's population has been long expressed, even in modern public politics:

We have to reinvent the paradigm of our existence, to build a new civilisation ... developing a global consciousness ... the next phase of human development. ... Civilisation will shift and new values and new ways of life will be needed to find real solutions to the problems of our environment, a way out of the ecological crisis. ... We have to change the nature of consumption. ... through culture and education and within the framework of laws we shall have to address the problem of controlling the world's population.⁶⁵

The unadorned truth is that we do not need now, and will not need later, much of the marginal labour -- the very young, the very old, the very uneducated, and the very stupid. 66

There was very strong agreement that religious institutions have to take primary responsibility for the population explosion. We must speak far more clearly about sexuality, about contraception, about abortion, about the values that control the

population, because the ecological crisis, in short, is the population crisis. Cut the [world's] population by 90 percent and there aren't enough people left to do a great deal of ecological damage.⁶⁷

Out of the full spectrum of human personality, one-fourth is electing to transcend One-fourth is destructive [and] they are defective seeds. In the past they were permitted to die a 'natural death.' ... Now as we approach the quantum shift from the creature-human to the co-creative human -- the human who is an inheritor of god-like powers -- the destructive one-fourth must be eliminated from the social body Fortunately, you are not responsible for this act. We are. We are in charge of God's selection process for planet Earth. He selects, we destroy. We are the riders of the pale horse, Death.⁶⁸

In 1932 *Plan for Peace,* by American Birth Control League founder Margaret Sanger, was published. She called for coercive sterilisation, mandatory segregation, and rehabilitative concentration camps for all 'dysgenic stocks', including Blacks, Hispanics, American Indians and Catholics.

Thus, even though it is quite true that any radical eugenic policy of controlled human breeding will be for many years politically and psychologically impossible, it will be important for UNESCO to see that the eugenic problem is examined with the greatest care and that the public mind is informed of the issues at stake that much that is now unthinkable may at least become thinkable.⁶⁹

It is alleged that the current insecurities about world population in the political elite can be traced, at least, to a symposium on world development in 1957, though worry about over-population goes back to Malthus. The fear was expressed that over-population would destroy the earth by the year 2000 (clearly these fears were unfounded). President Eisenhower secretly commissioned a group of scholars, known as *The JASON Society* to review the conclusions of the 1957 symposium. The participants were, allegedly, also key members of other elite groups such as the Order of the Quest and the Council on Foreign Relations. The group proposed three alternatives. The first (involving nuclear weapons) was rejected by Eisenhower, though he (and the Soviet Union) approved the other two.

The first of these was a network of about 75 underground cities (now said to be more numerous) for chosen elite members to hide away in when the self-destruction occurred (supposedly in 2000). The public was told that these were to deal with a nuclear holocaust. Also planned were strategies for birth control, sterilisation and the introduction of bio-engineered deadly diseases.

The fair face of population control comes under the UN's drive for 'sustainable development'. It raised awareness of this on what it termed '7 Billion Day' on 31 October (Halloween) 2011; the day when the earth's population was thought to hit 7 billion.

Agenda 21 is a programme launched by the UN for sustainable development (inc. population reduction) around the world.⁷⁰ 178 nations adopted this programme, covering consumption of natural resources, pollution, education and financial mechanisms.

The United Nations Population Fund was supposedly to provide supplies and services for reproductive health (begun in 1969) but was scandalised for using coerced sterilisation and forced abortions. Obama restored funding to UNFPA, which had been cut off by Regan, and both Bush presidents. Thus Obama has made US taxpayers fund (\$845.3m) for forced abortions and sterilisation in foreign countries. Britain contributed \$53m to the UNFPA in 2008. In 2009 UNFPA published a report blaming global warming on over-population.⁷¹

Modern aims to effect sustainable development are reflected in the following: Maintain humanity under 500,000,000 in perpetual balance with nature.⁷²

A total population of 250-300 million people, a 95% decline from present levels, would be ideal. 73

My three main goals would be to reduce human population to about 100 million worldwide, destroy the industrial infrastructure and see wilderness, with it's full complement of species, returning throughout the world.⁷⁴

The world today has 6.8 billion people. That's heading up to about nine billion. Now if we do a really great job on new vaccines, health care, reproductive health services, we could lower that by perhaps 10 or 15 percent.⁷⁵

In order to stabilise world population, we must eliminate 350,000 people per day.76

Proposed measures to reduce population

ABORTION

Abortions are now available on demand in the west; sometimes even without parental consent in teenagers. In China pregnant women lacking birth permits are hunted down and forcibly aborted. This could spread in the future, even in the US:

Indeed, it has been concluded that compulsory population-control laws, even including laws requiring compulsory abortion, could be sustained under the existing Constitution if the population crisis became sufficiently severe to endanger the society.⁷⁷

LIMITATIONS ON CHILD BIRTH.

The UN plans for 'Fertility Management' and 'family planning': '*What would it take to accelerate fertility decline in the least developed countries?*'.⁷⁸ Influential people in the US are already thinking about applying this to Americans:

Childbearing [should be] a punishable crime against society, unless the parents hold a government license ... All potential parents [should be] required to use contraceptive chemicals, the government issuing antidotes to citizens chosen for childbearing.⁷⁹

The most merciful thing that a family does to one of its infant members is to kill it.80

Birth control must lead ultimately to a cleaner race.⁸¹

STERILISATION

Forced sterilisation has already occurred in India in the 1970s. State-of-emergency powers were introduced to force an increase in sterilisation. From 1976 to 1977 the number of operations tripled to more than eight million. In certain states, sterilisation became a condition for receiving new housing or government benefits. In some cases the police rounded up poor people and took them to sterilisation camps.

The UN is already funding various sterilisation programs and the US is considering it according to Obama's chief science advisor John Holdren:

A program of sterilising women after their second or third child, despite the relatively greater difficulty of the operation than vasectomy, might be easier to implement than trying to sterilise men. ... The development of a long-term sterilising capsule that could be implanted under the skin and removed when pregnancy is desired opens additional possibilities for coercive fertility control. The capsule could be implanted at puberty and might be removable, with official permission, for a limited number of births.⁸²

Holdren has written about discussions to add chemicals to the water supply to sterilise entire populations. This is only a step up from the existing addition of toxic fluoride to the drinking water of most US states to further business interests. He says, 'Adding a sterilant to drinking water or staple foods is a suggestion that seems to horrify people more than most proposals for involuntary fertility control.' Clearly, it doesn't horrify him.⁸³ He also writes about forcing women to be sterilised after having two or three children and forcing women to have abortions: 'Indeed, it has been concluded that compulsory population-control laws, even including laws requiring compulsory abortion, could be sustained under the existing Constitution if the population crisis became sufficiently severe to endanger the society'.

PLANNED EPIDEMICS

While this is hard to believe, and harder to prove, many claim that this has already been implemented. Some claim that AIDS, Ebola and other serious diseases were developed in American laboratories. For instance, Dr. Len Horowitz affirms⁸⁴, that the HIV virus was introduced throughout the majority of black populations in Africa via the World Health Organisation during their mandatory smallpox vaccine campaigns of 1976-1980. Other respected scientists are open about the need to reduce human population.

The only feasible solution to saving the Earth is to reduce the population to 10 percent of the present number ... War and famine would not do. ... disease offered the most

efficient and fastest way to kill the billions that must soon die if the population crisis is to be solved. 85

This is not the first time this has been suggested. In 1947 Nobel prize-winning microbiologist Sir Fram Macfarlane urged the Australian government to use biological weapons against Indonesia and South-East Asia to target food crops and spread infectious diseases in order to kill large numbers of the population. This was disclosed in 2001 when top-secret files were declassified by the National Archives of Australia. Prince Phillip has been widely quoted as saying, '*In the event that I am reincarnated, I would like to return as a deadly virus, in order to contribute something to solve overpopulation.*'

What is noteworthy in all this is that fears about over-population lead directly to placing a cheap value on the human life of others.

However, we have considered enough evidence and supposition. Essentially a 90% reduction of the world population is impossible, by any means.⁸⁶ However, what is certain is that a fear about the rising world population exists in high-ranking elites and means to deal with this are in place. There is no doubt that many cases of innumerable deaths have occurred where the west did nothing to alleviate it, though they had the means.⁸⁷ Satan is active to kill many people and world governments are colluding in this mission one way or another.⁸⁸

Example: moves towards world government.89

The easiest way to show this is by an introductory timeline.

Obviously there is going to be no peace or prosperity for mankind as long as [the earth] remains divided into 50 or 60 independent states until some kind of international system is created...The real problem today is that of the world government.⁹⁰

We are at present working discreetly with all our might to wrest this mysterious force called sovereignty out of the clutches of the local nation states of the world. All the time we are denying with our lips what we are doing with our hands.⁹¹

An address by John Foster Dulles, later US Secretary of State, proposes that America lead the transition to a new order of less independent, semi-sovereign states bound together by a league or federal union. 28 October 1939.

H. G. Wells proposes a 'collectivist one-world state' or 'new world order' accomplished through 'universal law' and propaganda, which is comprised of 'socialist democracies'. He advocates 'universal conscription for service' and declares that 'nationalist individualism...is the world's disease. ... The manifest necessity for some collective world control to eliminate warfare and the

less generally admitted necessity for a collective control of the economic and biological life of mankind, are aspects of one and the same process." 1939.

The New World Order is published by the Carnegie Endowment for International Peace and contains a select list of references on regional and world federation, together with some special plans for world order after the war. 1940.

John G. Alexander calls for a world federation. 1940.92

World government is the ultimate aim...It must be recognised that the law of nations takes precedence over national law...The process will have to be assisted by the deletion of the nationalistic material employed in educational textbooks and its replacement by material explaining the benefits of wiser association.⁹³

It will be just as easy for nations to get along in a republic of the world as it is for us to get along in a republic of the United States.⁹⁴

24 October 1945 -- The United Nations Charter becomes effective. Senator Glen Taylor (D-Idaho) introduces Senate Resolution 183 calling upon the US Senate to go on record as favouring creation of a world republic including an international police force.

The preliminary draft of a World Constitution is published by US educators advocating regional federation on the way toward world federation or government with England incorporated into a European federation. The Constitution provides for a 'World Council' along with a 'Chamber of Guardians' to enforce world law. Also included is a 'Preamble' calling upon nations to surrender their arms to the world government, and includes the right of this 'Federal Republic of the World' to seize private property for federal use. 1948.

We shall have a world government, whether or not we like it. The question is only whether world government will be achieved by consent or by conquest.⁹⁵

Prince Bernhard of the Netherlands establishes the Bilderbergers; international politicians and bankers who meet secretly on an annual basis. 1954.

The path to total dictatorship in the United States can be laid by strictly legal means, unseen and unheard by the Congress, the President, or the people. ... outwardly we have a Constitutional government. We have operating within our government and political system, another body representing another form of government, a bureaucratic elite which believes our Constitution is outmoded and is sure that it is the winning side.... All the strange developments in the foreign policy agreements may be traced to this group who are going to make us over to suit their pleasure.... This political action group has its own local political support organisations, its own pressure groups, its own vested interests, its foothold within our government, and its own propaganda apparatus.⁹⁶

It would be tedious to add more quotes and information, (hundreds could be supplied); enough has been revealed to show that there has been a slow and steady move towards

world government in the last hundred years, more than at any other time in history when sovereign nations then vied for greater power by warfare.

Overt Satanism in the establishment

A problem arises here and that is the secret nature of Satanic and Black Magic societies. Since the activities of real Satanists are hidden away (usually because they are criminal), it is difficult to get to the truth of what is going on and how deep the wickedness is. Various websites will tell you all sorts of things, but these are rarely properly sourced and most parrot the same anecdotes.

Notwithstanding this, there is no doubt that real Satanism and Black Magic has penetrated very high levels of the establishment for a very long time. From time to time there is an exposure of this in some scandal, which is quickly hushed up and covered over. The vast proliferation of paedophile groups in high-level establishment departments is one refection of the Satanism that is closely allied to it.

All we can do here is point to some significant markers in the rise of Satanism in high levels of government and society.

The influence of Aleister Crowley on Satanism

Crowley [1875-1947] is the most famous occultist of the 20th century who had a very powerful influence on modern Satanism and the practice of magic.⁹⁷ You would be amazed at how many influential people were, in turn, affected by him – he even appears on the cover of Sgt. Pepper's Lonely Heart's Club Band.⁹⁸

Despite being raised in a Plymouth Brethren home, Crowley opted for the dark side from a very early age and was called 'The Great Beast 666' by his own mother; a title he gladly accepted. We can ignore a detailed biography of Crowley here, which will only waste space, but it is easy to discover this information should you want to. All we need to say is that he became a drug abuser, with a voracious bisexual, perverse sexual appetite and a master practitioner in the dark forces of the occult. He believed that sex and drugs could release powerful magical forces; and magic gives a person power to control the world around one. He is even said to have killed his first mentor in an occult duel.

Being too perverted for any group, he began to develop his own system, partly based on revelations given by a spirit guide claimed to be the devil himself. These became the basis of his famous *Book of the Law*. His next book was *The Equinox* (1909). In turn these, especially the latter, became the basis of modern Satanism, or devil worship, after the 1960s.⁹⁹ The summary of his philosophy is '*Do what you want*'; the essence of the devil's own character and the reverse of Christianity.

It is noteworthy that Anton LaVey's 1969 book, *The Satanic Bible*, represents Satanism in the following way:¹⁰⁰

• Indulgence instead of abstinence.

- Vengeance instead of turning the other cheek.
- Enjoying sin instead of fleeing sin.
- Pursuing personal gratification instead of self-denial and personal sacrifice to a higher morality.

In other words, the very opposite of Christian ethics. We could summarise Satanism as materialism and hedonism, which had been formerly expressed (without reference to Satan) by the Marquis de Sade in the 18th century.

Crowley's life was one of sheer perversion and evil based on sexual magic. He conducted perverse sexual orgies in his 'Abbey of Thelema' in Sicily in the 1920s and decorated the walls with images of his exploits, that included paedophilia and rape.¹⁰¹ The point of all this was to destroy all sense of morality in the conscience creating a vacuum; in this vacuum powerful supernatural beings would appear giving enablement. His essential code was to be as sinful as is humanly possible in order to attract demonic assistance.

Some elements of modern Satanism

- Many Satanists are also Freemasons.
- Sexual magic, including perverse sexual rituals.
- Bisexuality, homosexuality, paedophilia, necrophilia.¹⁰²
- Various types of blood sacrifices (usually of animals) to Satan.
- Drinking blood.
- Child sacrifice during a Black Mass.¹⁰³
- Hatred of Christianity.
- Sadism and masochism.
- Hedonism.

Here we see the essence of what we would expect to see if some high-level establishment figures were Satanists. Thus we see that many high-level, powerful figures are homosexuals, Freemasons, sexually perverse, haters of Christianity, haters of Christian morals in society and many paedophiles. Also we would expect to see that these powerful people would seek (over time) to subvert normal morality by gradually introducing laws to legalise perversions, such as: homosexuality, homosexual marriage, homosexual adoption, LGBT rights, lowering the age of consent and paedophilia.

The modern political stress on one's rights (actually the rights of only certain privileged sections of society at the expense of others)¹⁰⁴ is an outcome of the satanic emphasis on materialism and hedonism. Indeed, LaVey's *Satanic Bible* opens with the theme that Satanists will occupy a place of power in the coming new world order.

The influence of Aleister Crowley on the modern establishment

Some claim that a secret elite exists of about twelve men who are all Satanists and who really run the world through international banking. The problem is that no one can prove this. However, if Satan is working towards creating a global totalitarian government, then

it would not be surprising to find that there is already a secret cabal of a few people trying to engineer this through world finance. There is probably another cabal trying to organise power and control through military strategies, and probably another cabal seeking to construct global political power bases through continental political unions. Satan will, one day, weld these together under a supreme commandeer. To achieve this the population must be brainwashed.

Mind control - psychological warfare

The way that Satan brings people under his sway is through mind control, which is achieved through brainwashing and deception (as we have established earlier). Thus we would expect that mind control would be working towards the satanic goal in nations by reversing earlier Christian principles and traditional morality and establishing centralisation of power. The last fifty years, with one social revolution after another,¹⁰⁵ is proof that this satanic social engineering has occurred.

If we examine who was behind these changes we see eminent people in the establishment, finance world, politics, culture and media; such as: Rockefeller, the Rothschilds, the Dulles brothers, Hugh Heffner, the Bush family, Rupert Murdoch and so on. The satanic roots behind many societal icons can be seen in satanic (Luciferian) symbols used openly in various aspects of society.¹⁰⁶ Whole books have been written on where these symbols can be found, from product logos, media, movies to the design of whole cities.¹⁰⁷

Declassified documents have shown that Crowley worked with British Intelligence as well as high-ranking officers in the American government. His secret society (OTO, Order of the Temple of the Orient, which he did not found but did take over) had some of the world's most powerful people as members. Crowley maintained close ties to high-level establishment figures as well as men of influence in science, law and culture. He predicted society's abandonment of Christian morality to embrace the Age of Horus (an Egyptian god). The symbol of the Eye of Horus was featured in the Olympic ceremonies.

It is claimed¹⁰⁸ that the 60s social revolution was manufactured by an elite group in Britain, modelled upon an occult vision based on paganism, particularly Egyptian occultism (which had influenced Crowley). It is certain (as many have demonstrated¹⁰⁹) that LSD¹¹⁰ was infiltrated into unsuspecting hippie groups by the CIA. A passive drugged up young society is much more easily controlled than an intelligent, angry young society and LSD could break down behaviour patterns and re-programme people.

Crowley's principles were also deeply imbibed by people in the movie industry¹¹¹ and later in television. Many of his hedonistic themes have infiltrated films, plays, music, dramas, soaps and so on.¹¹² Much of today's permissiveness stems from Crowley-type morals (or lack of them). The sub-consciousness of individuals in society was swamped with such satanic ideas.

The goal of mind control is to get the people to love their servitude:

A really efficient totalitarian state would be one in which the all-powerful executive of political bosses and their army of managers control a population of slaves who do not have to be coerced, because they love their servitude.¹¹³

This is more effective than bloody revolution, which can never be maintained forever because people will always revolt against it. The sixties counter-cultural revolution followed a speech by Huxley in 1962 where he laid out the principles of a satanic dictatorship creating the ultimate bloodless revolution where people will be conditioned to enjoy their slavery by being drugged; a '*painless concentration camp*'.¹¹⁴ Huxley himself was one of the initiates in the 'Children of the Sun', a Dionysian cult comprised of Britain's Roundtable elite youth in Oxford.

Crowley was also behind the rise of the Gay movement. The founder of the Gay Liberation Movement, Harry Hay, was a disciple of Crowley and a member of the OTO and a practitioner of sex magic. Hay played a decisive role in changing society's views on homosexuality. He also complied with Crowley's request that his teachings be circulated amongst the young.

Thus Hay was a defender and participant in the paedophile organisation NAMBLA [North American Man-Boy Love Association]. Crowley's teaching was that when the Age of Horus arrived in a New Aeon (Age) sex with children would be legalised. It is not surprising, therefore, to find that Kinsey was influenced by Crowley. Wardell Pomeroy stated that Kinsey loved Crowley's homosexual writings, and went to Crowley's former sex temple, the Abbey of Thelema, to obtain Crowley's sex diaries.¹¹⁵ Crowley had instructed a number of paedophiles to keep sex diaries documenting the rape of children and kept one himself. Kinsey recorded this data that included the rape of babies a few months old. Kinsey (with Satanist Kenneth Anger) also removed the paint off the walls (placed by the Italian government) to uncover the paedophile pornographic images.

Thus we see the following:

Satan \rightarrow Crowley \rightarrow Kinsey \rightarrow The academic establishment \rightarrow The UN sexual rights agenda

We have looked here at only one proponent of magic and Satanism, Crowley, and the influence he brought to bear on society. We could list other Satanists and evaluate their influence also, beginning with Karl Marx, but enough has been said to make the point. The collapse of Christian morals in western society is the result of many people with overt satanic beliefs.

Conclusion

Lessons to learn from this

It is absolutely critical that believers prepare themselves to be free of all deception, which is very insidious. So many Christians today are already deceived and being deceived. To be safe for the future one has to shed all satanic brainwashing and focus clearly upon the word of God. Without proper Bible study no one will ever clear their minds of demonic lies and see the truth. This requires effort.

In everything put the Lord Jesus Christ centre. He must be pre-eminent. It is only when the Lord is put under something else in your life that problems arise; in fact this is idolatry. However, so many Christians, without realising it, put a man in place of Christ by trusting in authoritarian leaders or believing false teachers.

Do not be fooled by politicians. Power corrupts and we have more than enough evidence, even in recent years, that Parliament is riddled with corruption of even the baser sort. Some Christians have decided to throw in their lot with some of the newer political parties, or form one of their own. This is pointless. God has already told us where politics is heading; how can you expect to stop the tide that God empowers?

Try to get a good handle on eschatology so that you are informed about, at least, the generalities of the future. If God saw fit to give this information to us, then we should certainly search it out.

God is in control

We have to remember that all of God's purposes in the earth, whether it is providence to keep the world going or sovereignty in determining the nations, the purpose of God is the bringing forth of the elect and maturing them to fulness. All God's actions are centred in the nurturing of the elect, even when decreeing times of persecution.

The control of the times is not in the hands of some delegated angel but in the heart of our loving heavenly Father. Whatever he decides for our lifetimes, his purpose is always towards us for our good. As God was the power behind allowing Job to be tempted by severe trials, so he is behind the trials that the church undergoes in the time of the end. He is a God that does not change, that cannot change, and always loves his people.

The satanic strategy in the earth today is only active by the permission of a sovereign God who is using it to his own purpose.

Don't be fooled, either by demonic lies or triumphant misled Christians

Some (notably American triumphalist Charismatics) say, '*The power of Satan can be broken for this nation now*.' This is a delusion based upon a triumphal postmillennialist eschatology or Dominionism. Such claims are clearly contrary to Scripture, which states that at the end the church is in apostasy and the Lawless One is in control (2 Thess 2).

Such people seriously believe that they can change their nation to be dominated by Christian values and can withstand the coming antichristian world government until the return of Christ. This completely fails to see the point that the end is where the whole world fulfils its sinfulness in the eyes of God and is ripe for judgment. Thus all nations come under the power of the antichristian world government:

And all the world marvelled and followed the beast. ... All who dwell on the earth will worship him. ... He causes all, both small and great, rich and poor, free and slave, to receive a mark on their right hand or on their foreheads. Rev 13:3, 8, 16

Babylon is fallen, is fallen, that great city, because she has made all nations drink of the wine of the wrath of her fornication. Rev 14:8

The kings of the earth committed fornication, and the inhabitants of the earth were made drunk with the wine of her fornication. Rev 17:2

For all the nations have drunk of the wine of the wrath of her fornication, the kings of the earth have committed fornication with her, and the merchants of the earth have become rich through the abundance of her luxury. Rev 18:3

All the nations were deceived. Rev 18:23

Jesus is victorious

The only thing we need to be certain of, in all this, is that Jesus has the victory and the plan of God, in Christ, will succeed. Those who are faithful to God, those who are elect in Christ, will share in this victory and have eternal life.

I watched then because of the sound of the pompous words which the horn was speaking; I watched till the beast was slain, and its body destroyed and given to the burning flame. Dan 7:11

And then the lawless one will be revealed, whom the Lord will consume with the breath of His mouth and destroy with the brightness of His coming. 2 Thess 2:8

Jesus Christ, the faithful witness, the firstborn from the dead, and the ruler over the kings of the earth. Rev 1:5
