

The world has changed; be prepared

Introduction

One aspect of my job is to warn you about events and possible outcomes. This is part of any normal pastoral activity. In a sane world this should be unnecessary, as everyone should be able to see what is happening. However, in this world where the media and government do little but spout lies, this is not the case. I offer these thoughts to help you prepare to safeguard your future.

The dominant rouble (ruble)

The world changed yesterday. This is not an understatement; it is an economic fact of life.

As I previously warned, the insane Western sanctions on Russia have done nothing but harm Western people, especially poor people, and have strengthened Russia. It is as if this was the plan all along.

By making Russia unable to purchase commodities with euros, pounds or dollars, Putin has responded by demanding that the West (at least the 'unfriendly nations') pays for Russian oil and gas in roubles. It set up the rouble as a reserve currency backed by gold; 5,000 roubles equals one gram of gold. The finance minister has also intimated that they may accept crypto-currencies. This will give a boost to Bitcoin and other cryptos.

Before the sanctions Putin's approval rate was over 60% but now it is above 80%. So much for the lies of the media that he is facing massive opposition in Russia. This is comparative to the lies the media spouted against Assad in the last CIA/NATO sponsored war in Syria.

The sanctions were never going to seriously hurt Russia because Putin has so developed the nation's security (unlike Britain) that it is self-sufficient and he has trade relationships with China and India. Russia has the raw materials; China and India manufacture stuff with them. Food prices are not going up in Russia (there was a temporary blip) and neither are energy prices; Russia has vast reserves of grain and energy. At this point, petrol is 50 euro cents a litre (35p) in Moscow. Meanwhile in the West food and energy prices are going through the roof and this is but the beginning. People are going to die. Germany has already warned its citizens that food prices will now go up by 20-50%. Germany is in a critical situation.

Putin is also going to demand that Russian fertiliser, vital for Western farmers, must be paid for in roubles as well as wheat and other commodities. This poses problems for Western governments to actually get roubles, so they are likely to have to pay in gold thus increasing Russia's stocks (already high) and further strengthening the rouble. He later stated that Russia's '*enemies*' (Medvedev) or '*unfriendly nations*' (Putin) will not get anything.

Despite the stupid celebrations in the West that the rouble plunged against Western currencies when sanctions were announced, as anyone with one brain cell knew, this was a temporary blip. The rouble is already back to its previous position and is set to soar above

the pound, dollar and euro. The sanctions have strengthened the rouble and weakened the pound. Well done Boris!

This spells the beginning of the end of the Petro-dollar, which means that an economic reset has already begun. The dollar is heading for collapse along with America as the Orient takes the lead. The BRICS nations were already on side with Russia and are setting up currency deals right now. There will be a rouble/rupee and rouble/yuan system. Other nations will follow suit. The EU is also starting to boycott coal from BRICS countries in an act of provocation.

Meanwhile, the continual printing of billions of dollars a day is coming to a head, which the Federal Reserve can no longer control. It will either result in the dollar completely collapsing (which the Fed will not allow) or a very serious historic stock market crash. Either way, America is in trouble.

Instead of sanctions forcing nations away from Russia, South Ossetia has declared that it seeks to be part of the Russian federation and is holding a referendum to that effect. Russia previously recognised its independence from Georgia (which caused a civil war). It is rumoured that other states (such as Belarus) are seeking to rejoin Russia. Pushing Russia closer to China was a serious misjudgement that borders on insanity. But that is what has happened. Notice how many nations refused to condemn Russia in the UN. The demonisation of Russia is setting up the West (Europe/America) against the East (shades of 1984).¹

Further punishment

In further response to the illegal sanctions, Putin is punishing unfriendly nations by voiding their contracts. Some firms will be unable to buy Russian gas even with gold. Shell has been told that Russia will not accept anything from them and has voided its contract for gas.

The West has been absolutely stupid regarding its own security for all commodities. It continually aggravated relations with Russia for years while at the same time becoming dependent upon Russia for gas and oil. Austria is 90% dependent upon Russian energy supplies. Germany is also in a very bad position, as are many EU nations.² EU energy prices rose 44.7% in March. Just what did they think would happen when they applied sanctions, called Putin mad and clamoured for his assassination?

Not only was this policy stupid but most Western nations did not even boost their reserves in advance. Britain has very low gas reserves; other nations even less. President Trump filled the American gas containers but Biden has been running them down and they now have six months left. Many European nations have only weeks or days of reserves.

Britain's response has been ludicrous. Despite it now being obvious to a donkey that zero CO₂ is utterly insane and that Green energy is a complete failure, Boris has announced thousands more wind turbines to uglify the landscape. Has he not learned that in recent months wind farm energy produced only 3% of Britain's requirements? However, even getting the huge amount of raw materials to make these turbines is going to be difficult in

the commodity scarcity and rampant inflation that is already coming upon us. At least he has renewed contracts for North Sea drilling. What is really needed is a long-term plan for energy self-sufficiency that is based upon coal and nuclear power stations (it seems Boris is considering eight new ones but fulfilment is years away and we need more than eight). This is especially important as the cost of biomass pellets (trees from America) has already skyrocketed and will get worse. What about when there is not enough diesel to power cargo ships?

The clamour for electric cars has not yet declined despite the fact that rising inflation and scarcity of raw materials will put electric cars into items that only the super-rich will be able to afford. But how will people power them anyway when there will be power cuts? Germany is already proposing power rationing right now.

To make matters worse Biden has just announced that there will be no trade deal between the US and Britain. This is bad for both nations and makes no sense. It is a politically driven decision that ignores beneficial repercussions to businesses.

The depth of the coming crisis

People need to understand the crisis we are already in caused by stupid political acts.

Inflation

Inflation is officially about 7% but in reality is at least 15-20%. Prove this by comparing food prices from two years ago to today, as well as shrinkage inflation (where tins and packets are made smaller). Turkey already has an inflation rate of 50% and rising. Spain just announced 10%. This is where we are heading. Don't think that it cannot happen here because it has happened before. Whatever the end result, inflation is going to continue to rise and there will be recession by the end of the year.

By the way, the cause is not Russia, as Biden stupidly stated, it is the effect of money printing like there is no tomorrow, coupled with Covid policies like furlough, track and trace waste and pointless PPE. You cannot waste £400 billion, print more money to counter this, and expect nothing bad to happen.

Now high inflation means that everything goes up in price. Food prices are going to double very soon. Some products are already going up more than that. Certain items in supermarkets have gone up 360% in a couple of years. National Insurance has just been increased. Council tax has gone up.

So rising inflation is going to be a real shock to poor people. We are talking serious problems. When food, medicines, basic necessary items and petrol go up people are going to suffer very badly.

But the rising cost of petrol, already high because of inflation and oil prices, will go even higher when the Russian counter sanctions begin to come in. When petrol prices go up, everything goes up so food prices will skyrocket even further in a few months.

But some items are already in crisis.

A list of some of the problems:

- Food prices rapidly rising.
- Food shortages are coming.

- A rise in National Insurance.
- Petrol prices constantly rising, almost daily. People are already having difficulty getting diesel at all.
- Domestic energy prices doubling after 1 April, will be increased due to sanctions and will further increase in October.
- Council tax going up.
- The cost of travel will go up.
- Insurance premiums will rise.
- Commodities will rise.
- Certain commodities (such as timber, cement) will be in short supply and prices will rise. Cement has recently been rationed. House builds will become more expensive.
- Agriculture will collapse due to a lack of fertiliser.
- Workers are already beginning to strike even at this point. Refuse workers in Worthing have been on strike for a month despite drivers being offered a 13% pay rise. Workers in Greece have declared their intention of a general strike due to inflation.

Supply chain collapse

Fertiliser supplies from Russia and the Ukraine have already stopped. This means that farmers cannot grow crops. Many farmers have already ceased to grow certain crops in fields because they cannot get supplies or they are prohibitively expensive. It's too late for this coming year to change this. Russia has also threatened to cut off food exports to unfriendly nations.

For some stupid reason, the British government has also been paying farmers £100,000 to stop farming because of the UN great agenda. Just when we need more farmers many have quit.

Grain deliveries in America have been partially halted. This is shocking and can only be a deliberate action to cause food shortages. US rail carriers have declared force majeure and have cancelled contracts to deliver hundreds of thousands of rail cars of bulk grains to cattle and dairy operations. This will kill cattle herds. The result will be a lack of beef, milk, yoghurt and cheese.

The Ukraine situation means that a third of the world's wheat has stopped being exported. This alone is very serious. It not only means that bread will soon cost huge amounts, if any is available, but all the other items based on wheat will disappear: biscuits, cakes, breakfast cereals and so on. But more than that, grain is used to feed cattle. If there is no grain, the cattle will die or be culled. This will suit the global elite who want you to eat Bill Gates' synthetic meat and insects. They have already said that America will ban beef by 2024. One of the goals of the WEF is to reduce methane emissions by culling cattle. Be prepared for red meat to be a thing of the past in your diet.

The effects of the Covid crisis, which caused serious harm to the supply chains, have not fully begun to bite but will soon. America is already starting to see food shortages and France is considering food rationing right now.

The Covid crisis lockdowns also plunged millions of people in poverty in the developing world; many of these were poor farmers. The effect of this has either caused them to give up farming, or they died. In India hundreds of thousands of poor farmers have committed suicide (even before Covid due to failed GMO crops). Thus there is a decline in the amount of food being produced in some areas.

I have also explained before that colder weather (the Maunder Minimum – yes, global warming is a lie) is also collapsing food production; as in Paraguay. In epoch historic terms we are in a cool period. Having polar ice caps is indicative of a mini ice-age; the earth had ages where there were none.

All in all, the world is producing far less food than it needs; chiefly because of stupid policy decisions.

Larry Fink, head of Blackrock (that owns nearly everything), has warned, '*You are going to face shortages as you have never had before*'.

Energy

Here we have a series of crises all merging together.

As a result of Green energy policies, everyone is short of energy. Western nations have run down sensible power options and taken up stupid ones. I have explained that many times. Thus energy prices are through the roof, even before the Ukraine conflict began.

This meant that the government had to abandon the price cap on energy bills or all the energy companies would have gone bust (some of the smaller ones already have). You will now be aware that from 1 April energy prices have gone through the roof. My energy bills will go up £1,000 this year so far. Now this is gaining much publicity because people are finally waking up to how bad this is. But there is more to come.

Most people don't understand that there is going to be another energy price increase in October and the prices will go up again by a similar amount. Yes, that means that by autumn my energy bills could cost me £2,000 more than last year. This is unsustainable for most people. The poor are literally not going to have any heat. This will kill swathes of old and frail people.

But there is still more.

The effect of the Ukraine situation and the squeezing of the energy supply by Russia means that energy prices will go up again very soon. The price for a barrel of oil, already high, will go up even more and LNG³ will be like gold.

I am already hearing of businesses closing because they cannot afford the energy price rises of the first wave. Firms that use a lot of gas or electricity but have slender profits, like cafes and restaurants, will not be able to make ends meet. I expect that working from home will again become fashionable to keep office costs down. But workers need to factor in the incredible costs of staying at home with rising energy prices.

The push to World War III

I have explained many times that the elite plan since the late 1800s was for a third world war with Russia and/or possibly Muslim nations. In the modern era there is also the danger of war with China. In an unthinkable scenario, there could be a war between Western NATO allies against China, Iran, Syria, and Russia. It is even conceivable now that India, Belarus and South Ossetia could also be dragged in.

Only a complete fool would threaten war with Russia because it has a far greater military superiority than the West. If pushed against the wall it could destroy all of Britain or all of Texas with one Sargat II missile.⁴ Russian submarines are untraceable and deadly. Its Sukhoi warplanes, such as the Sukhoi SU-57, are generations ahead of US aircraft. Russia has the capability to shut down entire fleets of ships with an EMF device activated by an aeroplane and proved this in the Syrian conflict. Russia's claim of hypersonic missiles that cannot be stopped was denied by the West until they released a small one in the Ukraine that obliterated an entire NATO base killing 130 military personnel (not reported in the West).

Despite the insanity, American Neocons have been pushing for war with Russia for decades. It has been stated that the prime foreign policy goal is to get rid of Putin. Every effort so far has failed. Even the Russiagate hoax that lasted years only made American Neocons look stupid. The elite determination to get rid of Putin overwhelms every other consideration; even chaos. In 2019 the Rand Corporation set out a plan to destroy Russia by overextending its military and resources leading to imbalance. This included providing lethal aid to the Ukraine and media manipulation to demonise Russia. This plan is now in action.

As well as serious invective against Putin by Joe Biden, foolhardy Liz Truss⁵ virtually declared war on Russia in Brussels when she recently stated, '*the age of engagement with Russia is over. It's time for decisive action*'.⁶ Facile Ben Wallace⁷ also declared that Britain will '*kick Putin's bottom*'.⁸ Such foolhardy, provocative speech is shocking when statesmanship is required of our leaders. These are all preambles to war.

Poland has now closed its borders and is very concerned. Its military is weak and its leaders weaker. It is demanding help from NATO and has made itself a threat to Russia by being a staging post for the transfer of NATO weapons to Ukraine. America has just contracted to give Poland 250 Abrams tanks to bolster its military. If Russia takes over western Ukraine (not a priority but it may have to) then Russia would be on its doorstep. Germany is but one step away from that and its military is also weak as it is an occupied power (by the US). It depends on NATO for security.

Israel is practising bombing runs on Iran. Iran also has huge reserves of oil that it cannot sell due to sanctions. Could a war be precipitated in the Middle East?

America has just sold patriot missile defence systems to Taiwan. Could the long-threatened war between China and Taiwan erupt? While the West is distracted by Ukraine, it would be a clear strategic opportunity for China to attack.

Sanctions are the first form of warfare; make no mistake; they are an act of war. The West has often used economic sanctions as a preamble to war. Note this with Germany and Japan before WWII; later Iraq, Libya, Syria and many others. Issuing sanctions that strengthen the enemy but harm your own people shows a political motivation not a sane one; that is what is happening today. This proves that the driver is war against Russia at all costs, including self-sacrifice. The West is actively trying to start a war with Russia.

The constant propaganda, filled with lies, is another typical development in starting a war. American military personnel have already called for US boots on the ground in response to atrocity lies, such as Major John Spencer on MSNBC. News commentators, such as Ali Velshi on MSNBC have also called for '*direct military involvement*', which would trigger WWII. In fact there are already thousands of NATO troops active in Ukraine plus many mercenaries. We have many advisors (SAS) involved and a US general has just been captured trying to escape Mariupol after directing military strategy there.

At the moment it seems that the Pentagon chiefs, who understand that Russia would win a war on military grounds, are opposing the push to war but the politicians driven by the elite are striving to start it. As MEP Clare Daly said in the EU this week, '*the EU solution to war in Ukraine is more war*'. We will see who wins this argument.

Yanis Varoufakis⁹ said on *Unherd* to Freddie Sayers that Zelensky knows that he cannot win and that Western leaders know this too. There is a political game going on here to keep the war going in Ukraine and ruin the people but drain and destabilise Russia and make lots of money for the bankers. But his could still spiral into a hot world war.

Any war between the West and Russia (and possibly others) would be disastrous and ruin life for generations. At worst, if hypersonic nuclear weapons are deployed, it could be the end of the world completely. No one wins in this war. So why are the elite pushing for it? The answer is that they are insane psychopaths bent on revenge for past offences,¹⁰ that seek to remove a Christian power base¹¹ and remove an obstacle to world government.¹²

So what can we expect?

There is no good news. I will simply list some of the obvious effects that may appear.

Now many of these have happened before but times were very different. I remember constant power cuts and the three-day week of the Heath recession. We would go to supermarkets in the dark with a candle on the trolley. All shops and cafes were lit by candles day after day. This lasted months, on and off. We coped pretty well and it was quite romantic. But times are now different. Everyone relies upon electricity for everything they do. What will young people do when they cannot charge their 'phones. They will go nuts. Computers won't work, TVs won't work. Cookers won't work. Hospitals will collapse when back-up batteries fail and no one can afford diesel generators. Electric cars will go nowhere. Electric trains will stop. Landline telephones won't work. Heating systems won't work (even gas central heating relies upon electrical components like timers and ignition).

Now these **may or may not all happen**, it depends if our politicians begin to wake up in time and set up critical changes. Energy prices could be reduced immediately by 30% if the government cut the Green tax element. Petrol prices could be reduced by cutting fuel tax. VAT could be reduced now that we are not part of the EU. Income tax could be reduced. Note that Rishi Sunak's budget did nothing for poor people. However, the following could happen and several are certain.

- Food prices through the roof.
- Scarcity of many food items, especially grains. Supermarket shelves could be empty. France is already considering food rationing. Shelves in some American supermarkets are already empty. Germany has warned of food shortages and rising prices. Food riots have already broken out in some developing countries, such as Sri Lanka – which has declared a state of emergency. Waitrose is already rationing cooking oil. Ireland is already experiencing a shortage of glasshouse crops, such as tomatoes and cucumbers. All over the UK tomatoes and such like are being abandoned by growers due to the high cost of energy to heat glasshouses. This is the result of factors gathering speed in the last year. Many UK food organisations have issued warnings that there will be shortages very soon of: tomatoes, cucumbers, peppers, aubergines and suchlike. In addition, shortages of free range eggs, beer, wine and spirits. The knock on effect will be shortages of pizzas, pasta sauces and suchlike. This is but the beginning. There will also be unemployment of crop pickers.
- Unemployment will soar as people get made redundant from collapsing firms.
- Meat could become hugely expensive.
- Power cuts.
- Petrol will soon become too expensive to use a car – if you can find any.
- Many medicines may become unavailable. In Sri Lanka this has already happened.
- Hospital services could be cut; some hospitals may close. Dialysis may be threatened.
- Many forms of travel could cease altogether for periods of time (electric trains, electric cars, many domestic vehicles).
- The crime rate will soar. It has already gone up significantly in Germany as food prices rise.
- Russia is heading to become the dominant world power. America will begin to collapse. The dominance of the dollar is over. The longer Biden remains in power, the quicker this will happen. I suspect he is going to be removed.
- CBDCs¹³ will begin to be rolled out as currencies fail.

Time is running out for the government to alleviate this with sensible policies. It needs to stop illegal economic immigration, which costs millions per day and puts huge stress upon local infrastructure. It needs to store any gas it can get its hands on. It needs to immediately commission quick-build effective power stations (these can be built safely).¹⁴ It needs to stockpile food. It needs to rejuvenate farming; especially agriculture. It needs to cut waste. It needs to stop foreign aid, which mostly goes to corrupt leaders and terrorists anyway. We must deal with our own poor first. It should provide advice to people that have no idea how to cope with the coming crisis. We should also get our military out of Ukraine and stop providing missiles to bomb Russia.

CBDCs

The global elite have long indicated that central bank digital currency is on the cards and the current crises will accelerate that process. This is one of the chief goals of the WEF.

The purpose of CBDCs is to enable complete control of the governing body over people because they will be linked to a social credit system, which is already operational in China. This means that those controlling your money can restrict your ability to choose what you

spend it on. It can also fine you directly at source for non-compliance in a social demand (such as being vaccinated). We have already seen this in Canada. People that donated as little as \$50 to the truckers convoy had their bank accounts frozen. If the government doesn't like your politics, it can terminate your ability to buy anything under CBDCs.

Thus your social credit (compliance) will determine everything you do – where you can buy a house, whether you can go on holiday, whether you have purchased the wrong things and get restricted etc. In China your social credit is diminished and your purchasing power reduced if you jaywalk.

CBDCs enable total authoritarian control over a society.

Thus banks will begin to run down and cash become ever more difficult to obtain or be accepted for transactions. Note the massive closure of bank branches already despite no major reduction of staff numbers. Banks are preparing for CBDCs. The Bank of England is working on a CBDC.

CBDCs will be linked to a digital ID system that everyone will be forced to accept. The vaccine passport system is but a harbinger of this new ID system. This has also been spelled out by the global elite in projects such as ID 2020. Your digital wallet will be linked to your ID system, ultimately to be internalised through vaccines (another booster has been announced) but currently utilising Smartphones that track your every move, hear everything you say, monitors your texts and online activity and records your purchases.

The end of separate national currencies will be heralded as a beneficial step forward that will make global transactions much easier. Gone will be all the problematic currency transfers and exchanges, replaced by a global CBDC. The elite will claim that it nullifies the dangers of inflation and recessions and makes life easier. In fact it shackles everyone on Earth into a system of serfdom where they are controlled by bankers. If your services are not required or if you are labelled a dissenting influence, your ability to purchase anything at all will be terminated at the flick of a computer button.

ESG

ESG (Environmental, Social and Governance) is currently being rolled out by the elite to change the way that corporations function. This is a global standard for corporate behaviour to ensure compliance to elite programmes. It is a form of social credit but applied to firms. All businesses will have social credit scores (ESG scores).

It is promoted by all the elite agencies: the WEF, the UN, Blackrock and so on. Firms won't be responsible to shareholders any longer but will submit to global standards that will be initially promoted as socially beneficent. Firms that fail in the ESG score will be denied loans and other services. For example, if firm A does business with firm B and firm B is considered to have a bad ESG score, then firm A will find their position downgraded. Fall too far and you will be put out of business.

Considering today's situation, any corporation that did business with Russia would be targeted for a bad ESG score. Currently, corporations with outposts in Russia quit them voluntarily. In the future, under ESG, such action would be coerced.

So it is not only individuals who will have to live with social credit evaluations but also corporations. Don't comply with the elite and you will be punished. It is a means to police authoritarian policies and enact global governance.

AI

Another cabal initiative is to enable as much labour as possible to be performed by robots and algorithms. The elite have openly stated that they don't need people (e.g. the WEF). They are stupid enough to believe that digital systems will be able to take over most tasks in manufacture and other systems.

People that become unemployed will be placed on a universal basic income ('*you will own nothing*' – Schwab) which will be controlled through CBDCs and social credit. Eventually the aim will be to eradicate all the unnecessary work force through eugenic programmes such as sterilisation and cancer-causing attacks. This has already begun with Covid and other vaccines.¹⁵

Notice how already everything is being determined by apps, even when they make life more difficult. To pay for a car park space you use an app. To book a blood test in hospital you now need an app, even though this cannot work as many blood tests are required immediately and cannot wait a week for an appointment. To order repeat prescriptions you need an app. To get NHS appointments you now need an app. The NHS Long Term Plan is for your contact with a GP to be remote via an app. This is all to help bring about dependence upon AI systems.

What can you do?

I have told you many times to be prepared for a crisis and get stocked up with essential items. This is sound advice for any time period but especially so today.

- Build up stocks of food that do not perish quickly. Especially build up stocks of grains and dried goods, tins, dehydrated foods.
- Start planting your own food wherever you can. Tomatoes and potatoes are easy to grow and can be grown in bags. You could survive on these if you had to. Even window boxes can grow useful items.
- If possible, start stockpiling medicines.
- Store batteries for essential items.
- Buy several torches.
- Get wind-up radios, lamps, and torches.
- Buy a camping gas stove and gas canisters.
- Store essential equipment and home infrastructure; such as buckets, tools, hand powered kitchen appliances.
- Buy a survival manual, such as the SAS guide. For example, you can eat dandelion leaves and they are a good source of vitamin K2.
- Learn what you can forage from local green spaces, such as berries, mushrooms.
- Country folk should prepare to start hunting for food (rabbits, hares, birds).
- Consider getting some alternative source of heat, such as a wood burner. In the seventies my family survived with a paraffin heater – but these no longer exist; neither can you easily get paraffin. A propane gas heater may be an option.

¹⁵ The Covid vaccines destroy the immune system by introducing three HIV proteins that switch it off to allow the mRNA to survive with no ingredient to switch it back on again. This is why hospitals are full of vaccinated patients (90%) and why vaccinated people keep getting Covid. Eventually cancer cells appear but there is no immune system to destroy them. Cancer rates are currently skyrocketing.

- Get a water filter. Tap water is already contaminated but purification systems may collapse in power cuts. Get water butts and store water in your garden.
- Buy extra blankets and hot water bottles.

A Biblical perspective

If the right policies are not enacted, Western civilisation could actually collapse. Already the standard of UK living has been set back by many decades, and this is only the beginning. Why is all this happening?

My answer is: what did you expect?

The last two years have seen the most appalling dereliction of ethical government and social policy in British history. The list of the harms done to society is beyond the scope of this paper and I have discussed them many times before. The continuing murder of the elderly and frail with Midazolam, Morphine and Remdesivir in hospitals and care homes is but one aspect.

All this was an affront to God. We spurned God's law and trod it underfoot. We did harm to the poor, the young, the frail, the needy, the mentally sick and the elderly – just what did anyone expect?

God holds the nations in derision and will not tolerate such actions. Even though most of his condemnation is reserved for the Day of Judgment, God often issues forth his temporal judgment as a warning to the nations and for serious blasphemies. In addition worship was banned. Never in history has such a thing ever happened on a widespread scale (dissenters were outlawed but never the whole population). This was a national blasphemy. What did they expect?

I saw under the sun: In the place of judgment, wickedness was there; and in the place of righteousness, iniquity was there. I said in my heart, 'God shall judge the righteous and the wicked, for there is a time there for every purpose and for every work.' Eccles 3:16-17

If you see the oppression of the poor, and the violent perversion of justice and righteousness in a province, do not marvel at the matter; for high official watches over high official, and higher officials are over them. Eccles 5:8

'For the oppression of the poor, for the sighing of the needy, now I will arise', says the LORD. Ps 12:5

For I have seen violence and strife in the city. Day and night they go around it on its walls; iniquity and trouble are also in the midst of it. Destruction is in its midst; oppression and deceit do not depart from its streets. Ps 55:9-11

He who oppresses the poor reproaches his Maker. Prov 14:31

Do not rob the poor because he *is* poor, nor oppress the afflicted at the gate; for the LORD will plead their cause, and plunder the soul of those who plunder them. Prov 22:22-23

For behold, the LORD comes out of His place to punish the inhabitants of the earth for their iniquity. Isa 26:21

Sadly, when God's judgment is meted out on nations, many suffer because of their connections to the ruling power. However, those that seek God can find his blessing and protection in these times. There is also the sense of collusion. Evil rulers are only in power in Britain because the population tolerates them. In the Covid farce most people supported government actions and will suffer God's judgment.

The nation as a whole allowed the killing of the elderly, the destruction of small businesses, the ruination of the economy, the destruction of children's education, the collapse of medical treatments in hospitals, the termination of GP face to face appointments which killed people, the scaremongering that made people mentally ill and so on. The nation, as a whole, will be judged.

God will avenge the blood of those destroyed by evil policies.

Conclusion

We thought ten years of austerity under Cameron, Osborne and May was bad; that was nothing compared to what is starting right now. The world has changed; we need to prepare ourselves to deal with it.
