# **The Coronavirus Patents**

### Introduction

I have been explaining for over a year that the SARS-Cov-2 novel coronavirus does not exist as a natural virus. Also that an infectious coronavirus was manipulated in an American laboratory and that this was released before the Wuhan epidemic. There is strong epidemiological evidence that Covid-19 was active in Italy in September 2019 and some evidence that it was circulating globally before that.

I also mentioned, many months ago, that certain coronaviruses were patented by Big Pharma as far back as 2003.

Well now there is bombshell documentary evidence and testimony from Dr David Martin to Reiner Fuellmich's class action suit investigation<sup>1</sup> blowing the lid on the hard evidence for all this as exhibited in US patent records. This proves that what caused Covid was a bioweapon made in America for profit (and other reasons). He explicitly cites the CDC, the NIH, the NIAD / Anthony Fauci and Peter Daszak as being involved in what amounts to a RICO<sup>2</sup> case and, potentially, crimes against humanity.

The people and institutions firmly in the driver's seat regarding pushing pandemic fear, restrictions, vaccines and lockdowns are the very people that created the pathogen.

I will endeavour to summarise and collate Dr David Martin's evidence in as simple a way as I can by use of a timeline.

This evidence proves categorically that the whole Covid crisis was an artificial created panic by American Big Pharma to make trillions of dollars with the chief goal to vaccinate every person on Earth (a long held goal).<sup>3</sup>

This shocking news is not being published as wide as it should be. The Conservative Woman has two pieces on it by Neville Hodgkinson (good on them). The Lockdown Sceptics blog mentioned it in passing but has not done an article on it. Brighteon has republished the video of the 2-hour interview with David Martin but not written it up. Stew Peters did a 1-hour interview. I am hoping that the dossier of Martin's evidence given to Fuellmich will be published soon.

# Who is Dr David Martin; why is he trustworthy?

Martin heads up M-CAM International (Innovation Risk Management); a US company that monitors innovations relevant to financial interests. He has been commissioned by national and federation bodies, such as the EU, to investigate probity in commercial affairs, such as copyright, financial and patent issues. He investigates patents, patent

applications, federal grants, procurement records, e-government records and so on. He tracks what is happening, who is involved and monitors thematic interests.

He and his firm are the absolute top global professionals in this line of investigative work. His firm is the world's largest underwriter of intangible assets used in finance in 168 countries.

Martin has been investigating Big Pharma's involvement in coronavirus research, development and patents for more than 20 years. This involved reviewing over 4,000 patents issued around SARS coronavirus and monitoring the manipulation of the virus which gave rise to SARS.

He compared the genetic sequences, reportedly novel, and compared these to the patent records. This showed over 120 patented pieces of evidence to suggest that the declaration of a novel coronavirus was a fallacy. There is no novel coronavirus. There are, however, countless human modifications of coronavirus sequences that have been uploaded.

Patent records of sequences supposed to be novel go back to 1999. The virus is not just not novel, it has not been novel for over 20 years.

# The SARS-Cov-2 patent timeline

### Note: vaccinations

The elite cabal has long desired to have a rolling vaccination programme that affected everyone on the planet. They tried for decades to achieve this with constant pushes for take up of the Flu vaccines. # Dr Sam Bailey

Bailey works on the foundation laid by Martin and explains the origins of the Covid crisis showing how it was manipulated by using fraudulent genome computer sequences followed by fraudulent PCR tests.

It was obtained from crude broncho-alveoli fluid samples from a single patient that contained billions of genetic fragments; not from purified viral particles. A computer was used to analyse sequences and potential combinations and combine them into a potential genome. Circular reasoning was used to claim a new virus: take a sample from a patient, claim it is new Covid, identify genetic sequences from this patient, which must then be Covid.
23 January 2020	Christian Drosten and his team published their study explaining the diagnostic discovery of Covid-19 by a PCR test. <sup>9</sup> This protocol was ' <i>designed in absence of available virus isolates or of orignal patient specimens</i> '. The test was based on downloaded computer genetic sequences from uploaded gene banks released by China on 3 January 2020. Still SARS-Cov-2 had not been proved to actually exist. They generated a hypothetical sequence from previously detected sequences and then created primers to target short sequences within that sequence. There was no explanation as to what these primers might react to. There was no virus involved at any stage. This dodgy paper was published within 24-hours of submission! Furthermore, several authors failed to disclose their commercial conflict of interest with the PCR test. The first edition appeared on the WHO website nine days before the paper was accepted for publication. This test was then rolled out to the world as the prime test for Covid. There are multiple technical issues with the Drosten paper, which have been condemned by scientists all over the world and a retraction was demanded very soon after publication. Essentially, Drosten just created a new PCR protocol that could be used to
	detect the new virus with no proof of its veracity. The Drosten paper has nothing to do with clinical application – how well the test works in the field. We don't know the PCR's diagnostic specificity. No nation in the world using PCR tests can provide any evidence that it can diagnose Covid (though they say it can). As the inventor of the PCR test (Kary Mullis) explained, you can find anything you want with the PCR if you manipulate it by amplification. Every drop of saliva contains many millions of bacteria and other cells. A single mammalian cell has 360,000 mRNA molecules.
Late February 2020	People began claiming that they had isolated SARS-Cov-2 supplying electron microscope pictures. Certain cellular debris was claimed to be the virus just because they said so. When contacted, all these people could not say that they used purified viruses. None of them used purified viral particles. They used samples from someone with a positive PCR test and then claimed the samples were the new virus. They then matched tissue samples with the Chinese published sequence and claimed a connection; but at no point has anyone isolated a new virus. The electron computer images simply show vesicles <sup>10</sup> or viral-like particles. But these particles must be shown to cause infection and that infection must be Covid-19 (one of Koch's postulates). No one did this.
	The medical industry continually invents epidemics / pandemics in order to generate billions of dollars of profit. Covid-19 is the latest in a long list.

Kingston is a senior Big Pharma insider. She is a former Pfizer senior analyst and is currently an analyst working in pharmaceuticals and medical devices.

Kingston has done two interviews with Dr Andrew Kaufman and Stew Peters wherein she blows the whistle on what is in the Pfizer and other vaccines; how the trials were fixed and how toxic the ingredients are. Both interviews should be watched. I cannot list all the technicalities but some salient items are as follows:

- mRNA vaccines are very fragile and can be destroyed easily by sunlight and other factors. This requires them to be coated in a substance to protect them and enable them to get into cells. This coating is a lipid (fat) [aka hydrogel or lipid nano-particle]. The four PEGylated lipid nano-particles are 1) a cholesterol lipid to enable transportation by the blood. 2) Phospholipid adheres to the cell membrane to make it permeable. 3) An ionisable lipid provides a positive charge so that the mRNA can enter the cell. 4) A lipid made by SINOPEG, a Chinese company.
- One of the ingredients of this coating is graphene oxide, which aids the delivery of the mRNA. Graphene aids gene delivery. This is discovered by comparing the code name for graphene in the patent with the same code name on the SINOPEG website.
- Graphene oxide is very toxic to the human body. It is 4,000 times stronger than titanium, can host a magnetic field and is an excellent conductor of electricity.
- The graphene tends to accumulate in the organs of the body and particularly the reproductive organs. The body cannot get rid of it.
- Graphene oxide is not listed in the patent ingredients because it is poisonous to humans.
- Graphene is the main ingredient in hydrogel, which can be used to create a braincomputer interface.
- The graphene oxide in vaccines is neutrally charged (inactive), but it becomes positively charged by electromagnetic radiation, such as wi-fi, 5G etc. When this happens it kills anything it comes into contact with.
- The graphene alone will kill many people (let alone the spike protein); depending on how much of it exists in the body and where it is located.
- Multiple booster shots will increase the amount of graphene in the body.
- The Pfizer study should have been stopped when 80% of mice died within 24-hours and the rest died within a week.
- A recent autopsy proved that the spike protein had entered every organ of a vaccinated body.
- The Pfizer trials showed that viral shedding occurs with this gene treatment. This means that unvaccinated people can contract the spike protein directly from vaccinated people, such as by fluids or even dermal touch.
- The Pfizer trials showed that vaccinated people contract Covid more easily than unvaccinated people but Pfizer covered this up. [This is now proven by hard data in the field.]
- Children should never be given the vaccine.
- All of the Covid vaccines are bioweapons.
- 'They are just seeing how much they can put into people before they ... die.'

## Dr Luc Montagnier / Indian researchers

Montagnier appeared on the French cable TV show, Cnews on 17 April 2020. He announced that the virus that causes Covid is manmade and has elements of HIV and Plasmodium falciparum (a parasite that causes Malaria).<sup>11</sup>

He refered to Indian researchers affirming the same thing published on the science website Biorxiv on 31 January 2020 (since withdrawn). They said, 'We found 4 insertions in the spike glycoprotein (S) which are unique to the 2019-nCov and are not present in other coronaviruses. Importantly, amino acid residues in all the 4 inserts have identity or similarity to those in the HIV-1 gp120 or HIV- Gag. The finding of 4 unique inserts in the 20129-nCov, all of which have identity / similarity to amino acid residues in key structural proteins of HIV-1 is unlikely to be fortuitous in nature.'

In an appearance on the French podcast Pouquoi Docteur, 17 April 2020, Montagnier said that the coronavirus had escaped in an *'industrial accident'* while Chinese scientists at the Wuhan city laboratory were trying to develop a vaccine against HIV. We could add, resourced by Fauci and the NIH and it may not have been accidental.

# **Dr Judy Mikovits**

Mikovits is an esteemed virologist involved in the analysis of HIV and formerly a US government virologist.

In a Brighteon interview she confirmed the following:

- The SARS-Cov-2 virus has never been isolated from human cells and was never a human virus in the first place.
- It can only be manufactured and replicated in the vero monkey kidney cell line, which is a group of epithelial cells (lung cells) extricated from African green monkeys in the 1960s.
- These monkey cell lines, contaminated with latent retroviruses, have been injected into the population since the mid-90s through the flu, MMR and polio vaccines and are the originating vector by which SARS-Cov-2 can manifest disease in humans.
- Every bio-safety level 4 lab that claimed to isolate SARS-Cov-2 from humans ultimately placed the sample in a monkey kidney cell line to 'prove' its replication. The virus is not a truly isolated human virus because it could only be replicated in the monkey kidney cell line.
- To determine whether the virus is an infectious human virus it must be taken from the blood, sputum or lung lavage of an infected human; but the infectious RNA of SARS-Cov-2 was never cultured in a continuously growing human cell line that supports replication. Since this coronavirus only replicates in vero monkey cell lines, it has never been proven to originate or spread from human to human. It is not infectious.
- Since the current flu, MMR and polio vaccines contain these same vero monkey cell lines, the only way to deploy SARS-Cov-2 is through transfection via vaccines.
- SARS-Cov-2 is a lab-made sequence that originates and spreads through the existing influenza vaccine supply. [Remember that the Dept. of Defence (US) discovered that the flu vaccine recipients from 2017 to 2018 were increasingly susceptible to coronavirus interference.]
- When you take a synthetic part of a virus and grow it in monkey cells you can get recombination events of all the monkey viruses. It is a monkey virus.

- The HIV component comes from the Simian immune deficiency virus, which is also a natural monkey virus.
- The vector that promises to save humanity is the tool being used to transfect us.
- The envelope of the virus, the S-1 sub-unit of the coronavirus spike protein, is assaulting the population through the very vectors which Fauci says will save us. The new infectious sequences are in the cell lines, which are then injected into the population.
- Fauci (once her boss) funded and acquired cell lines and genetic material from biosecurity labs in the US (including Fort Detrick) that could be further weaponised in Wuhan. He, with others, e.g. Danszak, conducted unethical human-virus experiments using gain-of-function.
- These virus experiments using monkey cells lines can create endless variants. Two amino acid changes in the envelope of the spike can change a leukaemia virus to a Parkinson-causing virus.
- Fauci is pushing the narrative in order to cover up his crimes against humanity and blame nature. This is why Big Pharma is brutally censoring debate and contra knowledge (the same people controlling Big Pharma control the media). Fauci is the prime cause of SARS and SARS-Cov-2.
- The mandating of facemasks suppresses the immune system and makes all wearers more susceptible to disease.

Mikovits agrees with David Martin on the gene sequencing and manipulation of the alleged 'new' virus, but disagrees with Andy Kaufman (and many others) on the issue of viruses in general (that they do not exist).

# Dr Richard M Fleming

In an interview with Mike Adams on InfoWars (available on Brighteon) Fleming explains how the vaccine is a bio-weapon that was developed in America and enhanced in Wuhan under the control of Fauci. This video is a must watch that is impossible for me to fully explain due to the technical arguments.

- The spike protein is the bio-weapon. The dangerous part of the alleged virus is what is in the vaccines.
- The spike protein crosses the blood-brain barrier and causes the brain to be spongy (like Mad Cow disease).
- It causes Alzheimer's Disease, due to prions in the brain.
- It damages the heart, due to blood clotting all over the body.
- The outcome is not consistent; everybody will react differently over time.
- It carries the genetic information (self-amplifying mRNA) to make more and more spike protein. It gets into the DNA and human chromosomes. The injections do not remain at the site of the injection and Moderna knew this in trial studies going back years (at least to 2017). People become spike protein factories. The medical establishment lied when it said that the mRNA stayed at the injection site and disappeared over time.
- The American government gave billions for research on gain-of function to make viruses more infectious and dangerous, even when this research was made illegal. Research papers and patents show how these genetic sequences were changed. Fauci hold patents on some HIV components that are in SARS-Cov-2.
- SARS-Cov-1 was the first bio-weapon. SARS-Cov-2 is the updated version. They were developed intentionally as bio-weapons. The total control of the media has been necessary to hide this fact and silence critiques.

- There is not one type of SARS-Cov-2. Part of the sequence of this particle is put into the vaccine. The vaccines have billions of these particles. There are at least 17 variants that can be made from this sequence. With the mass of particles (spike protein load) in the vaccine, even the healthy body develops massive inflammation as the immune system reacts to this invasion. There is something in the body that should not be there. This is what causes blood clots.
- You don't have to change these viruses much in order to create a different disease. Changing one amino acid is enough.
- The lockdowns promoted ill-health by suppressing the immune system. [Lack of sunshine, masks, lack of fresh air, not enough exercise, loneliness, stress, poor nutrition, alcohol abuse etc.]
- Black people are more susceptible to this virus due to the receptors required.
- The vaccines don't work; this can be statistically proven.
- There are multiple proven good treatments, such as Ivermectin.
- This is nothing different from what happened in 1930s Germany.

Fleming is also part of a group of doctors and scientists taking governments to the International Court of Human Rights for abuses of the Nuremberg Code, with the intent of prosecuting ministers, advisors, Fauci, doctors and the media for crimes against humanity. Fleming and his colleagues are being tracked.

# Matters arising

### The vaccines are not safe

A UK evidence-based consulting group (advisor to the WHO) review of the Covid vaccines states that the Covid vaccines are not safe for human use and must be removed from the public: Dr Hamid Merchant (pharmacologist) says the vaccines are not safe. The European Medicines Agency also issued warnings after a review of vaccines.<sup>12</sup> Dr Tess Lawrie (contract analyst to the WHO) submitted a report to the MHRA proving that the vaccines are not safe for human use.<sup>13</sup>

A group of medics and clinicians petitioned the FDA to refrain from fully approving any Covid-19 vaccines this year. Their case was published in the BMJ.<sup>14</sup>

The FDA officially describes the Covid vaccines as '*genetic transfer programmes*' that formally require a five-year testing programme.

There has been no review by the FDA or the CDC of the effects of Covid vaccines. These should be done weekly based on adverse reaction reports.

A legal case in America has reported in evidence to a court that 45,000 Americans have died from the vaccines.

Dr Peter Mcullough, the most cited doctor in the world, is utterly opposed to the vaccine, says it is not safe, and is demanding it be stopped. The vaccines have failed and have killed more people than Covid. New strains of Covid are being created by the vaccines.

ADE is already emerging (Dr Robert Malone, inventor of the mRNA vaccine technology). The wave of post-vaccine deaths from a cytokine storm is beginning.

The Japanese medicine regulator has found that those who have been vaccinated have a concentration of spike proteins in every organ of the body; in particular the ovaries. This is a bio-distribution study of the sort that the British MHRA has refused to undertake. [NB. the spike protein is toxic.]

The first US autopsy of a dead person vaccinated for Covid showed spike proteins in every organ. This is proof of what alternative doctors (like Sherri Tenpenny) have been saying for months.

Calls for ambulance services due to cardiac arrest and unconsciousness have surged since young adults started getting the Covid vaccine. [See Public Health England, 'Syndromic indicators at a glance'.] The Pfizer and Moderna vaccines now have warnings added to the safety labels regarding myocarditis and pericarditis in younger adults, usually after the second dose.

Pfizer admitted that viral shedding (infection from a vaccinated person to an unvaccinated person) occurs with its vaccine. There is a transfer of vaccine components person to person. Pfizer expressed strong fears about this. ['A phase 1/2/3, placebo-controlled, randomised, observer-blind, dose-finding study to evaluate the safety, tolerability, immunogenicity, and efficacy of SARS-Cov-2RNA vaccine candidates against Covid-19 in healthy individuals', (page 67).]

### The vaccines don't work

The vaccines do not stop infection and they do not prevent serious illness. The Scottish Herald: '*Covid hospital admissions triple in over-60s – and nearly half of patients (are) fully vaccinated*'. [See *The Daily Sceptic*, 'Are the vaccines reducing hospitalisations?', Toby Young.]

The latest data from PHE shows the fatality rate in the vaccinated under-50s is 57% greater than in the unvaccinated. ['PHE, Technical briefings 17 and 20. *The Daily Sceptic*, Will Jones, 'Alarming data from PHE ...'.]

Israel is 90% vaccinated but new Covid cases include over 70%-vaccinated people.

27 July 2021: The CDC director (Rochelle Walensky) stated that vaccines are failing and that vaccinated people may now carry higher viral loads than unvaccinated people, contributing to the spread of Covid. Fully vaccinated people can catch and spread the virus. The Delta variant makes it easier for vaccinated people to transmit the virus. Vaccinated people, as predicted, are super-spreaders. So why virus passports? Walensky also said that the virus is just a few mutations away from rendering all existing vaccines obsolete. Vaccinated people are also the super-breeders of variants.

Fauci admitted that Covid vaccines are spreading disease. [Face the Nation, interview; – video deleted.]

Vaccine immunity is now stated to only last six weeks. After this you become MORE vulnerable to the virus.

In California, the highest count of new Covid cases is being recorded in counties with the highest vaccination rates.

The majority of Covid cases in British hospitals are vaccinated people. In addition, hospitals are now being overrun and two have announced a state of emergency due to the huge backlog of people who put off going to hospital during the lockdowns and are now presenting at A and E. For hospitals to be in crisis in the summer is unprecedented. If the predicted ADE<sup>15</sup> crisis appears in September onwards, hospitals will collapse with serious ill vaccinated people.

The Kings College Zoë App, as of 15 July 2021, shows cases amongst the unvaccinated going down but the cases in the vaccinated group rising. The Health Secretary, Sajid Javid, was typical, announcing on 17 July that despite two jabs he tested positive.

Dr Jane Ruby affirmed that the majority of hospitalised Covid patients are vaccinated. [The Stew Peters Show.] She specifically itemised Britain and Israel. Patients are presenting with serious conditions after being vaccinated in February or March.

30 July 2021: The CDC published research proving that 74% of people testing positive were vaccinated with both jabs. 90% of the infections were the Delta variant. They used this data to demand that people mask up again. This proved the lie of health officials, such as Fauci, that affirmed that the fourfold rise in US Covid cases since June was caused by unvaccinated people. In addition the viral loads were high meaning that there was an increased rate of transmission amongst the vaccinated.

Data from Public Health England (PHE) shows that fully vaccinated people are 65% more likely to be hospitalised and 1540% more likely to die from Covid than people who are unvaccinated.<sup>16</sup>

PHE data confirms that new infections peaked and dropped in the unvaccinated before they did in the vaccinated.  $^{17}$ 

A panel of experts told MPs that there is no way of stopping Covid from spreading through the entire population because the vaccines don't prevent infection and transmission. Community testing should also be terminated.<sup>18</sup>

The world's most vaccinated nations (ranked by Johns Hopkins University) are also some of the highest at risk for Covid surges (as categorised by the CDC as at risk for travel).

### Variants

As many epidemiologists warned (e.g. Dr Bossche), and I wrote months ago, it is the vaccination programme that is initiating the variants. When overused, vaccines can cause mutations just like antibiotic resistance. The process is called 'leaky vaccines'.

The current variants can all be traced to areas where there was an earlier vaccine testing programme (India, Britain, Brazil, America, South Africa). For example, the Indian Delta variant was first identified in December 2020 just a few weeks after the Phase 3 testing

programme of Covaxin on 16 November 2020. 22,500 individuals were vaccinated before the trials were complete.

### Corruption and conflict of interests

Rick Bright, the person who blocked Hydroxychloroquine to America, joined Pfizer.

Stephen Hahn, former FDA commissioner who blocked Ivermectin and Hydroxychloroquine, joined Moderna.

The NIH (US National Institutes of Health) co-owns the Moderna vaccine patent.

### DIVOC

This is an open-source, digital platform for large-scale vaccination credentialing programs. It is used for credentialing Covid vaccines.

It is built upon the generalised electronic registry and credentialing framework of the OpenSABER project under Sunbird Registry and Credentialing.

Its use in India has already issued more than 100 million digitally verifiable credentials. For example, it can include: vaccine approval, procurement, supply chain logistics, capacity building, testing, training certification, field support, management and feedback. There are already 20 DIVOC labs in India with more being built.

Note that DIVOC is 'Covid' spelt backwards. Luciferians love reversing words to hide connections. In Latin it would mean 'to call apart'. In Greek it would mean 'to call twice'.

### PCR tests

The CDC has decided to terminate the PCR tests on 31 December because they cannot distinguish between Covid and Flu. Why is Britain still enforcing them on travellers and others?

The FDA admits that the PCR test for Covid was developed without isolated Covid samples. Thus it is a complete fraud. The genetic material for a marker was from the common cold.<sup>19</sup> People who had a cold or Flu tested positive and became Covid cases. This is why Flu disappeared in 2020.

### Genocide of the elderly

The treatment of the elderly, especially in care homes, throughout this crisis has resulted in many thousands of unnecessary deaths. This can genuinely be called genocide. The elderly were refused medical treatment, refused to have a doctor attend them, were kicked out of hospitals to care homes with no support where they infected many others, were often left without food, water and due care (in hospitals and some care homes) and all the time forbidden to see their loved ones. Many died in deep anxiety, depression and loneliness. It is a crime that God will remember of the Day of Judgment. May God bring vengeance on the guilty.

The average age of people dying from Covid in Italy was 79.5. Italy's National Institute of Health.

Deaths in UK Care homes tripled in three weeks after the vaccine was introduced.

A whistleblower posted two videos explaining how the elderly are being systematically murdered.<sup>20</sup> This is largely done by prescribing morphine (to reduce pain) and Midazolam (to cause sleepiness). In reality it means that hospitals can then ignore these patients who will not complain or cry out as they are starved and left thirsty in their own filth (it's called 'a care pathway'). Midazolam is highly toxic and has never been authorised. It is a substance used in executions by lethal injection. But the dose given to old people is five times what is normally medically prescribed (10 mg instead of 2). It can also hinder breathing and lower blood pressure. The whistleblower also discovered that multiple hospices and care homes have death rates far in excess of the norm. One near me has about ten times the death rate than is normal. He contacted the police and other authorities, which refused to take any action. Shortly after posting these videos and complaining to the authorities, the healthy middle-aged whistleblower mysteriously died. He was trying to secure an interview with the UK Column to expose the genocide at the time.

### Compensation

The government makes it extremely difficult for relatives to get compensation for the maiming and death of loved ones. No compensation is payable unless it can be proved that there has been 60% disability caused by a vaccine. For people that died this cannot be proved.

### Totalitarianism

### No end in sight

Various establishment lackeys have mentioned an end date of 2025. The World Bank has established that the pandemic period will last until March 2025. The 'New Normal' is supposed to be activated in 2025. The NHS has stated that waiting times will not return to normal until 2025. The emergency morgues being contracted out (see later) last until 2025.

Despite the virus scare coming to an end, when even Neil Ferguson says the epidemic is over, with statistics showing low levels of deaths and hospitalisation, the government is extending various Covid contracts. It has advertised jobs and contracts dealing with contact tracing that extend for three years.

American states are advertising for thousands of Covid jobs, such as contact tracers, researchers, vaccine co-ordinators, facility testers, investigators and so on. These are full-time well-paid jobs with no end date.

Scotland is advertising for multiple Covid jobs in all counties, paid on average £130 a day. These include, Covid tester assistant, Covid tester, Covid customer service, Covid contact tracer etc.

New Zealand has said that it won't open its borders to vaccinated travellers until 2022.

### Scripted media

The proof that the media worldwide is following a set script mandated by the elite is proved by the use of the number 233 regarding cases. A search will show nation after

nation, state after state, mentioning that there has been a sudden surge of 233 cases. There are dozens of cases of this. This would be statistically impossible in real life.<sup>21</sup>

#### Isolating the unvaccinated

The local government of Lapu-Lapu in the Philippines issued an executive order that unvaccinated people are banned from purchasing food.

America is on the verge of making vaccines mandatory. Due to the low take up of vaccines amongst the army, the US government is saying that it will mandate it for all forces.

Macron has made vaccine passports necessary for continuing normal life. As a result, France is on the brink of civil war with demonstrations becoming violent. However, in some protests the police switched sides and marched with the activists.

#### Police violence

A British police officer who kicked a 15-year old boy in the head during lockdown has been convicted of assault.

US police violently arrested and broke the arm of a 73-year old woman suffering from dementia.

### Taking children

There has long been a process of the state kidnapping children from their parents under various excuses. In many cases, these children are then abused. The UK Column has been analysing this for many years.

Now we have the state stealing children from parents on the basis of Covid restrictions. I have seen a video of Israeli police taking a baby from a screaming mother. In Britain an 11-year old girl was taken by police in the night from her father. The reason given was due to his denial of Covid and the vaccine He was also home schooling her.

#### Prison camps

Various countries are erecting new prison camps, e.g. Canada, America, Australia, Britain, New Zealand.

I have seen a prison camp being built in Britain that is the size of a small town. The government will admit that it is a prison but offer no other information. It is not being built like a traditional prison.

That these camps are for unvaccinated non-conformists is proven by the first executive order. On 6 August Tennessee governor Bill Lee signed Executive Order 83 which authorises the National Guard and State Guard troops to break into people's homes, kidnap them at gunpoint and incarcerate them in a Covid internment camp – without any due legal process. The camps are called '*temporary quarantine and isolation facilities*'.<sup>22</sup>

The CDC announced that Covid camps will be set up on a nationwide basis with people being medically kidnapped and taken to '*humanitarian settings*' but with the minimum of humanitarian standards.<sup>23</sup> The purpose of this is alleged to separate '*high-risk*' individuals,

meaning the elderly and sick, from the main population to protect it from infection. Couples and families will be separated. The camps are called '*Green Zones*' for shielding. The sort of people targeted for this includes over 60s and people with chronic illness, such as hypertension. [Notice the use of more and more names using the word 'Green'. Also the fear narrative is being directed towards global warming and doomsday.]

The Western world has now fully become 1930s Germany.

### Opinion

Surely only a fool can now deny that this process has been nothing to do with a virus (not that it even exists) but is about social control and a programme of revolutionary social change. I said that right at the beginning of this mess 18 months ago. It is truer today.

It is all about social control, social coercion and social manipulation. This is achieved through illegal regulations, destroying centuries old conventions and the massive use of behavioural psychology and neurolinguistic programming to create fear and make people compliant. The end goal is a world population of slaves.<sup>24</sup>

We are now at the point where non-conformists are close to being illegally rounded up and incarcerated in prison camps.

When doctors all around the world are condemning the vaccines as highly dangerous and toxic, and yet the government is forcing them upon young children (let alone adults) we are in something worse than a dystopia; we are in a world run by psychopaths and Satanists.

You need to wake up and see the agenda.

#### The coming mass death event

Warnings

You can never exclude the possibility that there will be some new disease ... we may have a rough winter for all sorts of reasons.

Boris Johnson, *The Telegra*ph, Maighna Nanu & Catherine Neilan, 'Boris Johnson warns of summer travel disruption as he plays down double vaccination plan', 21 June 2021.

The British government warned that 2.6 billion people may die as a result of the mutations <u>coming from the Covid vaccines</u>. [SPARS (sic) Pandemic simulation document 2025-2028, which developed into the Crimson Contagion exercise.]<sup>25</sup> The reality will be ADE and viral shedding not variants.<sup>26</sup>

The SPI-M<sup>27</sup> 'experts' have already advised the government that there will be a third wave of Covid infections in the autumn and it will result in mass deaths and new lockdowns, but the deaths are amongst the vaccinated:

The resurgence in both hospitalisations and deaths is dominated by those that have received two doses of the vaccine, comprising around 60% and 70% of the wave respectively.<sup>28</sup>

Most deaths and admissions in a post-Roadmap resurgence are in people who have received two vaccine doses.<sup>29</sup>

This is being driven by computer modelling from Warwick University and Imperial College.

So the government agrees with me that the vaccines are going to cause mass death; at least 300 a day (vaccinated people account for 250). Fully vaccinated people will account for 60-70% of hospital admissions.

### *Emergency morgues*

UK councils have been asked by government to set up emergency body-storage centres for this autumn and purchase large numbers of body-bags. The contract published by Westminster City Council was one example. The contract period for this continues for <u>four years</u> and is worth £6 million. Many factors are pointing to social disruption continuing until 2025.

Emergency morgues were already being established in the spring <u>after</u> the virus peak in March/April 2021. This is part of the government's 'Excess death contingency planning' strategy and 'mass-death preparedness plans'. These plans were not enacted during the Swine Flu and SARS pandemics nor in the heat of the virus epidemic in March 2020.

Emergency morgues were set up at Norwich, Newcastle, Bristol, Wanstead Flats, Leatherhead, Leeds, Poole, Salisbury and Aylesford (Kent).

Ruislip, West London council set up an overflow morgue for 1,300 bodies and built the third biggest crematorium costing £4 million.

Kent established three emergency morgues to store 3,000 bodies at a cost of £11 million.

A morgue centre was set up at a disused RAF site in Oxfordshire to hold 5,000 dead.

Conscientious whistleblower undertakers have explained that last year (2020) business was pretty much as usual; that is, the death rate was normal. This year, since the vaccine roll out, the death rate has skyrocketed and undertakers are having trouble coping with the amount of clients. This suggests that the real death rate is much higher than government figures.

# Dr Sam White

Sam White is just one example of a conscientious doctor committed to caring for patients properly who has spoken out about the fraud of Covid and the danger of vaccines. For expressing his views on social media he has been suspended from the NHS and lost his job, even though other doctors have done the same.

He made a video of his testimony which went viral, with over a million views in a few weeks, and shows the wickedness of the establishment. As a result of this expose, he has been warned that his life is at risk.

The bare bones of this testimony is:

- He was a partner in a thriving GP practice.
- He has been a doctor for 24 years with a breadth of experience.
- There are safe, proven, cheap treatments for Covid (HCQ, Ivermectin, and budesonide). The NHS is not allowed to use them.
- The vaccine is genetic manipulation.
- The Yellow Card system shows huge amounts of adverse reactions and these are about 1% of the real figure.
- The PCR test is a fraud.
- Do not have the vaccine.
- We need to re-establish Common Law.
- Facemasks cause problems with respiratory systems. He has never worn a mask.
- He wrote an open letter to Sir Simon Stevens head of the NHS via his lawyer (look this up). It is unassailable and has not yet received a reply. It alleges criminal conduct and breach of legal obligations by leaders in the NHS. The chief legal points are: 1) the vaccine programme has been rolled out in breach of legal regulations for clinicians to obtain free and informed consent of those vaccinated. 2) The requirement to wear facemasks in the NHS is in breach of Common Law obligations not to cause harm and breached statutory obligations in relation to provision of PPE. It claims that White has been victimised and harassed for telling the truth. The people alleged to have acted illegally are listed as: the government, the executive board of the NHS, SAGE, senior public office leaders, the executive board of the MHRA. There is a great more clinical detail in the letter and exposes of financial connections between government advisors and ministers with the vaccine industry and Bill Gates.

White now practices as a Functional Medicine doctor (i.e. not allopathic) and tries to eke out a living privately. He is passionate about health and preventive action (nutrition). He typically spends 40 minutes with any patient trying to get to the root of problems, as opposed to ten minutes and prescribing a pill.

# Dr Ryan Cole

Cole is the CEO and the Medical Director of Cole Diagnostics; an independent lab in Idaho. He is a formally trained pathologist but also has PhD. experience in immunology and virology and has seen over 350,000 patients in his career. In a lecture from April 2021 he discussed cures for Covid and the problem of the vaccines. In another lecture in Texas in August, he gave a presentation to Frontline Doctors.

Cole said,

The spike is the toxin. ... We are spending billions on advertising the 'clot shots' to children. ... Why in the world would we put a toxin into the human body that is going to disrupt the blood vessels in your brain, allow the spike in there, and cause inflammation? ... This isn't a vaccine. They keep lying to the public by calling this a vaccine. It's an experiment on humanity.... Once you have heart damage the heart does not heal itself. The heart is damaged forever. We're ruining kid's hearts for life with these shots. We need to stop the insanity immediately. This is over. Game over. This is no longer good science. This is a poisonous attack on our population and it needs to stop now. (sic.)

He lamented that billions is being spent on advertising to improve the vaccine take up but nothing on the science to study the effects on the population.

He proved his points showing that the vaccine causes specific inflammation in the organs by showing photographic slides of actual damage to actual organs caused by the vaccines. He also said that he has seen an increase in cancer cases since the shots began.

His short lecture should be watched.

# The Pfizer contract

# Dr Sucharit Bhakdi on Covid vaccines

Dr Bhakdi has a video summarising the latest published papers analysing how the immune system combats Covid and how the vaccine destroys blood vessels causing clotting. This is published medical analysis, not some sort of speculation.

I will try to summarise this without getting too technical, adding some of my own material.

### The immune response

Recent scientific papers have demonstrated what Mike Yeadon affirmed months ago, that the supposedly novel coronavirus is not so new that the immune system cannot recognise it. Because it is so similar to known coronaviruses, the immune system recognises it as a threat and springs into action. This puts paid to the idea of a need for universal vaccines.

The immune system makes many different components; one of these is antibodies. It takes about four weeks to make new antibodies. If the immune system remembers the pathogen it very quickly makes IGG and IGA antibodies. These try to prevent the pathogen getting into cells. If the cells do get infected then lymphocytes<sup>30</sup> and leucocytes (white blood cells) kill the cell to stop the virus factory.

Three research groups studied how fast the immune system reacted to coronavirus. The response was fast with IGG and IGA antibodies. All the Covid variants are identified by the immune system and are defeated. Herd immunity is already present and ready to be actioned and kills the virus before it gets to the lungs. 99% of people have this immune

response ready. There is no need for dread of Covid coronavirus. Vaccination is not necessary.

### The damage caused by the mRNA-created spike protein

The latest evidence proves what we already knew. The mRNA vaccine controls the body's cells making them code for the spike protein. Every cell begins to manufacture the spike protein. However, the genes immediately enter the cell walls of the blood vessels first and create spike proteins.

The cells populating the lining of the blood vessels gradually develop spike proteins, which protrude from the cell's surface and these are recognised by the immune system, which then attacks them with lymphocytes to get rid of them. This is done in the two stages mentioned above.

The first response by the leucocytes begins the process of attacking the cells causing some damage. However, the later response (after 30 days) by antibodies continues this attack and destroys the cells. The immune system will try to eat the blood vessel cells. The body is now in a fight for life between the immune system attacking blood vessel cells and other systems (such as cholesterol and platelets) trying to repair the damage to the vessel lining.

This is what causes both bleeding and blood clots, which then pass to organs causing failure, such as heart attack, thrombosis or stroke. It is almost impossible to survive this attack.

# Dr Charles Hoffe on Covid vaccines

Tests of vaccinated people show signs of new onset blood clotting. As a result of warning about this, Hoffe was relieved of his emergency room duties, losing half of his income. He noticed that his patients that had been vaccinated had their capillaries plugging up which will lead to cardiovascular damage.

The mRNA causes the body to become a spike protein factory and these mass-produced spike proteins cause progressive blood clotting. Hoffe claims that 60% of vaccinated people will suffer from blood clots that will eventually kill them.

Only 25% of the vaccine contents remain in the arm. The rest is collected by the lymphatic system and fed into the circulation system. A single dose of the Moderna vaccine contains 40 trillion mRNA molecules.

The mRNA was designed to go into the cells of the body, but the only place they end up is in the blood vessels and capillary networks. Trillions of the spike proteins are then created and stick out of the cell wall of the lining of the blood vessels (the vascular endothelium). The cell walls of blood vessels are intended to be smooth so that blood flows well but now the protruding spikes hinders the blood flow and cause clots in capillaries. Blood platelets (which detect damaged vessels) circulate around trying to fix the problem by creating increasingly more clots. The platelet hits the spikes in the capillary and forms blood clots that block the vessel.

These blood clots are different to the 'rare' big clots mentioned in the media that show up on CT scans and MRIs and cause strokes. They are microscopic and do not show up on scans and can only be detected using a blood test known as D-dimer which shows recent blood clots. Using this blood test Hoffe discovered blood clots in his 62% of his vaccinated patients. Key organs that cannot regenerate, such as the brain, spinal cord, heart and lungs are permanently damaged by these blood clots, leading to death within three years.

With each successive shot the damage is cumulative.

#### Dr Peter McCullough

There's a whole variety of cerebral, cerebellar, even peripheral nervous system abnormalities [from the vaccines]. ... I've seen it in my clinic and they seem to be emerging three, four or five, six months later after vaccination. ... So I'm getting increasingly alarmed here that this is not just a simple one or two day problem. And so there's great concern, particularly in younger kids that over a course of three or six or nine months, they'll end up with heart failure or cardiac death. ... And the concept here, we're dealing with a Hitler/Stalin type of mentality with weapons of mass destruction

#### **Dr Tess Lawrie**

[The vaccines are] actually not safe for anybody and it's clear. The databases are screaming. The databases are early warning systems, and the databases around the world are screaming that we are facing a tsunami of chronic disease.

#### **Dr Richard Urso**

Early on, we were seeing things, mostly thrombotic, but later, as we get into two and three months [after vaccination], we're seeing a lot of inflammatory issues. I've had a host of people with inflammatory ocular disorders, as well as having orbital inflammatory diseases. I typically don't see this rash number of people.

#### **Dr Richard Fleming**

You're going to see an inflammable thrombotic response. That's the primary thing that people are noticing, be that heart disease or retinol disease. [Prions are] also a chronic smouldering disease. ... What we've seen is something that's been implemented that is an ideal bio-weapon. ... This is an inflammable thrombotic process affecting every organ system and prion diseases that not only affect the brain, but also affect the heart and other vital organs.

#### Dr Ryan Cole

I'm seeing countless adverse reactions ... It's really post-vaccination immunodeficiency syndrome ... I'm seeing a marked increase in herpetic family viruses, human papilloma viruses in the post-vaccinated. ... I have seen ... about a 10 to 20-fold increase of uterine cancer. ... Post-vaccinated patients are having diseases that we normally don't see at rates that are ... alarming.

#### Dr Sherri Tenpenny

We're injecting a synthetically made messenger RNA and strips of synthetically made double-stranded DNA by different mechanisms, and if that transmission goes to the other person [viral shedding], they don't get Covid, ... they just get bleeding, they get blood clots, they get headaches, they get heart disease.
