

# When conspiracy theories were right

## A look at the Covid crisis

### Introduction

A long history of conspiracy theories would require a huge book, covering such things as Lyndon Johnson's lie about the Gulf of Tonkin incident that prompted the Vietnam War, or the deliberate Israeli attack on the USS Liberty. The conspiracy theorists view on these issues is now a matter of confirmed history.

Lacking the time or inclination for a comprehensive investigation, in this paper I concentrate on the events during the fake Covid crisis. Despite massive hype by the mainstream media, over and over again the conspiracy theorists were right and eventually the media had to acknowledge it grudgingly.

**Since I have fully documented data covering all these issues in previous papers, I will not use extensive footnotes here but stick to the main thesis – unless I am reporting new information.** The headings are the so-called conspiracy theory that is now proved to have been correct.<sup>1</sup>

Only some of these points are now being admitted by all the mainstream media but slowly the fake narrative is breaking down. Mainstream media organisations, such as in the Denmark, are now openly admitting that they failed in a very serious way and did not hold politicians to account. It is interesting that as multiple court cases against the Covid manipulators are being presented to High Courts, and as hospitals and police stations are being served notices of legal liability, the mainstream media is beginning to turn around to a sceptical point of view. Politicians are also stepping back. Boris rescinded Plan B (which prompted Drakeford to apply the same thing to Wales) and Javid said that vaccine passports will be scrapped. Do they fear prosecution?

### Covid virus issues

#### SARS-CoV-2 does not exist as a natural virus

Two years later and no health agency anywhere in the world has been able to demonstrate a purified, properly isolated sample of the virus or supply a complete genome. With so many claimed victims, there should be loads of samples available from lung tissue and mucus – but there are none.

What is claimed to be the virus genome is actually a chimera involving other particles such as monkey kidney cells, not a natural virus, and not a full genome.

Some claim that genomic sequences have been published in various places but these include cells from foreign bodies, such as monkey kidney cells, extraneous genomic matter, antibacterial items and so on. They have not fulfilled Koch's postulates to isolate and purify the virus from a patient, and then re-infect a lab rat with only that isolated virus. Dr Andrew Kaufman gives a good scientific explanation of why these claims are false and

unscientific. For example, ‘isolation’ of the virus is not proper isolation but merely something grown in a Petri dish<sup>2</sup> with other contaminants present.

### **The pathogen originated in a laboratory in America and was finalised in Wuhan**

This theory was discredited for over a year but now it is widely accepted that a lab-leak is the most likely origin of the pathogen.

The discovery of American patents on all the variations of the gain-of-function coronavirus show that this was being developed initially in America at Fort Detrick and Chapel Hill (involving Ralph Baric) and then passed on by Fauci, with funding, to Wuhan for continuation since such development had become illegal in America.

This development is of a bio-weapon containing various particles and toxins based on a common cold coronavirus. The gain-of-function engineering is to make a pathogen that is highly infectious and dangerous to human beings. This development was done under the control of Fauci and Peter Daszak. [How can that ever be justified?] It has recently been alleged that Daszak works for the CIA.

In actual fact this pathogen turned out to be not as deadly as hoped. The severe cases in 2020 were: a) of people over 82 (who would be vulnerable to any infection); b) people with severe co-morbidities; c) people who had taken the previous flu vaccine containing monkey retroviruses. These developed hypoxia. To healthy adults the pathogen was like a bad flu; for healthy young people there were usually mild or no symptoms at all. [There is also the effect of 5G radiation in some cases causing hypoxia – see later.]

What was claimed to be Covid deaths were actually from a variety of illnesses, some of which statistically disappeared or unexpectedly decreased in 2020, such as: Influenza A and B, sepsis, TB and other things.

The government cancellation of autopsies meant that discovery of the true cause of death could not be ascertained. Many virologists, such as Delores Cahill, did their own genomic sequence tests of victims and found only influenza A.

### **Covid is not a lethal disease**

- The infection fatality rate was around 0.15% in most people (slightly higher in the over 80s). The low fatality rate was known and stated by John Ioannidis at the beginning after the cruise ship incident (the Diamond Princess outbreak).
- Covid was downgraded from being a highly infectious serious disease by the government on 19 March 2020 (before lockdown 1).
- Young healthy people had no risk at all.

- A freedom of information request to the ONS has shown that just 17,371 actually died from Covid without other co-morbidities in the whole period in England and Wales up to the end of September 2021.<sup>3</sup> Per year this is 8,685. In a bad flu season<sup>4</sup> more than 20 or even 30,000 will die from flu. Covid was far less of a health problem than flu. The government said that 148,536 people died from Covid.<sup>5</sup>

### **There were always existing, safe medications for Covid**

These include vitamin C, vitamin D, zinc, Hydroxychloroquine and Ivermectin, or a combination of these. There are others.

These treatments were all registered as safe and were cheap to produce. However, the objective of the fake crisis was to get everybody vaccinated and vaccines are not licensed if there are existing safe treatments. Therefore, these treatments had to be vilified. In some cases, fraudulent published papers castigating Hydroxychloroquine were forced to be retracted from journals like the Lancet after global protests.

Today dozens of published papers from independent researchers have proved beyond a shadow of doubt that Ivermectin is effective against Covid. But experimental practice around the globe has also proved, in real time, the efficacy of Ivermectin. The province of Utter Pradesh in India virtually eradicated Covid in three weeks when the government gave its 230 million population a package including Ivermectin.

Hospitals in America and France that used Ivermectin saw it heal virtually every single patient. Yet the drug is illegal in Britain. You need to ask yourself why. In fact one woman seriously ill in hospital with Covid was deteriorating under NHS treatment (e.g. Remdesivir). Her husband smuggled in Ivermectin in chocolate and she showed rapid improvement; the doctors were amazed. Then the smuggling was discovered and her husband was thrown out and banned.

### **It was never highly infectious**

In a clinical test patients were given high dose infections of the ‘virus’ but only 44% had symptomatic infection. Real world doses would be lower and even less likely to infect. Most people are not susceptible to any one variant.

## Test and trace issues

### PCR tests are fake

For two years people like me have been saying that the PCR tests cannot diagnose a disease, cannot diagnose Covid and produce a false positive rate of over 97% if run at more than 28 cycles.

This was ignored because the PCR tests were necessary to drive the panic and keep the mystical case rates high. That is, people testing positive and having to isolate but were never sick.

In the last few days the US CDC<sup>7</sup> has admitted that PCR tests cannot differentiate between a flu case and Covid. In detail the CDC says:

- PCR tests can remain positive for up to 12 weeks after infection; i.e. when a person is perfectly well. Viral transmission occurs in the first day or two before symptom onset and two or three days after symptom onset. The test picks up dead viral debris.
- The test cannot identify active infection or measure contagiousness.

Researchers have been claiming this for the last two years. The PCR test inventor, Kary Mullis, explained this before Covid began. The CDC is admitting that people have been forced into isolation (and perhaps lost their jobs) for no reason.

Despite PCR tests being effectively deemed useless in the US, the British government mandated that every school child going back to school after Christmas had to be tested twice in the first week.

It should be noted that PCR tests are dangerous for several reasons:

- Wrongful administering causes damage to nerves in the nasal pharynx close to the blood brain barrier. Many people have been harmed and some have died.
- Some swabs contain hydrogel – a form of nano-medication. No one knows what this is. The tip of the swab is not cotton but a bundle of hollow nylon fibres that contain ethylene oxide and other substances in the form of DARPA hydrogel.
- Swabs contain unusual unknown micro-fibres that move under heat.
- Chinese swabs have been found to contain multiple parasites moving around.
- Swabs are coated with ethylene oxide, which causes cancer and is mutagenic. It is banned in food production in the EU under EU Regulation No. 2015/868. The maximum residue level for ethylene oxide and the conversion product (2-chloroethanol) is 0.05 mg/kg but levels of 0.36 mg/kg have been found on swabs.
- Carbon nano-tubes are present; these are structures made from graphene [see later].

Multiple child psychologists are now demanding that the mass testing of children be eradicated immediately. It damages children psychologically. It serves no useful purpose and it costs inordinate amounts of money. Demands to stop this useless invasive policy came at a meeting of the Pandemic Response and Recovery All-Party Parliamentary Group.

Ethylene oxide is a poison. When the swab penetrates the mucosa at 30 degrees C the hydrogel melts. Ethylene oxide boils at 10.4 degrees C, which is why it is so painful. It is then released and generates an ulcer at the base of the rhino pharynx. This is doing great harm. Dr Jose Luis Gettor, an emergency physician in Spain, has warned about this

damage and urged people not to take the test, as have other doctors. Repeated use of PCR tests will increase the likelihood of cancer and destruction of the immune system.

### **Lateral flow tests are fake**

Similarly, we have condemned the use of LFTs because they simply do not work. If anything they give a false negative result.

The US CDC abandoned LFTs months ago because they were deemed useless.

### **The track and trace fiasco**

Epidemiologists warned the government that this would not work, would do no good and would waste millions of pounds. They were proved right. A government select committee also condemned the waste of public money (£37 billion).

On top of this the enforced quarantine of ‘pinged’ people (even if they were not sick) has caused chaos to businesses and hospitals. A hospital in Lincolnshire went into emergency measures because so many staff had been forced to self-isolate; others followed.

## **Non clinical intervention issues**

### **Lockdowns are medically pointless but are totalitarianism**

The SAGE experts claimed that lockdowns were necessary to flatten the curve and protect the NHS. Epidemiologists around the world explained that they were not only useless in fighting a virus but would do incalculable harm.

The data is now in. The government was wrong and the counter argument was right. The effect, as I predicted two years ago, is that lockdowns have killed more people than the epidemic and have caused devastation that will continue for generations. In short lockdowns caused:

- A dramatic shock to the economy. The worst effect for over 200 years.
- Collapse of many small and medium sized businesses.
- The ruination of the education of a generation of children.
- A massive rise in world poverty.
- A massive rise in mental health issues.
- A rise in suicides.
- A massive rise in cancer cases.
- A rise in self-harm, drug abuse, alcohol abuse and domestic abuse.
- An illegal loss of personal rights and freedoms.

- The creation of a tidal wave of backed up medical treatments now leading to serious issues or needless death because the NHS became a Covid-only service.
- The loss of normal GP services.

Proof that the government and civil service never believed that the lockdowns had any medical benefit and were just theatre is in the 17 plus drink parties held in Downing Street and Whitehall at a time when ordinary people were prevented from being with their loved ones as they died and suffered alone.

### **Lockdown policy is driven by computer model lies**

Throughout the whole crisis the SAGE decisions were based on modelling that proved to be false, over and over again. For example: in the current situation, the models predicted that there would be 3-5,000 daily Omicron deaths in January unless lockdowns were put in place. As I write this paragraph (4 January) the number of deaths was 48 without lockdowns. Ten days later the Covid hospitalisation cases were falling dramatically and data showed that Omicron had mutated into a bad cold. Not once have the Ferguson models been correct.

### **Facemasks are pointless**

Over and over again, study after study, proved that facemasks were utterly useless in combating a virus.

Most people have now seen through this façade. Multiple studies (such as the Danmask study) confirmed that facemasks offered little help.

Recently it has been acknowledged that Mask Asphyxiation Disease is now sweeping across the world. Usually this is hypercapnia where CO<sub>2</sub> levels become elevated causing hypoxia. However, other bacterial infections are also occurring from mask-wearing. In fact, changed body chemistry is affecting people’s emotions and causing neurological damage. Multiple diseases can be caused by facemasks, such as bacterial pneumonia, dermatitis or sepsis.

Facemasks have also been found to contain carbon nano-tubes. These are structures made from graphene for the purposes of nano-technology [see later].

An example of how dangerous a lack of communication can be due to facemasks is seen in the death of an epileptic man when a junior doctor misheard ‘15mg’ as ‘50mg’ before giving a fatal dose of an anti-seizure drug.

### **Social distancing is stupid**

It is laughable to think that a distance of six feet will keep you safe from an airborne virus that will fill a supermarket in minutes. Viruses can travel miles on the air.

Most people are sick of this nonsense and do not obey the rule even when imposed.

### **Perspex screens are useless**

Not only does the science show that Perspex screens at cashier points are a complete waste of time in trying to impede a virus, the data shows that they actually increase the chances of being infected by a virus because they concentrate viral particles in a small area and impede ventilation.

### **Travel will be restricted**

This occurred shortly after the first lockdown and has varied in intensity for two years. Some countries stopped people leaving full stop (Australia); others temporarily (UK). Then some people were allowed to travel under certain conditions (two jabs, negative tests, vaccine passport etc.). Even at this late stage as the crisis dwindles, Mexico is one of the few nations that admit travellers without being Covid-vaccinated or requiring tests.

### **Vaccine-based social credit control system**

This is when the government controls the minutiae that you are allowed to do within society over and above laws against crime (e.g. travel, go to a restaurant, go to a nightclub, go to a football game). This has not yet been fully implemented but many countries are close to doing so while a few already have this control system. Many commentators now see the danger of this becoming a reality in Britain.

## **NHS issues**

### **Nosocomial infections are driving case numbers**

For a very long time we have argued that huge numbers of people catch Covid in hospital. People attend hospital with a variety of issues, such as a broken leg, and then catch Covid due to the failing of hospitals (such as lack of proper ventilation in wards or lack of sufficient isolation of Caved patients).

This is now widely accepted and the statistics prove it to still be the case. The average figure is 40% but in some places it was as high as 60%.

### **Death with, not from, Covid is driving fatality statistics**

People like me have been shouting out that the Covid death statistics are false. Over and over again people who died from a gunshot, a car crash or a heart-attack were listed as a Covid death if they tested positive up to 28 days before death and had no symptoms.

### **Hospitalisation of incidental infections is classified as Covid**

For a long time the NHS denied this and ignored the Primary Diagnosis Supplement published weekly. It was only changed in the last week of December 2021.

### **Asymptomatic infection is a lie**

From the beginning I explained that non-symptomatic people do not spread the disease. Study after study proved this beyond reasonable doubt. Nevertheless the government and the NHS whipped up hysteria claiming the opposite.

### **Normal medical care collapsed**

From the beginning I predicted that the lockdowns would kill and damage more people than any epidemic. I wrote to the Prime Minister and my MP saying so. This has now been proved to be true in multiple areas: increase in poverty, collapse of supply chains, crashing of businesses, unemployment, suicides, collapse of education, mental health issues and so on.

But the worst result is the termination of normal health care services, such as cancer scans, face-to-face doctor appointments, elective surgery, consolations, testing services, minor treatment clinics and so on. This has led to a real tsunami of people now attending hospital very sick from preventable conditions.

Doctors from multiple disciplines, such as Dr Karol Sikora on cancer, have explained the scale of this collapse of treatment. It is shocking. In the case of cancer, up to 740,000 people should have been seen and assessed that were ignored. At least 15% of these will die when they could have been saved.

### **Misrepresentation of data**

Again and again data has been manipulated to give the impression that deaths from Covid were similar to the Spanish Flu pandemic. In fact, multiple data sets show clearly that 2020 was a normal year for excess deaths. There simply were no excess deaths. In fact, most years before 2009 had more deaths than 2020.

### **The Nightingale hospitals were a publicity stunt**

Set up at a cost of millions, these never used tents (apart from a very few people up north) could never work as there was never any staff to make them function.

After being much lauded, people now see that they were a waste of money. They were merely window dressing to give a political appearance of doing something.

### **The whole Covid narrative was fake**

The arc of the Covid narrative was a complete fraud. Months with high death rates were not due to Covid but other things.

Viruses don’t do waves. A virus epidemic rises quite quickly, plateaus out and then slowly falls until the virus is endemic and the population has herd immunity. That is how viruses always behave. There is no other strategy than gaining herd immunity by natural means. Lockdowns only cause problems.

In the Spring of 2020 where lots of people over 80 died, mostly in care homes, this was not Covid but the result of government strategies, chiefly two in number.

The first was the official standard treatment given to ‘Covid’ patients in hospital. This included Remdesivir, morphine and then ventilation. These proved fatal. Firstly they ignored known effective treatments and prophylactics, such as: Vitamin C and D, Zinc, the HCQ complex and Ivermectin. Dozens of studies have proved the effectiveness of these and the empirical results when used in different countries give hard real time data on how effective they are. [Uttar Pradesh eradicated Covid when it gave everyone Ivermectin; population 230 million.]

Ventilation is especially stupid and fatal when patient’s alveoli are clogged with plaque, which occurs in severe ‘Covid’ patients. It results in collapsed lungs because the air has nowhere to go. Intubating patients with clogged lungs is essentially murder.

Remdesivir is an experimental antiviral that has dubious authenticity. When it was being trialled against Ebola in Africa 54% of the patients died. It causes a depletion of iron in the blood, which is the very thing that patients with hypoxia vitally need. It also causes kidney

damage, liver damage and affects other organs. Treating elderly people with this was utterly stupid and criminal (but it is still being done).

It only has emergency approval for use against Covid, not full authorisation. It must be given slowly over time and with constant blood tests to check for liver damage (was this done with the old?). If there is no observable improvement after two days the treatment should be stopped (was this done?). This drug helped to kill sick people. Combined with morphine (which also reduces breathing) it is a fatal cocktail.

So hospital treatments ignored safe effective protocols and instead gave dangerously wrong treatments.

In care homes and in hospitals Covid patients were given Midazolam. This is another powerful sedative that is one of the ingredients used in US executions. The dose that was given to patients was ten times the normal dose and this was enough to kill certain people on its own. Midazolam can slow or stop your breathing, which is one of the key problems with Covid – so it will worsen the condition.

Patients on Midazolam must be watched carefully in a hospital setting to make sure that there are no side effects. Yet patients in hospital were left on their own for long periods, and often not even given water.

Decadron (Dexamethasone) is a type of steroid that can be helpful for a large number of medical conditions; however, it is also used to treat Covid patients. The problem is that there are a huge amount of adverse side effects for this drug. These include: cardiovascular disease, central nervous system effects, skin disorders, endocrine and metabolic disorders, gastrointestinal disorders, genitourinary problems, haematological and oncologic issues hepatic problems, hypersensitivity issues, neuromuscular problems, eye problems, respiratory issues and more. Why would you use this drug, especially if it affects respiratory issues, for a respiratory illness when there are safe drugs available that don't have these side effects?

So what happened in the Spring of 2020? We saw massive fatalities of elderly people because the treatments were killing them. On top of this, stupid lockdown policies stopped them seeing loved ones in their final days.

The lockdowns and various restrictions altered the course of the epidemic which artificially created the second wave. People were out of contact and so did not catch flu and colds in the normal way. These built up in strength and new varieties broke out on the Autumn of 2020 resulting in the higher death rate. Note that flu officially disappeared in 2020; it was re-labelled as Covid. Also the restrictions had weakened everybody's immune system (facemasks, being cooped-up inside).

The next wave was caused by the vaccines. It is now very clear that the adverse events are very serious and number in the millions. Deaths started rising again after the vaccine rollout. Nations with high vaccine take-up, like Israel, started seeing vaccinated people fill hospitals with Covid and other symptoms, especially blood clots.

So there was never a Covid pandemic flowing through three or four waves. That is a false narrative.

**First Wave: Spring 2020**  
Death of the elderly from bad treatments:  
Remdesivir, morphine, Midazolam etc.

**Second Wave: Autumn 2020**  
Death from flu held back by lockdowns, plus bad treatments.

**Third Wave: Spring 2021**  
Hospitalisations and deaths caused by the vaccines.

More and more people are beginning to figure this out.

## Vaccine issues

### The vaccine is not a vaccine

In theory, a vaccine injects an attenuated virus particle that the immune system deals with and enables it to then recognise the wild virus quickly and combat it. The Covid vaccines are mRNA vehicles to change the body's DNA to manufacture the spike protein of the claimed SARS-CoV-2 virus. This is a gene treatment not a vaccine. Since it was never properly tested or authorised, it is also experimental with the population as the guinea pigs.<sup>8</sup> Since no one in the world has isolated and purified the SARS-CoV-2 virus it is impossible to make a vaccine for it.<sup>9</sup>

### The vaccines don't work

Most people now realise that the vaccines do not stop transmission or infection. Even Boris and the head of Pfizer admitted this long ago. However, people think that they stop serious effects of Covid; this is also untrue; the vaccines make it worse if you catch Covid.

Israel is very highly vaccinated with up to four jabs but the hospitals are 80% full of vaccinated people.

UKHSA data in February 2022 showed that vaccine effectiveness had plummeted to MINUS 183%.

### The vaccines are NOT safe and effective

Leaders around the world, with one voice, stated that the vaccines were '*safe and effective*'. They did this despite there being no complete trials or the fact that the trials were fraudulent or the fact that the vaccines were not properly authorised as safe. Whistleblowers confirmed that the trials were filled with errors and misrepresentation. For example, the claim of 95% effectiveness was false. Trials showed that the absolute risk reduction was 0.84%. More vaccinated people died in the trial than the unvaccinated. All the test animals died. There was a 300% increase in adverse events directly caused by the vaccine. Severe events spiked at 75%. Cardiovascular deaths were twice as common in the vaccinated. Over 1,000 scientific studies prove that the Covid vaccines are dangerous.

US courts have now demanded that the FDA must release the first 55,000 pages of Pfizer trial data, which Pfizer demanded 75-years to release. Pfizer has warned investors of a wave of potential fraud revelations about to become public after making \$54 billion in one year from a vaccine that does not work but kills and maims people.

The reported adverse events are now at ridiculous high levels; worse than anything in history. Hundreds of thousands of people have died and millions badly affected. Sports stars are dropping dead on football pitches; now over 100 worldwide. Heart attack deaths among pro-footballers in 2021 were 300% higher than in the 12-year average. Pilots are dying in mid-air. Young children are dying from heart failure. These are all due to the blood clots that form from the vaccine. Myocarditis tops the list of Covid vaccine injuries among 12-17-year olds (VAERS data).

But there are many poisons in the vaccines; some that kill quickly, some over a period of time. The vaccines also sterilise people that don't die. The fact of the adverse events can no longer be ignored.

For example: the State of Indiana is below the average Covid vaccine take up rate of 74% (if you believe this) with 52% being fully vaccinated. Based on insurance claims, the death rate has skyrocketed. It has increased by an unprecedented 40% among those between the ages of 18 and 54 in the latter half of 2021. Data all over the world is showing a spike in excess deaths since the vaccine rollout.

The US VAERS data shows that deaths are much higher after the vaccination rollout. The number of deaths are far higher than the average for the last 31 years. There were 3,294 post vaccination deaths for one year between ages 18-65. Previously there was an average of 27 deaths per year following vaccinations.<sup>10</sup> That is a 12,100% increase. Similar data appears worldwide. If we consider that the real figure is up to 100 times worse (according to studies)<sup>11</sup> than there is a catastrophe going on. Britain now has over 2000 official post vaccination deaths, which is certainly a fraction of the true figure.

### **The vaccines don't work but natural immunity does**

We warned that this would happen but no one listened. However, everybody is now becoming more aware that something is seriously wrong.

People were told that the first vaccine would free them up. It didn't. Then they were told that the second vaccine would restore freedoms. It didn't. Now a third booster shot is being demanded and Israel has started its fourth booster. The NHS has said that vaccine will be needed every three months and the government has already purchased millions of bottles.

People are seeing through this and uptake of the booster is extremely low. The Wembley Stadium vaccine centre, able to cater huge numbers of shots with many staff, was filmed being completely empty at mid-day.

An analysis of ONS data shows that the Pfizer vaccine, for example, has a minus 151% effectiveness rate. In other words, you are better off doing nothing. Claimed vaccine immunity disappears after a matter of weeks, hence the need for boosters forever. People with Covid infections in hospitals are mostly vaccinated. Many public figures who were vaccinated have caught Covid twice or even three times. Yet it is now established that natural immunity provides long-term, probably for life, protection against so-called Covid. The US regulator has warned that booster shots pose a risk to the immune system.<sup>12</sup>

The data is that everywhere with a high vaccine take up there is a corresponding high Covid hospital rate and a high death rate. This is true in Israel but also many other nations and states of America. Counties and states with a low vaccine take-up are seeing much fewer hospitalisations, cases and deaths. For instance: in Denmark Omicron hospitalisations occur primarily in the fully vaccinated.<sup>13</sup> Over 90% of the caseload is in the vaccinated. In Australia more fully vaccinated people are in hospital with Covid than unvaccinated.

The vaccines are causing serious health issues and deaths in high numbers. The public are beginning to understand this and mainstream media commentators have begun (two years too late) to ask relevant questions. The reason is that the vaccines are destroying the immune system. Even the New York Times was forced to admit this.<sup>14</sup>

The CEO of Pfizer, Albert Bourla, recently admitted that the Pfizer shots are useless, and that double-jabbed people have very limited protection if any.<sup>15</sup> Bourla said that the first two doses only offer '*limited protection*' and that the booster offers '*less protection*' against

### **The vaccines permanently damage the immune system**

More and more studies now prove this to be true. Even the MHRA had to admit it recently:

Recent observations from the UK Health Security Agency surveillance data that N antibody levels appear to be lower in individuals who acquire infection following two doses of vaccination.<sup>16</sup>

It goes on to say that this drop is permanent. The report also goes on to say that vaccinated adults are now much more likely to be infected than unvaccinated. The vaccines interfere with the body's ability to make antibodies after infection not only against the spike protein but also against the nucleocapsid protein, the envelope of the virus. This is a crucial part of the response in unvaccinated people. Therefore, the vaccinated are far more susceptible to mutations in the spike protein, even if they have already been infected.

A new unpublished paper by Stephanie Senett PhD explains that the vaccine suppresses the immune system by inhibiting the type-1 interferon pathway. Studies are showing that the immune system is deteriorating at a level of 5% per week in the double vaccinated. Within a few months there will be a zero defence against infections.

UKHSA data released in February 2022 showed that fully vaccinated Britons currently had a 65% lower immune response than the unvaccinated.

### **The vaccines are full of poison**

More and more doctors and scientists are discovering what is in the vaccines through stringent testing. The claims made by supposed conspiracy theorists months ago are being confirmed to be true by spectroscopy and other examinations.

Even senior whistleblowers from the WHO have confirmed that the vaccine is a bioweapon or a biotech-weapon. One example is Astrid Stuckelberger of Switzerland.<sup>17</sup>

### **The vaccines are killing thousands of people**

Claims on insurance policies regarding deaths from vaccine injury are already being denied. ### **There is selection within the vaccine programme**

People often ask why they are healthy after a vaccine shot if the vaccines are evil and dangerous. The answer is that only certain batches (lots) are deadly and cause harm. This has been proven categorically from analysis of the VAERS data, which delineates batch numbers. Scientists like Dr Mike Yeadon and Dr Wolfgang Wodarg have demonstrated this in presentations. Lawyer Reiner Fuellmich is using this as evidence to prove legal liability due to premeditated harmful intent.

A depopulation plan cannot kill everybody or the world stops working. The elite plan to reduce the world population and target certain demographics. In America, some of the deadly batches were demonstrably dispatched to Republican states. It is also proven that some of the vaccine vials are placebos containing saline solution. This proves premeditation to cause harm.

However, many of the problems with the vaccines are that they cause death slowly over time. Microscopic blood clots now will aggregate and build up over time to cause thrombosis in months or even years ahead. Death may result from the vaccines over many years.

### **The vaccines establish a biomarker operating system**

Using graphene and other metals, the vaccine contents self-assemble to form little wi-fi operating systems within the person. This can be read by a device with the right app.

It was openly claimed by the head of Moderna that nano-computer operating systems were being created in vaccinated people. Since then political leaders, like Tony Blair, have openly stated that people will become micro-chipped with biomarkers. Initially there may have been a need for actual chips, but the programme now is for a full nano operating system in the bloodstream placed via multiple vaccinations. At this point in time social access requires a QR code on a mobile ‘phone. Later it will be a ‘chip’, then the internal operating system.

The developer, *Dsruptive Subdermals* managing director Hannes Sjoberg, of an implanted microchip linked to a Covid vaccine passport stated recently that the mass chipping of all people as a means of ensuring compliance is happening, ‘*whether we like it or not*’. The purpose was to transform healthcare on a global scale. The microchip allows a person entrance into a public place.<sup>20</sup> The end result will be no chip, no food.<sup>21</sup>

Doctors have identified a MAC network address emanating from vaccinated people that can be detected by certain apps on a mobile ‘phone – so something is already transmitting from within the body of vaccinated people..

## **More on the internal operating system**

As time progresses, and more observations are being undertaken globally, we are beginning to understand how the vaccination-administered biochip is being assembled within the body.

We have understood how graphene, in its various forms, is being used to assemble electrical structures in the bloodstream along with other metals. New observations, both in the vaccine vials and in the blood of vaccinated people, are showing the components of these structures and we can surmise what they are doing by comparing these structures with scientific papers detailing nano-technology.

### *Explanation of some parasitic-type structures*

Science moves on by further study and observation. Initially researchers had noted what looked like parasites on swabs, facemasks and in vaccines. At the time this was a reasonable observation. Cylindrical structures and even hydra-like structures were not only observed but were also seen to respond to external stimuli, like heat or breath; they moved and wriggled. One scientist found what he thought was a parasite egg in the vaccine which, after heating, grew into a hydra-like structure.

All these structures are now understood to be mimicked by carbon nano-tubes. While we cannot be certain, as this is cutting edge science that is still being discerned, it appears that the real identity of these structures is graphene and not biological forms.

### *Bio-chips*

When the government was asked if there are biochips within the vaccines they asserted ‘No’. In one superficial sense this was true. There are no electrical circuits in the traditional sense in the vaccines, with wires and transistors; not even at a micro level (thousandth of a millimetre). But what **is** inserted is the nano-equivalent of these (millionth of a millimetre) using graphene-based structures that form transducers, transceivers and microprocessors without copper wires and circuit boards. The graphene nano-technology does form computer operating systems in the body.

### *Carbon nano-tubes*

These are structures made from graphene. These are used in nano-technology to be bio-compatible. They are neuro-sensing and neuro-activating. They can be used as a transducer<sup>22</sup> that responds to electrical signals to actuate neurological activity or feedback.

Carbon nano-tubes look like parasites and respond to stimuli, such as heat, like parasites. They have been observed both in vaccine vials and in the bloodstream of vaccinated people. They are made from graphene, which is a very hard material, that is an excellent conductor of electricity. Red blood cells are attracted to them by their negative electrical charge to the positively charged nano-tube.

### *Carbon nano-tube octopus forms*

These look like the hydra parasite or like spiders, or octopuses.<sup>23</sup>

### *Graphene quantum dots*

These form in the body to act as a transceiver<sup>24</sup> or transducer. They self-assemble into various formations. They also emit fluorescence. They form logic-gates, the building blocks of nano-technology. In effect they act like microprocessors.<sup>25</sup> They have been photographed entering red blood cells.

### *Quantum dot cellular automata*

These process information and are the equivalent of microchips – they act like a microprocessor. The structures combine to form complex patterns that act like circuits. In effect, they are a nano-computer.

### *The net conclusion*

All these nano structures have been observed and photographed, via powerful microscopes, by different scientists all over the world. So when the British government stated that there were no microchips in the vaccines, they were lying.

This graphene nano-technology fulfils what Klaus Schwab defined in his Great Reset and Fourth Industrial Revolution. This is the goal of transhumanism – to control and direct people's thoughts, behaviour and emotions and to provide feedback to an external control system. This is why the world had to be vaccinated – to initiate global control over people remotely.

### *The unexpected problem*

It seems that the elite did not factor in the property of graphene structures to rip apart the lining of the blood vessels and cause clotting – which is killing people in the form of myocarditis, pericarditis, thrombosis, heart attacks, strokes and other conditions. The attraction of red blood cells to the nano tubes, and even the absorption of nano-tubes into red blood cells, is possibly another cause of blood clots.

The vaccines were never tested on pregnant women and could not have been said to be safe. They are not safe. Women are having spontaneous abortions and giving birth to stillborn babies. Menstrual cycles have been damaged. Some women have been bleeding from the uterus outside their periods. Some 80-year old women have started bleeding again. Some countries have formally reported unusually high numbers of newborn deaths.<sup>26</sup> By Christmas 2021 vaccine reporting systems revealed that 3,010 babies had died of heart disease. That is a 4,080% increase in foetal deaths recorded in the VAERS system.

### **The first vaccine was not the end and would not bring back liberty**

This was the promise made by politicians. People dutifully lined up for their shots and were later put into lockdown again. They had their second shots and were put into lockdown again in Wales and Scotland or restricted in England.

### **Vaccines will be continually required every few months**

This was laughed at when first mentioned; however, it is now happening. Britain is on the third necessary jab with more already paid for by the government. Israel is on the fourth. Ministers have stated that jabs will be required every three months.

### **Young children will be vaccinated**

This was initially denied since children are at no risk from Covid. Then the government demanded jabs for teenagers, then under 12's then as young as five. Covid vaccines for infants are under consideration right now. The government went against the advice of the JCVI.

The real reason why this rollout to children was necessary is that eventually emergency licence will run out and vaccine manufacturers will seek full authorisation for every new booster. In order to gain indemnity in this situation the vaccines have to be administered to children, even if they are also given to adults. Getting kids vaccinated is to get immunity from lawsuits.

This is immoral. Children are at no risk from Covid whatsoever; yet they are demonstrably at a high risk of serious side effects from the vaccines which include: myocarditis, pericarditis, anaphylaxis, other ailments and death.

### **Vaccine passports (QR codes) will be required to live life**

This is already true in many countries. See above. It is operating now for certain venues in England, such as night-clubs (where it has proved to be a disaster).

### **Sanctions will applied to the non-vaccinated**

Every booster shot invalidates the previous vaccination status. That is, your QR code will not work even if you have had two vaccines; you are only considered vaccinated if you have the up-to-date booster (already this is number four in Israel).

In Australia there are already serious fines for those people who turn up for work and are unvaccinated. In America medical treatment is being denied to the unvaccinated. In some countries, such as France, food is being denied to the unvaccinated. I saw a video of a man going in to a local farmer's market in America and the security team threw him out because he was not vaccinated, despite this being an open-air warehouse.

### **The connection of 5G**

This claim caused more ridicule focused on conspiracy theorists than anything else. However ...

More people are realising that the effects of 5G at certain outputs cause the same symptoms of claimed Covid (hypoxia, headaches, multi-organ hypercoagulation, fever, fatigue, and death). Also the initial key centres of Covid were the places where 5G was tested at high capacity (Wuhan, Belgium, Lombardy, New York).<sup>27</sup>

Autopsies of claimed Covid corpses have discovered what was officially termed radiation poisoning.

Parallel etiologies<sup>28</sup> can be drawn between SARS-CoV-2 infection and radiation injuries. ... Both conditions initiate a cytokine storm, with similar pro-inflammatory molecules increased.<sup>29</sup>

The NIH<sup>30</sup> in America has formally admitted that there is a connection between 5G and Covid.<sup>31</sup>

The virus that caused the Covid-19 pandemic, surfaced in Wuhan, China shortly after the implementation of city-wide (fifth generation [5G of wireless communications radiation WCR]) and rapidly spread globally, initially demonstrating a statistical correlation to international communities with recently established 5G networks.

Despite this confirmed connection, people must start asking why:

- The government initiated a massive construction programme to erect 5G masts all over the country without planning permission. Gangs of workers defied coronavirus restrictions to do this work while the nation was in lockdown.

- Why have the public not been informed that microwave technology has been used as a military weapon for decades and deployed, e.g in Northern Ireland or Greenham Common?

## State overreach

### **The state used military behavioural psychology to drive fear into the population to elicit compliance**

This propaganda conditioning was in excess of the level used by the Nazis in 1930s Germany. It included: sloganeering, visuals, controlling the media, NPL programming, hypnosis by departments such as ‘the Nudge Unit’, SPI-B, 77 Brigade, the Cabinet Office and others.

### **The police are acting like fascist thugs**

More and more stories have emerged during recent months so that no one can deny that this is a fact. Multiple people have had their doors smashed in and their home raided illegally without a warrant, such as Alex Bellfield of The Voice of Reason. Officers cover up their epaulet numbers to try to hide identification, also illegally. Officers brutally manhandled old ladies marching peacefully on demonstrations and arrested them. Every single fine for breaching social distancing rules that went to court were overruled as illegal or the CPS did not press charges. Major mainstream commentators, like Peter Hitchens, have called for the police force to be abolished and replaced with a new system based on Robert Peel’s original principles.

In Australia police brutally pushed old ladies to the ground and then sprayed pepper spray directly into their faces. One 74-year old woman called Anne had to go to hospital after such an attack.<sup>32</sup> The police fired rubber bullets into the crowd of dispersing, peaceful demonstrators; one victim was a 10-year old boy. On at least one occasion, the military fired live rounds into the air above protestors. On many occasions multiple police officers brutally attacked young women, thrusting them to the floor and tossed them into wagons for merely having no mask. One woman was forced into 21 days in solitary confinement with no fresh air or exercise at all because she organised a demonstration on social media.

### **The state is controlling whether you can party or be entertained**

This is best exemplified by the current restrictions applicable in Scotland despite Covid cases flat-lining and hospitals containing relatively few Covid cases. At New Years Eve six police vans turned up, and multiple police officers, to arrest two old people for drinking in a Glasgow bar after 10pm.

## **The state is controlling personal health**

This is illegal and contrary to the Nuremberg Code.

On the 5<sup>th</sup> January New York State proposed a series of bills which include:

- Mandating Covid vaccinations in order to attend school.
- Vaccine records to be collated into a state database.
- Forced Covid vaccines to attend college.
- Mandated flu shots to attend school, pre-school and day care.
- Eliminate religious exemption to Covid shots for work and for college.
- Eliminate parental consent to shots when a child reaches 14 years of age.
- Eliminate parental consent to SPD shots for children
- Allow the governor to imprison without trial.
- Eliminate unvaccinated people's access to health insurance.

This is totalitarianism of the worst order.

Like Israel, Australia and New Zealand, New York is a test bed for a global roll out of draconian Covid policies. The elite plan this for everybody.

## **The state is deliberately collapsing small businesses**

The elite seek to crash small businesses and develop global corporations. The end result will be a universal wage system where workers will be under the complete control of the state. Localised private enterprise cannot be allowed to spoil this plan. The number of billionaires has increased by at least 25% since the Covid crisis began. Global corporations like Amazon have added billions to their value. 2020 saw the biggest ever transfer of wealth to the richest people.

The WEF Great Reset states that the goal is Communism, '*you will own nothing and be happy*'. However, the globalists will own everything while individuals will own nothing. To achieve this, small businesses must be destroyed.

People have woken up to the fact that closing down small businesses and high street shops but allowing large corporations to open up (such as supermarkets) made no medical sense. Amazon never closed; why should small businesses working under the same conditions have to close? Buses and trains posed a far greater risk of infection (indoor closed environments were the base of infections); small businesses had far less risk where people only mingled for a few minutes.

## **Government mandates are illegal**

I have explained why these are contrary to Common Law and various statutes many times.<sup>33</sup> There are now many lawsuits against national politicians and experts advising them. One is taking the British government people responsible to the International Criminal Court. Australian opposition parties hoping to gain power in the forthcoming elections intend to prosecute and imprison the politicians and advisors that mandated social restrictions and vaccines.

Common Law High Court appointed constables have been serving legal notice of liability to every chief Constable and police station in the country putting them on notice that they are liable to arrest and prosecution on charges of abetting crimes against humanity if they do not arrest politicians responsible and shut vaccine centres down. They have also done this

with hospitals and doctors. [Remember that the Nuremberg trials prosecuted<sup>34</sup> few generals but many doctors and nurses.]

### **Covid internment camps**

Although these prison camps are being constructed all over the world, including six in Britain,<sup>35</sup> they are already in use in Australia. A camp in the Northern Territory was highlighted when 38 people, merely suspected of being in contact with a PCR positive person, were manhandled and forced into insolation in a camp at Howard Springs. They were later forcibly vaccinated. Since then PCR positive people have also been interned.

More and more politicians, including British politicians, are calling for unvaccinated people to be locked away or even subjected to mind-training (thought conditioning).

The round up of the unvaccinated is beginning. In America people are being recruited to form security ‘strike teams’ to drag the unvaccinated from their homes and imprison them in internment camps. In Australia this has already occurred. Canada and New Zealand are preparing to effect this right now.

Why would Britain spend billions on new huge prison camps the size of a small town when they were prematurely releasing prisoners from normal jails in the Covid scare?

### **Persecution of the unvaccinated minority**

In multiple countries it is already illegal for unvaccinated people to enter shops to get essential supplies and food or go to entertainment and sport venues; France is but one example.

This went even further when Macron, President of France, issued an appalling denunciation of the unvaccinated, using foul language in an official speech.<sup>36</sup>

The mayor of Washington DC declared an emergency and demanded that all people must carry vaccine papers and a photo ID just to leave their house.<sup>37</sup>

Quebec is planning to steal the money of the unvaccinated in the form of a health levy.<sup>38</sup> Greece is also fining the unvaccinated while Austria is fining them 4,000 Euros.

### *Killing the elderly by design*

The British government enacted policies designed to kill old people in various ways. These included: using Remdesivir for Covid patients which kills the kidneys and other organs. Using an end of life care pathway that involves: starvation, morphine and Midazolam. Denying elderly Covid patients in care homes any doctor or hospital treatment. Issuing DNR notices to old and disabled people, often without any explanation or consent. Sending sick patients from hospital into care homes where they wiped out dozens of people.

### *Vaccine adverse events*

The adverse events to the Covid vaccines is already causing a massive spike in excess deaths world-wide. Over a million events have been recorded so far in Britain alone on the state MHRA Yellow Card system, which is acknowledged to be a fraction of the real number; especially as doctors are preventing cases being reported. Deaths are officially over 2,000. In Europe over 30,000 have died, again a fraction of the real number. In America the figure being discussed by experts is over 400,000 deaths. In November the official US figure was 18,853 fatalities.

Now bear in mind that in history any reported deaths above, say, 10 resulted in suspension or termination of the vaccine programme. In the Swine Flu epidemic the vaccine was pulled after less than 50 reported deaths and serious adverse events. On this basis the Covid vaccine should have been cancelled months ago. Why have they not been?

### *Eugenics*

The people in charge of this are committed to a depopulation of the Earth.

- Boris Johnson's father, Stanley, claimed on film that Britain's population needs to be reduced to 20-25 million (currently 70 Million). Boris himself said that he wakes up in a cold sweat panicking that there are too many people in the world.
- Bill Gates is a eugenicist from a line of eugenicists who has said that vaccines will be a means of reducing the world's population.

- Facemasks demanded of school children who are at no risk of Covid and do not pass it on to others.
- Believing that six feet social distancing will give protection to an airborne virus.
- A ban on singing.
- A ban on dancing.
- Wearing a mask alone in a car.
- Eating and drinking with a mask on.
- Being able to have alcohol in a bar but not coffee.
- Forcing young schoolchildren to do schoolwork outside in the winter cold.
- Forcing schoolchildren to eat their lunches outside in the cold.
- In the Netherlands you can currently go to a brothel but not to a pub.
- Not being allowed to let your mother visit but allowing a plumber to fix the boiler.
- Not being allowed swimming using backstroke but allowing the crawl.
- Nicola Sturgeon prepared to spend £300,000 on cutting a few inches of the bottom of school doors (fire doors) to improve ventilation for kids who are at no risk from Covid but are at great risk from fire and smoke inhalation.

## **An exposure of key government lies accurately stated by sceptics**

- *Lie: Covid is highly dangerous and you should panic.* Covid-19 is not a highly infectious disease (officially) and has a low mortality rate and is effectively a form of mild flu. Death numbers were massively inflated by government lies. There was never any pandemic.
- *Lie: PCR tests are the gold standard of evaluating Covid.* PCR tests are a complete fraud and cannot be used to diagnose a disease.
- *Lie: there have been high numbers of infected people.* The panic of case numbers was driven by false PCR positive test results; therefore there was never any crisis.
- *Lie: Facemasks protect you from viral infection.* Facemasks are utterly useless in preventing viral infection.
- *Lie: social distancing is necessary to prevent viral infection.* Social dancing is utterly pointless in combating an airborne epidemic.
- *Lie: the use of computer modelling by Imperial College and others gave good predictions of the Covid crisis proving that lockdowns were necessary.* The models were seriously wrong in every case, just as previous models led by Ferguson had been. - *Lie: daily presentations of death statistics and mandates were necessary. Heavy use of advertising was also effective.* The government damaged the psyche of the

population by constant scaremongering. It did this using military-based behavioural psychological methods wasting billions of pounds on advertising and media sponsorship.

- *Lie: government diktats and the Coronavirus laws were legal and necessary.* The totalitarian laws enacted by the government were illegal and contrary to Natural (Universal) Law (i.e. conscience), Common Law,<sup>43</sup> the Constitution<sup>44</sup> and even previous statutes.<sup>45</sup>

- Refusing severe patients safe treatments (e.g. Ivermectin) killed them.
- DNR notices (often issued without consultation) were euthanasia. These were issued to everyone over 60 and also disabled people.
- The government deliberately killed thousands of old people in care homes by wrong policies and corruption (e.g. Midazolam, relocating sick people from hospitals).
- The whole Covid crisis was planned years in advance.
- PCR test kits were patented and manufactured by Richard Rothschild from 2016.
- PCR test kits contain all manner of contaminants plus ethylene oxide, which causes cancer.
- PCR tests are also a DNA collection strategy.
- SARS-CoV-2 does not exist as a wild virus; there is no proof of a full genome anywhere.

The incompetence argument doesn't stack up. There are just too many fallacies within it. Also the SAGE scientists may be evil and corrupt but they are not stupid. For example they stated early on that facemasks don't work and are of no use but later changed their mind when the demand was made for a compliance test on the population. ### **The pandemic was planned for decades**

The whole thing complies with the strategy of the UN outlined in Agenda 2030 and the WEF's plans for a global reset, both of which result in the enslavement of humanity under a totalitarian world government.

### **CBDI reset**

The immediate need for this crisis was to implement a new global economic system as the existing Petro-Dollar, fiat currency, debt-based, system falls apart and will certainly collapse by 2026 (which is why the Covid measures were planned to continue until 2025).<sup>48</sup> This is for Central Bank Digital Currency systems that are being gradually rolled out. This is why vaccine passports, a new digital ID system with all your data, is required. It is the entry port into the CDBC system, which will eventually be a nano microchip in your body built up through successive vaccines injecting operating system updates. Why else push vaccine passports when the vaccines offer no safety and do not stop infection or transmission? The reason is not about a virus.

### **The corporate factor**

As with all cases of global elite control, it is possible to follow the money and trace cabal activity through the usual corporate culprits.

- The Institute of Virology in Wuhan is owned by GlaxoSmithKline.
- GlaxoSmithKline owns Pfizer.
- The Wuhan laboratory was funded \$7.4 million by Anthony Fauci, as head of the NIAID,<sup>49</sup> in 2019 to make gain of function enhancement of a coronavirus (i.e. make it more toxic and infectious to humans).
- The NIAID partnered with Moderna to make a Covid vaccine.
- Bill Gates invests in the NIAID as part of his global vaccine programme.
- Fauci and Gates profit from Covid vaccines.
- Fauci profits from his connections to vaccine manufacturers; as does Patrick Vallance, Neil Ferguson and Chris Whitty. Fauci sets US policy on health and vaccine issues. Vallance and Whitty set British policy on health and vaccine issues.
- The finances of GlaxoSmithKline are managed by Blackrock.
- Blackrock recently appointed Jeffrey P Kindler, former chairman and CEO of Pfizer, as a senior advisor.
- Blackrock also manages the finances of George Soros' Open Society foundation.
- Soros owns the German company that built the Wuhan laboratory.
- The laboratory was bought by the German financial services company Allianz, which has Vanguard as a shareholder.
- Vanguard is also a shareholder in Blackrock.
- Blackrock controls the central banks and manages a third of global investment capital. It is controlled by the Rothschilds, the Windsors and other chief elite people.
- Blackrock is also a major shareholder in Microsoft.
- Microsoft's Bill Gates is a major shareholder in the German company BioNTech, which makes the Pfizer Covid vaccine. Gates has been pushing vaccines for the last decade.
- Fauci and Gates are shareholders in Remdesivir and make a fortune from the rollout of this as the prime response to Covid in hospitals.

- Gates is an eugenicist pursuing global depopulation. He has stated that vaccines will help to achieve this.
- Gates is also a major sponsor of the WHO, which is a subsidiary of the UN, which is committed to depopulation as exhibited in its Agenda 2030.
- Gates is an agenda contributor to the WEF.
- The biotech firm Ginkgo Bioworks (which designs and licences organisms) ties together Bill Gates (through the company Cascade Investment), the WEF (Ginkgo is a WEF partner) and DARPA. Another investor in Gingko is Viking Global Investors, which is also a partner of the WEF. Gingko's public health and biosecurity team is Coincetric. The vice president of Coincetric business development, Dylan George, worked in In-Q-Tel, the CIA's venture capital firm (which helped start Facebook). He also worked as a senior advisor for BARDA,<sup>50</sup> the health equivalent to DARPA. The firm also employs other former military and DARPA personnel. Gingko's goal is to program cells as easily as computers as part of the WEF transhumanism plans.<sup>51</sup>
- In 2020 Gingko was given \$1.1 billion by the US government to do Covid testing and development.
- Gates and the WEF sponsored Event 201, which planned, prepared and simulated the Covid epidemic in 2019.
- The Covid crisis was kick-started by the doom-saying false predictions of Neil Ferguson and the Imperial College computer models. Gates funds Ferguson and Imperial College.
- The crisis was continued by the false Covid propaganda emanating from the BBC. Gates sponsors the BBC.
- The propaganda was also stimulated by the Guardian newspaper. Bill Gates funds the Guardian.
- The oversight of the crisis in Britain is by the corrupt MHRA. Gates gave the MHRA £900,000.
- The WEF funds a leadership training scheme for global leaders, (the 'Young Global Leaders Programme') which included most of the Covid hard-line players, and their cabinets, in the Covid crisis such as Jacinda Arden, Justin Trudeau, Angela Merkel, Emanuel Macron and many more.
- The WEF seeks to use vaccines in transhumanism and depopulation programmes.
- The US CDC makes profits from Covid vaccines through its patents on vaccine products. The CDC controls the response to Covid-19 and epidemics by advocating vaccines it owns.

## **Conclusion**

depopulation. This is not theory; they have openly stated this for decades. It is written in granite on monuments in Georgia.<sup>52</sup> See my previous papers for multiple quotes from world leaders advocating a reduction in global population of up to 95%. Most famously, Henry Kissinger called us plebs, ‘useless eaters’. The elite see humanity as cattle.

There is no doubt that the Covid crisis, and particularly the vaccine rollout, is a depopulation plan. Doctors around the world, observing the effects in patients, are beginning to see this. Let’s evaluate all the components contributing to mass death.

### *Lockdowns*

Lockdowns alone have caused a global spike in deaths from multiple causes. Time will reveal just how serious lockdowns were. For example, a young man in Australia had no family but for his grandmother, whom he was close to. Lockdown policies caused this woman to die and he was forbidden from being with her in her last moments. Being grief stricken, and alone, this young man killed himself.<sup>53</sup>

Lockdowns cause death in multiple ways. We could list:

- Suicide.
- Creating unemployment – which causes deaths.
- Loneliness. The lack of social contact results in mental deterioration, depression, anxiety, sickness and death.
- Suppression of the immune system through lack of exercise, lack of sun exposure, lack of fresh air, lack of normal pathogen contact (which stimulates the immune system), a sedentary lifestyle, no relief from domestic stress, and so on.
- Violent abuse. Deaths from domestic abuse have skyrocketed.
- Self-abuse: alcohol abuse, drug abuse, poor nutrition all increased. In some American cities more people died from drug abuse than from Covid.
- Wrecking the NHS, which became a Covid-only institution with multiple ailments failing to be diagnosed, scanned or treated. For example, many people died from treatable cancer.
- Mass death deliberately caused in care homes.

### *Facemasks*

We know that facemasks are pointless in a viral epidemic but they also are a serious medical threat. Problems caused by facemasks include:

- Bacterial pneumonia.
- Hypoxia.
- Brain damage due to hypoxia.
- Cancer. New studies are showing how facemask use causes cancer.
- Skin disorders.
- Bacterial infections.
- Sepsis.

### *PCR tests*

These have caused multiple medical problems including:

- The ethylene oxide coating (claimed to be used for sterilisation) causes cancer.
- Wrongful administration causes damage to the vagus nerve, which suppresses the immune system.
- Nasal infections.

- Infections breaking the blood brain barrier leading to brain damage.

### *Economic collapse*

This always brings an increase in mortality due to the multiple triggers it sets off. These include: unemployment, bankrupt businesses, increased debt, failure to pay the mortgage and losing your home, etc.

### **The pathway of death caused by the vaccine rollout**

This is complex as it causes death in multiple ways. In general the vaccines destroy the immune system, which leads to a slow death over time (which is the point, it hides the cause of death). In addition, they cause immediate death, or death within a few days, due to poisonous components. First we must look at the progress of the vaccines.

#### *First vaccine<sup>54</sup>*

This has a small amount of saline and a group of components, which are catastrophic to the cellular system. It damages the immune system by reducing the white blood cells by 50%.

#### *Second vaccine*

This is programmed for eight weeks later because that is the time for regeneration of white blood cells. This is to hit the immune system while it is recovering. It has reduced saline plus more harmful ingredients. This destroys another 25% of white blood cells. Now the immune system is 75% suppressed.

#### *Booster 1*

No saline. This introduces 81 strands of foreign bacteria that the body has never experienced. This causes chronic inflammation that worsens existing health issues, such as lungs, or heart. The body is now in a chronic inflammatory state with a low immune system.

#### *Booster 2*

No saline. This has eight strands of HIV, which completely shuts off the immune system resulting in AIDS type symptoms. This is why vaccinated people are experiencing AIDS type symptoms all over the world.

In each part of this process, 20-30% of the population will die.

More booster shots are being programmed which will make survivors dependent upon Big Pharma for life.

Secondly, we must briefly note the adverse reactions. The official MHRA reporting system lists the following reported adverse events.

- Blood disorders.
- Cardiac disorders.
- Congenital disorders.
- Ear disorders.
- Endocrine disorders.
- Eye disorders.
- Gastrointestinal disorders.
- General disorders

- Hepatic disorders.
- Immune system disorders
- Infections.
- Metabolic disorders.
- Muscle tissue disorders.
- Neoplasms.
- Nervous system disorders
- Pregnancy conditions.
- Psychiatric disorders
- Renal and urinary disorders
- Reproductive and breast disorders.
- Respiratory disorders.
- Vascular disorders.

In Britain alone there is officially over a million of these conditions appearing after vaccination with around 2,000 deaths. The MHRA admits that this is likely to be only 10% of the real figure. Other studies say that it is only 1%.<sup>55</sup> On this basis Britain alone has seen at least 20,000 vaccine deaths or possibly 200,000.

In previous vaccine rollouts, such as for Swine Flu, the programme was terminated after 50 reported adverse reaction deaths. Why is the vaccine rollout continuing? Because the plan is for mass death and so the truth is being covered up.

### **Conclusion**

There is no doubt (which lawyers are pursuing in the courts) that there is a premeditated plan to cause genocide through the whole Covid programme.

## **The legal fight-back**

As I warned Boris Johnson and the Leader of the House of Commons two years ago, there would be a legal prosecution of all the people in power and influence for their crimes against humanity during the Covid crisis. This is now underway.

### **The Reiner Fuellmich prosecution**

This German/American class action lawyer has spent two years with his Berlin Corona Committee gathering *prima facie* evidence on all the factors in the Covid crisis. This includes multiple videos of testimony from scientists, doctors, nurses and others.

His case is now complete which he claims proves harmful intent by world leaders, such as Johnson, Arden etc. and their advisors, Klaus Schwab and Bill Gates. Fuellmich has now given up trying to get the case heard in mainstream courts such as the ICC because they are completely corrupt. He states that 25% of European courts are owned by George Soros and Bill Gates money. [I would add that they are dominated by Freemasons.] Therefore, his case is being filmed as a Common Law Grand Jury so that all the evidence is presented for others to use in local jurisdictions and he advises all western nations to set up a new court system, which some are already doing.

### **The ICC prosecution**

This is a 46-page legal presentation charging Gates, Johnson, Hancock, Javid, Fauci, Daszak and others with genocide. It is now with the International Criminal Court in the Hague as from 6 December 2021. The crimes are violations of the Nuremberg Code and war crimes as defined by the Rome Statutes articles 6,7,8,15,21, 53. The case was brought by attorney Hannah Rose and seven applicants.

### **The Michael O'Bernicia case**

This comprises 1,100 pages of *prima facie* evidence accusing Johnson, Hancock et. al. of fraud, corruption, malfeasance and manslaughter. It includes the testimonies of doctors, nurses, police officers and lawyers. The case is currently being evaluated by a judge pending a hearing in the High Court. This case is now also tied in with the ICC case.

### **Multiple Notices of liability to police stations**

All over the country lawyers and others have brought case files to local police stations based on data compiled by ex-policeman Mark Sexton. Hundreds of pages of documentation have been supplied to chief constables. These also give notice of legal liability to police officers if they fail to investigate and arrest all those involved with the vaccine rollout for crimes against humanity, fraud, corruption and malfeasance.

The chief of these actions is a case brought to the Metropolitan Police at Hammersmith which has a specific case number. All police chiefs are now aware that there is massive evidence of a crime being committed and that they have a duty to investigate and arrest and terminate the vaccine rollout.

## **Conclusion**

I have maintained the majority of the headings in the paper for two years. I made verbal warnings about the dangers of lockdown policies and over-exaggerating Covid from January 2020 and wrote my first paper exposing the lies in March 2020. For this I have been pilloried and castigated, even by my own family. But everything I said has now proved to be true. Minor details in older papers may have changed due to growing levels of new information but I have not had to retract any important statements.
